PREFACE

The publication herewith presented, an index to the probate cases filed in Coleman County, Texas, is No. 42 of the Texas series of counties. The publication is intended to meet the requirements of day-to-day usage by the officials of the county, attorneys, businessmen, and other citizens who have occasion to consult probate case records for the proper conduct of their affairs. The publication may be used by historians and genealogists to obtain references to unpublished source material.

The names of the deceased persons, minors, and other principals are arranged alphabetically, with reference to the filing date of the case and the case number. Differentiation between probate cases assigned duplicate numbers is accomplished by the addition of a letter following the case number. The letters "L" and "P" were sometimes used by the clerk to indicate lunacy and paralytic cases. The following numbers in series 1-1721 were not used as case numbers: 47, 63, 90, 95, 123, 283, 297, 301, 367, 368, 416, 431, 798, 898.

In Coleman County all probate records are in the custody of the county clerk. Case papers are filed in numerical sequence in separate file jackets in plainly marked steel file drawers in the vault adjacent to the clerk's office on the first floor of the county clerk's office building on the courthouse square.

Upon the creation of Coleman County in 1858 the territory was attached to Brown County for judicial purposes. Although Coleman County was organized in 1867, no probate records of the period 1867 to August 1876 were found extant in the county.

Since the transfer of territory from one county to another has affected probate jurisdiction and has determined the county in which the probate case should be filed, a map and table of territorial changes are included herein. Notations concerning present location and availability of records pertinent to Coleman County follow:

Bexar County, San Antonio, all records extant

Brown County, Brownwood, all records destroyed by fire, 1880

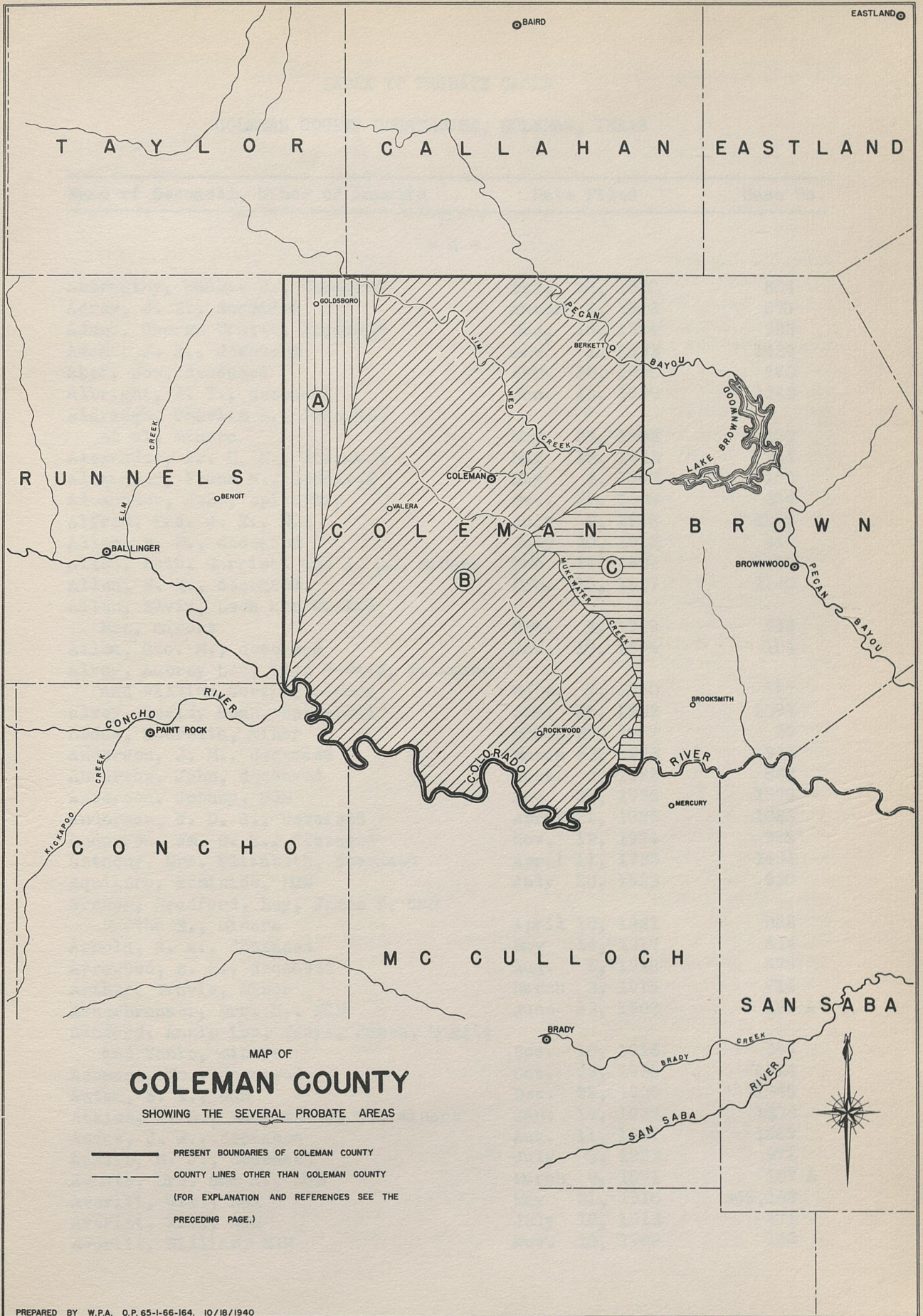
Travis County, Austin, all records extant
