"BE AFRAID, BE VERY AFRAID..."

November 8, 1994, was not a good day.

The election of notoriously conservative candidates (mostly Republican) throughout the nation, state and city, is frightening. Lamenting their victories and dreading their pending coronations in January, 1995, I've realized that:

1. It underscores the existence of strong grass roots organizations that focused their energies through receptive and supportive avenues.
2. Their organizations crossed lines (politically, financially, socially) and worked together to combine resources, raise funds, and promote mutually acceptable candidates of their choice.
3. Their organizations successfully motivated a segment of people to vote in an effective block.

A.M.A. CALLS FOR NON-DISCRIMINATION

The American Medical Association last week adopted a sweeping policy change regarding health care provided to gay men and lesbians, including a refutation of "reparative" therapies designed to "change" gays into heterosexuals. The AMA has 298,000 members and is the nation's largest and most powerful medical organization. The new policy, outlined in a 20 page report, Health Care Needs of Gay Men and Lesbians" calls for a "non-judgmental recognition of sexual orientation" by physicians and was passed by the AMA governing body, on Dec. 6. The report was presented to 430 delegates at an interim AMA meeting in Hawaii by W. Douglas Skelton, MD, chair of the AMA Council on Scientific Affairs, and passed "with little discussion."

The 20-page report covers a broad range of issues of concern to gays, including urging physicians to examine lesbians for a wider range of illnesses than is presently done, addressing the problem of substance abuse in the gay community, and calling for a "national health survey which should incorporate a representative sample of the US population of all ages (including adolescents) and should include questions on sexual orientation and sexual behavior.

GLSO DISCRIMINATION PROJECT RESULTS

According to a spokesman, so far this year the GLSO Discrimination project has received a total of 9 reports of sexual-orientation based discrimination from a total of 6 people. The largest category of incidents reports are verbal threats or harrassment (five), followed by being fired from a job or denied employment (3).

Several people reported being harassed at their workplace; one man was fired from a fast-food restaurant because a customer complained about his sexual orientation (the customer had overheard the man talking to friends while on a break), a transexual was ordered to wear regulation male attire, a worker at a factory in Berea was laid off, being told he wasn't "decent" (when other employees were called back from the layoff, this person was not), a gay man in western Kentucky was not hired by the police department, even though he scored well enough to qualify two different times when he took the civil service exam (he was told he might as well not even take the second exams by someone on the staff, because he would not be hired due to "something in his personal life -fortunately, he is currently working for another police department), one person had a formal complaint filed against them because they were working in the company. A lesbian complained that a neighbor threatened to rape her. An automobile with a rainbow flag was vandalized (just above the flag), and a woman reported she was not permitted to rent because of her sexual orientation.

Jeff Jones, the compiler of this information reports that the number of reported incidents is down somewhat from last year. It isn't clear whether there is actually less discrimination to report or people just aren't reporting the incidents as they happen. A gay man was killed in a gay-bashing incident in Louisville earlier this year, and this wasn't reported to this organization and the Lexington Herald-Leader ran a story on December 18, that told of a female coach who was fired from an area high school because of her sexual orientation. Documenting abuse is an important component of establishing the need for legal protections, if you have been a victim of discrimination because of your sexual orientation, be sure a contact the GLSO Discrimination Project at 276-5383.

HAWAII'S MARRIAGE CASE

Hawaii's case is due to be heard in late April of this year. The information listed here is a bit dated, but as far as we know, no further developments have been made. -EG

Baehr vs. Lewin is the official name of Hawaii's landmark marriage case, in which Ninia Baehr is the first in alphabetical order of six plaintiffs suing the State of Hawaii for marriage licenses. Jack Lewin, as head of the State Department of Health, denied these 3 same-sex couples their licenses and denied another same-sex couple their license on June 17, 1994. Jack Lewin has publicly distanced himself from the case. His public letter is appended below.

As Jack Lewin explains in his letter, Hawaii's Attorney General never called upon Lewin to testify in the court case. It would greatly embarrass the state, as it tries to demonstrate some "compelling state interest" in perpetuating sex discrimination, were the six plaintiffs to subpoena Lewin himself as a witness saying that there were no compelling state interests. It should add some levity to the April, 1995, proceedings.

For newcomers to the case, the Hawaii Supreme Court has ruled that denying same sex couples marriage licenses is sex discrimination, subject to the same scrutiny as racial, ethnic or religious discrimination. UNLESS the state can demonstrate a compelling state interest, the

According to this report, "Most of the emotional disturbance experienced by gay men and lesbians around their sexual identity is not based on physiological causes but rather is due more to a sense of alienation in an un-accepting environment," the report states. "For this reason aversion therapy (a behavioral or medical intervention which pairs unwanted behavior, in this case, homosexual behavior, with unpleasant sensations or aversive consequences) is no longer recommended for gay men and lesbians."

The new AMA policy also gives a nod to domestic partnerships and other similar personal relationships and urges physicians to "consider the special needs of gay men and lesbians who have significant partner relationships. Whenever possible," the report recommends, "physicians should explore surrogate decision making preferences of their homosexual patients before the need arises.... Physicians and gay male and lesbian patients should be aware of and plan for the possibility of conflict between the families and partners of these patients."

ANTI-GAY MEASURE COSTS CITED

According to Stacie Spector, director of the gay rights lobby Americans Against discrimination, passage of anti-gay legislation has cost city and state governments at least \$169 million dollars in lost business. Her group arrived at this estimate surveying convention and visitors bureaus, chambers of commerce and groups working to defeat such initiatives.

In Colorado, which passed Amendment 2 in 1992, the state has lost close to \$120 million in convention and tourism business through the end of 1993. At least 47 organizations canceled plans to hold conferences or conventions in Colorado as a result of this legislation. In addition, several companies dropped plans to move to the state.

The group estimated that Cincinnati has lost some \$19.2 million since voters there passed an initiative in 1993 repealing an ordinance protecting gays from discrimination based on sexual orientation.

In Portland, Ore., more than \$15 million worth of convention business has been put on hold pending the vote on a statewide anti-gay initiative in November. That figure represents business from eight conventions expected to bring almost 27,000 visitors. "Most are waiting to see," said Deborah Wakefield of the Portland Visitors Bureau. "I'm sure if this passes, the state will see an effect everywhere."

When asked whether any groups booked meetings or conventions in Oregon because they approved of the anti-gay measure, Wakefield said, "If there was anyone like that, they did not communicate with our office."

Cobb County, Ga., lost an estimated \$10 million when gay activists pressured the U.S. Olympic Committee into moving the 1996 volleyball competition elsewhere, Americans Against Discrimination said. The activists mounted a protest after the Cobb County Commission

passed an ordinance in August 1993 that said "lifestyles advocated by the gay community" were incompatible with community standards.

Following a vote in 1992 to repeal sections of the city's human rights ordinance, Tampa, Fla., lost at least \$5.5 million with the cancellation of the 5,000-member GALA Choruses convention and a meeting of the Catholic Campus Ministers Association, Spector's group said.

The Portland Visitors Association has spoken out against the local ballot initiative, as have several of the other affected convention and tourism offices. "Business organizations are standing up to the radical right groups as the costs of their divisive agenda become painfully clear," reports MS. Spector. Americans Against Discrimination, is a project of the Human Rights Campaign Fund.

licenses will be issued. The state will present its compelling state interests in April of 1995, and the courts will rule on their sufficiency after that.

The closest parallel to a compelling state interest was the internment of Japanese Americans in WWII, just for being of Japanese ancestry. At the time, such internment was legal—it is doubtful that any court would say so today.

Politically, Jack Lewin has an uphill battle against the Lt. Governor Cayetano. Cayetano has made it clear that he thinks that ALL couples should have domestic contracts in the law, straight or gay, and that the word marriage should be left to the private use of churches. Unfortunately, federal law uses the word marriage for tax benefits, prison visitations, immigration law, etc., so Cayetano has to be a bit more clever than that. To the credit of Cayetano, he's made it respectable for Democrats to say that the law should be the same for both—many Democratic party candidates have adopted Cayetano's position (first announced last March), including Lewin himself.

LEWIN'S LETTER

Dear Editor:

I would like to give notice to the gay and lesbian community on the issue of Baehr vs. Lewin. I resented having the Attorney General's office attach my name to this case without consulting me or verifying my views. I am not opposed to gay/lesbian unions. Moreover, in terms of the benefit of monogamy, such unions serve public health goals.

I have a strong record of supporting the rights of gays and of non-discrimination in this regard. I was not called to testify in this case for these reasons.

This issue should be decided in the courts. Whether the outcome is in the form of an expanded rights version of domestic partnership for all people, with marriage as a religious choice, or in the form of gay/lesbian unions, or as traditional marriage is incidental. The decision as to how to proceed with a relationship is personal and spiritual.

Nonetheless, the State must no longer discriminate in terms of civil, legal, and financial rights toward gays who elect to marry or form life partnerships of whatever name.

My name is attached to this case because I was Director of Health, and the Health Department issues marriage licenses. My point here is that I strongly support equal human rights. --Jack Lewin

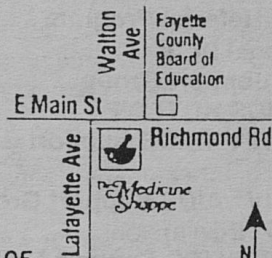
