

I enclose also a check for \$5.00, contributed by Mrs. McClure of Paris (Please send her a receipt) toward these expenses, so that more than pays for the fillard telephones and the State comes out on an even \$100.

Your answer was as fine a specimen of courtesy joined with a firm insistence on what was due to yourself as I have ever seen. It was an example worthy of emulation, and I am glad to have had the opportunity of seeing it.

> I don't wonder you are a little tired of going it alone. I have had those moods a few times myself. You certainly have been an excellent Treasurer. I'm sure that I personally feel grateful to you, as I know that every member of past and present Boards does. You can't, of course, be a finance committee all by yourself. But, I believe it's time enough for the President and the rest of us helping to give a pull all together. Y Try to get one on its feet: this time I think we might succeed. I shall offer my services to help, as I can, to do it, as soon as I can get around to write her. But, I'm still trying to wind up certain Lexington jobs by mail, - haven't even gotten time to work in the rest cure properly yet.

I hope you will get your big sums to hold up as prizes, which will undoubtedly make it easier. But, in the meantime, I'm pretty sure that we can do something with the smaller ones.

I didn't realize I was suggesting impossible things in my letter. I don't believe, for instance, that the suggestion about getting something from the other newspapers is impossible, though it will take a little patience and persistence, perhaps several of us trying it. If it is, if we can get nothing from the other papers, then I certainly shall not urge Desha to contribute for the Herald another year. As you say, \$100.00 is a small sum, and unless it has some value in bringing in other money, there is no use at all in the Herald putting it in, - especially when I know a dozen good ways to put in every hundred or every one that Desha or I can spare.

Just before I left we had a meeting of our Civic League Committee to see if we could give a little lunch to Kindergarten and 1st Grade children at Lincoln School. We had done some comparative weighing in the fall months: the proof that they needed it was there all right. But, when we figured up our other responsibilities we found we couldn't do it, and, we also found how much less our out-door children there had gained in November than in October; due apparently to the fact that they needed more food in cold weather and that we had cut down our milk supply from lack of funds. The Associated Charities has a similar showing. So, I am writing small checks and trying to get larger ones for those needs. It is, of course, difficult to do when we are all wanting to do all we can for the war sufferers. This just as an example of why we think a little more about how much execution we can squeeze out of each hundred.

Won't you mail me one of your last year's Treasurer's reports?

I'll be glad when Mrs. Kelly's money comes in finishing the 1917 account and letting me start the 1918. I am sorry to say I can't endorse your proposition for 1918, not to give your \$100.00 unless nine others excluding the Clay family, do the same. If it is fair for you to give your \$100.00 that way, then it is equally fair for the others to do the same. In that case I would have no right to collect a single \$100.00 until had the pledge of all ten, and if I did collect eight, and the ninth was not forth-coming and you did not pay the tenth, the other eight would have the full right to ask the return of theirs, giving as a reason that Mrs. Breckinridge's money was no more nor no better than theirs. If your proposition is fair, it is equally fair for Mrs. McDowell, or any of the others giving \$25.00, to say they will give provided forty others (bringing \$1000 just as yours does) do the same, or if I, who give but \$5.00, gave upon condition, two hundred others did the same. I dont think you have the right angle of the Carnegie plan. Your \$100.00 isn't worth working very hard for. If your proposition was, that you'd give \$100.00 without restriction, offering to raise it to \$1000.00 if ten others give \$100.00, making

Mrs. B. # 2. the other \$1000.00, then as a Treasurer, I would have a proposition to handle and so would the finance committee. And now, a word about that Committee -- It's easy for you to say "form a good finance Committee from different parts of the state and make 'em begin to work." I know you haven't forgotten how impossible it was for you to form one and those were not war times and people hadn't the excuse to offer that they are offering now. My opinion of a finance committee is that it should be composed first of you, Miss Clay, Mrs. Hutchison, Miss Averill and the others who were so certain the money would be forth-coming, then of other women you felt sure would really work. You know I will do my share but most money comes from personal influence and not because a Greasurer writes a note. The fact that you could get but \$2.00 from wealthy women is an indication of the difficulty confronting others. I think that League pledges should be taken from League trasuries, and that contributions from individuals should be credited to the individuals and not to Leagues. I am sorry to write you a letter that sounds almost rude, though surely you will not think I mean it to be so. Wilson. For though he wants the Federal Amendment, he still more desires his administration to be supported by a Democratic Congress.

Again: The twofold policy of the Asse. requires care for the interests of both methods to be safe-guarded. While one may be held in abeyance for cause, neither should be sacrificed for the other. On this principle I freely consented last winter to give ample time for the action of the Senate before askibg the Legislature for a State amendment. It was only on reaching the e limit of time possible for the Legislature to act that I felt the Board had failed in its duty to the instructions of the state convention. Now the Federal Amendment has been defeated in the senate. The fact that there is a motion for reconsideration to slight a claim to give it the right of way over other methods. It that were not true, it might claim right of way interminably on some slight plea or other. I consider that in zeal for measures in its behalf, the Board took action which might easily irritate wone of the parties in the State upon whose good will a state amend — ment must depend; and runs the danger of alienating our strongst friend in Pres. Wilson. This seems to me also as antagonistic trux friend in Pres. Wilson. This seems to me also as antagonistictour to our established policy of caring for woman suffrage as a whole.

I want to take this opportunity to express my satisfactor on that you have consented to be a candidate for the presidency the coming state convention. I did not say this in Louisville because in a conversation last spring with Mrs. Hutchison I had told her that she was my choice as a candidate. She did not then express any desire for the office; but as I had promised my sup-

Dear Madam President:-

At the State Convention in Louisville in March it was agreed that in addition to trying at the 1920 session of the Kentucky Legislature for ratification of the Federal Suffrage Amendment in case it has passed Congress—and we hope it may be passed at the special session—the K. E. R. A. should try for Presidential suffrage.

With regard to presenting bill to submit a State Amendment to the people of Kentucky granting woman suffrage, the following motion was carried:-

"That the question of asking the Kentucky Legislature to submit a state suffrage amendment to the voters of Kentucky be referred to the incoming Board of the K. E. R. A. to be taken up after the St. Louis meeting, and the recommendation of the Kentucky Board then sent to each local suffrage association for action."

The matter was taken up with the New National Board after the St. Louis National Convention with the result that the National Board passed a most liberal and gratifying motion to to the effect that the National Board trusted the judgement of the Kentucky Board and would stand by Kentucky in whatever she decided to do: Kentucky, of course, doing her best to obtain ratification of the Federal Amendment, if passed. At a meeting of the Board of the K. E. R. A. held in Louisville immediately after the National Convention, the matter was fully discussed and three motions were subsequently submitted, in writing, to the Board members for their vote. The following motion submitted by Mrs. Leech was passed:-

"Officially, I move that in recognition of Mrs. Catt's Recent request to the Kentucky members in St. Louis, to hold off a campaign for a state suffrage amendment, (if one was decided on) until it could not jeopardize the federal amendment, that we lay on the table motions involving discussion of such state amendments until the special session of the United States Congress submit to the state legislature a federal amendment or adjourn."

The matter is now referred to the local leagues for action. Will you kindly take a vote of your league at the very earliest possible moment and let me have your instruction?

The Republican State Convention will be held in Lexington, May14, and the K. H. R. A will twy to get a suffrage plank in its platform. The form of this plank will, of course, be influenced by your decision, though it is the present intention of the Board to ask for a plank broad enough and strong enough to commit the party's representatives to any form of woman suffrage asked for by the K. E. R. A.

It may be well to state briefly the differing positions of members of the Board as regards the state amendment. Some members of the Board feel that we should, under no circumstances, submit a state amendment, fearing that it would be defeated at the polls. Others, who feel that it may be wise to submit a state amendment before the next legislature of January, 1919 adjourns, believe that we should not state our purpose to do so, while it may in any way injure the chances of a federal amendment. Others feel that unless the federal amendment is through and ratified before the adjournment of our state legislature, we should absolutely submit a state amendment and not again lose our chance to do so for two years

Your league should vote as I understand the question (a) in favor of such action as is recommended by the Board in Mrs. Leesh's motion: or (b) in favor of deciding at once that a bill for a state amendment shall be presented in the 1920 legislature: or (c) in favor of deciding at once that a bill for a state amendment should not be submitted in the 1920 legislature.

In submitting the first letter to the league presidents after my election as your president, I should like to state the pleasure it gives me to be again actively allied with the suffrage work and to say how much pride I feel that the cause has really profited by my absence while you have been under the excellant guidance of my predecessor, Mrs. John C. Scuth.

Dear Board Member: I found Wonday night that Mrs. South was in a very unconfortable condition, because of the fact that she was obliged to act in a dual capacity as a member of our Board and Committee and also as chairman of the Woman's Committee and adviser of the Republicans. Her solution of the difficulty was to resign from the Equal Rights Board. This solution I felt sure would be as distressing to the rest of you as to me. I therefore proposed that in this particular job, she should simply be excused from service as a member of the Equal Rights Committee. pereurion I therefore, acting on the preference of the majority of the members as to the plank to be requested, ignoring preferableness granted in several cases that Mrs. South and I use our judgment.

I had asked a number of representative republication women of Lexington, to go with me to the State Resolution Committee, and I make the request for the Equal Rights Association, for the following plank:

The Republican Party of Kentucky re-affirms its belief in the Justice and expediency of suffrage for women, and calls upon its representatives in Congress to vote for the submission of a Federal amendment granting woman suffrage, and pledges its candidates for the Legislature of Kentucky and for all executive positions to use their votes and their influence for the speedy ratification by the Legislature of such Federal amendment when submitted, and also for the passage of a bill granting presidential suffrage to women.

Miss Clay was present also with a group of women, to ask a State amendment plank.

I rather expected the outcome to be the combination of one asked for by me and the one asked for by her, as did Christine.

The Republican Party is ready to grant anything it can in the way of Woman's suffrage, and seemed of course anxious to satisfy all comers. The upshot however was the blanket plank originally asked for as follows:

We re-affirm our belief in the justice and expediency of suffrage for women and call upon our representatives in the Congress of the United States, in the Legislature of Kentucky and in all executive positions to use their votes and their influence for all measures granting political rights to women.

In a number of organizations which I belong it has been customary to send out to each member of the Board at the beginning of the month, a treathurer's report showing both receipts and expenditures for the month before, lieu of frequent business of the Board. Dear Miss Clay:

The Bradford Historical Society has undertaken to raise, through public subscription, a fund to place in the Lexington Public Library a bronze tablet bearing the image and recalling the accomplishments of John Bradford, for whom the Society was named and who was the editor of the first newspaper to be published in Kentucky.

The Society enlists your aid, personally, in this enterprise. The Kentucky Gazette, the second newspaper to be published west of the Alleghanies, has been described as a "voice crying in the wilderness" for free speech. John Bradford, as an historian, as a champion of freedom of utterance guaranteed by constitutional provision and as a pioneer in journalism, contributed much to his own age. The fruits of his labors are, however, more abundantly enjoyed in the present than they were in the past and the benefits of his work will be reaped for centuries to come.

The lack of a suitable memorial to Kentucky's first editor has long been appreciated. This Society believes that members of the newspaper profession throughout the United States, lovers of free speech, teachers and students of history and all Kentuckians who cherish the memories of the trail-blazers who made the commonwealth of today a possibility, will approve its efforts to supply this lack.

A return envelope for whatever contribution you care to make is enclosed. The Society also requests your assistance in spreading the appeal for contributions to the fund and in emphasizing the importance of placing a tablet commemorating the achievements of Mr. Bradford in the Library he aided in founding and to which he donated the precious files of his paper.
