SUE HYDE, DIRECTOR OF NGLTF PRIVACY PROJECT, SPEAKS IN LEXINGTON

The Lexington Gay Pride Week Association gave our community a very special treat this year by sponsoring Sue Hyde as the keynote speaker for Gay Pride '87. Her appearance in Lexington, which was very generously hosted by Juice's Showroom, was the first stop on her Southern tour, including Gay Pride events in Memphis, Nashville, Knoxville, Johnson

City, Atlanta, and New Orleans.

Ms. Hyde is presently the director of the National Gay and Lesbian Task Force's Privacy Project, which was established in order to assist local and state organizations in their efforts to repeal sodomy legislation. Prior to her position with NGLTF, Ms. Hyde was an editor for the Boston newspaper Gay Community News and a founding member of the Cambridge (MA) Feminist Anti-Censorship Taskforce.

In her speech, Ms. Hyde addressed the state of sodomy law reform since the infamous 1986 Supreme Court decision upholding state's rights to criminalize homosexual activity. According to Ms. Hyde, several significant gains have been made in the past year, one of the most promising of which occurred here in Lexington.

Recently a Fayette County judge ruled that Kentucky's sodomy laws are unconstitutional. Presently, the decision is valid only within that judge's jurisdiction, but the appeal process offers the possibility for a similar state-wide decision which would effectively

decriminalize homosexual activity in Kentucky.

The primary thrust of Ms. Hyde's speech was that in light of this court decision, now is the time for the creation of local gay and lesbian political action groups, and, ultimately, such an organization at the state level, with the express purpose of working to achieve repeal of the state's sodomy laws. (Conviction under these laws can result in a heavy fine and a prison sentence.) Through her interest in our local community, her positive, affirming persuasive arguments, experience-based knowledge, Ms. Hyde was able to convince all of us that such political efforts can, indeed, succeed in Kentucky, especially given certain provisions within the state constitution. The primary ingredient for success is active, sustained, and organized participation from as many people as possible. Hopefully, the next time Sue Hyde visits Lexington, she will be able to see positive, concrete results of her recent appearance.

CKCPJ CIRCULATES ANTI-RACISM PETITION by P. Weingartner

The CKCPJ (Central Kentucky Council for Peace and Justice), a coalition of twenty-two peace an justice oriented groups in the Lexington area, is currently sponsoring and circulating an anti-racism petition. The council is seeking one thousand signatures and a donation of one to ten dollars from each signer. The donations will be used to offset the cost of having the petition and the signatures printed in a full-page advertisement in the

Lexington Herald-Leader on July 4th.

The council decided to write and circulate the petition when it was learned from two articles in the Herald-Leader that the Ku Klux Klan might be holding a demonstration or other activity in Lexington. On February 1, Herald-Leader quoted a Klan official On February 1, the reference to the January 24th picture burning of Martin Luther King, Jr. in Pleasure Ridge Park, stating, "the organization might do the same in Lexington soon." Don Ater, Grand Dragon of the Klan's Kentucky chapter, who took part in the picture burning, was quoted by the Herald-Leader on February 2: Klan "might come to Lexington."

The purpose of CKCPJ's petition is declared by the wording of its first sentence: "the undersigned residents of central Kentucky affirm our belief in the equality of all people." The petition goes on to condemn all forms of racism and racial violence, such as recent cross-burnings at Lexington churches over the King Holiday weekend.

WOMEN'S NEWS

The following is a continuation of an excerpt from Our Right to Love, a Lesbian Resource Book, which was produced in cooperation with women of the National Gay Task Force. The book was published in 1978 and is now out of print.

WOMAN TO WOMAN: LESBIAN INTIMACY

... This does not mean that lesbians suffer less discrimination than gay men. Once the label "lesbian" is applied, one is seen almost exclusively as a sexual being. In fact, studies have shown that lesbians are believed to be far more sexual than other women. There is no scientific evidence to support this belief, but that hasn't stopped many people from thinking that lesbians are sex-crazed. This misinformation has led to a host of other myths, including:

1. "Lesbians are child molesters." Lesbians are no more guilty of this offense than heterosexual women. Women in general are rarely child molesters. More than 90 percent of child molestation is committed by

heterosexual men.

2. "All a lesbian needs is sex with a man to 'cure' her." In fact, many if not most of us have had sex with men and it obviously hasn't done a thing for us! Isn't this idea an interesting commentary on men's perceptions of their own sexuality? Sex with a man is supposed to be so great that lesbians would willingly give up their assumed greater sexual appetite for it! Needless to say, this idea isn't true; in fact the opposite is true if one is strictly looking at sexual performance standards. According to Masters and Johnson, a woman is most likely to have an orgasm while masturbating, with lesbian sex a close second and heterosexual intercourse a poor third. Of course, the most important consideration in sexual pleasure is the psychology of the situation, and a lesbian is going to prefer having sex with a woman and a heterosexual woman is going to prefer having sex with a man.

3. "Lesbians are 'that way' because they are afraid of or hate men." While this may be true of some lesbians, there is no evidence that it is true of a large proportion. It is probably just as true that heterosexual women are "that way" because they fear or hate other women. But since straight scientists think that heterosexuality is the norm, which doesn't have to be explained, there hasn't been any

research on the latter subject.

4. "All two lesbians want from each other is sex, sex, sex!" (And to think of all the times I have avoided sex at all cost with 4 GLSO

another lesbian in order to preserve the friendship.)

Garbage, garbage, garbage! Lesbians are "that way" because they prefer other women for love and emotional support. It's as simple as that.

What we create here together in this Festival week is a community village that continually reflects a female spirit - in the music, the art, the dance, the crafts, the costumes, the humor, and the caring with which we live together. The experience of that for most of us is unique in our lives, and the empowerment that comes from living in a matriarchal spirit is something tangible that we take home with us. We invite you to come and join us - be part of carrying the vision to yet a new place in the creation of this summer's gathering.

The festival begins on Wednesday this year, marking the first time it has encompassed five full days. This allows for many more performances and workshops, comedic and musical performances will include, among others, Rhiannon, Ronnie Gilbert, Lucie Blue Tremblay, Alix Dobbin, Holly Near and Barbara Higbie. 
Dignity/Lexington has a new phone. The number is 269-8417. Don't forget to make a note of it and give us a call.





ASK AUNT MARY

ASK AUNT MARY

Dear Aunt Mary: I am a twenty-six year old lesbian and am totally out to my immediate family, friends and even at work. This means I am very open about myself and do not feel comfortable trying to hide or disguise my orientation. Normally I don't have too, but it does become a problem when I visit my parents or siblings who live in another city. variably these visits are on holidays when get togethers are planned with the extended family, which always leads to what seems to be an interrogation by assorted aunts, uncles, cousins, etc., etc., regarding my personal life. Are you dating anyone, when are you going to settle down, do you plan to have children? I'm not really close to these people and haven't much desire to come out to them, but how do you answer those kinds of questions? I might add that my parents and brothers and sisters would prefer that I do not discuss my orientation with my relatives. Confused - Louisville.

You don't really sound all Dear Confused: that confused to me, maybe you just need someone to confirm your thoughts. You don't feel close enough to your distant relatives to come out to them and only see them on occasional visits to another city, so it doesn't really effect you in your daily life. Under those circumstances and giving your feelings and the feelings of your immediate family on the subject, why bother? As to how to answer questions, how about the direct but brief approach? That would be Yes or No, as the case may be; I am, thank you; and I really haven't decided yet, but when I do you'll be among the first to know. As for your contention that you are being interrogated, my guess is that you are simply over reacting to mild expressions of interest from relatives who are not particularly close to you either, but don't want their conversations with you reduced to comments about the weather. 

AIDS UPDATE

KENTUCKY AIDS UPDATE

The State Health Department reports 14 new cases of AIDS diagnosed and reported in Kentucky through May 13th. If you project that figure for the balance of 1987 you would expect about three new cases per month By comparison, when they began statewide. keeping statistics five years ago there were only 3 cases reported statewide in 1982.

At the current rate chances are good we will see about one new case each month from Lexington this year. During the past fifteen months new cases reported from Lexington have increased 120% compared with an 80% increase in Louisville.

The message here is simple: AIDS is a problem in Kentucky and it will get worse. We may have a small number of cases compared to New York or San Francisco, but we also have a much smaller population. Over 21% of the high risk patients (primarily gay men) screened by the Health Department in both Lexington and Louisville have tested positive to the HIV antibody. If that is representative of the total gay male population, the odds are about one in five that you've already been exposed.



SAFEST SEX

Now that we have your attention we want to remind you of last month's article about condoms. Writing in the May 21st edition of the N. Eng. Journal of Medicine, Dr. James Goedert of the National Cancer Institute expanded the notion of safe sex by introducing the concept of He began with two reasonable safest sex. no one wants to die from an assumptions: incurable disease, and, most people prefer intercourse to the less intimate forms of sexual expression.

When AIDS was recognized as a sexually transmitted disease the gay community began to promote the use of condoms. Dr. Goedert writes, "however, 77 percent of the men in our studies who practiced anal sex in 1986 did not use condoms. Furthermore, it has recently been shown that condoms failed to prevent HIV transmission in 3 of 18 couples, suggesting that the rate of condom failure with HIV may be as high as 17 percent. It is clear that the use of condoms will not eliminate the risk of transmission and must be viewed as a secondary strategy."

The key phrase is "eliminate the risk of transmission." Jerry Falwell would propose monogamy, but Dr. Goedert seems to have a better understanding of human nature. doctor proposes each partner know the HIV status of the other and then engage in sexual activity that is appropriate to the risk.

summarize his recommendations:

HIV Status of Pair	Proposed Safe Sex	Risk-Reduction Measures
Neg-Neg	Any activity with absolute monogamy & no IV drugs.	Absolute condoms, no intercourse, HIV testing every six months.
Pos-Pos	NO HIV-Neg or HIV-unknown partners.	Condoms, avoid partners with infections.
Pos-Neg or Neg-Pos	Mutual masturbation	Absolute condoms, No intercourse.
Unknown	Mutual masturbation	Absolute condoms, monogamy, No intercourse.

If you haven't been tested for the HIV antibody call Greg Lee at the Health Dept. His number is listed in the Directory section of this Newsletter. If you have been tested and are negative, discuss periodic retesting with Greg. Your health and that of your partner(s) is your responsibility.

LEXINGTON POLITICAL ACTION ORGANIZATION FORMING

A new organization is being established in Lexington to promote the passage of anti-discrimination legislation by the Lexington Fayette County government. INSURANCE CONFIDENTIALITY

Responding to the demands of gay rights activists concerned about the confidentiality of HIV antibody tests, the Medical Information Bureau, Inc. (MIB) announced it had stopped keeping those records on applicants for life and health insurance. MIB is the computerized data service supported by the insurance industry as the central depository of medical records on all insurance applicants. For several months, about 800 insurance companies had been using a special code to report HIV test results to MIB. Effective May 14th, the change in policy included purging HIV results from all existing files. Applicants may still be tested for the HIV antibody by some insurance carriers, but nationwide results will no longer be contained in a central file in Boston.

GAY AMERICA

COLORADO

Colorado recently instituted sweeping legislation requiring doctors to disclose the names of people infected with the HIV virus and granting health officials the power to quarantine PWA's. Local gay leaders are threatening to open their own clandestine HIV testing sites and are urging gays in other parts of the country to boycott Colorado.

WISCONSIN

The University of Wisconsin recently urged Congress to allow gays to enter ROTC. Regent Ness Flores remarked, "It's (the antigay policy) to protect against security risks posed by homosexuals. I'm sure glad those Marine guards in Moscow were all heterosexual."

CALIFORNIA

The ACLU filed suit on behalf of a 33year old man who was evicted from a hospital drug-treatment program after he tested positive for the HIV virus.

MICHIGAN

A Michigan employer has settled out of court after firing an employee who has AIDS. The company agreed to pay an undisclosed amount of money and to post its present AIDS nondiscrimination policy in its offices.

NEW YORK

A federal lawsuit has been filed against Prudential Insurance Company of America for testing an applicant for HIV antibodies without his consent and then revealing the results at a public dinner in the community where he lives and works.

NEW YORK

The New York City Police Department has enlisted the Gay Officers Action League (GOAL) in a drive to recruit gay persons into the force. The New York action followed similar moves in Boston and Atlanta.

INTERNATIONAL NEWS DENMARK

The Danish parliament voted on May 8th to ban discrimination against homosexuals. A similar bill is to be considered soon in Sweden. The Swedish legislation would also give gay couples common law marital status.

CONGRESSMAN COMES OUT OF THE CLOSET

Rep. Barney Frank, D-MA, after years of ambivalence about disclosing the nature of his private life, has decided to acknowledge publicly that he is homosexual. "I don't think my sex life is relevant to my job, but on the other hand I don't want to leave the impression that I'm embarrassed about my life."
Rep. Frank continued, "If you ask the direct question: 'Are you gay?' the answer is: Yes. So what?"

Rep. Frank stated that recent scrutiny of Gary Hart's private life as well as disclosures about the homosexuality of the late Rep. Stewart B. McKinney, R-CN, who recently died of AIDS, had prompted him to make the disclosure. Massachusetts is now the only state with two openly gay members of Congress. Rep. Gary Studds acknowledged his homosexuality in 1983 after his sexual

relationship with a teenage page came to light.

The confirmation of Frank's sexuality came as no surprise to his House colleagues. "People who work with him already know about his sexual preference," said Rep. Brian J. Donnelly, D-MA. "But this enhances his image as a forthright, honest representative who's willing to say he has nothing to hide."
