Dr. Taylor was placed in charge of the division of agricultural education. Other committees were appointed to do research work. Other fields of the association are industrial, home economics, part-time, commercial and civilian rehabilitation.

ASSEMBLY WILL BE ASKED TO GIVE \$2,344,857

Appropriations Looking to Further Growth of Institution to Be Asked by Board of Trustees

MVEY RENDERS REPORTS

Recommendations Will Be Submitted to General Assembly in January

A program for a greater university, one that will give state-wide service, is contained in the report of Dr. Frank L. McVey, president of the University of Kentucky, which was submitted and approved by the trustees of the institution at their regular meeting held Tuesday morning.

Among the outstanding features of Dr. McVey's recommendations which covers a period of two years, were:

- 1—Appropriation of \$500,000 for the erection of additional classroom buildings
- 2—Purchase of 103 acres of land adjoining the foot of the Experiment Station
- 3—Annual appropriation of \$10,000 for development of the surplus acreage of the institution.
- 4—Appropriation of \$16,000 for buildings on the sub-Experiment Station at Princeton, in western Kentucky
- 5—Maintenance fees commensurate with the needs and growth of the university
- 6—Establishment of a student hospital at the institution with a total of 60 beds.

History of the University

The University of Kentucky is one of the agricultural and mechanical colleges that owes its origin to the Morrill Act of July 2, 1862. Instead of establishing at once, as most of the states did, a higher educational institution, the legislature did not place it upon an independent basis but made it one of the colleges of Kentucky University, now Transylvania College. To this institution the annual interest of the proceeds of the Congressional land-grant was given for the purpose of carrying on its operations. This continued until 1878 when the Act was repealed and a committee appointed to work out a plan for the state university. The City of Lexington offered the site and \$300,000 of city bonds which gift was supplemented by an additional \$20,000 in bonds given by Fayette County. With the money buildings were erected and the institution established at Lexington. In 1882 the name of the institution was changed from Agricultural and Mechanical College to that of State University and it was again modified in 1910 to the title of University of Kentucky. This institution is non-denominational in its character; it appeals to and caters to the people of all creeds, and endeavors, in strict conformity to the requirements of the law to afford advantages to all and exclusive privileges to none.

As a department of the University, the Agricultural Experiment Station was created in September, 1882, under the various provisions of the federal law which provide annual appropriations for the support of the Experiment Station. In 1912, the legislature voted an appropriation of \$50,000 in addition to the amounts granted by the Federal Government for this work.

The purpose of the Station is to carry on a continuous series of experiments by successful methods in order to learn what the application of science will do in bringing the best returns from the farm, the orchard, the vineyard, the stock yards and the dairy. In addition to this the Experiment Station is engaged in the publication of bulletins announcing the results of these experiments which have brought untold advantages to the farmer and the stock raiser. In 1912, the Smith-Lever Act was passed establishing Agricultural Extension work which places in the charge of the Agricultural College of the University of Kentucky, under the provisions of this Act, county agents are maintained by the State, and special home demonstration and agricultural agents are employed to carry on the work of agricultural education.

The teaching division of the University is divided into seven colleges, the Summer Session and the Extension. The colleges and schools thus established are those of Arts and Science, Engineering, Agricultural, Law, Political Science, and Graduate Work. The University also maintains a library which can be used by citizens of the State. The library now consists of 62,000 volumes and is engaged in gathering museum material that illustrates the history and development of Kentucky.

Space, Buildings and Equipment

The University has a considerable number of buildings but none of them were built with minimum amounts of money. The dormitory for men, about the most expensive building on the campus and was constructed at a cost of \$150,000 which was an appropriation in the 1920 legislature. In 1908 the legislature appropriated \$200,000 for the construction of buildings at the Experiment Station that date no buildings for educational purposes have been erected from special appropriations made by the legislature. In other words, the reclamation and laboratory space for the University has not been increased by the State for over thirty years. During the World War the Federal Government made an allowance for the erection of a shop in which to turn army mechanics. The University took advantage of this to build a permanent structure. This year an addition to the chemistry building has been made at a cost of \$186,000.00; \$136,393.14 of this amount came from the State, the balance heretax and the rest from operating income.

These are the only two additions made at the University for reclamation, laboratory or shop space during the past eighteen years. It has therefore been necessary to utilize basement space and to convert two old dormitories into more usable for residences for students, into recitation buildings. In this way, the University has been able to supply in the past few years for this situation to continue if the University is to meet the demands that are now being made upon it for the purpose of instruction. In order to meet the demands of the future it will be necessary for the State to make larger investments in the University if the increasing requirements of high school graduates for college education is met.

According to reports made by the State Board of Education in 1917 there were 1,200 graduates of the high schools in this state. In 1924 there were about 5,000 such graduates. Of this number about one-half enter college. According to figures

in possession of the registrar of the University of Kentucky one-third of those who enter college, come to the University of Kentucky and the United States Bureau of Education in an investigation of high schools shows that about 1 percent of children of school age should be in high schools. This would mean 70,000 high school students in Kentucky and on the basis of what is happening in other states throughout the country, our state should have approximately 17,000 high school graduates. If half of these went to college as they have been doing in the past there would be 8,500 boys and girls entering college and the University would have 2,500 freshmen and not 700 as at present. The denominational schools are about filled to capacity and therefore the source of training for these young people must come from the University of Kentucky if they are to obtain it within the borders of our state. It is extremely conservative to estimate that there are only 10,000 students seeking instruction at the University of Kentucky by 1930. What can an institution with scanty equipment to accommodate 2,000 students expect to do with twice that number? This is the most important question confronting the University of Kentucky and it is a question that will be solved in the same manner that other states have met it.

What the University Does

Students who have attended the University of Kentucky are to be found in every part of the country and undoubtedly, they have contributed materially to the welfare of the Commonwealth. The College of Arts and Science, the largest College of the University, not only trains in liberal education, it also prepares the service courses of all of the colleges: Mathematics, languages, sciences, economics, history and art. In addition, it gives a premedical course and prepares industrial chemists.

The Department of Journalism has graduates managing and editing newspapers in the towns and counties of Kentucky. The College of Electrical, Mining, and Civil Engineering, who are engaged in industry, mining and engineering in Kentucky and throughout the world, has had an estimated that there are ninety billion tons of surface oil and gas in the State which are capable of producing nearly one barrel to the ton at a little more than the cost of production. This means that there will be an industry in Kentucky, in the future, that will rival the coal industry in extent. For many years the Civil Engineering Department in this College has made for the State Road Department, the Department of Public Works and individuals several rock tests that have saved the State many thousands of dollars.

The College of Education is sending out carefully prepared teachers who are filling important positions in the schools of the State.

The College of Law is placing men in the State who are becoming the leaders of their profession.

The College of Agriculture has trained farmers and Economic leaders who contribute their knowledge and good sense to the advancement of farms and homes in the State.

The discoveries and work of the Experiment Station have added many, many thousands, even millions of dollars to the wealth of the State which are destined to increase its wealth even more in the future. It has been shown that diseases which are already present in the State have saved more than the annual support received from the State.

The development of the root-resistant tobacco saves Kentucky farmers many thousands of dollars annually by enabling them to grow tobacco on land infected with the black root-rot, a disease widely spread in many tobacco growing States which has been made in the control of two diseases very destructive to tobacco. The Kentucky Experiment Station has developed a strain of wheat that yields, in many instances, more than three bushels to the acre above the yield of other wheat. If the farmers of Kentucky would use this strain approximately two million dollars would be added annually to their income.

After various investigations and experiments, serums have been prepared which control abortion in mare and foal poisoning in animals that have meant, and will mean in the future, literally millions to Kentucky and Kentucky's farmers have been able to make a far greater wealth and greater happiness. And yet with increased equipment and with funds for additional workers the University could bring a greater number of the people of Kentucky greater scientific discoveries.

If the University of Kentucky is to adequately meet the demands for instruction and training which will be made upon it within the next five or six years, expenditures to the amount of \$5,180,000 will have to be made and would be distributed about as follows:

In making this statement concerning the needs of funds for building

and equipment at the University of Kentucky have been conservative that we have a feeling that an apology should be made to the future college men and women of our State. It is far shrewd that the University Commission recommended in 1921. Facts concerning this body and its recommendations are given in full.

The University Commission

It was these facts together with the necessity of Kentucky which led the Board of Trustees in their meeting in February, 1921, to adopt a resolution leading to the creation of the University Commission for the purpose of securing an unbiased study that would lead to definite recommendations. In May, 1921, the Commission consisting of John F. Hager, Ashland; George E. Engel, Covington; W. K. Stewart, Louisville; D. W. Gardner, Sayreville; Stanley Reed, Mayfield; E. F. Forgy, Ashland; Harry Giovannioli, Lexington; Lewis Humphrey, Louisville; F. M. McKee, Versailles; Newell Bright, Eminence; Charles H. Ellis, Sturgis; Clem S. Nunn, Marion; George Colvin, Frankfort; W. T. Fowler, Madison; J. D. Moscovitz, Paducah; McKenzie Moock, Bowling Green; Sainey T. Wall, Murray; T. H. Harrison, Lexington, and E. H. Woods, Paveville, visited the University at Lexington and then proceeded to Columbus, Ohio, afterwards visiting LaFayette, Ind., Madison, Wis., and Urbana, Ill., where they inspected the plans of the University of Wisconsin, University of Wisconsin and the University of Illinois. Upon their return the Commission issued the following statement to the people of Kentucky.

Report of the University Commission

To the People of Kentucky:
The Board of Trustees of the University of Kentucky are hereby glad to be at heart the interests of the people of Kentucky. They feel that the development of Kentucky industrially, agriculturally, and educationally is dependent in no small measure upon the advancement of a high grade State University for Kentucky. It has been in the view of the people of the State as some for a step forward, the more so because Kentucky cannot advance as rapidly as it should unless there is a steady flow of young men and women who are well trained in business and professional fields. Contemplating the matter seriously, the Board of Trustees asked a number of citizens to make a journey of inspection to the Universities of Ohio, Indiana, Wisconsin and Illinois and to report their views after studying the conditions in the University of Kentucky during the people of the State. In accordance with that request, this commission made a visit to these universities and the universities above referred to.

From this survey of these universities, this commission found a great variation in the character of the work done and the funds provided for carrying it out.
For the year ending July 1, 1921, a total of \$2,000,000 was levied for Ohio State University or Purdue \$900,000, Wisconsin \$3,000,000, Illinois \$2,500,000 and Kentucky \$400,000. The legislatures of the States of Ohio, Indiana, Illinois and Wisconsin during their present sessions have materially increased the figures given above for the coming biennium so that these institutions will have from their States increases varying from 30 to 60 per cent.
Kentucky excels these States in natural resources and this Commission is of the opinion that their superior industrial and agricultural development is largely traceable to the intensive training provided for their men and women. The University of Kentucky is excellently equipped with its buildings, its laboratories, its university budgets with that of Kentucky, Indiana with an assessment

roll of five billions, 100 percent valuation plans placing a million and a half at the disposal of Purdue and like amount for the University of Indiana. Wisconsin with the same area as Kentucky, yet with equal population and with \$2,500,000,000 upon its assessment roll as compared with Kentucky's two billion and a quarter (freely furnished) population, more than seven times the amount for University work. Wisconsin expends \$1.14 per capita, Indiana \$1.36, Illinois \$1.82, and Kentucky 14c.

Illinois has already invested \$9,000,000 in its plant; Ohio \$7,000,000, Wisconsin \$9,000,000; Purdue \$2,400,000 and Kentucky \$1,250,000.

With the exception of a shop erected during the war from federal funds, no new construction has been carried out during the past ten years at the University of Kentucky, while these institutions just to our north have new modern buildings and contemplated further construction at once. Purdue will have in the next two years \$1,200,000 for buildings and other institutions in proportion to a growth of 250 percent in the student body in the University of Kentucky, yet with equal available instruction purposes has increased by 3 percent.

Practically in every field of education these institutions eclipse the University of Kentucky. The buildings of our own institution are inadequate and old, the equipment insufficient, and the farm lands for agricultural, experimental, and instructional purposes meagre in acreage.

The presidents of the institutions and the deans of the agricultural colleges of the State and the view that agricultural instruction and demonstration required not less than 1,000 acres in the State and more than 1,000 acres after long experience. Kentucky has only 240 acres at the University now owned. In the matter of engineering and laboratory equipment the needs are equally great.

To be able to take a position commensurate with the population and growth of the State and to be equipped to meet the pressing educational requirements of its citizens, this commission is convinced that the University of Kentucky must have in the near future the following buildings:

- Chemistry building, equipped to instruct 1,000 students.
- An auditorium with a seating capacity of 2,500.
- Dormitories for women.
- Dormitories for men.
- A gymnasium for women.
- A gymnasium for men.

A modern dairy building equipped for the production, processing and distribution of dairy products.

- An agricultural engineering building.
- A home economics building.
- A heating plant.
- Engineering shops.
- An armory.
- Barns for horses, beef cattle, swine and machinery.
- A new poultry plant.
- A library building.

The inadequacy of the herds, flocks and studs for the work in animal husbandry is more than marked; it is astonishing. Substantial expenditures in this direction are needed at once. The Experiment station has performed splendid work with the funds that have been expended from the State, giving enormous returns for the expenditure. Fifty thousand dollars the purpose of the Experiment Station. This should be increased to \$100,000 annually to provide resources with which to carry on the work already in progress, but to give the added funds necessary for the investigation of the problems of market, farm management, and maintenance of soil fertility. The soil surveys and demonstration fields now in operation should be continued and enlarged.

At the earliest opportune time provision should be made for the establishment of sub-station stations to provide for the investigation of agricultural problems that cannot be successfully solved at the University of Kentucky. The creation of extension required to offset Smith-Lever funds appropriated by Congress should be made a part of the State appropriations enable the Agricultural College of the University of Kentucky to extend its services to the people of the State and bring them the information that will result in a marked increase in the agricultural wealth of the State.
In the opinion of this commission not less than \$8,000,000 will be needed for capital additions to the university plant and equipment in the next half a dozen years. With the growth being automatically forced by the large influx of students, operating expenditures must substantially increase.

The income of the university must be increased \$900,000 annually in the next two years. If additional increases to meet additional needs. Not less than \$800,000 should be provided annually for the next ten years for the construction of buildings and the purchase of additional equipment and grounds.

This commission has found that the personnel of the University of Kentucky is known and respected in the field of which it is a part. Considering the character of the equipment furnished, the character of the work done is extraordinarily high. As an educational leader, President McVey stands on a par with the chief executives of other state institutions. Kentucky is the basis for a great institution. Its leadership is of wide experience and high standing in their various lines. Under the direction of President McVey, Kentucky who take a pride in the position held by their chief institution of learning look forward to development which will place our university in position second to none in its special field. This result, however, can be obtained only by the expenditure of money. We can buy only what we pay for.
If by the youth of Kentucky are to have educational opportunities equal to those of other commonwealths, if Kentucky is to be developed by Ken-

tuckians, if our industry is to be manned, our educational institutions officered and led by scientific work done by the coming generation of the children of this commonwealth, they must be trained in an institution properly financed and adequately equipped to achieve this result requires the cooperation of every citizen interested in the development of educational opportunity. The university can but lead. Its support must come from the people of Kentucky.

Minimum Funds Needed for 1926 to '28

The amounts previously stated are what we believe and the University Commission believe should be given the University of Kentucky over a period of from six to ten years. The most ardent supporter of the university cannot hope to have the coming session of the legislature make an appropriation of \$10,000,000 to be used over a period of ten years, or even an appropriation of \$5,000,000 to be expended within the next five years, but it is entirely reasonable for all who are interested in the university to expect that the 1926 session of the legislature will bear in mind the long range needs of the university. It has had to do without special appropriations and will feel if not only their duty, but a privilege to make a special appropriation of \$7,000,000 or \$8,000,000 at least, to be expended during the next two years, made upon the imperative demands of the university for additional building and educational work.

In our judgment this is at least \$100,000 less than what should be provided to the university to carry on its work for the next two years in a respectable manner.

When we compare it with a few other universities it certainly looks small. In 1925 the State of West Virginia appropriated for her university \$1,300,000; Tennessee \$806,372; Missouri \$1,144,000, and these sums were given in addition to the regular maintenance. During that same year, 1925, the legislature of Illinois made the best appropriation of \$2,266,000 for her university, and in addition to this had already provided an income of \$1,144,000 annually. "Stand I stand idly by and see our sister states outdistance us in giving the young men and young women of these states so much better educational advantages than the boys and girls of Kentucky? We pride ourselves on having the best in the State, and we are all responsible, and it should be to bow and in shame the admission comes that other states are leading us in many of the things that are most essential to health, wealth and happiness.

WHAT ABOUT THE HONOR SYSTEM?

A committee of outstanding students in the College of Commerce of the University of Kentucky has recently organized a system as it exists in colleges and universities all over the country. From a fairly complete survey of the successes and failures of the system on other campuses, the committee reported that it was the unanimous opinion of its members that such a standard could be upheld by students in the College of Commerce.

The system as it stands has succeeded on many campuses, especially in the south. The latest system was first inaugurated at the University of Virginia. It has succeeded there for so many years that it has become one of the most cherished traditions of the institution. Washington and Lee, Princeton, Annapolis, West Point, Vanderbilt, University of California, and Tulane may be cited among other notable instances of success. The system has succeeded on about three-fourths of the campuses where it has been tried. Most of these are state institutions.

Under the system the student signs the pledge that he will neither receive nor give aid on an examination and that he will report any violation of the pledge which comes under his observation. On most campuses the decision of an accusation is handed down by a student council. Action rests in the hands of a faculty committee.

Harvard is one of the leading schools of the country which has not attempted to establish the system. There the students feel that they have not a homogenous body, that there are too many foreigners, and that the spirit is not sufficient to uphold it.

The system was tried at the University of Illinois but there it failed, presumably because of the large freshman class. With approximately 4,000 freshmen each year, the institution found it practically impossible to have a forceful administration of the system. Four thousand freshmen could not be made to recognize it as a personal obligation.

If the University of Kentucky were able to establish and uphold such a standard, its degree would be conferred only upon the true scholar, whose success at present, no doubt some receive the diploma who do not deserve it and who are not fully qualified to take their places in the world as college graduates. The successful establishment of the honor system would eliminate the so-called student who "rides through" on the work of others, and would, therefore, increase the value of the diploma.

The question is, would the honor system succeed at the University of Kentucky? As the system stands, it is the opinion of the writer that it can never be established in the whole student body. We believe that every student would like to be put upon his honor—that he would sign that part of the pledge which affects only himself, but that he would not uphold that part which relates to the classmates. It is one thing to ask a student to give his word of honor that he will not receive aid on an examination; it is quite another thing to expect him to refuse aid to a friend who asks it, or to report anyone whom he sees receiving or receiving help.

It is the belief of the writer that University of Kentucky students would live up to a much higher moral level if they were placed solely on their honor. The professor who watches his classes with "an eagle eye" provokes the urge to cheat if only for the thrill of "getting by" with it.

A student remarked the other day, "There is one man on this campus that you just couldn't try to put anything over on. He's too white!" Isn't that the spirit which we all cherish in everyone, ALWAYS? This student intimated that he would as soon cheat in certain other classes as not! Isn't it true that youth usually lives up to what is expected of it? If a professor expects his student to cheat, don't they feel relieved of moral responsibility?

We believe that this system of leaving students on their honor might be called a success. Certainly, the watchful professor is unable to cope with the situation. With all his earnestness he is unable to see everything.

If every student realized that he had a free-will choice to make, we believe he would not be found wanting. Then, indeed, we would have a TRUE honor system, one in which the student is using only the finest and wisest of his nature and is not cramping the individual by the constant dread of having to act the part of the "tell-tale" whom we all find so contemptible.

The Kernel asked the privilege of reproducing it here; not necessarily as its own opinion on this live university subject but rather as an incentive to still further discussion of the honor system by the students and faculty.

ETHICS IN BUSINESS

Industrial progress in the last quarter of a century has been very rapid, and has resulted in removing the isolated status of virtually all classes of people through the automobile and the radio. It has provided inexpensive amusements for the masses in the form of the moving picture, and has made possible the gratification of other new human wants through a greater variety and a greater mobility of goods than in the past. The great mass of consumers. In view of this industrial progress one may well ask whether the idealism of the country is moving forward at the same pace. Is business morality neglected, is it standing still, or is it moving to higher standards?

The answer to this question may be found in a number of historical incidents and in the recent action of the United States Chamber of Commerce. In its 1924 meeting the Chamber adopted fifteen rules of business conduct, summarized very briefly, they stand for genuine service to the public as the only justification for a business enterprise, cooperation between capital and labor, and a fair reward to all elements participating in the business including the management, the investor and the wage-earner. The membership of chambers of commerce is made up primarily of merchants. About 6,000 individual members of local chambers of commerce have subscribed to these rules of conduct and have pledged themselves to run their businesses on the basis of this philosophy. The declaration of principles is magnificent and should be heartily supported by all economic groups including manufacturers' associations, agricultural and labor organizations.

A glance at history discloses much improvement in the generally accepted ethical standards in business. The Teapot Dome incident appeared to be a step backward, but the terrible shock it gave the country shows clearly that it was wholly out of tune with the accepted rules of the business game.

Looking backward, we come across a number of crooked business practices that today are no longer sanctioned and have now virtually wholly disappeared. Going back to early railroad building we come across the construction company that sapped the railroad companies of a large portion of its property and doled it out among the few stockholders of the construction company. The Mobile is familiar to all students of American history. Unfair competition, business combination and attempts to freeze out the small competitor was a phenomenon that congress and state legislatures struggled with for a quarter of a century before measures were evolved capable of coping with its evils. Stock manipulation on the part of directors of corporations resulting in the loss of property values held by widows and orphans, were considered shrewd business deals in the days of Jim

Flake and the early life of Edward Harriman, but such incidents occurring as late as 1915 are regarded by the governors of the New York stock exchange as sufficient reason for excluding the stock of companies allowing such manipulation from being dealt in on the exchange. We have blue-sky laws in all states intended to protect the unsophisticated investor from purchasing spurious or worthless securities. From the days of the Civil War to 1906 we struggled with the adulteration of dairy and other food products. The end of the struggle came with the enactment of a federal statute giving control over interstate shipment of these products.

Progress in business conduct has been made. Legislation was made use of to compel obedience to moral standards, but the same can be accomplished through voluntary action of the part of private organizations. The recent action of the United States Chamber of Commerce is commendable and should be whole-heartedly endorsed by all economic groups.

It has jarred the very foundation of conservatism in the Middle West and the South. No hot-bed of Bolshevism could have caused more talk or excitement among students. Mayhap it has its equal in the memorable fight in Tennessee, "Are we monkeys or are we not?"

Seriously speaking, however, the old question of the harmfulness of tobacco is again raised. Prominent scientists and medical men claim that tobacco is more harmful to women than to men, and investigations show that there are quite a number of cases of cigarette blindness among society women who smoke incessantly. There seems to be no explanation for this but the fact remains. Physicians are further claiming that the child of a woman who smokes is not as physically fit as the one whose mother abstains from the use of the "weed". On the other hand, the temperate smoker does no harm to herself. If all the users of tobacco were temperate, there would be no occasion to debate its harmfulness. But when was the human race ever temperate? Hence temperance organizations, which would soon lead to anti-tobacco leagues, followed quickly by an anti-ice cream organization, anti-coke-cola, anti-everything, anti-anything to take the joy out of life.

The criticism has been criticized from a moral viewpoint, but undoubtedly morality does not enter into the discussion, or should not as it is irrelevant. Many folk feel that when a woman smokes she ceases to be a woman, and becomes a swart. This is about as lame as declaring a man guilty of murder on circumstantial evidence, for the girl in question probably is as pure, as sweet, as good, and with as high ideals as any woman ever possessed.

If most of the women smokers were honest with themselves, they would admit that they smoked to be "smart" and for the looks of the thing, because "they simply adored those sophisticated women," or on account of their favorite actress, Pola Negri, who "smoked so cunningly" in her last film. This rather makes one wonder that if such a cry had not been raised against it and so much talk created, whether smoking among women would not have died a natural death. Perhaps then Bryn Mawr is the wisest of schools, in showing her students that she does not consider them "ultra-smart," but rather ordinary beings, who are doing nothing out of the way.

Last week three girls attended a conference of the athletic women of Ohio, in Cincinnati. All three of these young ladies—Elizabeth Heffernan, Mable Mill and Martha Ried—were thoroughly convinced that girls should be permitted to play interscholastic basketball by boys' rules. The conference proposed to convince all delegates that girls should not be permitted to take part in too strenuous a program of sports. The best test of the success of such a conference is in its effect upon those attending. These same three girls returned to the University on Sunday with the firm belief that the W. A. A. of Kentucky should sponsor only intra-mural games played by girls' rules.

Doubtless there are many who believe thoroughly that the girlhood of our country should be permitted to play ball with unmodified boys' rules if it so desires. For the benefit of those individuals I shall try to pass on to you some of the information and inspiration instilled into us by the conference at Cincinnati.

In the first place, man has had his athletics and competitive sports for centuries. Physical culture for woman is a comparatively new thing. Her struggle for equality in franchise and business, and her recent interest in affairs of the world have caused her to throw herself into athletics in

order to prove her prowess in that field as well. Her enthusiasm has been woefully misdirected in this, however, and great harm to many a girl has resulted therefrom. Our major sports were designed for man, and woman is doing herself an injustice by adopting them. Physiologically woman differs greatly from the male of the species, and therefore she should play only those games suited to her individual make-up.

Do not think for an instant, fellow college girls, that we prove man's superiority by ceasing to play games designed for him. We merely admit that the two sexes are different and that woman receives more benefit from sports suited to her than she does from attempting to take over the games of man. We, as college girls, believe that a woman's greatest glory is in being a whole-souled, well-rounded woman. We do not aspire to be masculine, nor do we admit to being the lesser sex. Is the tiger lily superior to the rose? We have merely awakened to the situation and are willing to place boys'-rule basketball up beside football as a game for men which we admire and enjoy, but one which we realize is not suited to us.

If you are one of those who believe that basketball, as played by the girls this year at Kentucky, will be an uninteresting game, you have a great shock in store for you. Girls' basketball is not a lifeless affair; it is a sport reduced to a scientific basis and adapted for real athletic women.

BATTLE CRIES

The following resolution has been adopted by the Senate by the University Council:

Whereas, at a recent assembly of the students of the advanced course R. O. T. C., U. K., it was unanimously voted to adopt the honor system in said course:

And whereas, the students of the advanced course, R. O. T. C., U. K., to carry out such honor system, unanimously agreed not to cheat in any way in any military work, whether it be recitation, lecture, examination, or field work; to conduct themselves at all such times as officers and gentlemen; and further, to report to the honor court, hereinafter described, any member of the advanced course, R. O. T. C., U. K., who may be found cheating or who may be found conducting himself in a manner unbecoming an officer and a gentleman while actually engaged in military training:

And whereas, the students of the advanced course, R. O. T. C., U. K., unanimously agreed that an honor court shall be constituted and conducted as is required for a general court-martial under the articles of war and the manual for court-martial, the members thereof to be elected by majority vote of the students of the advanced course, R. O. T. C., U. K., subject to the approval of the president of the University of Kentucky.

And whereas, the members of the advanced course, R. O. T. C., U. K., unanimously agreed that the proceedings of the honor court shall be submitted to the president of the University of Kentucky for final action as reviewing authority: And whereas, the students of the advanced course, R. O. T. C., U. K., unanimously agreed that any student of the advanced course, R. O. T. C., U. K., convicted of cheating, or of any other conduct unbecoming an officer and a gentleman while actually engaged in military training at the U. K. shall be expelled from said university:

Therefore, be it enacted by the senate of the University of Kentucky that the honor system as above outlined be approved and supported; that all rules and regulations now in force, in conflict with the honor system in so far as the advanced course, R. O. T. C., U. K., is concerned, be revoked; that an honor court, constituted and conducted as is required for a general court-martial under the articles of war and the manual for court-martial, be approved by the approval of the president of the University of Kentucky; said court to have jurisdiction over members of the advanced course, R. O. T. C., U. K., in all cases involving cheating or other conduct unbecoming an officer and a gentleman while actually

engaged in military training at this university; that the proceedings of said court be submitted to the president of the university for final action as reviewing authority; that any student of the advanced course R. O. T. C., U. K., convicted of cheating or any other conduct, unbecoming an officer and a gentleman, while actually engaged in military training, said proceedings having been approved by the reviewing authority, shall be expelled from the University of Kentucky; that the P. M. S. & T. U. K., be authorized and required to promulgate such orders and regulations, subject to the approval of the president of the University of Kentucky, as are necessary to carry out effectively the provisions of the honor system as above enacted.

CAT BASKETBALL SEASON TO OPEN WEEK FROM TOMORROW

Depauw University Five Will Come to Lexington For Game; Team Appears Formidable On Eve of Strenuous Campaign

UNIVERSITY GIRLS WILL NOT SMOKE

Dean Franke Says Although There Is No Rule Against It, Tradition Here Makes One Unnecessary

HAS GREATLY INCREASED

Prompted by the publication of the stand of numerous colleges and universities of the Middle West against woman students smoking, Miss Virginia E. Franke, dean of the women at the University of Kentucky, said that though there was no rule against it at the university, it was not necessary since tradition here was against it. A similar position was taken by Miss Hilda Threlkeld, principal of Hamilton College, who said that smoking among the girls of that institution would be " frowned upon."

Casual observations within the past several years alone is necessary to determine that smoking among girls and women of the nation has increased alarmingly within that time. Perhaps it is a fad which will pass, some observers aver, but at any rate the growth has been steady. Much discussion has been aroused by the situation in several larger eastern colleges. Most of them prohibit smoking but at least one or two allow the girls to amuse themselves with their so-called pastime.

Throughout Ohio there is an unspoken law against it although in some cases the rule is specific in prohibiting smoking. Some college and university officials are quite emphatic in denouncing the puffing among girls. In the Southern colleges and universities, as there is here, there is some smoking, but in general very little in comparison with the number of students in the institutions. Certainly there is no likelihood of a repetition of the Bryn Mawr action in the South, especially at the University of Kentucky.

Rehabilitation work conducted at the University of Florida for the benefit of disabled World War veterans has accomplished much good. A special farm has been provided expressly for them where they are taught various methods of cultivation of crops.

"Red" spoke in New York and the message was broadcast from Washington. He told of his career as a player and why he decided to be an ice man. He spoke of the importance of good living in its relation to football and other sports. He emphasized plenty of sleep and lots of good food and hard work as essentials to an outstanding athlete. Grange said that coordination of muscles and mind and quickness of thought came only through these methods of training. In fact, he said that he had trained all his life and this constant training brought him to his present position in the football world.

tissue slough off and the underlying structures may also become involved producing a deep ulceration. Except for localized pain, which is by no means constant, the disease is usually mild but it is occasionally accompanied by general disturbances, such as fever, loss of appetite or malaise.

Gums Become Red and Bleed Increased redness of the gums, which bleed easily, especially after brushing of the teeth, is a rather constant finding. If the clinical appearance of the mouth is such that a definite statement cannot be made as to whether the individual has Vincent's Angina, a microscopic examination of scrapings from the suspicious-looking areas will settle the question.

The disease is caused by two types of organisms being present at the same time (living symbiotically, as it is called). It is usually conceded that the organisms are not of very great virulence and that they cannot find conditions suitable to their growth and development in a perfectly normal, healthy mouth.

Localization of the infection depends on the condition of the part attacked and the organisms obtain access at the point of lowest resistance. It has been noted that the usual place primarily involved is either the gums or tonsils.

The predisposing causes (those which favor the organisms gaining a foothold) are heat, moisture, lack of cleanliness, and especially the absence of air. Wherever proper conditions prevail and infection takes place, these ordinarily harmless organisms quickly manifest themselves, with the result that sores and ulcerations occur.

Disease Readily Communicated The disease is readily communicated to others, the organisms being disseminated by direct contact, coughing, or contact with contaminated objects which have come in contact with the discharges of the mouth, and so on.

Certain preventative measures may be instituted, such as brushing of the teeth and perhaps in the presence of an abnormal number of cases, a mild disinfectant for use in the mouth may be indicated.

Care should always be taken that only clean articles reach the mouth—eating or drinking with other people is always to be condemned.

The greatest care should be taken in any communicable disease, when associating with those known to be suffering with the disease.

As above stated the predisposing causes of this condition are the lack of cleanliness and the absence of oxygen. Therefore the careful brushing of the teeth accompanied by the use of a disinfectant or oxidizing nature would seem to be the rational treatment.

It may be that in certain cases the above treatment will prove ineffective, when recourse must be had to the scaling of the teeth and locally applied applications of either salicylic acid or nitrate by a physician or dentist.
