ABOUT THE LIBRARIES

Seminar in Graphic Design at King Press:

A "Seminar in Graphic Design with Hermann Zapf at the King Library Press" is scheduled for next Thursday and Friday, 21-22 October. The seminar will be conducted by Hermann Zapf, an internationally known calligrapher, typographer and graphic designer, who has lectured widely in the US, authored a dozen books, and designed a number of widely known typefaces (including Melior, Michelangelo, Optima, and Palatino).

The two-day event will consist of a calligraphy workshop (10 AM, Thursday) and a graphic design workshop (2PM, Friday)--both to be held in the Gallery--and two lectures: "Typography in the computer age" (3 PM Thursday) and "The typographer's art" (illustrated with slides; 11 AM Friday)--both in room 118 Class-room Building.

A reception is scheduled following the Thursday afternoon lecture; it is being organized by Jean Robinson and the Staff Organization. The workshops, lectures and reception are open to the public, and library staff members are expecially welcome.

An exhibition of Mr. Zapf's work is currently on display in the lobby of King Library South.

Co-sponsors for the seminar are: the King Library Press, the Department of Art, the College of Architecture, the Graduate Seminar Fund, the Kentucky Arts Commission and the National Endowment for the Arts.

Music in the Gallery series:

The inaugural concert of the Music in the Gallery series will be presented on Friday, 15 October, at noon in the Gallery (or in the King Plaza, if weather permits). Members of the School of Music will perform three more recitals in the series on 29 October and 12 & 19 November, and a Christmas Concert is scheduled for 10 December in the Reference Room.

The recitals are free and open to the public.

Nota Bene: serials costs:

A recent issue of Library journal notes that the average cost of American serials in 1976 is \$22.52, an increase of \$2.58 (or 12.9%) over last year's average.

SENATE MEETING NOTES:

The University Senate at its October 11 meeting acted on the following items:

- 1. Re: Election of voting faculty members of the Board of Trustees
 Elucidated the requirement that elected faculty members must
 have as their primary assignment research and/or teaching. The
 requirement will not exclude department of division chairmen
 from election to the Board.
- 2. Re: Procedures for auditing courses

 Adopted the requirement that changes from credit to audit or
 vice versa must be accomplished by the last date to drop a
 course without a grade in any given term.
- 3. Re: Banning discrimination in admissions

 Tabled until the next Senate meeting, in order to re-word the resolution, a statement outlining specific discriminatory practices.
- 4. Re: Review of graduate programs

 Postponed until the next Senate meeting action on proposed additions to the Senate Rules concerning procedures for review of graduate programs.

BLUEGRASS LIBRARIANS:

Copyright law and its implications for libraries will be the topic of a talk by William James, UK Law Librarian, at the next meeting of the Bluegrass Librarians Association on Monday, October 18 at 7:00 P.M. in the Gallery of M. I. King Library. The litigation surprounding the Williams & Wilkins case, as well as recent congressional legislation, has great potential impact on the operations of libraries, especially in the realm of xeroxing.

Mr. James' topic will prove of interest to all librarians regardless of the type of library in which they work. The meeting is free and is open to all.
