The faculty met in regular session Friday, December the third, nineteen hundred and fifteen, quorum present.

The meeting was called to order by President Barker and the minutes of the last meeting were read and approved.

Professor Miller, Dean of the College of Arts and Science, presented the following ~~the following~~ names as candidates for degrees in December:

A. B. in Education.
Chesley W. Bailey
Mary Belle Johnson
Newell P. Smith

A. B. English.
Jacqueline T. Hall

On motion it was ordered that the list as presented be recommended to the Board of Trustees for the degrees named.

In the absence of Professor Rowe, Dean of the College of Civil Engineering, Professor Carrel presented the name of Robert Ehrlich for the degree of Bachelor of Civil Engineering in December. On motion it was recommended that his name be presented to the Board of Trustees in December for the degree named.

On motion of Professor Melcher the following resolution was adopted:

"The faculty of the State University of Kentucky in regular session assembled, approve the action of the President in ordering the battalion of cadets to participate in the inaugural parade at Frankfort on the seventh inst., and in order to enable all the students to take part in the inaugural ceremonies, a holiday is hereby declared on that day. And we recommend that all members of the faculty who can do so, go to Frankfort on the inaugural day and participate in that great function.

This is not done in a partisan spirit but to honor him who has been selected as Governor of all the people of the Commonwealth of Kentucky."

At the request of the Secretary, ~~Professor Ezra L. Gillis~~, Professors Mathews, Tuttle and Farquhar were appointed as an advisory committee to aid the Secretary in publishing an abstract of the minutes of the faculty.

The special committee^{appointed} to investigate and report on the classification that should be assigned Mr. Ferris in the College of Civil Engineering made the following report which

was read by Dr. Boyd, chairman of the committee;

"The committee appointed to report on the standing of Mr. G. M. Ferris, has examined the credits submitted from the University of Tennessee the substitution proposed for certain required subjects in our own course in Civil Engineering, and the course of study laid out for Mr. Ferris for the coming year. At a conference between Dean Rowe and the Committee, it was agreed that Mr. Ferris should enter at once the class in Advanced Strength of Materials in order to settle any question as to his preparation in the subject. It was also agreed to add one semester of Analytics to the requirements, this shortage having escaped attention at first on account of the confusing way in which the record of Tennessee was written. After allowing for substitutions, Mr. Ferris has 17 3/4 credits (as computed here) which cannot be applied to our Civil Engineering course. The course finally proposed gives Mr. Ferris at least fifteen hours per week class work through the second semester, leaving, as Dean Rowe pointed out, not sufficient time in the second half of the second semester for thesis work."

The opinion of the Committee on Mr. Ferris' case was expressed in two motions:

- (1) In view of Mr. Ferris' record as transferred from the University of Tennessee, we think it inadvisable to classify him as a senior. (Carried Unanimously).
- (2) It is our judgement that Mr. Ferris should not be eligible for a degree before December, 1916. (Passed with Professor Carrel dissenting).

The Committee begs leave to make two recommendations:

- (1) That the Committee on Entrance and Accredited Relations be given entire control over the matter of advanced credits transferred from other institutions.
- (2) That the Committee of Deans, or some special Committee, be instructed to collect and classify present conditions for senior classification, and perhaps to enlarge the statements so as to mention specifically the requirements in the various Colleges of the University."

On motion of Professor Mathews, seconded by Professor Miller, the report was adopted.

The following report was made by Professor Zembrod, Chairman of the Committee on Student Activities - Non-Athletic:

- " (1) We recommend that all dances be held on the Campus with the exception of the Junior Prom.
- (2) There shall be no intermission. Reasons therefore:
- (a) Unwillingness of Faculty to attend dances at so late an hour.
 - (b) On account of Saturday classes.
 - (c) Abuse of intermission, students going about campus and into town.

- (3) All dances to close at midnight.

(4) Senior Class Dance to close at 1:30.

(5) All of the dances shall be under the supervision of the Committee on Non-Athletic Entertainments.

(6) Fraternity House Dances shall close at 11 o'clock. There shall be at least one representative, in the list of chaperones, who will make a report of the dance to the Entertainment Committee.

(7) Where a Fraternity House has no room for a dance, it shall be given on the campus.

On motion this report was adopted.

The Secretary read the following transcript from the minutes of the meeting held by the Committee of Deans in June, 1914:

"On motion by Dr. Kastle, seconded by Professor Rowe, it was voted that the Entrance Committee assign all conditioned students sufficient work to remove entrance conditions, and that this should take precedence over college work, after which, they were to be sent to the dean to complete their classification."

Motion was made and seconded that this be adopted.

Dr. Pryor, Chairman of the Committee on Student Organizations, reported that he had made the following arrangement with the fraternities:

"(1) Conduct all initiations in the Chapter House, unless otherwise provided by your ritual.

(2) Confine initiatory ceremonies to that provided by your ritual.

(3) Have an alumnus, preferably a member of the faculty, reside in the Chapter House. If this is impossible, ^{Have an alumnus,} preferably a member of the Faculty, agree to visit the Chapter House and Chapter frequently, advise with the men, and act more or less as a Sponsor.

(4) See that in the future, the rules of the Committee on Entertainments, Non-Athletic, are strictly enforced."
