

Minutes of the Meeting of the Executive Committee of the Board of Trustees, July 31, 1958.

The Executive Committee of the University of Kentucky met in the President's Office at 9:05 a.m. CST, Thursday, July 31, 1958, with the following members present: R. P. Hobson, Louis Cox and J. Stephen Watkins. Absent: Harper Gatton and Dr. Ralph J. Angelucci. President Frank G. Dickey and Secretary Frank D. Peterson met with the Committee.

A. Minutes Approved.

Upon motion duly made, seconded and carried, the minutes of the Executive Committee of June 20, 1958, were approved as published.

B. Nursery School Fees Approved.

Mr. Peterson submitted a recommendation that the Director of the School of Home Economics be permitted to hold an afternoon program at the Nursery School and that a fee of \$25.00 per semester for the afternoon sessions be charged. He explained that the current charge was \$60.00 per semester for the Nursery School, which is a four-hour morning session with luncheon.

The Executive Committee being advised, upon motion duly made, seconded and carried, authorized a charge of \$25.00 per semester for afternoon sessions for four to five-year-old children.

C. Requisitions for Purchases Approved.

Mr. Peterson submitted a list of documents requesting and authorizing various purchases made by the University from April 1 through June 30, 1958. He explained that the original documents were available and were made a part of the recommendation.

were ratified, authorized and approved.

D. Purchase of Property.

Mr. Peterson submitted a recommendation for the purchase of one house and lot at 441 Pennsylvania Avenue, consisting of two bedrooms, living room, dining room, kitchen, study room and full bath downstairs, and one large upstairs room. The property is situated on a lot with a 50-foot front by 105 feet. It joins the sorority lots. The house is of brick construction with composition roof, and contains one air conditioner and one television tower, with all appurtenances attached to the building. It has a concrete basement, gas furnace and vegetable storage room.

The second piece of property, located at 439 Pennsylvania Avenue, is situated on a lot 60 by 105 feet. It joins the sorority court. This property consists of two 4-room apartments with basement and with separate heating systems and utility connections. One apartment is currently rented for \$85.00 a month and the other is rented for \$77.00 per month.

These buildings are in excellent condition, both of brick construction in a good state of repair, and it is thought that the property is vital to the expansion of the University and may be amortized over a period of twelve years. Both pieces of property are available for the sum of \$41,000. Mr. Peterson and President Dickey recommended that the property be acquired and paid for from the Haggin Fund, and that the rentals be returned to the Haggin Fund to amortize the investment.

Mr. Peterson also reported to the Executive Committee that a house and lot at 154 Bonnie Brae, which is just off of Maxwellton Court, was available for purchase. He stated that this property was entailed in the estate of Eliza O'Neil. It has been appraised by a realtor for \$17,500.00. The property consists of a two-story brick residence containing ten large rooms, two small rooms and two full baths, approved roof, no central heating system, space heater in each room, small dirt basement under kitchen area. The outside of the building is in fair condition; the inside is in poor condition and needs to be repaired. Hardwood floors are in all rooms except the kitchen and the two small rooms. The lot is 44' x 176.3'. Mr. Peterson suggested that the property is worth the appraised value if the University desires to acquire additional property in this area. The campus map was consulted.

Upon motion duly made, seconded and carried, the property at 441 and 439 Pennsylvania Avenue was authorized acquired at the price of \$41,000, and the property at 154 Bonnie Brae Drive was authorized purchased at the Price of \$17,500. It was further directed that income from these properties be returned to the Haggin Fund and applied to amortization of the purchase prices.

E. Purchase of Property at 410 Rose Lane.

Mr. Peterson reported the availability of a house and lot at 410 Rose Lane. He said that the lot was fifty feet wide, with a depth of 190 feet, with a five-room brick house in fair condition. There is no central heat. There are space heaters in each room. He said this property could be purchased for the sum of \$16,000. He explained that it joined the sorority court and was a valuable piece of property in connection with expansion of the University. Mr. Peterson further reported that, in his opinion, the fair market value of this property on today's market would make this a favorable purchase.

Upon motion duly made, seconded and carried, the property at 410 Rose Lane was authorized purchased for the sum of \$16,000, the money to be taken from the Haggin Fund, and rentals returned to the Haggin Fund for amortization of the purchase price.

F. Injuries.

Robert Coffey

✓ Mr. Peterson submitted report of an injury to Robert Coffey, who received a cut on two fingers which required 24 stitches to close the wound. The hospital submitted invoice for \$15.55 and Dr. John S. Sprague submitted bill for \$35.00 for medical services.

Thomas C. Wilson

Mr. Peterson reported an accident to Thomas C. Wilson. He stated that the index finger was amputated. Treatment was received at the Good Samaritan Hospital and medical services were rendered by Dr. William T. Swartz. The hospital submitted invoice for \$10.55 and Doctor Swartz submitted bill for \$25.00 for medical services.

Leonard H. Plunkett

Mr. Peterson reported an injury to Leonard H. Plunkett. Mr. Plunkett received a laceration on the right hand. He was given treatment at the Good Samaritan Hospital by Dr. Melvin Dean. The hospital submitted an invoice for \$6.75 and Doctor Dean submitted bill for \$23.00 for medical services.

Tomas J. Scarce

Mr. Peterson reported accident to Tomas J. Scarce. Mr. Scarce slipped on a wet floor in the Student Union Cafeteria and injured his foot in the fall. He received x-ray and medical care from Dr. J. S. Williams of Nicholasville, and Doctor Williams submitted bill for \$10.00 for x-ray and two office calls.

Andrew R. Shaver

Mr. Peterson reported injury to Andrew R. Shaver. Mr. Shaver was standing in a truck bed while the truck was in motion. The truck turned a corner and Mr. Shaver fell out. He suffered abrasions around the right side of the nose and forehead, lost a couple of teeth, bruised his mouth and cut it on the inside. Stitches were required. He was treated at the Good Samaritan Hospital by Dr. John S. Sprague. Doctor Sprague submitted invoice for \$35.00 for services rendered. The hospital has not yet submitted an invoice.

Lester Carmack

Mr. Peterson reported an injury to Lester Carmack. Mr. Carmack was trimming vines around the windows of the Library. He pulled a vine from the building, causing a small piece of mortar to fall into his left eye. He was given treatment by Dr. Claude W. Trapp. Doctor Trapp has rendered invoice in the amount of \$6.00 for his services, and an invoice for \$4.25 for medicine has been submitted.

Omar Carrier

Mr. Peterson reported injury to Omar Carrier. Mr. Carrier received a foreign particle in the eye which required medical service to remove it. He reported to Dr. Claude W. Trapp's office for treatment. A bill for \$10.00 was submitted for medical services rendered.

Mr. Peterson said that he had made inquiries concerning the charges in connection with these invoices and recommended that the invoices in connection with Robert Coffee, Thomas C. Wilson, Leonard H. Plunkett, Tomas J. Scarce, Andrew R. Shaver, Lester Carmack and Omar Carrier be approved and authorized paid, with the expressed understanding that the University does not admit negligence or liability in connection with the accidents to Robert Coffey, Thomas C. Wilson, Leonard H. Plunkett, Tomas J. Scarce, Andrew R. Shaver, Lester Carmack and Omar Carrier.

Members of the Committee being advised, upon motion duly made, seconded and carried, concurred in the recommendation of Mr. Peterson and the hospital bills and medical bills were authorized paid to the above-named recipients, with the expressed understanding that the University does not admit negligence or liability in connection with either one or all of these accidents.

F. Report of Survey.

Mr. Peterson recalled to the members of the Executive Committee that he had forwarded to each member of the Board results of a survey made by his office concerning the cost of payments for hospital and medical services to employees over the last ten years. The total cost approximated \$10,000 for the ten-year period. Workmen's Compensation costs for a one-year period would be in excess of \$50,000. The information was received.

G. Contract between the University of Kentucky and the Department of Fish and Wildlife Resources.

Mr. Peterson submitted a contract for a game refuge in Robinson Forest area. He stated that this was a continuation of an existing contract and recommended its approval.

Upon motion duly made, seconded and carried, the contract was authorized entered into and executed on behalf of the University.

H. Contract between the University of Kentucky and the City of Frankfort.

Mr. Peterson submitted contract which had been recommended by Dr. C. C. Carpenter, Dean of the College of Commerce, whereby the Bureau of Business Research would make a factual study of the expenditures and revenues for the past decade of the city of Frankfort and present a description of revenue sources without recommendation, and future requirements to finance alternate expenditure levels of the city. The Bureau would also give an analysis of some revenue problems, including assessment levels and exemptions under the property tax as modified. He reported that the Bureau would be paid for services rendered in amount of \$800.00 per month for a period of five months.

The members of the Committee discussed at length the advisability of making the survey, and upon motion duly made, seconded and carried, approved the contract and authorized same executed, with the expressed understanding that the Bureau of Business Research would make a factual study of revenue sources, future requirements, expenditure levels and assessment problems without recommendation as to source of revenue.

I. Contract between the University of Kentucky and Quartermaster Research and Engineering Command.

Mr. Peterson explained that this was a Supplemental Agreement to an existing contract which had been heretofore approved by the Board of Trustees and provided for the continuation of a study concerning various vegetables.

Upon motion duly made, seconded and carried, the modified contract and continuation was authorized approved and executed on behalf of the University.

J. Agreement, Geological Survey, Water Resources, with University of Kentucky.

Mr. Peterson explained that this contract called for expenditure of \$179,000 by the University and \$179,000 by the Geological Survey, U. S. Department of the Interior. He stated that \$102,200 would come from the appropriation for water investigations; \$25,000 from appropriation for Eastern

Kentucky mineral and water surveys; \$51,100 from the Kentucky Highway Department, and \$700.00 from a gift to the University. This contract will provide for continuation of an existing working arrangement with the U. S. Geological Survey. Mr. Peterson recommended that the contract be authorized executed on behalf of the University.

The members being advised, upon motion duly made, seconded and carried, the Agreement was authorized approved and executed.

K. Contract between the University of Kentucky and the Geological Survey, U. S. Department of the Interior.

Mr. Peterson explained that this contract is for a period of two years, provides for the continuing map program and is made on a matching basis whereby the University will appropriate \$24,000 to match a like sum from the federal government for the year ending June 30, 1959, and \$32,000 to match a like sum for the year ending 1960. Mr. Peterson explained that this money was appropriated for the University by the 1958 Legislature. He recommended approval of the agreement, and upon motion duly made, seconded and carried, the agreement was authorized executed.

L. Investments Approved.

Mr. Peterson submitted investments as follows:

1. Purchased one University of Kentucky Journalism Revenue Bond, due January 1, 1970, to yield 3%.
2. Purchased 20 Cooperstown Apartment Revenue Bonds, due June 1, 1986, to yield 3.55%.
3. Purchased five Cooperstown Apartment Revenue Bonds, due June 1, 1986, to yield 3.55%.
4. Purchased 1427 shares of Pioneer Fund, Inc., for \$19,992.27. The market value is in excess of \$20,500.00.

Mr. Peterson explained that these funds were invested with the approval of the President, subject to action of the Executive Committee or the Board of Trustees, and that any of the purchases could be sold at this time to recover purchase price plus a modest gain if, in the judgment of the Executive Committee, investment should not be made.

On motion duly made, seconded and carried, the investments made were ratified and approved.

M. Easement, Kentucky Utilities Company.

Mr. Peterson submitted Easement between the University of Kentucky and the Kentucky Utilities Company for right-of-way along Rose Street. Members of the Committee read the Easement, examined the map and, being duly advised, on motion duly made, seconded and carried, authorized the Easement executed on behalf of the Commonwealth of Kentucky and the University of Kentucky Board of Trustees.

N. Degrees Granted.

President Dickey submitted the following list of persons recommended for degrees at the August Commencement. He stated that persons named had been recommended by their respective colleges and the University Faculty. He recommended that the degree to which each is entitled be authorized granted.

Upon motion duly made, seconded and carried, the list of candidates was approved and the President was authorized to confer upon each the degree to which he is entitled.

O. Honorary Degrees Granted.

The Executive Committee of June 20, 1958, approved honorary degrees granted to Bishop William Theodore Mulloy, Bishop of Covington; Bishop William Turner Watkins, Bishop of the Louisville Conference of the Methodist Episcopal Conference; and Dr. Walter Pearson Kelley, Professor of Soil Chemistry, Emeritus, University of California, Berkeley. It was understood that names of these recipients would be withheld from the June minutes until each could be contacted. It was further understood that the names would be recorded in these minutes. Data concerning these recipients are as follows:

William Theodore Mulloy, Bishop of Covington, was born in Ardock, N. D., 1892, and received his formal higher education in Manitoba, Canada, and St. Paul, Minnesota. He was ordained a Priest in 1916, was elevated to the rank of Domestic Prelate in 1941, and has been Bishop of Covington since 1945. Since 1945 he has been President and Chancellor of Villa Madonna College. For four years (1949-1953) he was a member of the Board of Directors of North American College in Rome, Italy. He is a member of the Medieval Academy of America. He is the first bishop in Kentucky awarded the Noble and Exalted Degree of the Holy Cross of the Knights of St. John and the first to have been President of the Liturgical Conference of America.

Besides his very great humanitarian work in Kentucky in promoting vastly increased hospital facilities and parochial schools, Bishop Mulloy has made a distinguished career of rural life improvements, serving twice as President of the National Catholic Rural Life Conference, helping prepare the Manifesto on Rural Life, and attending two international conferences on

rural life development. In recognition of his great achievements in this specialty, he was awarded a Distinguished Service Citation six years ago.

William Turner Watkins, Bishop of the Louisville Conference of the Methodist Episcopal Conference, was born in Maysville, Georgia, 1895, and received his higher education at Emory, Yale, the University of Glasgow and the University of Edinburgh. Foreight years he was Professor of Church History at Emory and for four was editor of the Wesleyan Christian Advocate. In 1943 he was invited to deliver the Jarrell Lectures, a distinguished series sponsored by Emory.

He has spent the past twenty years in the various services of a bishop of the Methodist Episcopal Church, with presiding offices in Missouri, Mississippi, South Carolina and Kentucky. He is now ending his fourteenth year in Kentucky as Bishop of the Louisville Area consisting of the Kentucky, Louisville and Memphis Conferences.

He is the author of several religious books and articles and is a trustee of five colleges, four of them in Kentucky.

Walter Pearson Kelley was born on a Kentucky farm in 1878. He received his Bachelor of Science degree from the University of Kentucky in 1904, his Master of Science degree from Purdue University in 1907, and his Doctor of Philosophy degree from the University of California in 1912. Dr. Kelley began his professional work as chemist in Indiana, served as Chief Chemist at the Hawaii Agricultural Experiment Station for six years, and as Professor of Agricultural Chemistry at the University of California for thirty-four years.

He has become well known internationally for his distinguished contributions to soil chemistry. He has published more than a hundred papers in scientific journals in the United States, England, Germany, Holland and Hungary, and is the author of two standard reference books on soils. He has been consulted by soil specialists from semi-arid regions throughout the world. His most famous scientific contributions have been to establish the importance and principles of base exchange and to add greatly to what the world knows about alkali soils and their reclamation.

Dr. Kelley is a member of many learned societies, among them the American Chemical Society, the Soil Science Society of America, the International Society of Soil Science, the American Association for the Advancement of Science, and the National Academy of Sciences.

P. Free Fee Tuition for He Bong Kim.

President Dickey recommended that the University again grant to He Bong Kim free fees for the first semester of 1958-59. He stated that this student was worthy and intelligent and seemed to be doing a good job in the College of Engineering. Upon motion duly made, seconded and carried, the recommendation was concurred in.

Q. Dr. W. A. Seay to Serve as Acting Dean and Director.

President Dickey submitted a recommendation that Dr. W. A. Seay, Vice Director of the Agricultural Experiment Station, serve as Acting Dean and Director of the College of Agriculture and Home Economics, Agricultural Experiment Station and Extension Service during the official leave of Acting Dean and Director H. Bruce Price. He stated that the period involved would begin July 25 and end September 28, 1958.

Upon motion duly made, seconded and carried, the recommendation was concurred in and Dr. Seay was named Acting Dean and Director.

R. Sternbergs to Do Outside Work.

President Dickey reported a request of Janis K. Sternbergs to prepare six scenes depicting ancient Indian activities on Shell Mound camp sites to be used in Professor W. S. Webb's book. He stated that Professor Webb had tried various artists through the year but had found no one able to prepare satisfactory sketches for the book. Members of the Committee asked concerning the free time of Janis Sternbergs and, on motion duly made, seconded and carried, authorized the work, subject to report being made as to the amount of time involved and the pay received.

S. James W. Martin to Do Outside Work.

President Dickey submitted a request from James W. Martin, approved by Dr. Cecil C. Carpenter, Dean of the College of Commerce, requesting approval for outside activities which would require about one day per week in consultation with state governmental departments.

Members of the Committee discussed at some length outside activities of the University staff and approved the request, with the understanding that compensation would be reported and proper adjustment made in University salary.

T. Ora Florence Given Change-of-Work Status.

Ora Florence, Assistant Superintendent of the Dairy Center, College of Agriculture, was born August 1, 1888. He has been continuously employed at the University for a period of 15 years, 6½ months, and is entitled to change-of-work with annual salary of \$923.00. His supervisors suggest that his change of duties be to supervise work of dairy students in the operation of dairy herds.

Upon motion duly made, seconded and carried, Mr. Ora Florence was given change-of-work status at an annual salary of \$923.00, effective September 1, 1958, his duties to consist of supervisory work in connection with operation of the dairy herds.

U. Budget Adjustments.

President Dickey recommended that the sum of \$3,000.00 be appropriated from the unappropriated surplus of the University and placed in Account 920 to take care of the portion of the salary of Bernard Fagan which was supposed to have been taken care of by the Department of Finance, but funds failed to materialize.

President Dickey recommended that the sum of \$160.00 be transferred from the unappropriated surplus of the University to Account 270 to take care of an error in budget request.

President Dickey recommended that the sum of \$15,300 be appropriated for labor and materials to construct an educational library room in the basement of the Taylor Building, according to plans and specifications.

Upon motion duly made, seconded and carried, recommendations for budget adjustments were concurred in and the necessary budget adjustments authorized.

V. Resolution--Death of Professor A. J. Olney.

President Dickey reported the death of Professor A. J. Olney, who on April 15, 1958, had reached his 70th birthday and was about to take change-of-work status. He submitted the following Resolution and recommended that same be spread upon the minutes, with a copy sent to the family.

ALBERT J. OLNEY

Prof. A. J. Olney, head of the Department of Horticulture, died unexpectedly at his home on Tahoma Road, on Sunday, June 29. He was 70 years old on April 15, but due to his teaching was requested to defer retirement until July 1.

Born in Fremont, Michigan, and educated there through high school, he then entered the Michigan State University, where he received his B.S. in Agriculture in 1913. Following his graduation from Michigan State, he taught agriculture and science in high school at Greenville, Michigan, for one year. He was employed after that as horticulturist at the Lyndonville, Vermont Sub-experiment Station and continued there until 1916 when he came to the University of Kentucky, College of Agriculture as horticulturist.

Professor Olney completed his work for a Master of Science degree at the University of Chicago in June, 1925.

In April, 1930, he was made head of the Department of Horticulture at the College of Agriculture and served in that capacity until his death.

During Professor Olney's administration as head of the Department of Horticulture at the University of Kentucky, College of Agriculture and Home Economics, horticulture made a steady growth and today the work has national recognition.

Professor Olney was very thorough in all of his work and his counsel was sought on many committees in research, teaching, and agricultural extension. The three divisions of work which he headed required his constant attention to the research in connection with fruits and vegetables, the teaching program in the College and the supervision of the extension work in the field.

Professor Olney was a member of the Second Presbyterian Church, the Alpha Zeta, Sigma Xi, Gamma Sigma Delta, American Society of Horticultural Science, Kentucky State Horticultural Society, and the Kentucky Academy of Science.

He will always be remembered for his kindly manner and genuine friendship not only to the students and those who worked with him, but to all those who knew him. He had a way of instilling a love for the subject he taught, and many men in Kentucky today owe their fondness for horticulture to his teaching. His interest in all phases of education made him a friend of most of the University staff, and his contribution to the University over the many years he served would be hard to equal.

Professor Olney is survived by his wife, Lydia, and two sons, Charles and Robert, both graduates of the University, the former in Engineering and the latter in Pre-Med.

Upon motion duly made, seconded and carried, the Resolution was adopted and authorized made of record, and a copy was ordered sent to the bereaved family.

W. Resolution--Death of Dean T. T. Jones.

President Dickey reported the death of Dr. Theodore Tolman Jones who had been on change-of-work status since 1947. President Dickey recommended that a Resolution be adopted and placed in the minutes, and a copy sent to the family.

THEODORE TOLMAN JONES

Dean Theodore Tolman Jones was born at Manchester, Kentucky, April 15, 1877. He taught school in Clay County from 1890 to 1895. He received his secondary school education from private teachers in his home community and from the Academy of the University of Kentucky, of which Walter Patterson was then the principal. In 1897 he came to the University of Kentucky and studied Latin and Greek under John H. Neville who was the first Professor of Latin and Greek in the University. He received his B. A. Degree at the University of Kentucky in 1902 and was made an instructor in Latin the same year. He advanced rapidly to the rank of Assistant Professor and became Professor and Head of the Department of Ancient Languages and Literatures in 1909. This rank he held until he went on change-of-work in 1947.

In 1908 he received the M. A. in classical philology from Harvard University, and the Ph. D. in classical philology in 1929 from the same institution. In 1916 he was a student at the University of Chicago.

In 1922-23 he was Acting Dean of Men and in 1932-33 he was Acting Dean of the Graduate School. In 1933 he was appointed Dean of Men, a position which he held until his change-of-work in 1947. At the time of his change-of-work he had spent forty-five years of almost continuous service to the University.

In the same year that he was appointed instructor in Latin and Greek he married Martha E. Marion, who was his constant helper throughout their married life. To this union was born one child, Mrs. Ann J. Borders, who resides in Lexington, Kentucky.

As head of the Department of Ancient Languages and Literatures and as Dean of Men, he went through the extremely trying days of the Depression and of World War II. During this period he carried an enormous amount of work and responsibility.

Professor T. T. Jones was one of the best teachers that the University of Kentucky has had in our time. He was able to stimulate his students to excel and they were devoted to him. He was a most modest man although his intellectual attainments were high in several fields.

His moral character and his deep sincerity were innate; they were not acquired. As Dean of Men for many years, he was considered as above reproach in all his dealings with the students. He was of that sturdy Kentucky mountain stock which had a clear concept of right and wrong, and by that concept he lived. He was proud of his mountain background. He was a devout man, a member of the Baptist Church, and taught Sunday School classes over a period of years. At the time of his death he was a member of the Central Baptist Church, Lexington, Kentucky.

No mean contribution of Professor Jones to the University was his part in the organization of the first Summer Session. He was devoted to his students and they were devoted to him. He was financially helpful to many worthy students and his will continues that interest.

The passing of Professor Jones is a break with the early formative days of the University. He represented a professional tradition that is fast passing away. He had his roots deep in the early history of the University.

Upon motion duly made, seconded and carried, the Executive Committee concurred in the recommendation of the President.

X. Meeting of Association of Governing Boards.

President Dickey called attention to the annual meeting of the members of the Association of Governing Boards of Universities and Allied Institutions. He stated that the University would be delighted to have any or all of the members of the Board of Trustees attend this meeting at the expense of the University. Members of the Committee present were unable to make commitments, but on motion duly made, seconded and carried, the Committee designated Mr. Harper Gatton to represent the University at this meeting if he could find it possible to attend.

Y. William Andrew Patterson School of Diplomacy and International Commerce.

President Dickey reported that the judgment entered by the Fayette Circuit Court held that the income from the James K. Patterson Trust Fund could be made available to the University to assist in establishing the William Andrew Patterson School of Diplomacy and International Commerce. He stated that the Security Trust Company had definitely decided not to appeal the judgment and that the University was at liberty to request the income from the Trust Fund and establish the School of Diplomacy as envisioned by President Patterson. President Dickey recommended, therefore, that in keeping with the provisions of the James K. Patterson will and with the judgment of the Fayette Circuit Court, that the William Andrew Patterson School of Diplomacy and International Commerce be officially established and that steps be taken toward implementing the School for the coming fiscal year.

Members of the Executive Committee discussed at some length the provisions of the James K. Patterson will and, upon motion duly made, seconded and carried, authorized established the "William Andrew Patterson School of Diplomacy and International Commerce."

Z. Doctor Vandebosch Named Director of School of Diplomacy.

President Dickey recommended that Dr. Amry Vandebosch, head of the Department of Political Science and a Distinguished Professor, be appointed Director of the William Andrew Patterson School of Diplomacy and International Commerce.

Upon motion duly made, seconded and carried, the recommendation of President Dickey was concurred in and Dr. Amry Vandebosch was appointed Director of the William Andrew Patterson School of Diplomacy and International Commerce.

A-1. Trimble Named Acting Director of the Department of Political Science.

President Dickey recommended that Dr. E. G. Trimble, professor in the Department of Political Science for a number of years, be made Acting Head of the Department of Political Science in order to relieve Doctor Vandebosch to give more attention to the activation of the William Andrew Patterson School of Diplomacy and International Commerce.

Upon motion duly made, seconded and carried, the recommendation of the President was concurred in and Dr. Trimble was named Acting Head of the Department of Political Science.

B-1. Auxiliary Revolving Fund.

President Dickey and Mr. Peterson explained to the members of the Committee that the 1958 session of the Legislature enacted a law which permits the income from dining halls and dormitories to be co-mingled and used for the operation and service of housing and/or dining units. They reported that the receipts of the housing and food units were currently being deposited in the General Revolving Fund of the University. It seemed desirable to segregate income from students for food and room from the income of the University for general operation. They recommended that an Auxiliary Revolving Fund be established so as to more properly account for student receipts for room and board. A detailed report was read to members of the Committee, and upon motion duly made, seconded and carried, an Auxiliary Revolving Fund was authorized established and residence halls and dining unit revenue was authorized placed to the credit of such fund and used for the interest of housing and dining units.

C-1. Gifts.

From: John B. Hamilton Estate - Check for
\$18,000.00.

President Dickey reported a bequest from Mr. John B. Hamilton in the amount of \$18,000.00 to be used to establish "The William Z. and Elizabeth Rodgers Hamilton Fellowship Memorial Fund", in accordance with the provisions set forth in Mr. Hamilton's will. He expressed his appreciation of this gift and recommended that it be accepted and used in future years to bring aid to students in the University.

Upon motion duly made, seconded and carried, the Executive Committee concurred in the recommendation of the President and requested him to write a letter of appreciation to executors of the John B. Hamilton Estate.

From: Lexington Junior League--\$3,000.00 per
Year for Two Years.

President Dickey read a communication from Dean M. M. White of the College of Arts and Sciences which reported the offer of the Lexington Junior League to give to the University the sum of \$3,000.00 for each of two years for the purpose of building a language laboratory. The letter stated that this laboratory would make possible aural-oral instruction in a foreign language, a technique of language instruction which has been found by most institutions to be superior to the traditional techniques used in most cases. The President recommended acceptance of the grant.

Upon motion duly made, seconded and carried, the gift of \$3,000.00 for each of two years was authorized accepted, and the President was requested to write a letter of appreciation to members of the Lexington Junior League.

From: Kentucky Utilities Company--\$700.00.

President Dickey reported that the Kentucky Utilities Company had offered to the University the sum of \$700.00 to be applied on the cost of operating gaging stations on Dix River and at Dix Dam for the period of July 1, 1958, through June 30, 1959. He recommended acceptance of the check.

Upon motion duly made, seconded and carried, the check for \$700.00 was ordered accepted and the President was requested to thank officials of Kentucky Utilities Company.

From: United States Tobacco Company--\$2,400.00.

President Dickey reported receipt of check for \$2,400.00 from the United States Tobacco Company to be used as a grant-in-aid to continue studies on low nicotine tobacco under the original memorandum of agreement entered into between the Kentucky Agricultural Experiment Station and the United States Tobacco Company on May 1, 1956. He explained that this grant was in support of a very important area of the Experiment Station's research and recommended that it be accepted.

Upon motion duly made, seconded and carried, the gift of \$2,400.00 was ordered accepted, and the President was requested to thank the donors.

From: Ralph E. Mills Foundation--\$1,000.00.

President Dickey presented check for \$1,000.00, made payable to the Kentucky Research Foundation by the Ralph E. Mills Foundation, and stated that the grant was given in support of two scholarships Mr. Ralph E. Mills had been supporting during the past years. He explained that Mr. Mills is much interested in the University's educational program and has requested that one of the scholarships shall be in Engineering and one in Agriculture.

Upon motion duly made, seconded and carried, the gift of \$1,000.00 from the Ralph E. Mills Foundation was ordered accepted, and the President was requested to write a letter of appreciation to Mr. Ralph E. Mills, Frankfort, Ky.

From: Anonymous Donor--\$250.00.

President Dickey stated that he was in receipt of check for \$250.00 from a donor who wished to remain anonymous, to be used for affiliation of the University with the American School of Classical Studies in Athens for the fiscal year 1958-59. He expressed his belief that this affiliation would be of considerable value to the University, especially in the Department of Ancient Languages and Literatures, and recommended that the check be accepted.

Upon motion duly made, seconded and carried, the Executive Committee concurred in the recommendation of the President and authorized acceptance of the gift.

From: Northern Kentucky Independent Druggists Association, Covington, Ky. --Colored Photograph and \$200.00.

President Dickey reported that the Northern Kentucky Independent Druggists Association had presented to the College of Pharmacy a color photograph of the late Walter H. Pitts, once very active in the Association, and a check for \$200.00. He stated that the picture would be displayed in an appropriate place and the money used as a memorial to Mr. Pitts, probably in the form of rare books for the College library. He recommended that the gifts

be accepted.

Upon motion duly made, seconded and carried, the Executive Committee authorized acceptance of the color photograph and the check for \$200.00 and requested the President to thank members of the Northern Kentucky Independent Druggists Association for their generosity.

From: Lambda Chapter of Alpha Zeta Omega
Pharmaceutical Fraternity---\$500.00.

President Dickey stated that actives and alumni of Lambda Chapter of Alpha Zeta Omega Pharmaceutical Fraternity had contributed \$500.00 to the College of Pharmacy for the purchase of audio-visual equipment. He recommended that the gift be accepted.

Upon motion duly made, seconded and carried, the Committee concurred in the recommendation of the President and requested him to write a letter of appreciation to members of the fraternity.

President Dickey stated that the First District of the Kentucky Pharmaceutical Association had given to the College of Pharmacy \$300.00 for the purchase of an air conditioner for the College Library. He recommended that the gift be accepted.

Upon motion duly made, seconded and carried, the gift of the General Building, Savings & Loan Association was authorized accepted, and the President was requested to thank the donors.

President Dickey presented check for \$500.00 from the Kentucky Association of Highway Contractors, made to the Kentucky Research Foundation. He explained that this check was in support of a Highway Scholarship for the school year 1958-59, and recommended that it be accepted.

Upon motion duly made, seconded and carried, the Executive Committee concurred in the recommendation of the President and requested him to write a letter of appreciation to officials of the Kentucky Association of Highway Contractors.

Upon motion duly made, seconded and carried, the gift of \$3,000.00 was ordered accepted, and the President was requested to thank officials of Carrier Foundation.

President Dickey stated that he was in receipt of check for \$900.00 from Mr. Hamilton R.
