SEVERAL NOVEMBER RACES INVOLVE GAY ISSUES

With the elections coming up in November, the GLSO News looks at races of interest to Bluegrass gays and lesbians. State representative Leslie Trapp—who was iffy and unhelpful on gay issues in the last regular legislative session—faces someone even worse, Ernest Fletcher, who has issued some frankly antigay statements. Elsewhere around Lexington, the questionable Stan Cave is running unopposed.

But the main events are the races in the Kentucky Senate and the U.S. House of Representatives.

Kentucky state Sen. Tim "Sodomy" Philpot faces former Lexington Urban County Council member Don Todd. Philpot has led the effort to contradict the wisdom of the state Supreme Court, through his bills that would have provided for a state constitutional amendment to recriminalize sodomy. Under the guise of self-proclaimed "caring and compassion," he has attacked and smeared the homosexual population through his tirades in which he spins dubious statistics into lurid character assassination. For instance, he claims on the Senate floor that only "one percent of the gay men in the United States live to be 65. There is three times more alcohol and drugs among the gay population. Suicide is exponentially higher." And the caring, compassionate solution is to make us criminals? See page 6.

U.S. Rep. Scotty Baesler has shown an unwillingness to listen to our concerns. He opposes the Employment Non-Discrimination Act because he thinks it provides too much

protection—yet he has done nothing to ensure that we receive whatever limited protection he would mete out, if any. See page 4.

Baesler's Republican opponent is Matthew Wills, but there is now a write-in campaign for Lexingtonian Keith Elston. Elston views his chances of winning as minimal, but has agreed to stand for office as a way of allowing gay and lesbian (and other) voters a visible protest vote. Since Elston believes that neither the Democratic nor the Republican candidate is likely to work for the interests of the sexual-orientation minority, a write-in campaign will allow the votes of the dissatisfied to be counted and aggregated in a way that will be apparent to whoever wins. Elston has encouraged his followers, "If you're going to waste your vote, waste it for me."

The deadline for registering to vote is OCTOBER 10. If you have moved and need to change your registration, or if you aren't registered, go to the county clerk's office on Main Street. Or call the League of Women Voters at 255-7563. Stop reading this. Go register now. Go. Do it.

Chris is very active with me in the Pagan community, so we simply don't have the time and energy to revive the group. Besides that, I'm not even bisexual! But I still keep hearing from lots of men and women who are, and there's no doubt in my mind but that if someone would have him/herself listed as the bisexual group contact in the GLSO Newsletter and other regional lesbigay publications, within a few months a thriving group could be built up, which, with a bit of care and attention, could grow into a permanent, thriving asset to our community. PLEASE, SOMEONE, STEP FORWARD. It's definitely worth another try. Many local bisexuals need support and understanding. They get flak from both gays and straights. Many straights blame them for introducing AIDS into the heterosexual community. As for the gay/lesbian side of things, I keep seeing personal ads reading "no bi's," and on a more personal note, my partner has been called "breeder fag" down at The Bar. Talk about bigotry! Definitely, much work needs to be done to help bisexual men and women feel that they are truly a part of our lesbigay community. (That's what the "bi" stands for, y'all.)

On the religious front (by the way, I'm the Pat listed as the contact for the Pagan Forum), I'd like to see some ecumenical sharing of spiritual journeys in next year's Pride Week We tried it once, and it degenerated into a near shouting match between those of us for whom leaving the Church was a crucial part of our spiritual/sexual awakening, and others who came to accept and affirm their own homo/bisexuality while remaining committed Christians. INTRODUCTION TO "CELEBRATING THE **BODY EROTIC" PLANNED** BY CRAIG CLERE

Many men long for a deeper connection with their bodies. Most of our education has taken us out of our bodies, away from the simple pleasures of touching and being touched. Social conditioning and western religion have taught us to abstain from pleasure and to disconnect from our bodies rather than celebrate our birthright to feel pleasure.

The Celebrating the Body Erotic workshop teaches men how to feel at home in their erotic bodies. Through sacred sex rituals and conscious breathwork, men are guided into feeling states that awaken their deepest centers of pleasure. Erotic initiation rituals, based on Taoist, Tantric, and Sufi traditions, allow men to experience their erotic energy as playful, sacred, energizing, and transformative. Men learn to explore the potential benefits of a full-body orgasm without ejaculation. Other opportunities are present for exploring the spiritual of erotic energy, dimensions self-acceptance as an erotic being, and ways to become more conscious in erotic relations with others.

I completed the Celebrating the Body Erotic (CBE) workshop in early April in Washington, DC. At that time changes occurred in the way my body, mind, and spirit connected with one another. I decided to seek additional training and attended the week-long intensive workshop, the Dear Love of Comrades Intensive, in Northern California in late June sponsored by the Body Electric School of Oakland, CA.

The week was life-transforming for me, unlike anything I had experienced previously. I connected with twenty-eight men in special and unique ways. I spent a week of sharing with these men and exploring our connection to each other as gay brothers. I've kept up that connection with many of my "sacred brothers" and have made lifelong friendships.

That leads me to this introduction. The first

step for me along this path was the Celebrating the Body Erotic (CBE) workshop. I would like to let men in the Central Kentucky area know more about Celebrating the Body Erotic and, eventually, form a local group of Body Electric School alumni. In other cities these groups continue to meet monthly for sharing with one another. These workshops are not for the masses, but for the select few who are seeking another path and exploration between themselves and other gay men.

I anticipate meeting in early October to answer questions and share my experiences with the Body Electric School. Please call me, Craig, at 269-8215 for any questions, directions, date, time,

Linda West is taking some time off, but she is allowing to reprint a letter she recently received:

"Dear Ms. West:

"Thank you for contacting me in reference to your concerns about the so-called 'Gay Civil Rights' Bill. Your views are important to me and I appreciate the fact that you have contacted me about this particular issue. I have made note of your concerns and I will keep them in mind as Congress continues to debate this controversial issue.

"The measure seeks to add the category of 'sexual orientation' to the list of minority groups protected under the 1964 Civil Rights Act. I am opposed to 'The Employment Non-Discrimination Act' (H.R. 4636 & S. 2238) and I am opposed to the attempts to include sexual behavior under the heading of special legal behavior.

"As written, The Employment Non-Discrimination Act would prohibit discrimination on account of sexual orientation. The bill, also known in some circles as the 'Gay Jobs BIll', [sic] makes it unlawful to discriminate against a person because of his or her sexual orientation in terms of opportunities in employment, education, credit, housing, the sale or use of goods and services, with respect to any public facility, or in any federal assisted program or activity.

"The bill seeks to exploit the legacy of the civil rights movement by re-defining the term to now include sexual orientation and sexual behavior. I want to be clear about my position on this matter: I am opposed to attempts to re-define the term, and consequently, I am opposed to this measure as it is written.

"The 'Gay Jobs Bill' has come under fire from a number of groups, including many religious bodies, who fear the measure would force them to hire individuals who have lifestyles that they oppose.

"As indicated, I have a number of strong reservations about the intent of the bill. I especially worry about the impact that it will have on religious schools, churches and other ministries.

"As a result, I will not support this measure nor will I vote for it. If I can be of additional assistance to you on this, or any other matter, please feel free to contact me right away.

FOR YOUR INFORMATION...

This year, Rep. Scotty Baesler is running against Matthew Wills. If you like Baesler, you can rest easy, as he is certain to win. Wills has not shown himself to be pro-gay, but there are those who feel that if one must choose between two evils, vote for the non-incumbent, so at least he'll be a freshman with comparatively less power to work his mischief.

There is also the strong possibility of a write-in candidate; voting for this third person would register a protest.

The following analysis of Baesler's letter to Linda West was compiled by Keith D. Elston, ACLU of Kentucky Public Education Director and recently announced write-in candidate for Congress.

Scotty says: "I am opposed to the attempts to include sexual behavior under the heading of special legal behavior."

The truth: ENDA is not about sexual behavior. To require employers to put up with sexual behavior in the workplace would be wrong. ENDA only prohibits employers from using orientation—gay, lesbian, bisexual, or heterosexual—as the basis for adverse or different treatment in employment or employment opportunities. The underlying principle behind ENDA is that people who work hard and perform well should not be kept from leading productive and responsible lives—paying taxes, covering their mortgages, and contributing to the economic life of the nation.

Scotty says: "[ENDA] makes it unlawful to discriminate against a person because of his or her sexual orientation in terms of opportunities in employment..."

The truth: This much is true. ENDA would include discrimination in hiring, firing, promotions, compensation, and other employment decisions. Regrettably, job discrimination against lesbian and gay people is widespread, and there is no federal anti-discrimination law that covers them. ENDA takes a modest step toward securing equal treatment for millions of Americans who continue to experience discrimination in the workplace.

Scotty continues: "...education..."

The truth: ENDA does not address educational opportunities. ENDA only addresses employment discrimination.

Scotty continues: "... credit..."

The truth: ENDA does not address credit discrimination. ENDA only addresses employment discrimination.

Scotty continues: "...housing..."

The truth: ENDA does not address housing discrimination. ENDA only addresses employment discrimination.

Scotty continues: "...the sale or use of goods and services, ..."

The truth: ENDA does not address discrimination in the sale/use of goods and services. ENDA only addresses employment discrimination.

Scotty continues: "...with respect to any public facility..."

The truth: ENDA does not address discrimination in the use of public facilities. ENDA only addresses employment discrimination.

Scotty continues: "... or in any federally assisted program or activity."

The truth: Again, ENDA does not address discrimination in federally assisted programs or activities. ENDA addresses only employment discrimination.

Scotty: "I especially worry about the impact that [ENDA] will have on religious schools, churches, and other ministries."

The truth: Not to worry. Section 7 of ENDA specifically exempts religious organizations, including educational institutions substantially owned, managed, controlled, or supported by religious organizations and education institutions whose curriculum is directed to the teaching of religious doctrine. The bill only covers a religious organization's for-profit activities subject to taxation under the Internal Revenue Code. ENDA also exempts small businesses with fewer than 15 employees. Additionally, ENDA specifically exempts the Armed Forces and does not repeal or modify any other law that gives special preferences to veterans. Some other things that ENDA won't allow: disparate impact claims, quotas, and preferential treatment based on sexual orientation, or benefits for same-sex partners of employees.

Scotty: "[ENDA] seeks to exploit the recognized leaders of the legacy civil rights movementby re-defining the term to now include sexual orientation and sexual behavior."

The truth: In fact, most recognized leaders of the civil rights movement, including Coretta Scott King and Leadership Conference on Civil Rights Executive Director Ralph G. Neas, have strongly supported ENDA. The National Board of the Leadership Conference met this past June to designate ENDA a top legislative priority underscoring the growing bipartisan consensus in this country that prohibiting discrimination against gays and lesbians is a fundamental civil rights issue.

KENTUCKY REPUBLICAN PARTY: OFFICIALLY ANTI-GAY

During its June 4 annual convention in Lexington, the Kentucky Republican Party adopted a resolution calling for the recriminalization of consensual oral/anal sex between members of the same sex even in the privacy of the bedroom.

Ironically, considering the above, the GOP also issued a resolution calling for "limited government and limited taxation with more personal freedom and more personal responsibility by individuals..."

Resolution VIII reads: "Whereas, the AIDS and other sexually transmitted diseases are serious threats to public health and whereas, a violation of physical and moral union of the opposite sexes leads to physical, mental and social dysfunction, disease, and death,Be It Resolved, that the Republican Party of Kentucky supports letting Kentucky voters decide the issue by placing a constitutional amendment [note: thus making Kentucky the only state in the Union with such an amendment and in direct violation of the right to privacy afforded in the Kentucky Constitution] to reinstate the ban on homosexual sodomy [defined as oral or anal sex] on the ballot before the voters."




