PROCLAMATION.

To the United Brothers of Friendship and Sisters of the Mysterious Ten of N. A., S. A., E., A. A., Greeting:—

I, W. A. GAINES, N. G. M., by and with the consent of Nine Grand Masters; and at their earnest solicitations, do hereby call off the Fourteenth Triennial Session of the National Grand Lodge at Muskogee, Okla.; and call on the National Grand Session at Chicago, Ill., to be held July 22, 23, 24, 25, 26, 1912 for the following causes:

1. The National Grand Camp on account of the numerous riots and conflicts between the races refused to attend the session if held in Oklahoma.

2. The South Central Passenger Association representing all the states south of the Ohio River and east of the Mississippi River, representing the states of Kentucky, Alabama, Mississippi and Tennessee, after several months waiting, have refused or withheld their consent to special rates for delegates to the convention.

3. From reliable information no adequate preparation or program of exercises have yet been arranged by the brotherhood in Oklahoma.

4. A lawsuit still pending in the Supreme Court of Oklahoma to annul the charter filed by the National Body which might be invoked to the discomfiture and harmony of our Supreme Body.

By the supreme power invested in me, and for the best interest of the order, and by and with the consent of the National Knight Commander, and the National Grand Princess, do ordain and declare the above place and time as the meeting place of the National Grand Lodge and the National Grand Temple, and the National Grand Camp of the U. B. F. and S. M. T. of N. A., S. A., E., A. A.

THIRD QUARTERLY REPORT OF THE GRAND BOARD OF
MANAGEMENT OF U. B. F. & S. M. T. OF KENTUCKY.

April 20, 1912.

To the Lodges, Temples and Juveniles, Greeting:

We, your Grand Board of Managers, beg leave to submit our report for the third quarter of this Grand Lodge Year.

The Board met in regular session in the office of the Grand Secretary with the full Board present. Present also, were Brethren W. D. Tardif (Grand Master), W. H. Ballard (Deputy Grand Master), Stephen Bell (Grand Secretary), and E. W. Chenault (Grand Treasurer).

Grand Master, Dr. Tardif, addressed the Board, mentioning among other things that in many cases officers of subordinate lodges do not understand the importance and necessity of the Grand Medical Examiner, and that in one instance a complaint has been filed questioning the authority of the G. M. to appoint that officer. As to this point, it will be recalled that the Grand Lodge at Mt. Sterling failed to elect a Grand Examiner. (See Section 3, Article 7, Articles of Incorporation.) So, using his prerogative under Section 4, Articles of Incorporation, he, with the approval of the Grand Board, appointed Dr. A. D. Kelley, of 514 Scott St., Covington, Ky., to the place. We recognize the Grand Medical Examiner as a very necessary officer to guard our Order against persons who are physically unfit. Cases have been brought to our notice where physicians have recommended for membership persons who at the time, had all the symptoms of consumption and other wasting diseases, and who immediately after their initiation became burdens upon the Lodges. Under our new system the local examiner is required to examine the applicant, state the conditions just as found, fill out the questions on the examination blank, and then turn over the blank to be sent to the Grand Examiner, who makes a careful study of these facts and recommends or rejects the applicant. This system is certainly an improvement over the old one. Further, in this connection, we think it advisable to remind officers of Lodges to be careful in the selection of physicians for local examiners, for in doing so you can help guard our Relief Bureau against many unnecessary obligations.

We wish to call attention again to the new constitutions. Every member of the Order should be well versed in the laws. Officers shall call attention to this, and send orders to Brother Stephen Bell for as many copies as needed. The price is 15 cents.

We suggest that officers, in sending in their reports hereafter, will be careful to keep separate the reports for the Relief Bureau and those of the Grand Lodge. Ofttimes money for both departments is sent in one item, thus causing unnecessary work and confusion in keeping accounts. The accounts of the two departments are kept separate, so you can, by keeping this in mind, help us in our efforts to conduct your business on a strictly business basis. Notice is also given that all reports not in the office of the Grand Secretary by July 1, of this quarter, and on the first of the month following the close of each quarter hereafter, will not be reported in the Quarterly Circular.
