Irregularities

Minutes of the Meeting of the Executive Committee of the Board of Trustees, University of Kentucky, May 1, 1946.

The Executive Committee of the Board of Trustees of the University of Kentucky met in the President's Office at 10:30 a.m., Wednesday, May 1, 1946. The following members were present: Judge Richard C. Stoll, Chairman; R. P. Hobson, H. D. Palmore, H. S. Cleveland, and John C. Everett. President H. L. Donovan and Comptroller Frank D. Peterson, Secretary of the Board of Trustees, were also present.

A. Contract for Construction of Men's Residence Hall.

The Chairman of the Executive Committee, Judge Stoll, reported that pursuant to authorization of the Board of Trustees, the contract for the construction of the Residence Hall for Men, at a cost of \$413,200.00, base bid, and the acceptance of alternates 2, 3 and 4, had been signed by the Vice Chairman of the Board of Trustees, attested to by the Secretary of the Board, and construction of the building had begun. The Comptroller reported that contract documents had been approved by the Attorney General.

B. Report of the Comptroller.

The Comptroller submitted a financial report of operations of the University for the period July 1, 1945, to and including March 30, 1946. The following analysis was read to the Committee:

Dear President Donovan;

I submit hereto attached the financial report for the period ended March 30, 1946.

Income

During the first nine months of the fiscal year 88.8% of the total budgeted income had been realized. Apparently the Realized Income was in a favorable position on the date of the report. However, there is a possibility that the income budgeted for Student Fees will not be realized in full by the end of the fiscal year. During the period covered by the report only 55.5% of the estimate of Student Fees had been realized. The original estimates and subsequent revising of the Student Fee Accounts were based upon the idea that a large portion of the fees of Veterans under Public Laws 16 and 346 would be available, due allowance being made for the fact that such fees were to be paid in arrears. However,

experience has proven that it takes approximately two months after the close of a quarter to prepare invoices to meet the requirements of the Veterans Administration and that payment of the fees is not made until three or four months after invoices are rendered. On March 30, 1946, fees of veterans had been paid through the summer quarter. The fees receivable in connection with veterans amounted to approximately \$130,000 on that date.

State Appropriations were allotted in full on April 1, In order to realize the entire amount of the appropriations, it is planned to encumber the general appropriations for the payment of April, May and June salaries. ance of appropriations for Repairs to Buildings and Home Economics Equipment is to be used to reimburse the College Revolving Fund in connection with Job Orders. The balance of the appropriations for Scientific Laboratory Equipment and Engineering Equipment is to be used to reimburse the College Revolving Fund for funds advanced to acquire Surplus and Excess Government Property. Other appropriations have small balances which will be encumbered before the end of the year. No balance of any sizable amount is expected to revert to the State General Fund.

Federal Fund Accounts have small unrealized balances which are expected to be fully realized before the end of the fiscal year.

The University has little control over the amount of income derived through the State Department of Education in connection with the Smith-Hughes Teaching Act and corresponding State Funds. A major portion of the estimated income from this source is expected to be realized.

Income of Residence Halls amounting to \$79,133.17, has been credited to Clearing Accounts. This is in process of being transmitted to the State Treasury. This amount, together with additional income for April, May and June, should cause the estimate of Auxiliary income to be fully realized by the end of the year.

Other income items are expected to be realized in excess of the estimates.

From the standpoint of the total budget, there should be no large variation between the budget estimate and the total income realized by the end of the year.

Expenditures

Expenditures and encumbrances recorded during the period amounted to 71.9% of the Revised Departmental Appropriations.

An analysis of the appropriation accounts reveals that several accounts will close the year with balances, which

will revert to the unappropriated surplus of the University Current General Fund. It was also apparent that a few appropriations should be revised to provide for expenditures not anticipated in the original budgets and subsequent revisions.

The unprecedented enrollment at the registration for the Spring Quarter has caused an increase in the expenditures of certain of the Administration and General Expense Accounts. There has also been an increase in the expenditures of the Maintenance and Operations Division. The current rate of expenditures being charged to these accounts cannot be maintained without overdrafts resulting.

The expenditures charged to the College Budgets and Auxiliary Enterprises fall below the budgeted requirements. These accounts should complete the year with small credit balances.

The Experiment Station has submitted a revised budget which had not been recorded on March 30, 1946.

C. Budget Additions Authorized.

President Donovan stated that it was necessary from time to time to authorize various additions to departmental budgets. These additions are required to handle the increased work of the departments, primarily due to the increased enrollment of the University, and necessary to provide funds for returning staff members from leaves of absence. He read a list of recommended increases and asked for the approval of the Executive Committee.

The Committee heard the recommendation of the President and took the following action:

Upon motion duly made, seconded and carried, the budget increases, as recommended, are authorized, the Comptroller is directed to transfer the amounts from the unappropriated surplus of the general University budget, and the list of increases is ordered filed with the Secretary of the Committee.

D. Sale of Dormitory Revenue Bonds.

It was stated that the Board of Trustees, at its meeting April 2, 1946, authorized the issuance of \$430,000 Dormitory Revenue Bonds of 1946, the funds to be used for the construction of a residence hall for men. The resolution adopted at that meeting was approved by the Attorney General, as set forth in the following letter:

Dear Sir:

Pursuant to your request, this office has considered the resolution of the Board of Trustees of the University of Kentucky proposing the issuance and sale of Dormitory Revenue Bonds.

The Board of Trustees of the University of Kentucky is granted the authority for the issuance of such bonds for the purpose indicated by Sections 162.350 through 162.380 KRS.

A study of the resolution of the Board of Trustees and of the proposed bond reflect very few irregularities. Inasmuch as the governing body of the University is the Board of Trustees, the references throughout the resolution and the bond of "University of Kentucky by its Board of Trustees" or similar expressions should be "the Board of Trustees of the University of Kentucky." I have indicated on Pages

3, 6; 10 and 12 of the resolution the places where the change should be made.

The first paragraph on Page 9 of the resolution provides that all moneys held in the bond fund or as a reserve for contingencies shall be deposited in a bank which is a member of the Federal Reserve System and of the Federal Deposit Insurance Corporation. Question has been raised as the right of the institution to deposit the money in a bank Question has been raised as to and not deposit it with the Treasurer of the Commonwealth of Kentucky. The revenues from the sale of these bonds are placed in a special fund which does not become a part of the general revenue of the state of Kentucky, but is a special fund set apart for the construction of the dormitory. revenues from the use of the dormitory are likewise not funds of the state, but are funds earmarked and set aside for the redemption of revenue bonds. As such, it is not state revenue and need not be placed in the Treasury of the Commonwealth of Kentucky, but may be placed in a bank as provided by this section.

We call your attention to the case of J. D. Van Hooser & Co. v. University of Kentucky, 262 Ky. 581, wherein the Court of Appeals had before it for its consideration a similar bond issue from the University of Kentucky. The Court of Appeals approved the issue there; and that before, being similar to that considered by the Court of Appeals, meets all the requirements of the statute, and, subject to the abovementioned changes, are in proper legal form.

It was stated that the changes in the resolution recommended in the Attorney General's letter were made, and the resolution adopted by the Board of Trustees at its meeting April 2, 1946, contained those changes. The Comptroller reported that, pursuant to direction of the Board of Trustees on April 2, 1946, he had caused the following advertisement to appear in the Louisville Times and the Courier-Journal, Louisville, Kentucky; and in the Bond Buyer, a national publication issued weekly, and the Daily Bond Buyer, a national publication.

at 10 o'clock A.M., and then and there further consider the matter of issuing said bonds and also receive and consider proposals for the purchase of said bonds. The minimum bid to be considered will be 102% of par plus accrued interest.

Each bidder will be required to qualify by furnishing a certified check on a state or national bank in the sum of \$8,000 payable to the order of the Secretary of said Board of Trustees. Such checks of any unsuccessful bidders will be returned after the opening and consideration of the bids but the check of the successful bidder will be retained until delivery of the bonds and the amount thereof shall constitute the agreed liquidated damages in the event the successful bidder fails or refuses to perform in accordance with the accepted bid. In the event that prior to the delivery of said bonds the income therefrom to an individual becomes taxable under any federal income tax law, the successful bidder will be relieved of the obligation to accept delivery and the deposited check will be returned on request.

He also reported that the following statements were issued and mailed to investment houses making inquiry concerning the issuance of \$430,000 Dormitory Revenue Bonds of 1946.

Gentlemen:

We enclose data concerning the proposed issue of \$430,000.00 University of Kentucky Dormitory Revenue Bonds of 1946 on which the Board of Trustees of the University will accept sealed proposals at 10:00 a.m. Central Standard Daylight Saving Time, May 1, 1946.

We wish to correct one error contained in this information. On the page headed "Bonded Indebtedness of the University of Kentucky" we make the statement that the bonded indebtedness of the University is \$938,000.00 less than the maximum eight years ago. That is not correct, as a careful examination of the figures on that page will show. You will note that to retire a like amount of bonds, \$507,000.00 of refunding bonds were issued last year bearing interest 1-3/4%.

Further, the proposed \$430,000.00 bond issue is callable from time to time in part "in the inverse order of their numbering", on any interest payment date, etc.

The legal opinion of Messrs. Chapman & Cutler, Chicago, Illinois, will be furnished to the successful bidder.

NEED FOR THIS BUILDING

As against an average pre-war fall term enrollment of thirty-five hundred, the present spring quarter enrollment is 4,273. The fall enrollment for 1946-47 is estimated to reach six thousand, if housing facilities can be found within the City of Lexington, or made available through other sources by the University. It is estimated by the administration of the University that the enrollment will exceed five thousand for many years to come, and will reach and be maintained at six thousand when housing accommodations can be provided. At the present time, the University owns and operates three residence halls for men, normally housing three hundred and thirty students; we are now housing three hundred and ninety-four in these dormitories. In normal years, the ratio of men students to women students has been approximately two to one. This new dormitory will house men students and provide recreational and social accommodations for men students housed in all dormitories for men.

SOURCES OF REVENUE FOR RETIRING BONDS

It is contemplated that one hundred and eight men students will be housed in the proposed residence hall, from which rental income in excess of seventeen thousand dollars will be derived. The room rental will be approximately forty dollars per quarter per student, collected each quarter in advance at the time the student registers in the University. No student is allowed to occupy a room in the dormitory until his room rent has been paid. The University operates on a four quarter system, therefore the residence halls will be in operation during the entire year. This housing rental of forty dollars per quarter is substantially below normal rent rates for housing facilities obtainable from private sources in Lexington. The basement level floor, and the ground floor in the proposed building will care for recreational and social needs for students living in all existing men's residence halls; it will provide for a coffee shop, administrative offices, director's apartment, etc., which facilities will be leased directly to the University and paid for from income derived from rental of dormitory facilities to other men students. The income from this source will not be less than sixteen thousand dollars per year, making a total annual income in excess of thirty-three thousand dollars. The total expense of operating the new men's residence hall will not exceed ten thousand dollars per annum, allowing for bond interest and principle retirement an amount in excess of twenty-three thousand dollars annually as against maximum debt service charges in any one year of twenty thousand five hundred dollars. Thus the new dormitory will be self supporting.

Contract for the erection of the proposed Residence Hall for Men has been let on a firm competitive bid of \$418,000.00 awarded to the Hargett Construction Company of Lexington, Kentucky. The contract has been authorized by the Board of Trustees and executed and performance bond given by the contractor. A work order for commencing actual construction has been issued. Actual construction will start immediately and contract provides that the construction will be completed within a period of 245 calendar days.

The University of Kentucky is located at Lexington, an urban community of about 70,000 population. It is a state supported institution operated under the direction of a board of trustees of fifteen members. The membership of this board includes the Governor, the Superintendent of Public Instruction, and the Commissioner of Agriculture, ex officio, and twelve members appointed by the Governor, three of whom are alumni of the University and three; members of the State Board of Agriculture. The University is one of a number of institutions known as land-grant colleges which were established by the Morrill Act of 1862 and which have continued to receive federal assistance under the provisions of this and subsequent laws relating to the teaching of agriculture and the mechanic arts and the provision of agricultural experiment stations and extension services in agriculture and home economics.

The University of Kentucky is on the approved list of the Association of American Universities, and is a member of the Southern Association of Colleges and Secondary Schools and the Kentucky Association of Colleges and Secondary Schools. It is accredited in its respective colleges or departments by the Association of American Law Schools, the American Association of Collegiate Schools of Business, the American Association of Schools and Departments of Journalism, the American Library Association, the National Association of Schools of Music, and the Engineers' Council for Professional Development.

The major function of the University is that of instruction. For the performance of this function it is organized into the College of Arts and Sciences, the College of Agriculture and Home Economics, the College of Engineering, the College of Law, the College of Education, the College of Commerce, the Graduate School, and a Department of University Extension. Residence instruction is given through four quarters of approximately twelve weeks each, the summer quarter being divided into two terms.

In addition to giving instruction to its student body, the University contributes to the welfare of the state through research, experimentation, and public service. While all departments make important contributions along these lines, certain divisions and bureaus have been established specifically for these purposes. Included in this group are the Experiment Station and the Extension Division of the College of Agriculture and Home Economics, the Bureau of Business Research, the Bureau of Government Research, the Bureau of School Service, the Bureau of Source Materials in Higher Education, the Personnel Bureau, the Teachers Placement Bureau, the Department of University Extension, and the Department of Public Relations.

The University of Kentucky began as a part of Kentucky University under a cooperative plan authorized by the legislature in 1865. The purpose of this plan was to unite sectarian and public education under one organization. This experiment wastried for a number of years. In the meantime, the federal funds authorized under the Morrill Act were used to develop agriculture and mechanic arts in Kentucky University. In 1878, when the people of Kentucky decided to establish a state institution of higher learning, the College of Agriculture and Mechanic Arts was separated from Kentucky University and reestablished on land, given by the City of Lexington and the County of Fayette. Thirty years later the legislature changed the name of the institution to the

State University of Kentucky, and gave it additional financial support. In 1916 the name was again changed, this time to the present title, and additional maintenance was arranged by legislative act.

A representative of Pohl and Company, Inc., Cincinnati, Ohio, and a representative of a syndicate headed by the Bankers Bond Company, were present. The Comptroller further reported that the above bid represented a net interest cost of 1.96% on maturities for 1949 to 1976 inclusive.

Taylor & Co., and Fox, Reusch & Company, by their Authorized Agent, Wood Hannah, now therefore be it resolved by the Executive Committee of the Board of Trustees of the University of Kentucky, as follows:

E. Proposal for the Purchase of Alfred Miller Property.

President Donovan reported that he had contacted C. N. Manning, Agent for the Alfred Miller property, located on Limestone Street and Maxwelton Court, and extending westward to Winnie Ave., a distance of 397 feet and along Winnie Ave. approximately 326 feet. He stated that it seemed desirable to purchase this property if a satisfactory price could be secured. The members of the Committee considered the question and took the following action:

F. Sale of Smith Hall.

Members of the Committee reported that they had visited and inspected Smith Hall and that it was to the best interest of the University to dispose of this property. It was further stated that this property is separated from the University campus and does not fit into the future expansion program of the University.

after due consideration of the question, the Committee took the following action:

4. Upon motion duly made, seconded and carried, President Donovan and Comptroller Peterson are authorized and directed to advertise and sell this property at public auction to the highest and best bidder, and they are given power to reject or accept any and all bids.

G. Agreement with Steel Founders' Society of America.

President Donovan submitted agreement between the Steel Founders' Society of America and the University of Kentucky. He read the following agreement:

THIS AGREEMENT, made this 6th day of April, 1946, between STEEL FOUNDERS' SOCIETY OF AMERICA, an unincorporated association having executive offices at the Midland Building, Cleveland, Ohio, hereinafter called the Society, and UNI-VERSITY OF KENTUCKY, a corporate body incorporated under the statutes of the state of Kentucky, located in Lexington, Kentucky,

WITNESSETH:

That in consideration of the covenants of the parties hereinafter set forth, it is mutually agreed as follows:

FIRST: University of Kentucky agrees to perform during a period of one year beginning May 1, 1946, research required for an investigation of the surface finish of steel castings.

SECOND: The Society agrees to pay University of Kentucky \$6,000, payable \$1,500 May 1, 1946, and a like sum on August 1, 1946; November 1, 1946; and February 1, 1947, respectively.

THIRD: University of Kentucky shall select and control the personnel for said research, and shall have exclusive control over the expenditure of the funds paid for said research.

FOURTH: University of Kentucky shall provide without additional cost to the Society all laboratory supplies and standard equipment necessary in connection with said research. If, in addition to said standard equipment, University of Kentucky requests special equipment for the prosecution of said research, which the Society agrees to be necessary or proper, such special equipment may be either furnished by the Society to University of Kentucky, or upon the written authorization of the Society specifying the price to be paid, may be purchased by University of Kentucky as agent for the Society, which agrees to pay the invoices therefor upon University of Kentucky's proper certification or to mimburse University of Kentucky for the cost thereof. Special equipment so furnished by the Society or purchased upon the written authorization of the Society shall be at all times the property of the Society, but shall be subject to the exclusive control of University of Kentucky, for use only in connection with said research, until the completion of said research.

FIFTH: University of Kentucky agrees to prepare and to send to the Society monthly reports of the progress of said research in reasonable detail, and at the end of the project a complete final report upon said research and its results.

SIXTH: All reports and results of said research furnished to the Society by University of Kentucky, and the contents of said reports, shall be the property of the Society, and may be distributed, published or otherwise utilized by the Society as it may determine.

SEVENTH: University of Kentucky agrees that it will in no event, either during the progress of said research or thereafter, disclose or publish, or permit the disclosure or publication of any information or results obtained by University of Kentucky or any members of its staff or any of its employees in the course of said research, except to the Society or upon the written permission of the Society.

EIGHTH: University of Kentucky agrees that any invention or other patentable material or thing resulting from said research shall be the property of the Society, and University of Kentucky agrees to execute and deliver to the Society any assignments or other documents required by the Society to establish or protect its rights in respect thereof. University of Kentucky agrees that any members of its staff or any of its employees who shall in the course of said research make any discovery or invention or other patentable thing, shall promptly make such discovery, invention or other patentable thing known to University of Kentucky and the Society, and upon the request and at the expense of the Society make application for letters patent thereon and assign any and all rights to such discovery, invention, or patentable thing and to such letters patent to the Society.

H. Agreement with the Lexington Water Company.

President Donovan submitted an agreement between the Lexington Water Company of Lexington, Ky., and the University of Kentucky, which assigns a right-of-way across the University of Kentucky Agricultural Experiment Station Farm for a water line. He read the following letter from Dean Cooper:

April 29, 1946

President H. L. Donovan University of Kentucky

Dear President Donovan:

The Lexington Water Company has requested permission to run a water line across the Experiment Station property from the Montclair Subdivision to the Board of Education lines on the Nicholasville Pike. I have had the matter looked into carefully and recommend that this right of way be granted. A blue print showing the location of the prospective water line and an agreement to be entered into, accompany this letter. If the recommendation is accepted, I suggest that the agreement be signed and that a copy of the agreement and the blue print be retained for the file and one copy of the signed agreement be returned to Mr. Wallace Muir, Bank of Commerce Building, Lexington, Kentucky.

THIS INDENTURE made and entered into this the day of May, 1946, by and between UNIVERSITY OF KENTUCKY, a Corporation, of Lexington, Kentucky, party of the first part, and LEXINGTON WATER COMPANY, a Corporation, of Lexington, Kentucky, party of the second part:

WITNESSETH:

That in consideration of the benefits to be derived by the party of the first part by the construction by the party of the second part of a water line across the property of the party of the first part hereinafter described, the party of the first part does hereby sell, transfer, assign and convey unto the party of the second part, its successors and assigns, a right of way across the property of the party of the first part for the purpose of constructing a water line thereon, as herein provided, which said right of way is more particularly described as follows:

Beginning at a point in the rear line of Lot #32 of the Mcrton Subdivision #3, said beginning point being 3.85 feet North of the rear line between Lots 32 and 33 of the Morton Subdivision #3 and being in the line of the University of Kentucky property; thence N. 84-22 E. 2165 feet to a stake; thence N. 22-28 E. 1547.7 feet to a stake; thence N. 32-10 E. 231.8 feet to a stake; thence S. 62-15 E. 12 feet to a stake at the end of Montclair Drive, said point being 18 feet southwest of the center-line of Montclair Drive.

Said party of the second part agrees to construct an eight inch water line on said right of way and to place the pipe used in the construction thereof at a depth of thirty-six (36) inches below the surface. Said party of the second part shall have the right of ingress and egress to and from said right of way for the purpose of constructing said pipe line, of inspecting, repairing, replacing and maintaining same as from time to time may be required in the operation of its business.

Said party of the first part shall have the right from time to time to tap said water line for the purpose of obtaining water therefrom under the usual and customary conditions that may be prescribed by the party of the second part and in accordance with the franchise granted to the party of the second part by the City of Lexington, and in accordance with the rules and regulations of the Public Service Commission of the State of Kentucky.

The property across which said right of way runs is known as the Experiment Station Farm of the University of Kentucky, located at the southerly limits of the City of Lexington, in Fayette County, Kentucky, and a plat of said right of way is attached to and made a part hereof, marked for identification "Exhibit A."

Said party of the first part covenants to Warrant Specially the title to said right of way herein granted.

The party of the second part hereby agrees to save and hold the party of the first part harmless from any and all damages either to persons or property resulting from the negligent construction and or maintenance of said line by said party of the second part.

IN TESTIMONY WHEREOF party of the first part has set its hand by Richard C. Stoll, Chairman of its Executive Committee, and his act has been attested and the corporate seal of the first party has been affixed by Frank D. Peterson, its Secretary, this the day and year first above written.

I. Report of a Special Committee of the Kentucky Chapter of the American Association of University Professors Regarding the Housing Situation of the University Faculty.

President Donovan reported that a faculty committee had made an investigation of the housing situation of the University Faculty. He read the summarized report of the Committee, which revealed a serious housing problem facing a large number of the faculty.

The Executive Committee considered the acute housing problem and took the following action:

J. Recess for Luncheon.

The Board recessed at 1:00 p.m. for luncheon, which was served in the President's Office. The Board re-convened at 2:00 p.m. and a gain took up the business on the agenda.

K. Establishment of an Engineering Experiment Station.

President Donovan reported that he had requested the 1946 Legislature for an appropriation of \$50,000 to enable the University to establish and operate an Engineering Experiment Station, but that the requested appropriation was not granted by the Legislature. He reviewed the progress made toward the establishment of an Engineering Experiment Station during the past several years, and read the following letter and recommendation.

March 26, 1946

President H. L. Donovan University of Kentucky

My dear President Donovan:

Although the \$25,000-\$50,000 appropriation for establishing an engineering experiment station within the College of Engineering may be deleted from the University's budget for the approaching biennial period, I recommend that such an engineering experiment station shall be approved formally by the University, by and through the action of the Board of Trustees. My reasons for the making of this recommendation are as follows:

- 1. There has existed for some years an Association of Engineering Experiment Stations within the Land Grant Colleges and Universities. Although this College is not listed as a member of this Association, the College has performed much more work informally along this line than many listed members of the Association.
- 2. The College has accumulated and will accumulate in the near future much information and material which would not only be interesting, but also valuable, to many individuals and to industry throughout this and other states, if published in proper bulletin form and circulated under the sponsorship of the Engineering Experiment Station of this College. I believe that during the next two years we can find sufficient active material to warrant at least the publication of fifty such bulletins.
- 5. It is well within the range of possibility that federal aid will be made available eventually for the support of such experiment stations within the engineering colleges. If and when this is done, it will be well to at least have such an organization already formally approved and listed as a member of a national organization, with some history behind it.
- 4. I estimate that such a program, including printing and circulation, can be well executed at a cost of approximately \$8,000 per year.

My dear Dean Graham:

I am conveying to the Board of Trustees, with my approval, the recommendation you have made that we go ahead and formally establish the experiment station of the College of Engineering, even though the Legislature made no direct appropriation for this activity. If the

Trustees approve of this action, I will recommend \$8,000 from the general appropriation for colleges to be allotted to this activity.

President Donovan further explained that it would not be possible to do the job with an appropriation of \$8,000 a year, but that this amount would permit an Engineering Experiment Station to be established, and would get such a station into operation for future expansion.

The Committee considered the question and passed the following motion:

Upon motion duly made, seconded and carried, an Engineering Experiment Station is hereby established within and under the supervision of the College of Engineering, and an appropriation of \$8,000 per annum from unappropriated surplus of the general University budget is allocated for the expenses necessary. This appropriation shall become effective July 1, 1946.

L. Kentucky Press Association

President Donovan reported that the Kentucky Press Association by resolution and proper action had established an annual award of \$100 for the sophomore major in Journalism most deserving, and who had earned the highest scholarship standing during his or her freshman and sophomore years in Journalism. He read the following letter from Mr. Victor R. Portmann, Secretary-Manager of the Kentucky Press Association, and the resolution of the Kentucky Press Association.

N. Injury of J. E. Abrams.

The Comptroller reported to the Committee on the condition of Mr. J. E. Abrams. He stated that Dr. H. S. Herring had reported that Mr. Abrams' elbow would be stiff because of the bad condition of the fracture and the infection of the elbow which followed the accident. He reported that Mr. Abrams' hip is healing nicely and he should be able to walk on it shortly. Mr. Peterson further reported that, since the accident, Mr. Abrams has been carried on the payroll, allowing the time to be credited against sick leave and vacation earned by Mr. Abrams prior to his accident. He further reported that these leaves have been exhausted and that Mr. Abrams had not been paid since April 15, and he believed the Committee should take some action as to continuing his salary until he is able to return to work.

The Committee considered the question and took the following action:

It is the expressed understanding that the action on the case is without commitment as to future action of the Executive Committee, and that it does not establish a precedent, and does not admit negligence or liability in paying wages, pending this employee's return to work.

O. Report on Work of Architects.

President Donovan stated that Frankel & Curtis, architects on the Women's Residence Hall, and Gillig, Johnson and Meriwether, ar chitects on the Field House-Auditorium had been asked for a statement as to the delay in finishing plans and specifications on these buildings, and the date upon which the plans or specifications might be ready to be transmitted to the University authorities. He reported receipt of letter from each architectural firm and stated that Frankel & Curtis promise to complete the plans and specifications for the Women's Residence Hall by May 15, and that Gillig, Johnson and Meriwether estimate that the plans and specifications for the Field House-Auditorium should be ready about June 1. The report and statements were ordered filed.

P. Schedule of Graded Rents for Cooperstown.

The Comptroller reported a schedule of rents for Cooperstown as worked out and approved by the Federal Public Housing Administration. It was explained that the University had been collecting a flat rate on all like houses but that it was necessary, due to requirement of Federal Public Housing Administration, to install the graded rent schedule to meet Federal provisions and regulations.
