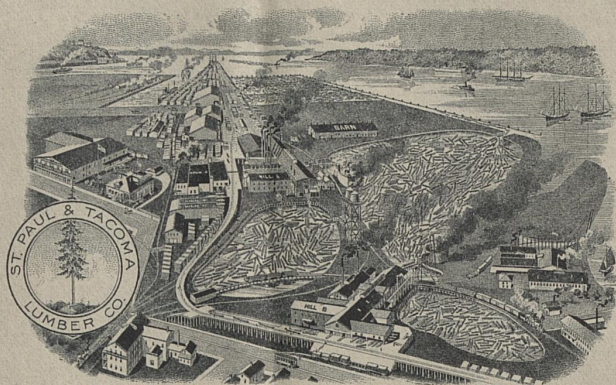

I sent you the following telegram today, not having heard from you since before Christmas:--

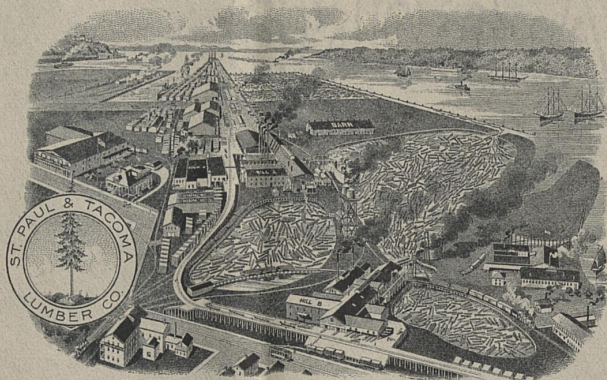
"Did you receive watch? All have colds here otherwise serene."

Hoping you are all well and enjoying the Holidays, and that you will surely be in Andover in time for your new term work,-- with love to all, I am

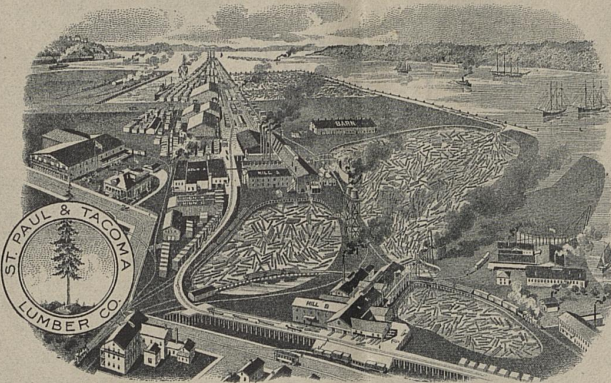

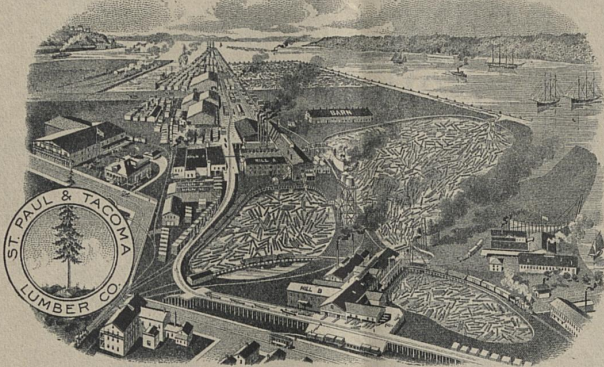
My dear Gibson:--

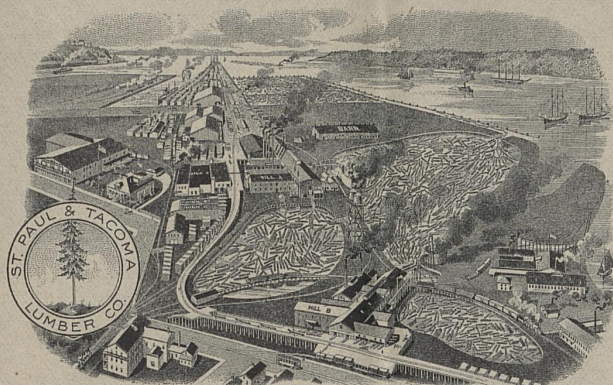
Cappa wrote me that he had written you a letter; he seemed very much pleased with his penuche set you sent him.

We were very glad to get your letter at last, and know that you had landed in Andover safely; also to know that you enjoyed yourself.

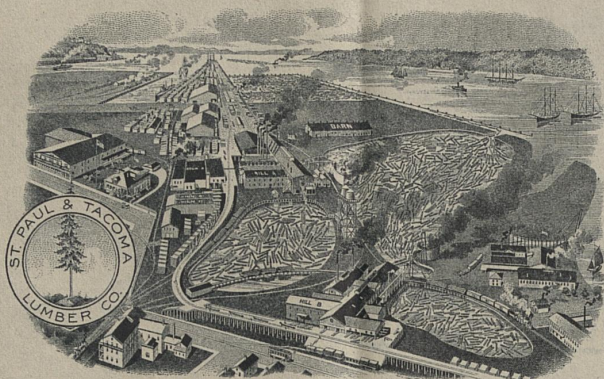

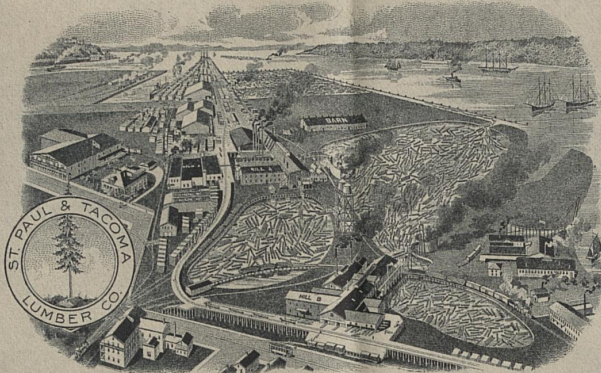
I received a letter from Cappa saying that the penicile set was fine, and also from your Grandma saying she at once put your picture and that of Elizabeth Dunster in the frame.
