Minutes of the Meeting of the Executive Committee of the Board of Trustees. University of Kentucky, August 25, 1946.

The Executive Committee of the Board of Trustees of the University of Kentucky met in the President's Office at 10:30 a.m., Friday, August 23, 1946. The following members were present: Judge Richard C. Stoll, Chairman; H. D. Palmore, H. S. Cleveland, R. P. Hobson, and J. C. Everett. President H. L. Donovan and Comptroller Frank D. Peterson, Secretary of the Board of Trustees, were also present.

A. Approval of Minutes.

The minutes of the Executive Committee of June 22, 1946, were approved as published.

B. New Construction and Expansion of the University.

President Donovan briefly outlined future prospects for public education in the United States, and applied these to the University of Kentucky. He stated that about 6100 applications for admittance to the University had been approved, but it was probable that the enrollment this fall would approximate 5500 because it would be physically impossible for many of the applicants desiring to attend the University of Kentucky to secure housing facilities. He outlined some of the needs of the University for housing space, classroom and library facilities. He stated that the present University plant was designed to teach and accommodate a student body of about 4000, whereas we should prepare to teach and accommodate an enrollment in the University of 7000 to 8000 students in future years.

Some of the current needs for housing and classroom facilities were enumerated. President Donovan emphasized the need for additional dormitories and discussed various probable sites for new buildings. He related that he had conferred with Dean Cooper concerning possible sites and that Doctor Cooper had just written him a letter expressing his point of view, which letter President Donovan read to the Trustees. A lengthy discussion of the University's future growth and expansion by the Trustees followed. The direction in which the University should expand was thoroughly examined by members of the Board. It was finally decided unanimously by the Executive Committee that the new dormitory for men should be on the east side of Rose Street as near the other dormitories as it is possible to place it.

* * * * * * * * * *

1. Upon motion duly made, seconded and carried, the new Dormitory for Men is ordered constructed on the plat of ground on the east side of Rose Street between the Aeronautical Research Laboratory and the Dairy Products Building.

C. Employment of Planning Engineers.

The discussion of possible sites for the location of a new dormitory for men raised the problem of future expansion of the University. The Trustees discussed the desirability of having expert guidance in order to avoid mistakes in planning for the expansion and growth of an institution that will probably be called upon to take care of eight or ten thousand students within the decade. The Executive Committee took the following action:

* * * * * * * * * *

2. Upon motion duly made, seconded and carried, President Donovan and Comptroller Peterson are directed to employ a firm of competent planning engineers to study plans for future expansion and the location of new buildings of the University, and to make their report at an early date.

D. Employment of Architect for Men's Dormitory.

President Donovan reported that Mr. John F. Wilson, architect, was available and that he desired that Mr. Wilson be permitted to talk to the Committee about the proposed men's dormitories. It was further explained that a fireproof residence hall, consisting of four floors, was proposed. The dormitory would house approximately three hundred and sixty-six men, and would include a cafeteria adequate to serve all students housed in the Men's Dormitories. It was further related that funds had been advanced by the Federal Works Agency to pay for plan preparation.

A general discussion followed, and after due consideration, the Committee took the following action with reference to the construction of another Men's Dormitory and the employment of an architect.

* * * * * * * * * *

3. Upon motion duly made, seconded and carried, it is ordered that the men's dormitory be planned and constructed on a site heretofore authorized on the east side of Rose Street and that John F. Wilson, architect of Lexington, Kentucky, be employed to plan and supervise the construction of the new men's dormitory to house approximately 366 men, including a cafeteria adequate to serve all men students housed in men's dormitories. The Comptroller is authorized to execute a contract on behalf of the University with John F. Wilson, architect.

E. Alterations in Plans and Specifications of New Service Building Authorized.

President Donovan recalled that the Board of Trustees had rejected bids received for the construction of the Service Building, because the low bid was in excess of the amount available for the construction of this building. He stated that he had talked with some of the bidding contractors and with the architects concerning the possibility of eliminating some of the proposed interior of the building and had requested Messrs. William B. Brock and Ernst V. Johnson, Architects Associated, Lexington, Ky., to be present to discuss some of the problems in connection with these alterations. Messrs. Brock and Johnson were asked to enter the meeting and, after general discussion concerning the alterations, deletions and possible changes in an effort to reduce the cost of the construction of the Service Building, the Committee took the following action:

* * * * * * * * * *

4. Upon motion duly made, seconded and carried, the architects are directed to make revisions and deletions as directed by President Donovan, and to submit the revised plans and specifications to President Donovan and Comptroller Peterson, and it is ordered that the construction of the building be re-advertised at such a time as would seem most advantageous, but not later than December 5, in order that the bids may be considered by the Board of Trustees at its meeting in December.

F. University Lock Box to be Entered only in the Presence of Two People.

It was called to the attention of the members of the Committee that the Treasurer, who is also Custodian of Securities, had requested Mr. J. Monroe Sellers, Cashier of the First National Bank and Trust Company, to have joint control of the University lock box, with reference to entering same, and that it would be well for the Committee to authorize officially the First National Bank and Trust Company not to permit anyone to enter University lock box #200, in which all securities are held, except the Treasurer and Custodian of Securities, Frank D. Peterson, and J. Monroe Sellers, Cashier of the First National Bank and Trust Company. Whereupon, the Committee took the following action:

* * * * * * * * * *

5. Upon motion duly made, seconded and carried, the Secretary of the Board of Trustees is directed to notify the First National Bank and Trust Company not to permit anyone to enter University lock box #200, in which all securities owned by the University and Agencies are kept, except Frank D. Peterson, Comptroller, Treasurer, and Custodian of Securities, and J. Monroe Sellers, Cashier of the First National Bank and Trust Company, and that said box shall only be entered at such time as these two may desire.

G. Committee to Check Securities.

Comptroller Peterson stated that it has been the policy of the Board to have securities held by the Treasurer checked annually, and that he desired that a committee be appointed to make such an inspection and report its findings to the Board. Whereupon the following action was taken:

6. Upon motion duly made, seconded and carried, J. C. Everett and H. D. Palmore are appointed as a committee and directed to check all securities held by the Treasurer in lock box #200 at the First National Bank and Trust Company, and make a report to the Committee at its next meeting.

H. Report of the Comptroller.

The Comptroller read the following analysis of the financial report for the year ended June 30, 1946.

My dear President Donovan:

I am submitting hereto attached the financial report of the University for the year ended June 30, 1946.

The total income realized amounted to \$3,632,619.65, which is 102.4% of the total estimate of \$3,551,680.76. The income exceeded the amount realized during the fiscal year ended June 30, 1945 by \$363,568.22. This is a 10.0% increase.

General Fund expenditures totalled \$3,511,966.82, or 96.1% of Departmental appropriations amounting to \$3,656,506.08. The expenditures exceed the General Fund expenditures of the preceding fiscal year by \$580,871.40, a 16.5% increase.

Plant Funds available for expenditure during the year and expenditures therefrom are indicated in the following statements:

I. Budget Adjustments for 1945-46.

President Donovan submitted a list of budget accounts which had been overdrawn as of June 30, 1946, and recommended that the Committee authorize appropriations to cover the deficits in the various accounts. He reported that the overdrafts were incurred after he had given his approval.

He also reported that he was recommending approval of a request to make certain budget transfers between accounts. The budget increases and transfers requested were read to the Committee, after which the following action was taken:

8. Upon motion duly made, seconded and carried, the appropriations for the various accounts are ordered increased by the amounts recommended, and the Comptroller is authorized and directed to transfer the amounts approved from the unappropriated surplus of the general University budget to the various accounts, and to make the budget transfers requested. A copy of the recommendation is ordered filed with the Secretary of the Board.

J. Budget Increases for 1946-47.

President Donovan stated that he felt it necessary to request increase in the appropriation for the Alumni Association for travel expense for the Executive Secretary, and that the budget request for the War Memorial Survey was misplaced and not included in the general budget at the time it was before the Board of Trustees for adoption. He recommended that the budget for the War Memorial Survey be approved. Whereupon the Committee took the following action:

Upon motion duly made, seconded and carried, the Comptroller is authorized and directed to increase the appropriation made to the Alumni Association, and to establish a budget account for War Memorial Survey, these funds to be appropriated out of unappropriated surplus of the general University budget. The budget request and President's recommendation shall be filed with the Secretary.

K. Approval of Purchases of the Comptroller's Office.

President Donovan read a letter from the Comptroller listing state requisitions, advices of emergency purchases, special purchase orders, food contracts and departmental purchase orders for the period between April 1, 1946, and June 30, 1946, inclusive. It was further stated that the documents were available for inspection by members of the Committee.

This letter concerns the sale of Smith Hall as authorized by the Board of Trustees.

The sale of Smith Hall was advertised in the Lexington Herald-Leader. A sign was erected on the property calling the attention of the public to the auction to be held there on July 16th at 10:00 a.m. The property was auctioned by Sam B. Downing, a professional auctioneer of Lexington, Kentucky, and was sold to the highest bidder for the sum of \$18,825.00. Mrs. Agnes S. Cooper of Lexington, Kentucky, was the high bidder.

A deed of conveyance has been given to her, executed by Richard C. Stoll, Chairman of the Executive Committee and attested by Frank D. Peterson, Secretary of the Board of Trustees. Delivery was made as of August 1, 1946.

M. Sale of Maxwelton Park.

President Donovan stated that the Board of Trustees, at its meeting on July 19, 1946, authorized the President, Comptroller, and T.H. Cutler, member of the Board, to have the Maxwelton Park property appraised, and to give to The College of the Bible an option on the property at an agreed purchase price, and that the Committee had requested L. T. Rankin, president of the Lexington Real Estate Board, to appoint a valuation committee to appraise Maxwelton Park. A committee was appointed, consisting of E. D. Hinkle, R. D. Norwood, and E. G. Logan, which committee placed a value of \$13,440 on the property. He further stated that the committee had agreed to sell the property to The College of the Bible at a price of \$14,000, and the College of the Bible had accepted, as evidenced by a letter under date of August 5, 1946, signed by W.C. Lawwill, Business Manager of the College of the Bible. The Committee took the following action:

The Comptroller reported that it had been necessary to request the Attorney General to file eviction notices with a justice of the peace of Fayette County in order to secure possession of houses owned by the University and needed for classroom and other purposes. He stated that such notices were filed against E. C. Johns, 115 Graham Avenue, J. E. Jones, 650 Maxwelton Court, and Mr. Thurman Hagan, 650 South Limestone. After due consideration, the Committee took the following action:

P. Extra Fees.

President Donovan stated that some of the departments of the University found it necessary from time to time to charge extra fees in various courses. He read a list of the fees as recommended by Dr. Thomas Cooper, Dean of the College of Agriculture and Home Economics, Dr. M. M. White, Associate Dean of the College of Arts and Sciences, Dr. L. L. Dantzler, head of the Department of English Language and Literature, Dr. Arthur C. McFarlan, head of the Department of Geology, Dr. Alexander Capurso, Head of the Department of Music, and Dr. Merwin E. Potter, Head of the Department of Physical Education; also a special laboratory fee for a course for clinical psychologists as recommended by Dr. M. M. White, head of the Department of Psychology.

The faculty of the College of Agriculture and Home Economics, on August 22, approved a course fee of \$35.00 for Animal Industry 102, Advanced Livestock Judging. It is planned to offer this course in the fall quarter and it is desirable that the fee which is provided for the paying of travel expense be approved prior to the opening of the quarter.

Dear President Donovan:

Accompanying this letter are the requests from the Departments of English, Geology, Music, and Physical Education for extra fees in various courses.

English: The Department of English established the rental library for the sole purpose of reducing the number of books students in Freshman English were required to purchase. The amount of record keeping would be considerably less if a flat fee were charged each student; but Dr. Dantzler thinks such a charge would be unfair to two groups of students, those who wish to purchase the books, and those who already possess them.

Geology: Departments of Geology in general charge a field fee for certain courses. A large part of geological laboratory work is done in the field and cannot be done elsewhere. Such field work, consequently, is required of all majors here and at every other school where recognized professional training is given. The Department of Geology at the University has been collecting these fees from students for seventeen years. The restrictions on these courses are sufficiently stringent to protect the University from any charge of misappropriation of funds.

Music: The fees charged by the Music Department for individual instruction are customary. The University has never attempted to supply students with individual instruction solely on the basis of the general incidental fee charged for class instruction.

Physical Education: The fees required by the Department of Physical Education are justified on two bases: (1) the fee for the required courses is used for personal services for the particular student; (2) the fee for elective courses is charged only in the event that the University does not possess the equipment, but must make arrangements with an outside agency for the use of such equipment.

I recommend that the University authorize the collection of the above fees, and which are listed for convenience on the accompanying page.

Letters from the Heads of the Departments are also submitted.

Pursuant to your request regarding fees charged by the Physical Education Department the following information is offered:

- 1. Locker fee \$1.50 per quarter for each student enrolled in a physical education activity course and includes locker rental, clean towel service and soap. (This fee is collected by the Physical Education Department and deposited in the Comptroller's Office.)
- 2. Physical education classes in Bowling from \$3.00 to \$3.50 per quarter per student enrolled in Bowling classes. This is a fee charged for use of the Bowling Alleys and the amount is dependent upon the number of times per quarter that the student bowls.
- 3. Physical education classes in Golf \$5.00 to \$8.00 per quarter per student enrolled in Golf and is the cost of green fees and the amount is dependent upon the number of times per quarter the student visits the Golf Course.
- 4. Physical education classes in Horseback Riding \$20.00 to \$28.00 per quarter per student enrolled in classes in Horseback Riding. The amount of the fee is dependent upon the number of times each student rides per quarter and is a charge made to cover cost of rental of horses per quarter by a local stable.

Attention is invited to the fact that 2, 3 and 4 above cover fees for physical education classes which are elective courses and are for service of facilities and equipment which the University does not own or operate. No student is required to enroll in any one or more of these courses.

It is recommended that the appropriate action be taken to authorize the fees as indicated above.

Q. Agreement between University of Kentucky and the Central Kentucky Natural Gas Company.

President Donovan submitted agreement between University of Kentucky and the Central Kentucky Natural Gas Company, which gives a right-of-way to the Central Kentucky Natural Gas Company to cross certain properties of the University of Kentucky. He read the following letter from Dean Cooper, which was concurred in by the Comptroller:

August 15, 1946

President H. L. Donovan University of Kentucky

Dear President Donovan:

Some time back, I transmitted a proposed agreement under which the Central Kentucky Natural Gas Company would be permitted to lay a pipe line on a part of the property of the Experiment Station. As I understand it, the matter was presented to the Board and the proposed agreement was referred to Dr. Murray, certain questions having been raised, particularly as to the location of the line. I was requested to take up the matter again, which I have done. Enclosed, is an original and copy of a revised agreement with the Gas Company. Both are accompanied by a plat which, in addition to the description, shows in red the general location of the pipe line on the property of the Experiment Station.

So far as practicable, I think the proposed revised agreement meets the points raised by Dr. Murray. In the revised agreement, an item, left blank in the one previously submitted, has been included requiring the payment of \$100 as a consideration for the agreement. I do not know whether this meets your viewpoint and that of the Board as to adequacy. However, it is in accord with arrangements which have been made from time to time with utility companies.

Previous to the last action of the Boad of Trustees, the Company had changed its plans, particularly on Rose Street in front of the buildings, as to the location of pipe line and had decided to use the street. Mr. Peterson accompanied us when we went over the proposed location of the pipe line this week and is familiar with the plans and reasons for the location proposed.

R. Appropriation for Erection of a Storage Shed.

President Donovan stated that the University was without storage space for much of its property, and recommended an appropriation for the erection of a storage shed to be used for storing excess and surplus war property secured from the Government, and other University property. He stated that such storage shed was especially needed in view of the fact that we are unable to begin construction of the new Service Building. The Committee took the following action:

17. Upon motion duly made, seconded and carried, a storage shed is authorized erected, and the sum of \$6500 is authorized appropriated out of unappropriated surplus of the University budget for costs of material and erection.

S. Proper Protection of Maxwell Place.

President Donovan stated that many people evidently do not understand that Maxwell Place driveway is a private, dead-end street, and many cars enter Maxwell Place and sometimes park on and off the grass. He expressed the opinion that some study should be given to ways and means to maintain the privacy of Maxwell Place, and not permit the driveway to become a public thoroughfare. He suggested that a committee be appointed to study the problem.

After due consideration, the Committee took the following action:

18. Upon motion duly made, seconded and carried, the Chairman is authorized to appoint Mr. E. B. Farris, Mr. N. B. Elliott and Mr. Ernst V. Johnson a committee to study the problem and make report as soon as possible.

T. Field House Property Used as Parking Lot.

President Donovan stated that since conditions were such as to make it impossible to begin construction of the Memorial Field House-Auditorium, the property would undoubtedly be used as a parking lot during the football season, and that some supervision should probably be given to parking cars on the lot. He further explained that, if the lot were cleaned off and leveled down, it could well be used temporarily in connection with the physical education program under the supervision of Dr. Potter. The Committee discussed the question and, after due consideration, took the following action:

19. Upon motion duly made, seconded and carried, the Memorial Field House-Auditorium site is ordered cleared of all stumps and debris and leveled so as to be used as a parking lot during the football season, under the direction of B. A. Shively, who is authorized to employ necessary help. A charge of 50% for each car prked shall be made and deposited in a fund to be used to defray partially the cost of repairing and enlarging the football stadium.

U. Cooperstown and Shawneetown Officially Named.

President Donovan explained that 324 family dwelling units had been erected on Hilltop and Woodland Avenues, extending westward of the Observatory building, and that 180 family dwelling units will be provided on a building site southeast of Shawnee Court, off the Nicholasville Pike, and that these villages had not been officially given a name, but that for identification purposes we have been referring to them as Cooperstown and Shawneetown. He recommended that they be officially named. Whereupon the Committee took the following action:

Upon motion duly made, seconded and carried, it is ordered that the housing project located near Hilltop Avenue and Woodland Avenue shall be officially known as "Cooperstown"; and that the housing project southeast of Shawnee Court, east of the Nicholasville Pike, shall be officially known as "Shawneetown".

V. Use of the Name "University of Kentucky" Prohibited.

President Donovan reported that sometimes firms and individuals use the name of the University, or abbreviations of the name, in various ways; that the public was often misled by the use of the name and, since the firms or individuals had no connection with the University, he was of the opinion that use of the name of the University should be prohibited by an order of the Board of Trustees. The members of the Committee discussed the recommendation and, after due consideration, took the following action:

Upon motion duly made, seconded and carried, the name of the University of Kentucky or any abbreviation thereof should not be used in any way for advertising purposes or otherwise by any private enterprise not connected with the institution. The Board further resolves that the University officials be directed to request any business firm so using the name of the University of Kentucky or any abbreviation thereof immediately to discontinue such practice.

W. Gifts:

From Keeneland Foundation.

President Donovan reported a gift of \$750.00 from the Keeneland Foundation to be used for the payment of the salary of Dr. O. S. Edwards while he is on leave from the University, taking a course of instruction in the use of the electron microscope, which has been purchased by the Foundation, for installation at the University of Kentucky, and recommended that same be accepted.

22. Upon motion duly made, seconded and carried, it is ordered that the grant of Keeneland Foundation in the sum of \$750.00 be accepted, and President Donovan is directed to convey to Keeneland Foundation the appreciation of the University and the Executive Committee for this gift.

X. War Department Extends Commendation to the University of Kentucky.

President Donovan reported that he was in receipt of a letter from General LeR. Lutes of the Army Service Forces Headquarters, Washington, D.C., extending the grateful thanks of the War Department to the University for the unstinted and wholehearted cooperation given the conduct and successful completion of the program of instruction for Army personnel. President Donovan read the following letter which was received and ordered copied into the minutes:

HEADQUARTERS ARMY SERVICE FORCES

10 June 1946

President H. L. Donovan University of Kentucky Lexington, Kentucky

Dear President Donovan:

The War Department wishes to extend to you, as the representative of the staff and faculty of your school, the thanks of a grateful government for the unstinted and wholehearted cooperation given to the War Department, in the preparation, conduct, and successful completion of programs of instruction for Army personnel.

The training so provided was a vital part of the national effort expended in the triumphant prosecution of World War II, and the Secretary of War will dispatch to you a suitably engraved certificate as soon as it can be completed.

Inasmuch as the Army Service Forces under which this program has been conducted ceases to exist after today, I am taking this opportunity to add my appreciation for your efforts.

Y. A Policy on Out of State Travel.

President Donovan stated that he had appointed a committee of the faculty to study the problem of out-of-state travel by staff members of the University, that the committee had made a report, which had been approved by the University Faculty, and that he desired to submit these recommendations to the Executive Committee for adoption. He read the recommendations to the Committee.

Your committee suggests that the Faculty of the University of Kentucky make the following recommendations to the President and the Board of Trustees.

- 1. That a separate item for administrative travel be set up in the annual budget of the University.
- 2. That in addition to the budget for administrative travel the sum of \$4,500 be made available for out-of-state travel to be used exclusively for granting aid to members of the teaching faculty with the rank of instructor or above traveling to meetings of learned and or professional societies under the conditions specified in the following paragraphs. Future appropriations should be adjusted as requirements become known.
 - a. That the sum indicated above be distributed to the colleges on the basis of the ratio of the number of members of the active teaching staff with the rank of instructor or above in each college to the total teaching staff of all of the colleges.
 - b. That the University adopt the policy of paying first class railroad fare and Bullman not to exceed \$40 to any member of the teaching staff with the rank of instructor or above desiring to attend a professional meeting for at least one meeting each alternate year.
 - c. That no member of the faculty shall receive a grant for more than one trip to meetings of learned and/or professional societies in any one year.
 - d. Approval for all trips must be obtained in advance. The forms authorizing the trip must be signed by the Dean of the College, the President of the University, and the Commissioner of Finance of the state of Kentucky. Any trip made without advance approval of the above mentioned officers shall not be chargeable to the out-of-state travel fund of the University of Kentucky.

e. The allotment to each college shall be made as indicated above by the President of the University or a committee named by him. When the allotment has been made to a college, the Dean shall be responsible for assigning it to the members of his staff. Care should be exercised to see that there is a fair and proper distribution of the assigned fund among the four quarters of the year, among the departments, and among individuals within departments.

The Committee took the following action:

24. Upon motion duly made, seconded and carried, it is ordered that the recommendations of the committee be adopted as the official action of this Committee.

Z. Outside Work for Professor J. W. Martin.

President Donovan stated that he had a recommendation from Dean Edward Wiest, College of Commerce, requesting approval for Professor J. W. Martin to serve as a consultant to the Virginia Interim Public Service Tax Study Committee. He stated that the outside work would not interfere with Professor Martin's regular University duties and that he had given his approval for him to do the outside work requested.

The Committee took the following action:

A-1. Change of Occupation for A. C. Burnette.

President Donovan read a letter from Dean Cooper, recommending change of occupation for Mr. A. C. Burnette, Field Agent in Charge of Negro Education Work.

26. Upon motion duly made, seconded and carried, the recommendations of President Donovan and Dean Cooper are concurred in, and a change of occupation for Mr. A. C. Burnette is authorized, effective September 1, 1946.

B-1. Change of Occupation for Tom Dowd.

President Donovan reported that he was in receipt of a recommendation from B. A. Shively, Director of Athletics, and Leo M. Chamberlain, Dean of the University, that Mr. Tom Dowd be given change of occupation effective September 1, 1946. He stated that Mr. Dowd had been with the Department of Athletics at the University of Kentucky since 1919, and that he would perform such duties as assigned by Mr. B. A. Shively. His salary is \$1092, and his salary under change of occupation shall be in accordance with the rules of the Board of Trustees concerning change of occupation. President Donovan recommended that the request be granted.

27. Upon motion duly made, seconded and carried, the recommendation of the President is concurred in, and Mr. Tom Dowd is given a change of work. His duties shall be assigned by B. A. Shively, Director of Athletics.

C-1. Leave without Pay for Katie Gardner.

President Donovan stated that Miss Katie Gardner, employee of the Division of Maintenance and Operations since 1931, had been a loyal, faithful and dependable worker, and that on March 6, 1946, she suffered a paralytic stroke and is at this time unable to perform her duties. He stated that Miss Gardner is now 63 years of age and that he wished to recommend a leave of absence without pay until such time as she may be able to return to her job or until further action of the Board.

The Committee considered the recommendation and took the following action:

D-1. Agreement with Hartford Herald.

President Donovan submitted agreement between the University of Kentucky and the <u>Hartford Herald</u> whereby the <u>Hartford Herald</u> agrees to lend to the University of Kentucky Library a file of the <u>Hartford</u> Herald from 1887 to 1925. He read the agreement.

The University of Kentucky Library proposes to borrow the file of the <u>Hartford Herald 1887-1925</u>, to be placed in the University of Kentucky Library and it is agreed that should said file be loaned to us, that we will:

- l. Collate this file and return any duplicates which may appear among it to you. We will keep this file in bound condition and maintain it and keep it in good order.
- 2. We will lend you at any time any volume of the file of the <u>Hartford Herald</u> which you may wish to borrow with the understanding that when you have finished with it you will return it to the University of Kentucky Library for safe keeping.
- 3. We understand that at any time you and your associates wish to sell this newspaper and you desire that this file pass as a part of the assets of the sale of said newspaper, that such file will be returned to you and we will renounce all claim thereto. Files may also be removed from Library at any time on demand of owner.
- 4. It is agreed and understood that this proposal was presented to the Executive Committee of the Board of Trustees of the University of Kentucky and that said Executive Committee authorized the chairman and secretary to make this proposal to you, a copy thereof having been incorporated in the minutes of the Executive Committee meeting of date June 22, 1946, and a copy of this proposal will likewise be incorporated as a part of said minutes.

E-1. Request to Office of Education for Additional Housing Facilities.

President Donovan reported that President Truman had signed the Meade Bill (S. 2085) passed by Congress appropriating a sum of money to pay the costs of demounting, transporting and erecting temporary educational facilities for public and non-profit educational institutions. He stated that the bill provided that such institutions should submit to the Office of Education information to justify the need for additional temporary educational housing facilities. After the Office of Education had passed upon the need of institutions, the Federal Works Agency was directed to provide facilities needed. He recommended that the administration be authorized to submit to the Office of Education "Justification of Need", to do any and all other acts required by any agency of the federal government to secure housing facilities to alleviate the distressed condition now facing the University. Members of the Committee discussed the recommendation and took the following action:

* * * * * * * * * *

30. Upon motion duly made, seconded and carried, the following resolution was authorized:

WHEREAS, Board of Trustees, University of Kentucky (herein called the "Applicant") acting by and through its governing body, upon the basis of available data, has found that there exists or impends an acute shortage of educational facilities required for persons engaged in the pursuit of courses of training or education under Title II of the Servicemen's Readjustment Act of 1944, as amended, and to relieve such shortage proposes to request the United States of America through the Bureau of Community Facilities, Federal Works Agency, (Herein called the "Government"), to provide educational facilities, pursuant to Public Law

697, 79th Congress, (Section 504 of the Lanham Act, as amended), and in connection therewith, has examined and considered such law, the Regulations, the Information for Applicants, the form of application and the form of proposed agreement:

NOW, THEREFORE, be it resolved the Board of Trustees of the Applicant (herein called the "Governing Body") that a justification of need and that an application or applications be filed, in such form as may be required by the Government, to provide such educational facilities as are required to alleviate such acute shortage, and that the Applicant will comply with the various requirements and conditions necessary to enable the Government to provide such facilities; and

BE IT FURTHER RESOLVED THAT H. L. Donovan, is hereby designated as the Applicant's Representative and is authorized in his capacity as such Representative to file with the Government a justification of need and an application or applications to negotiate, execute and enter into an agreement or agreements with the Government in substantially the form of agreement considered by the Governing Body, to negotiate, execute and enter into such other agreements and instruments and to perform and do any and all acts as may be necessary to provide a suitable site and site preparation, streets or roadways, sidewalks, landscaping, utility mains, technical or engineering data, architectural or engineering services, necessary rights of entry and rights of way for Government operations to accept on behalf of the Applicant ownership and possession of such facilities, to assure the Government that such facilities will be utilized by the Applicant to carry out the purposes of such law, and to do or perform any and all other acts that are necessary to accomplish the purposes of the Applicant's application, to perform the Applicant's obligations under its agreement with the Government, and to obtain the provision of such facilities.

* * * * * * * * * *

F-1. Application for Advance for Plan Preparation of New Buildings.

President Donovan reported that the Board had previously authorized the Comptroller to submit four applications for advance of funds necessary to defray the cost of plans and specifications for four buildings which are deemed necessary for expansion. He further explained that the Federal Works Agency is willing to receive additional applications for advances of funds necessary to defray the cost of plans and specifications for other buildings to be constructed on the campus and that he was recommending the Board approve the submission of additional applications for advances to defray like expenses on four additional buildings. The Board received the recommendation of the President and took the following action:
