by business engagements
later. Try to come at
or before the middle
of June - rather before
the 1st of June. Let me
hear from you - none
of our exemplars however
in this file for years.

Dear Brethren:

In submitting
my report of work done
during the past year at
King's Mountain, Pulaski
and Burnside I would
state that I had visited
these churches several
times before they were
put under my care,
and found them in a
depleted and much
discouraged condition.

They had had
no preaching for more
than two years and
had become almost
extinct.

I have filled regular monthly appointments at each of these places, after preaching several days each visit.

I have visited King's Mountain to Delaski on week day nights, giving also on occasional Sabbath. At Burnsville I preach once a month, on Sat. night.

At King's Mountain I held a meeting of two weeks with Evangelists, Querns & Kopper. We had four accessions thru by letter and one on profession of faith.

We have received in all at this point during the year seven members and the Church sums

to be encouraged. We have good congregations, and I preached a series of doctrinal sermons recently, expounding our Presbyterian system which I think were favorably received. Two additional Elders have been elected and ordained.

At Prelacki the membership had been reduced to three, and there were no officers.

With our evangelists we held a meeting of thirteen days, during which thirty three were received into the Church, chiefly heads of families.

We will elect officers in this church early in Oct.

At Burnside I have
 yet had no protracted
 services, but expect to do
 so sometime in the fall
 or early winter.

There is no church
 building at this point
 & services are held in
 the school house.

The congregations are
 good. We have at
 Burnside two elders,
 two deacons ~~and~~ and
 twelve members.

The population at
 Burnside is more migratory
 than at the other points,
 being composed largely
 of lumber men.

While there is no
 prospect of building up
 large churches at either
 of these places, I think

that under judicious
management and careful
nursing much good can
be done, and there will
be growth sufficient to
encourage a maintenance
of the work.

The people are poor
and can give but little
financial help. They
have about paid my
travelling expenses, and
are very hospitable and
kind. In conclusion
I would say that if the
Committee wish me to
continue the care of these
churches, I will do the
best I can for them.

My work at
Lomerut and Pisgah
is enough for one man,
and I could wish

that another man were
put ~~over~~ over these churches
on the C. S. R.R. including
McKinney, but can not
say that it would be
wise, as his support would
have to come almost
entirely from the Synod's
fund.

Asking your prayerful
interest in these churches,
and hoping for a larger
outpouring of the Holy Spirit
upon all the churches,
I am yours in the

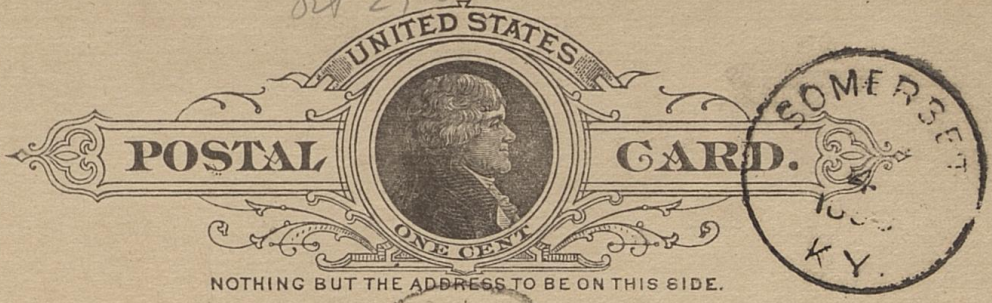

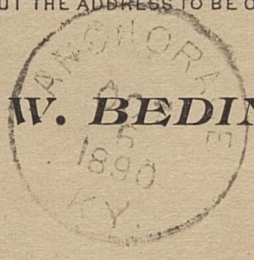

and will not send their
children. I have had
no accusers recently
except one valuable one
at Dulaski

The congregations have
been very good except when
the weather was extremely
unfavorable.

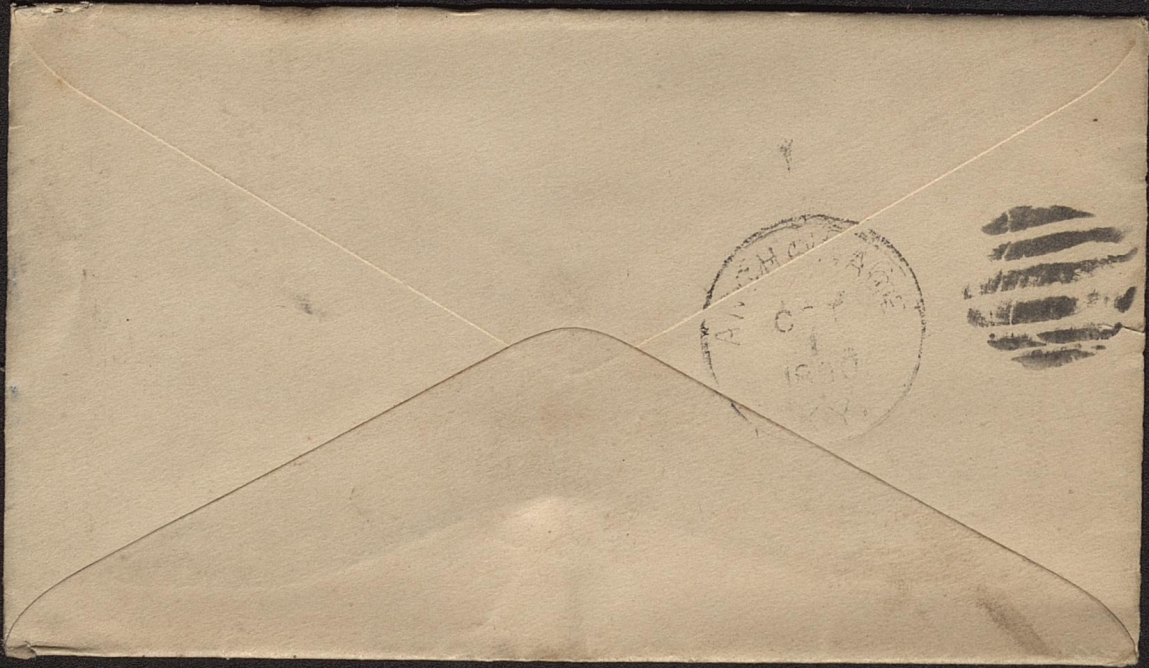

To the Evangelistic Committee.

Dear Brother:

My report of the quarter now closing has much that is encouraging, and calls for thanksgiving to Almighty God for his abounding grace.

During the last two months of my labors in this field he has put the seal of his approval upon the work in a signal manner.

I have filled all appointments except one, and that failure was occasioned by protracted work in one of my other churches. At Kings Mountain we have repaired and improved our house of worship without taking any aid outside of the congregation, and our little flock there is in a healthy hopeful condition.

At Melicki, I held a meeting of four days and received four members upon profession of faith, and others are interested who I think will soon come into the Ch.

The Sabbath School is kept up and has done good work, and is now in a more flourishing condition than ever before. We have also repaired our house and improved the grounds at this place.

In August Bro Hopper came to my help and we held a meeting of 12 days at the old Pisgah Church five miles south of Somers and the result was 15 additions to the Church and the Christian graces of the members revived and strengthened.

In this service I was assisted several days by Rev W. M. Bruce of Hustonville

On Sept 14th Bro Hopper

returned to my assistance and we began services at Burnside, using the school house for the night service, and the Masonic Hall ~~for the~~ which was kindly offered us by the Fraternity - for the morning service. The interest de-

veloped early and God was with us in power there. During the thirteen days of prayer and labor 60 were added to the Church, and others who make the good confession will join other churches.

Our church has taken deep root at Burnside, and we have already taken steps to build a house of worship which when completed will set us greatly forward, it being the first and only house of worship in the place.

Many of those received were heads of families, and it has wrought a marked change in the community such as was

obscure by all, and was the subject of favorable comment by unconverted people. I was never in a work of such quiet power where the people seemed so eager to press into the Kingdom.

To God be all the praise.

Bro Hopper did faithful and hard ^{work}, though the heat was intense and at times suffocating almost in the school house, so closely were the people crowded, and as many as 100 on the outside with the doors & windows filled with eager listeners.

A church building is an absolute necessity here, and were the Committee will allow me a few words upon that subject as I shall have to appeal to them for aid in the erection of this house.

The people of Burnside are not able of themselves to build the house. They are very enthusiastic, and in charge earnest about it, and will do their best. The committee who are taking the subscriptions report that all are eager to do their utmost, and even the children asking to have a part in the work.

They will be able to raise six or seven hundred dollars, but it will take twelve hundred dollars to build a suitable house. I have engaged to raise \$500⁰⁰ of this, and I ask the Committee to give me \$250⁰⁰. I think this ought to be done because I believe there is no place where that amount of money invested in a house of worship would yield larger results than at this point.

Will the committee pardon me for saying that those of them who press me will

agree that I am not a visionary man.

I have never been willing to undertake a church building by using the funds of the church until its necessity has been demonstrated! Will the committee appear as soon as possible of its help in this matter?

And may I be allowed to see another plea? I have for three years been doing a great deal of work, having the care of three mission churches, separated by a distance of 30 miles, for small compensation.

The work has been hard, especially in rough weather. It is sufficient compensation to see these well-nigh ruined churches repaired and built up; but will not the committee give me their endorsement by helping to build a house which the Lord has said must be built?

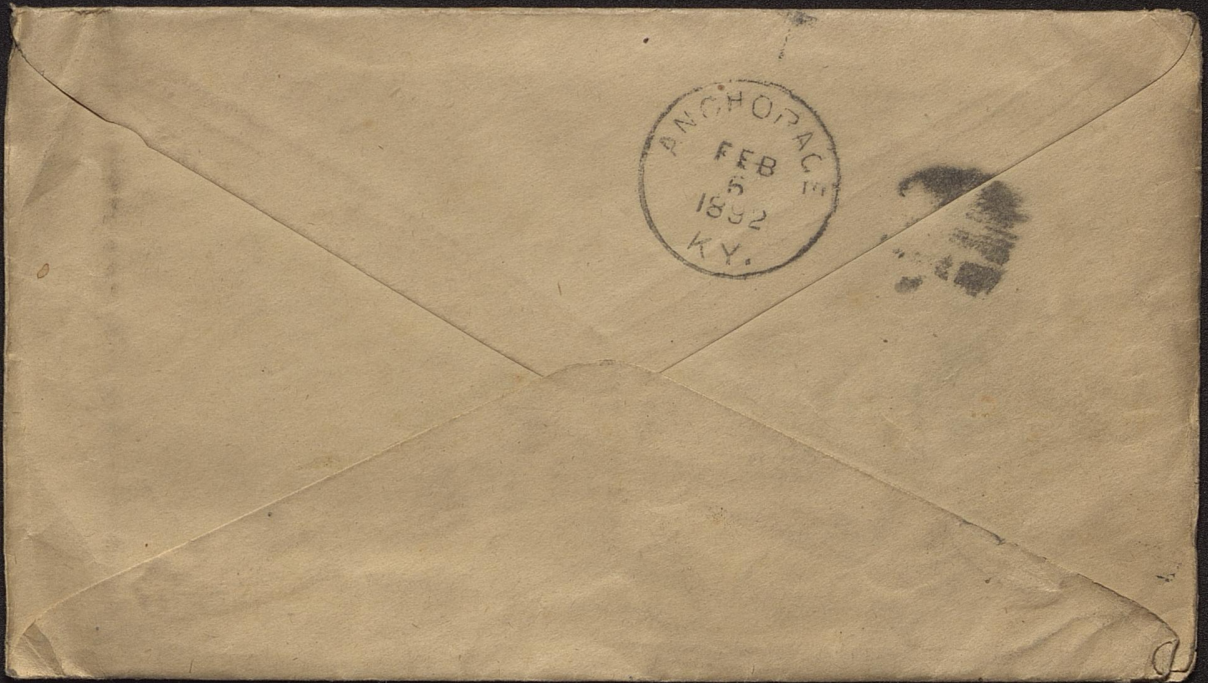
