Two Battles Won, Two Battles Lost

Voters addressed 4 issues in various places on lesbigay rights on Nov. 3. While Portland, Maine, voters upheld their city's inclusion of "sexual orientation" in the city's anti-discrimination ordinance by a 57 to 43% margin, Tampa, Florida, voters chose to repeal a similar ordinance by a 58 to 42% vote.

After an ugly and violent campaign leading to the deaths by arson of a lesbian and her gay roommate, Oregon voted down Measure 9 which would have amended the state constitution to ban any type of rights for homo/bisexuals and forced the state to teach that homosexuality was "perverse and unclean." The final tally was 56% against vs. 44% for the hate-ridden measure.

Disturbingly, Colorado voters passed the less publicized Amendment 2 to the Colorado State constitution by a 52 to 47% margin. It amends Sec. 30 to state: "Neither the State of Colorado, through any of its branches or departments, nor any of its agencies, political subdivisions, municipalities or school districts, shall enact, adopt or enforce any statute, regulation, ordinance or policy whereby homosexual, lesbian or bisexual orientation, conduct, practices or relationships shall constitute or otherwise be the basis of, or entitle any person or class of persons to have or claim any minority status, quota preferences, protected status or claim of discrimination. This Section of the Constitution shall be in all respects self-executing." This amendment effectively repeals any current or future public protections from discrimination for homo/bisexuals on

Cutting Off Colorado

Colorado voters decided on Nov. 3 to amend their state constitution to ban any state or local level protections from discrimination for lesbigays. It does not pass moral judgment on lesbigays as did Oregon's Measure 9 and was campaigned for by religious, right-wing extremists as a "no special rights for gays" platform. Also unlike in Oregon where almost all state officials and then presidential candidate Bill Clinton condemned it, Colorado's Proposition 2 had the support of prominent figures and politicians such as Bill McCartney, outspoken homophobic, anti-choice coach of the Colorado Buffalos football team and head of the sponsoring group for Prop. 2, the Coalition for Family Value (CFV). The Religious Right spearheaded its funds towards these amendments in Oregon, Colorado and a now defeated statewide ERA in Iowa. It lost only in Oregon and by a much lower margin there than expected by opponents. There is already talk by these right-wing groups to put similar amendments on the ballots of more traditionally conservative states throughout the South, Utah, etc.

March on Washington Platform Finalized

An Oct. 3, Denver meeting of the National Steering Committee of the 1993 March on Washington has finalized 7 demands to focus on within the general purpose for the March: calling attention to demands for equal rights and liberation for lesbians, gays and bisexuals. The 7 major demands as quoted from the MOW Steering Committee:

1. We demand the passage of a Lesbian, Gay, Bisexual and Transgender (LGBT) civil rights bill and an end to discrimination by state and federal governments including the military; repeal of all sodomy laws and other laws that criminalize private sexual expression between consenting adults.
2. We demand a massive increase in funding for AIDS education, research and patient care; universal access to health care including alternative therapies; and an end to sexism in medical research and health care.
3. We demand legislation to prevent discrimination against LGBT people in the areas of family diversity, custody, adoption and foster care and that the definition of family include the full diversity of all family structures.
4. We demand full and equal inclusion of LGBT people in the educational system, and inclusion of LGBT studies in multicultural curricula.
5. We demand the right to reproductive freedom and choice, to control our own bodies, and an end to sexist discrimination.
6. We demand an end to racial and ethnic discrimination in all forms.
7. We demand an end to discrimination and violent oppression based on actual or perceived sexual orientation/identification, race, religion, identity, sex and gender expression, disability, age, class, and AIDS/HIV infection.

Action Statement: The LGBT movement recognizes that our quest for social justice fundamentally links us to the struggles against racism and sexism, class bias, economic injustice and religious intolerance. We must realize if one of us is oppressed we all are oppressed. The diversity of our movement requires and compels us to stand in opposition to all forms of oppression that diminish the equality of life for all people. We will be vigilant in our determination to rid our movement and our society of all forms of oppression and exploitation, so that all of us can develop to our full human potential without regard to race, religion, sexual orientation/identification, identity, gender and gender expression, ability, age or class.

Congratulations Lexington and Kentucky!

1992 has been a special year for Kentucky's lesbian communities. Here in Lexington we have seen a surge in lesbian services and networking with the birth of the: Gay/Lesbian Services Network, Diversity Business Coalition, the Pink Pages, GLSO Discrimination Project, Bluegrass Bisexual Network, Lesbian Overeaters Anonymous, Lesbian Parents Group, Women's Chorus, HIV+ Youth Support Group, Fairness of Lexington, and Neo-Pagan Group to name a few. Lesbian student groups have sprouted at ECU, NKU, and Morehead St. We proudly marched as a group in our first parade here in Lexington this summer before 50,000 fellow Kentuckians. Our Supreme Court upheld that we do have equal rights in Kentucky and repealed the sodomy law after one of us, Jeff Wasson, stood up to this injustice. The harassment of members of our community in Russellville showed that Kentucky's lesbians (and ACLU) will not sit back while our members are terrorized: we will publicize and reach out. There have been setbacks to be sure, but as a community, Lexington and Kentucky deserve a big congratulations for collecting and connecting to help ourselves.

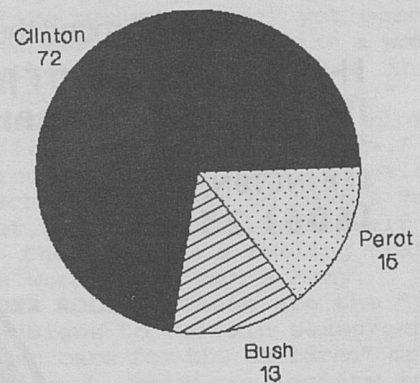

The anti-discrimination ordinances that included "sexual orientation" for the cities of Denver, Boulder and Aspen are also repealed by this amendment. 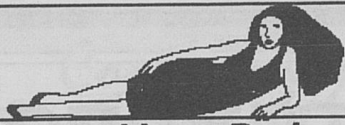

Life and Relationship Changes After Baby

This article could also be subtitled: "I thought you picked him up from preschool" or "I'm too tired to breathe much less kiss you." And, no matter what anyone tells you NOTHING can completely prepare you for the impact of the arrival of a child. Having the knowledge of the intensity of this impact can help in two ways.

First, you perhaps won't feel as alone with the inevitable frustration and despair. Raising Alex is terrific and has also magnified the stresses of life. We've found talking to other couples (both gay and strays) with kids a real comfort. It not only alleviates that feeling of isolation but lets us see we are not the only parents facing these types of feelings. We've discovered that way before he was born, we erected a set of expectations for us as parents and Alex as baby. And each day as we fail to meet these expectations our feeling of frustration increases. It is when we talk with others that we discover how ludicrous these expectations are. And, these discussions help us realize that the stresses our relationship is facing are for the most part the same as those experienced by every couple with a 2 year old.

The second reason to recognize the impact of parenthood is to stress the importance of creating a certain attitude before hand to protect your peace of mind and relationship. In our community we create enlarged families in several ways: the birth of an infant, adoption of an older child, or the merging of two adults, one or both with children from previous relationships. I have lived through both the infant and merged family experiences and find them a little different. In fact, Ann and I, have found that we share more similar issues with stray couples with infants than with lesbian couples with merged families.

Next month I will share with you my list of considerations when preparing for parenthood no matter which course you take and also the prospects of adoption.

Sermon from the Keyboard: How Queer Are You?

Recently, a gay Unitarian minister named Exoo did a study of men who have sex with other men at four South Carolina rest stops. His concern was AIDS prevention for this group. Frighteningly, Exoo found that 80% of the men did not practice safer sex. Also interestingly, 85% of the men were in a bonded relationship with a woman and identified themselves mostly as strays. None identified themselves as gay and only a handful as bisexual. These men disliked gays and avoided health services and practices that might identify themselves as "gay."

The question this study poses is: just what is this quality of "being gay." (For these men in SC obviously, being gay or bisexual is not defined by who you have sex with.) Moreover, who can be a "lesbian" or a "bisexual." For that matter, when is a heterosexual "stray?"

Talking with activist and researcher Nora Brashear at the University of Louisville, she points to six factors that make up our sexual identity. I felt our readers would find this of interest:

- 1. SEX:** Your physiological characteristics (penis, vagina, both organs). A person can be female, male or other (hermaphrodite).
- 2. GENDER:** Often confused with SEX, this is actually the characteristics designated by society to belong to a certain SEX. Our society generally sees only two genders (feminine woman and masculine man) but occasionally concedes there are androgynous people. Some other societies have up to 7 genders, and Native Americans usually had 3. Transvestites and transgendered people challenge our society's construction of only two genders by a) being males, b) sometimes dressing "like women" and c) yet possibly being a heterosexual male ("unlike a woman") or taking the dominant position in sex generally thought of as more "male."
- 3. GENDER IDENTITY:** How one experiences "maleness/femaleness/ otherness." A transgendered person may have the male sex and be expected by society to have a "male" gender. Yet, he may identify himself as a "herself": there may be a feeling that the person is a woman in a man's body.
- 4. SEX/GENDER ROLES:** These are the "jobs" a culture assigns to certain sexes/genders such as "women care for the children" or "men do the hunting." American society in the last decades have seen many of these roles challenged by feminists.

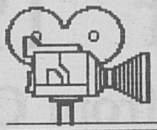

Lexington Men Sing OUT

Anyone who happens to be walking by a certain big, old, red house in downtown Lexington on a Thursday night might well have reason to pause for a moment, maybe even stretch her/his neck a bit to peer through the window. The picture before them would be that of 25 men sitting shoulder-to-shoulder in rows of folding chairs, their eyes transfixed on the robust, energetic young lady standing before them. No, it's not some unsavory scene from a bachelor party, but the weekly rehearsal of the Lexington Men's Chorus' upcoming **Winter Festival of Song**.

Even before McAlpin's began trimming its first Christmas trees of the season, the Lexington Men's Chorus has been busy honing a heart-warming mix of winter-themed melodies for its upcoming concert under the musical direction of Nancy Ward. The group, a member of the international Gay & Lesbian Association of Choruses (GALA), has made over a dozen appearances since its inception just two years ago. The Chorus has appeared at a Civil War encampment in Harrodsburg to a gig with the nationally touring musical production, "Heart Strings."

"The chorus has really been a positive force in Lexington," says Shelby Reynolds, the group's president. "I think we not only help to instill a sense of pride in Lexington's gay and lesbian community, but hopefully we can help portray the community in a positive light to the rest of the city as well."

"Our upcoming performance includes a few of the traditional Christmas songs," Reynolds says, "but also features numbers that are not traditionally associated with the Christmas season per se; some with wintery-type themes, and others that simply make you feel warm inside."

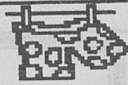

NEWS SHORTS



CANADA- The Federal Court of Canada ruled on October 27th that barring homosexuals from the Canadian military violated the Canadian Charter of Rights and Freedoms and ordered that the military no longer discriminate against homosexuals. The military said it would comply fully.

ATLANTA- Arson is to blame for a fire that badly damaged a clinic at the Atlanta Gay Center on August 28. There are currently no suspects but fundraising has begun to rebuild the clinic.

OREGON- The city of Springfield, OR, which recently voted in an anti-gay ordinance, had its city liability insurance suspended for 24 days by the Fireman's Fund in response to fears of possible losses arising from discrimination lawsuits over the new ordinance. Coverage has been reinstated but will now only cover \$1 million rather than \$3 million in losses.

ASHEVILLE, NC- An unnamed gay man won parental rights in a landmark artificial insemination case with a lesbian friend to whom he donated sperm. The resulting daughter was born under an agreement whereby the father surrendered rights as a parent but kept visitation rights. The unnamed lesbian mother sued after viewing the man and his mother's visits as taking on a role of emotional responsibility as a parent. NC law covers sperm donations to married couples in which the donor has not visitation rights but the law does not cover single women.

INDIANA- The Indiana United Methodist Church has ordered that no Indiana Methodist church may be used for commitment ceremonies similar to heterosexual marriages but reaffirmed its ministry to gay people.

MICHIGAN- Ann Arbor, MI, passed a resolution offering insurance and other benefits to the domestic partners of gays and lesbian city employees in an 8-1 vote.

CANADA- An independent board of inquiry ordered the provincial Ontario government to extend survivor benefits to the partners of gay and lesbian government employees under the Ontario Human Rights Code. Dental and health insurance benefits were granted in 1991 after a suit by a gay male lawyer in the Ontario government.

FLORIDA- Although Florida law bans adoption

by lesbians and gay men, foster parenting is not banned. A lesbian who directs an AIDS family counseling center received a license to foster a HIV-infected child. At the same time, a lesbian couple lost their 6-yr.-old foster child because Florida law does not allow unmarried couples to foster children. In a Catch-22, Florida law does not allow the women to legally marry.

SAN DIEGO- A California jury convicted 19 year old Todd Fluette, a Wisconsin sailor based in San Diego, of planning and carrying out the stabbing murder of a married bisexual man in Balboa Park. He faces a life sentence without parole.

WASHINGTON, DC- The Bush administration decided to support a New Orleans court decision allowing employers to cut HIV+ workers health coverage insurance.

LOUISVILLE- The General Assembly Permanent Judicial Commission of the Presbyterian Church (USA) issued a judgement on Nov. 4 that Rev. Jane Spahr, a "self-affirmed, practicing homosexual" as quoted by the decision, was improperly appointed as pastor of a Rochester, NY, church. Although the Downtown United Presbyterian Church chose Spahr as the best candidate and knew of her sexual orientation, a challenge by the regional Genesee Valley Presbytery led to Spahr's appointment being upheld until it reached the national judicial commission in Irving, TX.

NASHVILLE- The failure of Garth Brooks's song, "We Shall Be Free," to enter the top 10 country singles (it is currently at 12th place) is seen as a statement about the song's lyrics: "when we're free to love anyone we choose, when this world's big enough for all different views, when we can all worship from our own kind of pew, then we shall be free." The singles rankings in country music are based on airplay time and some stations are refusing to play this song with its message of tolerance. Brooks stated in a Sept. interview that "our grandkids will say-'How could anyone ever think someone's sexual preference affected how their mind works.'"

BOSTON- Kevin Smith, Commissioner of the Div. of Capital Planning, and Mitchell Adams, Revenue Commissioner, came out in the Boston Globe as the first high level gay couple to acknowledge their relationship. The couple shares a home and are members of Republican Gov. William Weld's administration for the Commonwealth of Massachusetts.

Fairness of Lexington

The Fairness Campaign of Lexington is alive and growing. Although the realization of our goal may be a long time in arriving, we have some projects in the works that we hope will bring our community closer together and develop interest in the campaign. Our 3 immediate projects are: 1) The Gay Apparel Drive: a clothes drive to benefit the homeless at the Hope Center, 2) election of a Steering Committee in January, and 3) Winterfest: an event featuring various workshops, food, and trade fair culminating with a dance.

The Hope Center is in need of warm clothing for the winter. If you have coats, gloves, hats or anything of this nature that you can donate, let us know. Especially needed are large sizes for women and men.

Fairness has so far developed under a coordinating committee where basically everyone is involved. But, now we are close to electing a steering committee to take over the general business so that individuals can concentrate on individual projects. The committee will consist of 1 representative from each sub-committee, 2 co-convenors (female and male), a scribe, a treasurer, and 2 at-large members. If you are interested

in what we are doing, there are three general meetings scheduled for Dec. 7, Jan. 11 and Jan. 25. All meetings are at Alfalfa's Restaurant and begin at 7:30pm.

Winterfest promises to be an exciting event but is still in the planning stages. If you are interested in helping in its organization and/or have ideas on what types of activities we should include, don't be shy: let us hear from you.

Fairness is everybody's campaign. We need anyone who has time and energy they can contribute. How much or how little time you can spare will go towards helping our lesbian, gay and bisexual community to establish lawful recognition of our civil rights. Near riots broke out in Denver when Prop. 2 broke out. The state Democratic Party celebration was cancelled as the governor and other officials joined over 1000 people in a protest march. Crowds of up to 7000 people have braved the cold as protests continue. Gov. Roemer has vowed that no gay/lesbian person will lose their job or home over this amendment.

As this amendment makes a public statement that Colorado will allow discrimination against gays, hate crimes in the state have surged. Lesbians and individuals are reporting a huge surge in harassment calls, vandalism and gay-bashing.

The only counties in Colorado to reject the amendment were the ones containing the ski resorts. As with the costly, \$200 million+ loss in business of a boycott of Arizona for not passing until Nov. 3 a Martin Luther King, Jr. holiday, the tourist areas feared a national boycott of the ski industry. Although Denver and Boulder were expected to reject the measure, the vote was very close for passing it.

The cities of Denver, Boulder and Aspen along with currently 10 other individual plaintiffs (including Martina Navratilova) have filed suit against the state claiming that Amendment 2 violates the Equal Protection Clause of the 14th Amendment of the US Constitution, violates the rights of expression and association of homosexuals, usurps the powers of home rule cities and requires the state of Colorado to recognize and promote a particular religious belief over the separation of church and state. Colorado Rep. Pat Schroeder has written President-elect Clinton to ask him to follow up on his campaign promise to support the federal gay rights bill and make it a priority so as to override the Colorado amendment.

In response to this amendment, a nationwide boycott of Colorado is underway until the amendment is repealed. As with Arizona over the King holiday, South Africa with apartheid, and Avon over animal testing, boycotts are sometimes effective. Already the state tourism office has been bombarded with people

calling to cancel winter ski trips. Business leaders in tourism, Colorado's #1 business, are predicting a gloomy ski season and blaming the CFV for dampening bright business prospects. Professional organizations such as the American Political Science Association, United Church of Christ and American Library Association are discussing plans to refuse to hold conferences in Colorado. Several conventions have already canceled. There is currently no word if organizers for the annual Gay Ski Week in Aspen will move the January event that brings over 5000 to the town. To put pressure on Colorado economically, gay activists both within and without the state are asking people to boycott Colorado products and events ranging from tourism to beer to beef. Finally, once considered a haven of tolerance, rugged individualism and progressive social/environmental policies, Colorado's passage of this amendment is seen as affecting the state's image.

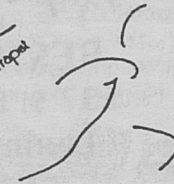

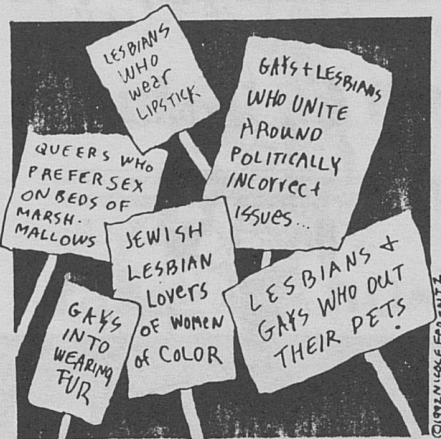
Join GLSO at the March on Washington

5. SEXUAL ORIENTATION: Sexual and affectional attraction to a person(s) of the same, opposite or both sexes.

6. SEXUAL ORIENTATION IDENTITY: One's reconciliation of one's sexual behavior and one's identity. Thus, there are lesbian prostitutes who sleep with men. The Exoo study subjects identify as heterosexual but are technically either bisexual or in a few cases homosexual. And, many lesbian and gay identified people may have had sexual/affectional relations with members of the opposite sex and thus have bisexual sexual orientations. The stigmas placed on these labels affect what one chooses.

If anything, these factors show that people are complex and not so easily fit into nice, neat categories such as "bisexual", "transgender" or "lesbian." For political reasons, lesbigays and heterosexuals seek to differentiate ourselves into an "us" and a "them." Yet, the mix is much more complex and as lesbigay sexual minorities, we need to also watch out for too quickly categorizing ourselves and others. Face it, folks: all of us (including heterosexuals) are queer in some way and should be happy that we and others are a little bit different.

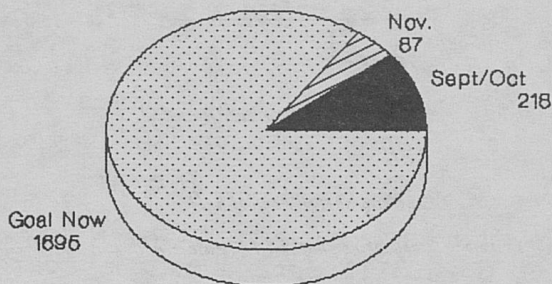

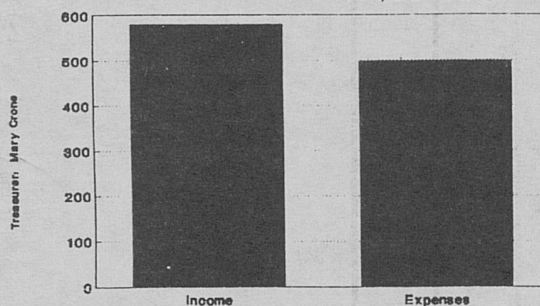
