#### Read Every Word of This.

Failure to make returns properly and forward them promptly, causes much trouble and expense.

## HOW TO MAKE OUT THIS RETURN.

Rule 1. On page 2 copy names of Officers, and give date of election. Read head-notes under "Past Masters," and fill accordingly.

Rule 2. Read the head-notes on page 3 and write in strictly alphabetical order, the full name of every Master Mason, member of your lodge, including Officers and Past Masters, thus:

### Adams, Hiram Henry.

Rule 3. After the name of ministers who are made "Free Members" by your by-laws, NOT OTHERWISE, write "Rev." thus:

### Hunter, Hiram Abif, Rev.

Rule 4. On page 7, write, in alphabetical order, the names of F. C's, and E. A's under those heads respectively.

Rule 5. Read the head-notes on pages 8 and 9, and enter the names of all who have been *initiated*, passed, or raised during the year, none others, and fill in the dates carefully. Always give dates on page 8.

Rule 6. On pages 10, 11, 12, 13, 14 and 15 appropriately fill the blanks as indicated under each head, designating the "Degree" thus: "P. M." for Past Master, "M. M." for Master Mason, and so on. Do not designate degrees by figures, or leave dates, etc., blank.

Rule 7. Check off the entire return by the last return to see that no name has been omitted.

RULE 8. Fill blanks on page 1, except date and amount of payment, and add up, to see if your work is *certainly* correct.

Rule 9. Make a neat copy in ink on the duplicate blank, attach Lodge Seal, compare with original carefully, mail the copy to the Grand Secretary, Louisville, Ky., SEPT. 1, without fail. Present the original to your lodge, if desired, but do not detain the return to be sent to Gr. Sec.

RULE 10. Write very plainly all names in full.

Rule II. Remit for dues and assessments October I, or before, by check, money order, registered letter, or express. If receipt is not promptly returned, ask Grand Secretary why.

RULE 12. An officer can not resign or dimit.

RULE 13. All "Free Members" (except as in Rule 16) must pay the assessment.

RULE 14. F. C's and E. A's are members and pay dues and assessments.

RULE 15. Life and Honorary Members are not recognized by the Grand Lodge.

Rule 16. No dues or assessment are required of a brother who has been 50 years a Mason, *provided* the words, "50 years," are written after his name, and in the margin, this information: "Made in ...... Lodge No...., at ......, State of ......, 18..." Not otherwise.

Rule 17. In writing to Grand Secretary *always* give name and number of lodge and your postoffice.

RULE 18. RETURNS OF LODGES U. D. are made to include the last meeting before Grand Lodge, and with the books and papers are delivered promptly to Grand Secretary, or sent by express as soon as possible before the Grand Lodge meets. Lodges U. D. do not elect officers.

Secretaries failing to conform to these instructions are liable to charges for disobeying the edicts of Grand Lodge. See 2d Digest, page 141.

Failure to make returns properly and forward them promptly, causes much trouble and expense.

## HOW TO MAKE OUT THIS RETURN.

RULE 1. On page 2 copy names of Officers, and give date of election. Read head-notes under "Past Masters," and fill accordingly.

Rule 2. Read the head-notes on page 3 and write in strictly alphabetical order, the Full name of every Master Mason, member of your lodge, including Officers and Past Masters, thus:

## Adams, Hiram Henry.

Rule 3. After the name of ministers who are made "Free Members" by your by-laws, NOT OTHERWISE, write "Rev." thus:

### Hunter, Hiram Abif, Rev.

Rule 4. On page 7, write, in alphabetical order, the names of F. C's, and E. A's under those heads respectively.

Rule 5. Read the head-notes on pages 8 and 9, and enter the names of all who have been *initiated*, passed, or raised during the year, none others, and fill in the dates carefully. Always give dates on page 8.

Rule 6. On pages 10, 11, 12, 13, 14 and 15 appropriately fill the blanks as indicated under each head, designating the "Degree" thus: "P. M." for Past Master, "M. M." for Master Mason, and so on. Do not designate degrees by figures, or leave dates, etc., blank.

Rule 7. Check off the entire return by the last return to see that no name has been omitted.

RULE 8. Fill blanks on page I, except date and amount of payment, and add up, to see if your work is *certainly* correct.

Rule 9. Make a neat copy in ink on the duplicate blank, attach Lodge Seal, compare with original carefully, mail the copy to the Grand Secretary, Louisville, Ky., SEPT. 1, without fail. Present the original to your lodge, if desired, but do not detain the return to be sent to Gr. Sec.

RULE 10. Write very plainly all names in full.

Rule II. Remit for dues and assessments before Oct. I, by check on Louisville, Cincinnati or New York, money order, registered letter, or express. If receipt is not promptly returned, ask Grand Secretary why. Don't send check on local bank.

RULE 12. An officer can not resign or dimit.

Rule 13. All "Free Members" must pay the assessment.

RULE 14. F. C's and E. A's are members and pay dues and assessments.

Rule 15. Life and Honorary Members are not recognized by G. L.

RULE 16. No dues are required of a brother who has been an affiliated Master Mason for 50 years and paid lodge dues all that time (See Const. xi, §9) Write the words, "50 years" after his name, and let him certify what lodges he has been a member of during the 50 years, with dates.

RULE 17. In writing to Grand Secretary always give name and number of lodge and your postoffice address. (See Reg. 539-543).

RULE 18. RETURNS OF LODGES U. D. are made the same as chartered lodges, but their books, by-laws, dispensation, etc., must be sent to Grand Secretary at least two weeks before Grand Lodge meets. (See Reg. 581, 582.)

Secretaries failing to conform to these instructions are liable to charges for disobeying the edicts of Grand Lodge. See Reg. 880, 919.



RULE 3. After the name of each minister, whose support depends upon his labor as such, and who is exempted by the lodge from paying dues, NOT OTHERWISE, write "Rev." In list of Master Masons, pages 3-6, put a cross or star (\*) after the name of every Past Master and two stars (\*\*) after names of P. Gr. M's, thus:

Bassett, Hiram.\*\*
Clark, William Thomas.\*
Douglass, Samuel Abif, Rev.

Rule 4. On page 7, write, in alphabetical order, the names of F. C's, and E. A's under those heads respectively.

RULE 5. Read the head-notes on pages 8 and 9, and enter the names of all who have been *initiated*, passed, or raised during the year, none others, and fill in the dates carefully. Always give dates on page 8.

Rule 6. On pages 10, 11, 12, 13, 14 and 15 appropriately fill the blanks as indicated under each head, designating the "Degree" thus: "P. M." for Past Master, "M. M." for Master Mason, and so on. Do *not* designate degrees by figures, or leave dates, etc., blank.

RULE 7. Check off the entire return by THE LAST RETURN to see that no name has been omitted.

RULE 8. Fill blanks on page 1, except date and amount of payment, and add up, to see if your work is certainly correct.

Rule 9. Make a neat copy in ink on the duplicate blank, attach Lodge Seal, compare with original carefully, mail the copy to the Grand Secretary, Louisville, Ky., SEPT. 1, without fail. Present the original to your lodge, if desired, but do not detain the return to be sent to Gr. Sec.

RULE 10. Write very plainly all names in full.

Rule 11. Remit for dues and assessments before Oct. 1, by check on Louisville, Cincinnati or New York, money order, registered letter, or express. If receipt is not promptly returned, ask Grand Secretary why. Don't send check on local bank.

Rule 12. An officer can not resign or dimit.

Rule 13. All "Free Members" must pay the assessment.

Rule 14. F. C's and E. A's are members and pay dues and assessments.

RULE 15. Life and Honorary Members are not recognized by G. L.

Rule 16. No dues are required of a brother who has been an affiliated Master Mason for 50 years and paid lodge dues all that time (See Const. xi, §9) Write the words, "50 years" after his name, and let him certify what lodges he has been a member of during the 50 years, with dates.

RULE 17. In writing to Grand Secreta always give name and number of lodge and your postoffice address. See Reg. 539-543).

RULE 18. RETURNS OF LODGES U. D. are made the same as chartered lodges, but their books, by-laws, dispensation, etc., must be sent to Grand Secretary at least two weeks before Grand Lodge meets. (See Reg. 581, 582.)

Secretaries failing to conform to these instructions are liable to charges for disobeying the edicts of Grand Lodge. See Reg. 880, 919.

RULE 6. On pages 10, 11, 12, 13, 14 and 15 appropriately fill the blanks as indicated under each head, designating the "Degree" thus: "P. M." for Past Master, "M. M." for Mason, and so on. Do not designate degrees by figures, or leave dates, blank.

RULE 7. Check return by THE LAST RETURN to see that no name has been the see that no

RULE 8. First of an interest in the state and amount of payment, and add up, to see it trainly correct.

Rule 9. Make ink on the duplicate blank, attach Lodge Seal, compare we ully, mail the copy to the Grand Secretary, Louisville, would fail. Present the original to your lodge, if desired, but to be sent to Gr. Sec.

RULE 10. Way all names in full.

RULE II. Research as and assessments BEFORE Oct. I, by check on Louisvie or New York, money order, registered letter, or express. If a sonot promptly returned, ask Grand Secretary why. Don't send check on local bank.

RULE 12. An office can not resign or dimit.

Rule 13. All "Free Members" must pay the assessment.

RULE 14. F. C's and E. A's are members and pay dues and assessments.

RULE 15. Life and Honorary Members are not recognized by G. L.

RULE 16. No dues are required of a brother who has been an affiliated Master Mason for 50 years and paid lodge dues all that time (See Const. xi, §9) Write the words, "50 years" after his name, and let him certify what lodges he has been a member of during the 50 years, with dates.

RULE 17. In writing to Grand Secretary always give name and number of lodge and your postoffice address. (See Reg. 539-543).

RULE 18. RETURNS OF LODGES U. D. are made the same as chartered lodges, but their books, by-laws, dispensation, etc., must be sent to Grand Secretary at least two weeks before Grand Lodge meets. (See Reg. 581, 582.)

Secretaries failing to conform to these instructions are liable to charges for disobeying the edicts of Grand Lodge. See Reg. 880, 919.







## HOW TO MAKE THIS RETURN.

Rule 1. On page 2 copy names of Officers, and give date of election. Read head-notes under "Past Masters," and fill accordingly.

Rule 2. Read the head-notes on page 3 and write, in strictly alphabetical order, the Full name of Every Master Mason who is a member of your lodge, INCLUDING Officers and Past Masters.

RULE 3. After the name of each minister, whose support depends upon his labor as such, and who is exempted by the lodge from paying dues, NOT OTHERWISE, write "Rev." In list of Master Masons, pages 3-6, put a cross or star (\*) after the name of every Past Master and two stars (\*\*) after names of P. Gr. M's, thus:

Examples under Rules 2-3:

Adam, John Henry.
Bassett, Hiram.\*\*
Clark, William Thomas.\*
Douglass, Samuel Abif, Rev.

Rule 4. On page 7, write, in alphabetical order, the names of F. C's, and E. A's under those heads respectively.

Rule 5. Read the head-notes on pages 8 and 9, and enter the names of all who have been *initiated*, passed, or raised during the year, none others, and fill in the dates carefully. Always give dates on page 8.

RULE 6. On pages 10, 11, 12, 13, 14 and 15 appropriately fill the blanks as indicated under each head, designating the "Degree" thus: "P. M." for Past Master, "M. M." for Master Mason, and so on. Do *not* designate degrees by figures, or leave dates, etc., blank.

Rule 7. Check off the entire return by the last return to see that no name has been omitted.

RULE 8. Fill blanks on page I, except date and amount of payment, and add up, to see if your work is *certainly* correct.

Rule 9. Make a neat copy in ink on the duplicate blank, attach Lodge Seal, compare with original carefully, mail the copy to the Grand Secretary, Louisville, Ky., SEPT. 1, without fail. Present the original to your lodge, if desired, but do not detain the return to be sent to Gr. Sec.

RULE 10. Write very plainly all names in full.

Rule II. Remit for dues and assessments before Oct. I, by check on Louisville, Cincinnati or New York, money order, registered letter, or express. If receipt is not promptly returned, ask Grand Secretary why. Don't send check on local bank.

RULE 12. An officer can not resign or dimit.

Rule 13. All "Free Members" must pay the assessment.

RULE 14. F. C's and E. A's are members and pay dues and assessments.

RULE 15. Life and Honorary Members are not recognized by G. L.

Rule 16. No dues are required of a brother who has been an affiliated Master Mason for 50 years and paid lodge dues all that time (See Const. xi, §9) Write the words, "50 years" after his name, and let him certify what lodges he has been a member of during the 50 years, with dates.

Rule 17. In writing to Grand Secretary always give name and number of lodge and your postoffice address. (See Reg. 539-543).

RULE 18. RETURNS OF LODGES U. D. are made the same as chartered lodges, but their books, by-laws, dispensation, etc., must be sent to Grand Secretary at least two weeks before Grand Lodge meets. (See Reg. 581, 582.)

Secretaries failing to conform to these instructions are liable to charges for disobeying the edicts of Grand Lodge. See Reg. 880, 919.

### HOW TO MAKE THIS RETURN.

RULE 1. On page 2 copy names of Officers, and give date of election. Read head-notes under "Past Masters," and fill accordingly.

Rule 2. Read the head-notes on page 3 and write, in strictly alphabetical order, the FULL name of EVERY Master Mason who is a member of your lodge, INCLUDING Officers and Past Masters.

RULE 3. After the name of each minister, whose support depends upon his labor as such, and who is exempted by the lodge from paying dues, NOT OTHERWISE, write "Rev." In list of Master Masons, pages 3-6, put a cross or star (\*) after the name of every Past Master and two stars (\*\*) after names of P. Gr. M's, thus:

Adam, John Henry.

Examples under Rules 2-3: Bassett, Hiram.\*\*\*
Clark, William Chomas.\* Douglass, Samuel Abif, Rev.

RULE 4. On page 7, write, in alphabetical order, the names of F. C's, and E. A's under those heads respectively.

RULE 5. Read the head-notes on pages 8 and 9, and enter the names of all who have been initiated, passed, or raised during the year, none others, and fill in the dates carefully. Always give dates on page 8.

RULE 6. On pages 10, 11, 12, 13, 14 and 15 appropriately fill the blanks as indicated under each head, designating the "Degree" thus: "P. M." for Past Master, "M. M." for Master Mason, and so on. Do not designate degrees by figures, or leave dates, etc., blank.

RULE 7. Check off the entire return by the last return to see that no name has been omitted.

RULE 8. Fill blanks on page I, except date and amount of payment, and add up, to see if your work is certainly correct.

RULE 9. Make a neat copy in ink on the duplicate blank, attach Lodge Seal, compare with original carefully, mail the copy to the Grand Secretary, Louisville, Ky., SEPT. 1, without fail. Present the original to your lodge, if desired, but do not detain the return to be sent to Gr. Sec.

RULE 10. Write very plainly all names in full.

RULE 11. Remit for dues and assessments before Oct. 1, by check on Louisville, Cincinnati or New York, money order, registered letter, or express. If receipt is not promptly returned, ask Grand Secretary why. Don't send check on local bank.

RULE 12. An officer can not resign or dimit.

Rule 13. All "Free Members" must pay the assessment.

RULE 14. F. C's and E. A's are members and pay dues and assessments.

RULE 15. Life and Honorary Members are not recognized by G. L.

RULE 16. No dues are required of a brother who has been an affiliated Master Mason for 50 years and paid lodge dues all that time (See Const. xi, §9) Write the words, "50 years" after his name, and let him certify what lodges he has been a member of during the 50 years, with dates.

RULE 17. In writing to Grand Secretary always give name and number of lodge and your postoffice address. (See Reg. 539-543).

RULE 18. RETURNS OF LODGES U. D. are made the same as chartered lodges, but their books, by-laws, dispensation, etc., must be sent to Grand Secretary at least two weeks before Grand Lodge meets. (See Reg. 581, 582.)

Secretaries failing to conform to these instructions are liable to charges for disobeying the edicts of Grand Lodge. See Reg. 880, 919.

## HOW TO MAKE THIS RETURN.

Rule 1. On page 2 copy names of Officers, and give date of election. Read head-notes under "Past Masters," and fill accordingly.

RULE 2. Read the head-notes on page 3 and write, in strictly alphabetical order, the FULL name of EVERY Master Mason who is a member of your lodge, INCLUDING Officers and Past Masters.

RULE 3. After the name of each minister, whose support depends upon his labor as such, and who is exempted by the lodge from paying dues, NOT OTHERWISE, write "Rev." In list of Master Masons, pages 3-6, put a cross or star (\*) after the name of every Past Master and two stars (\*\*) after names of P. Gr. M's, thus:

Examples under Rules 2-3:

Adam, John Henry.
Bassett, Hiram.\*\*
Clark, William Thomas.\*
Douglass, Samuel Abif, Nev.

Rule 4. On page 7, write, in alphabetical order, the names of F. C's, and E. A's under those heads respectively.

RULE 5. Read the head-notes on pages 8 and 9, and enter the names of all who have been *initiated*, passed, or raised during the year, none others, and fill in the dates carefully. Always give dates on page 8.

Rule 6. On pages 10, 11, 12, 13, 14 and 15 appropriately fill the blanks as indicated under each head, designating the "Degree" thus: "P. M." for Past Master, "M. M." for Master Mason, and so on. Do not designate degrees by figures, or leave dates, etc., blank.

Rule 7. Check off the entire return by the last return to see that no name has been omitted.

RULE 8. Fill blanks on page I, except date and amount of payment, and add up, to see if your work is *certainly* correct.

Rule 9. Make a neat copy in ink on the duplicate blank, attach Lodge Seal, compare with original carefully, mail the copy to the Grand Secretary, Louisville, Ky., SEPT. 1, without fail. Present the original to your lodge, if desired, but do not detain the return to be sent to Gr. Sec.

RULE 10. Write very plainly all names in full.

Rule II. Remit for dues and assessments before Oct. I, by check on Louisville, Cincinnati or New York, money order, registered letter, or express. If receipt is not promptly returned, ask Grand Secretary why. Don't send check on local bank.

Rule 12. An officer can not resign or dimit.

Rule 13. All "Free Members" must pay the assessment.

Rule 14. F. C's and E. A's are members and pay dues and assessments.

RULE 15. Life and Honorary Members are not recognized by G. L.

RULE 16. No dues are required of a brother who has been an affiliated Master Mason for 50 years and paid lodge dues all that time (See Const. xi, §9) Write the words, "50 years" after his name, and let him certify what lodges he has been a member of during the 50 years, with dates.

RULE 17. In writing to Grand Secretary always give name and number of lodge and your postoffice address. (See Reg. 539-543).

RULE 18. RETURNS OF LODGES U. D. are made the same as chartered lodges, but their books, by-laws, dispensation, etc., must be sent to Grand Secretary at least two weeks before Grand Lodge meets. (See Reg. 581, 582.)

Secretaries failing to conform to these instructions are liable to charges for disobeying the edicts of Grand Lodge. See Reg. 880, 919.

### IN MAKING RETURNS OBSERVE THE FOLLOWING

### RULES:

000

- 1. Follow instructions at the top of each page.
- 2. Remember the military report at *dress parade*: "ALL present or accounted for." So *all* who were reported as members last year must be "present" members, "or accounted for" as dead, demitted, suspended, or expelled. All who are now members are "accounted for" as having been members per last return, or who have since become members by initiation, admission, or reinstatement.
- 3. Write plainly, or the printer (who uses your return for his "copy") will not get the names correct in the printed proceedings.
- 4. Make out return, check it off by last year's return and prove it—see page 1; make a copy in ink, compare it with the original; preserve one copy and send the other to Grand Secretary September 1.
- 5. Only ministers who derive their support from preaching, and members who have been affiliated Master Masons for fifty years are exempt from dues to Grand Lodge, but ALL pay the Home Assessment. If a minister who is in charge of a church, put "Rev." after his name. If a Master Mason, affiliated for 50 years, put "50 years" after his name, and in the margin give name and number of lodge in which he was initiated, and date of making. These must be given to secure credit.
  - 6. An officer can not resign or demit.
- 7. "Life members" and "Honorary members" are not recognized.
- 8. Lodges U. D. are governed by the same rules as chartered lodges, except they do not elect officers and need not have a seal.

The penalty for non-compliance with the law is a \$5 fine, which must be paid or charter is forfeited. (See proceedings 1898, page 54.)

Answer questions about return *promptly*, or errors will appear in printed proceedings. The printer can not wait.
