

## FIRST DAY'S PROCEEDINGS.

#### MORNING SESSION.

LANCASTER, KY., May 24, 1900.

The Eighteenth Annual Encampment of the Grand Army of the Republic, Department of Kentucky, was called to order in the Court-house, at 9 a. m., Department Commander Joseph H. Browning in the chair.

The Comrades were welcomed by Messrs. L. Walker and W. T. Williams and Comrade Wm. Herndon, all of Lancaster, and responded to by Comrade Capt. Carr, of Glasgow, in behalf of the Department of Kentucky, G. A. R.

Department Chaplain P. H. Jackman invoked Divine blessing. Roll called and all officers answered to their names.

Department Commander Joseph H. Browning appointed Comrade P. B. Cloud, of Post 75, Officer of the Day, and Comrades John Fey and G. W. Smith, Officers of the Guard.



# DEPARTMENT COMMANDER'S ADDRESS.

COMRADES:-

At your Seventeenth Annual Encampment, held at Glasgow, Ky., May 23 and 24, 1899, one year ago, you kindly bestowed upon me the highest honors within your gift. Today at the close of my official term you expect of me an account of stewardship and are to pass judgment upon the administration for which you justly hold me responsible.

The reports of the several members of the Department Staff which will be submitted to the Encampment shows that they have each zealously and faithfully discharged the duties of their several offices, and for the very efficient aid and assistance which they have been so ready and willing at all times to render to the Department Commander he makes his grateful acknowledgements.

The reports of the Assistant Adjutant General shows the losses by death sustained during the last year to have been 85. Comrades in good standing, 3,290. Lost from all sources, 142. From this time on our numbers will necessarily decrease. Death is no respecter of persons. Many of us have already reached the three score and ten limit of human life, more of us are rapidly hastening towards it. There are none of us who have not seen the spring flowers and the falling autumn leaves of more than half a century. No young blood can ever be transmitted into the veins of the Grand Army of the Republic, no young men can ever be enrolled in its ranks. With our lives it goes out forever, henceforth to be a notable page in the history of the great republic.

A few posts have surrendered their charters or have been disbanded, and no new ones chartered, and in the main the condition of the posts throughout the department is satisfactory.

The Assistant Quartermaster General's report shows that the financial affairs of the department have been conducted with economy, but the resources of the department are not sufficient to meet the expenses. The per capita tax will have to be raised or the running expenses will have to be reduced, and I hope this department will take some action in this matter.

Your time will not be taken up by special comments upon the reports of the other members of the department staff. They will be duly examined and reported upon by the several appropriate committees. Doubtless they will receive your hearty approval.

At the Thirty-third National Encampment at Philadelphia, September 5 to 9, 1900, this department made a very creditable showing. There was a goodly number of Comrades present and took part in the parade. For the number in attendance and the very excellent appearance made by the Comrades and to all Comrades present at the National Encampment your Commander is indebted in many ways, for which he returns his grateful acknowledgements.

When we came together in Department Encampment on the 23d and 24th of May, 1899, at Glasgow, we had with us two Comrades whom the most of us saw in life that day for the last time.

Noble, tried, true, never found wanting. One was Comrade George A. Jones. He was personally known to most of you. Had served you as Junior Vice Commander, was elected in Bowling Green, 1894; the other was Comrade Wentzell, who had served two terms on the Council of Administration, 1898 to 1900. These Comrades we all delighted to meet, and no good Comrade knew them but to love and trust them. Little did we think that to-day would find us mourning their deaths. But so it was, and while we mourn them as departed Comrades we may

Mere words cannot express the deep sense of gratitude which your Commander feels for the good and generous work the noble women of the Corps have done and are daily doing for the old soldiers and the families of those of our Comrades who have crossed to the other shore.

The unselfish devotion of our sisters to the best interests of the Grand Army in justice to the Women's Relief Corps demands at our hands, Comrades, something more than mere idle words of thanks or praise. It requires of us all faithful service and honest effort to promote and strengthen it in its beneficent work. bless the Woman's Relief Corps, is a fitting prayer to come from the hearts and the lips of every veteran soldier of the Union army. Much that is good and commendable has been done by the Ladies of the Grand Army and by the Daughters of Veterans, and it is to be greatly regretted that separate organizations composed of such worthy members have been allowed to exist when all are eligible to membership in the relief corps. It is to be hoped that the future may happily solve the problem of how to unite them and that ere long the sisterhood of the relief corps may gather within its membership all the loyal women of the nation.

#### THE SONS OF VETERANS.

The Grand Army has always a kind word and extended a helping hand to the Sons of Veterans. The organizations of our boys into a social society for fraternal and patriotic purposes was a noble and praiseworthy undertaking and has been productive of much good to

the country. We can not have too many societies based upon a love for the country and veneration for its defenders. Your Commander is assured that the organization is prosperous, and he congratulates the Commander of this organization in this State upon the very excellent record he has made as administrator of its affairs, he bespeaks for the Sons the hearty support and eucouragement of all our Comrades and extends to them his best wishes for their growth and prosperity.

#### HARMONY IN THE DEPARTMENT.

Your Commander takes great pleasure in announcing that during the year in which he has been entrusted with the command of the department nothing has occurred to disturb the harmony and fraternity which ought at all times exist among the Comrades of the Grand Army. He has undertaken no work beyond that of an honest effort for peace, cultivate fraternity and encourage the posts within his command, and he can justly claim to have done so through his Judge Advocate General, Michael Minton, that today there is less of factional strife, less of contention and unpleasant feeling among Comrades than at any former time since he has been at all active in its affairs.

Comrades, it is duty we all see that every soldier's grave is marked by a head stone so that those who come after us will know there lies a defender of our country. Get the name, company and regiment of soldier, make a requisition on the United States Quartermaster at Washington, who will have the headstone made and delivered at your railroad station without charge to you.

#### MEMORIAL DAY.

This should be a sacred day to the old soldier when we spread flowers over the graves. The day is better observed in our department now than ever before. Now half of our city turns out to hear the speeches and see the flowers strewn. A law of our order is that all

posts must attend divine service the Sunday before Decoration Day. I hope all posts will observe this law. Where it is not convenient to hear divine service, the Post Commander should order the post to assemble and have the Chaplain deliver a prayer.

In conclusion, your Commander gratefully acknowledges the many courtesies extended him on all occasions during his official term. He has everywhere been cheerfully aided and assisted by his comrades in his efforts to establish and maintain harmony and good feeling towards each other among all the members of the Grand Army, and his only regret is that he has not been able to visit more posts, to meet and to greet more of his comrades, and to better discharge the responsible and important duties of his office and when I again return to the ranks it will be my pleasant duty at all times to do my full duty for the prosperity of our noble order, the Grand Army of the Republic.

III. In compliance with the rules and regulations, the annual inspections of all posts in this department will be made prior to December 31st, 1899. Blank form H for such inspection is furnished each Post Commander, and attention is called to the fact that installation of newly-elected officers can not be held until this report has been properly made out and mailed to B. Matthews, Assistant Adjutant General, who, after obtaining the necessary data, will furnish the same to the Department Inspector and Assistant Inspector, who has been appointed in each post for the purpose of attending to this inspection, who is expected to make prompt report if for any reason it is so desired. However, the Post Commander on the meeting night designated for the inspection may appoint some Comrade present for the purpose, selecting the one best adapted for the responsible duties. The form of the inspection will be found in the service book.

Under the rules and regulations, the officers-elect of the post can not be installed until the report of inspection, with all other reports due and the per capita, have been properly made out and forwarded to headquarters of Department. It is very desirable when practicable that the post have public installations, inviting to be present all kindred organizations and everyone in sympathy with the noble objects of our order.

IV. The Post Surgeon's reports for the entire year, ending December 31, should be compiled promptly. It is the duty of Post Adjutants to aid the Post Surgeons in this report, or when necessary make them out and forward them themselves to the Assistant Adjutant General, who desires the data before forwarding to the Medical Director. A careful record should be appended to this report giving the usual details regarding the death of all Comrades during the year 1899.

V. By request the following extract from a recent letter received from William H. Baker, Surgeon General, is published: "Inasmuch as the report of the Surgeon has to be made up for the year, December 31, 1899, it is very important that the Post Surgeons make prompt reports on the proper blanks to the Department Headquarters as soon after that date as possible. In many cases, Comrades without medical education are elected as Post Surgeons, a great many of whom do not feel competent to properly fill the blank. In all such cases, Post Commanders are earnestly requested to have the Adjutants of the post attend to it, answering all questions as well as possible. Have it signed by the Surgeon and forwarded to Department Headquarters. By proper attention to this, the Surgeon General will be enabled to make a report to the National Encampment that will be a credit

to the department." We urge Post Commanders of this department to a prompt and cheerful compliance with this reasonable request.

VI. The Commander-in-Chief has made a most earnest appeal to posts to use every reasonable effort to reinstate all worthy members, who have been dropped or suspended for the non-payment of dues. There is still many an old soldier in this department who from his limited income can ill spare the small amount of his per capita tax. We can appreciate the natural pride which prevents his request that the same be remitted. As an act of charity we urge that the dues of worthy members of this class be remitted voluntarily by action of the post, with an assurance that it is not offered in the line of charity, but as a concession that under the circumstances is eminently due him, and that he will be as cordially welcomed to the privileges of the post as is the most wealthy and generous member. If desired, the member might be asked to contribute, if able, a sufficient amount to cover the cost of his per capita tax to the department.

VII. The Women's Relief Corps and the Ladies of the G. A. R. will hold their annual meeting with us at Lancaster on the same dates of our meeting.

VIII Comrades, under the laws of our State it is a violation of the law to wear any emblem, such as a badge, pin or button, that represents orders to which a man does not belong. Post Commanders are requested to do all in their power to stop Comrades who have been dropped from the rolls of this Department from wearing any of the emblems of our order. A Comrade who does not love the principals of our order well enough to pay his per capita tax and remain in good standing in his post should not want to wear the emblem of the ordor. Comrades, see that none wear the badge or button of honor where you live, unless they do so rightfully.

Chapter 10—An act to prohibit the wearing of badges of societies by others than members thereof:

Be it enacted by the General Assembly of the Commonwealth of Kentucky, Section 1, that any person who shall wilfully wear the badge of the Grand Army of the Republic, Masonic, Old Fellows, Knights of Pythias, Knights of Honor, Confederate Veterans, or other similiar secret societies, or who shall wear the same to obtain aid or assistance thereby within this State, unless they shall be entitled to wear or use the same under the rules and regulations governing said organization. shall be guilty of a misdemeanor, and upon conviction shall be punished by imprisonment for a term not exceeding thirty days in the county jail, or a fine not to exceed \$20, or by both such fine and imprisonment. Section 2—This act shall be in full force and effect from and after its passage. Approved March 17, 1896.

IX. The headquarters here will be closed on and after May

16, to give the Quartermaster General time to close up the business and get his reports for the Encampment. Headquarters will be opened again on May 24, at Lancaster. No requisition for supplies will be filled after May 16. Comrades should bear this in mind. The official train, carrying the Department Commander and staff, will leave Louisville Wednesday morning, May 23, at 8:30 a. m. The L. & N. road is the official route. All Comrades will try to reach Louisville so as to go on this train.

I again invite you to come and go with us, Comrades. Again submitting our cause to God, with thanks for his mercy and favors in all days past and asking continuance of the same.

MEMORIAL DAY CIRCULAR:

On the 30th day of May will occur our sacred Memorial Day services.

Thirty-six years have passed since peace dawned upon our land and established the righteousness of the cause for which our Comrades, forsaking home and loved ones, marched at the call of duty and endured the trials and privations of camp, march, hospital or prison. Those escaping immediate mortality and, bearing the resulting infirmities, have surrendered one by one as the years have gone by.

More than a million "tents of green" mark the final camp of those whose lives were offered to save the Republic, and each return of spring-time, with its fragrance and bloom, finds new-made mounds in the silent camp, calling for more markers and flags, more wreaths and flowers. At the grave we know no distinction but that of comradeship, and the beautiful flowers of spring and the flag they all loved are placed with the same tenderness and fond remembrance upon the graves of the humblest private as upon that of the leader of armies.

Since our last Memorial Day a new generation has been added to the list of the heroes of our nation, and already the little green mounds are beginning to appear upon the hillsides of our land, marking the resting places of our sons who have given their lives for the country they have been taught by their noble sires T:

Let them learn to sing the songs and love the flag they wave in honor of the soldier dead, and the nation will never lack defenders when in the coming years it is left to their care.

#### AFTERNOON SESSION.

Promptly at 2 p. m. Department Commander Joseph H. Browning called the Encampment to order, Department Chaplain P. H. Jackman asking divine blessing.

The newly-elected Senior Vice Commander, Wm. Herndon, presented Department Commander Browning with a very fine gavel, which was received with thanks by Commander Browning.

Junior Vice Commander-in-Chief Michael Minton stepped to the Department Commander's desk and presented Department Commander Browning with a beautiful Past Department Commander's badge, solid gold inlaid with diamonds. Junior Vice Commander-in-Chief Minton said: "I have been chosen by your Comrades to perform a very pleasant duty, and to express to you their best wishes and their high appreciation of your services as Commander of this Department.

The great interest which you have taken in the welfare and advancement of our order, the zeal with which you have discharged every duty pertaining to your high office; your impartial rulings as presiding officer and courteous treatment of every one has endeared you to each and every member of our order.

We know the fidelity and loyalty with which you have served this department in the various positions committed to your charge. We know that as soldier, citizen and Comrade you have discharged all duties as a good and faithful servant.

Dear Commander, I have known you since as little barefoot boys we played together. In all that time you have been to me more than a friend, and now I present to you from your Comrades of this department, with their love and prayers, this badge, emblem of our glorious order, the Grand Army of the Republic. Take it and wear it over a heart as true and loyal as ever went forth to battle in defense of home and country."

Commander Browning's emotion was so great that his response was brief, but full of feeling: "I thank you, my Comrades."

Michael Minton placed in nomination for Department Chaplain Comrade I. P. Marrs, of Louisville, and was seconded by Assistant Quartermaster General John Blaes. There being no further nominations, he was elected unanimously, Assistant Adjutant General B. Matthews casting the ballot for the Encampment.

Past Commander John W. Hammond, in a very neat speech, placed Past Department Commander Wm. Bowman in nomination for Medical Director, seconded by many Comrades. He was elected unanimously, Assistant Adjutant General B. Matthews casting the ballot.

Past Department Commander Michael Minton placed present Historian Comrade Geo. W. Saunders, of Mayfield, in nomination for Department Historian, seconded by Assistant Quartermaster General John Blaes. He was unanimously elected. Assistant Adjutant General B. Matthews casting the vote of the Encampment.

The Officer of the Guard announced that a committee of the Women's Relief Corps was in waiting at the door. The business of the Encampment was suspended. The Department Commander appointed the Comrades' newly elected Department Commander, L. M. Drye, Assistant Quartermaster General John Blaes and Comrade Judge Reuben Buckley to escort the ladies in. They were introduced by Comrade Drye. Mrs. Mary L. Reynolds, Department Secretary, in a neat and appropriate speech, presented the report of the Women's Relief Corps of the Department of Kentucky. Department Commander Browning appointed Assistant Quartermaster John Blaes to respond, who did credit to this honor. The committee then retired and the Encampment resumed its business.

The following Comrades were placed in nominations for Delegates to the National Encampment in Chicago, August 28, 1900: Warfield Carpenter, J. R. Spires, John Blaes, B. Matthews, Edward Vincent, Lewis Robinson, Phil Hager, M. L. Anderson, R. M. Buckley, Phil Roberts, C. C. Degman, S. D. Van Pelt, James B. Hicks and Boone Rigsbee. It was resolved that the five Comrades receiving the highest number of votes should be declared elected Delegates, and the next highest number the alternates.

The result of the election was as follows:

Delegates—R. M. Buckley, 106 votes; John Blaes, 101; B. Matthews, 98; Phil Hager, 96: Warfield Carpenter, 94.

Alternates—S. L. Van Pelt, 56; Edward Vincent, 42; C. C. Degman, 26; Phil Roberts, 26: Ed Robinson, 21.

The Comrades were declared duly elected Delegates and Alternates respectively.

Nominations for the selection of the place to hold the next Encampment was next in order. Past Department Commander O. A. Reynolds invited the Encampment to come to Covington in 1901. Past Department Commander Michael Minton spoke in favor of Covington, and Quartermaster General John Blaes moved that the Encampment go to Covington, which was carried by acclamation.

The Committee on Resolutions, to whom was referred the report of the Commander, offered the following resolution:

Whereas, It appears from the reports of the Department Commander and his assistants that the expenses have exceeded the income of the department, the Department Commander recommends increasing the per capita tax in order to meet the deficit. Therefore be it G

The Officer of the Guard announced that the Ladies of the G. A. R. were in waiting. Department Commander appointed Comrades newly elected Department Commander L. M. Drye, John Blaes and R. M. Buckley a committee to escort the ladies in, who introduced Mrs. Troll, Mrs. B. Laemmlein and Mrs. Hillerich, who in turn presented their report. See report L. G. A. R. Comrade Judge R. M. Buckley responded to address of Mrs. Hillerich in well chosen remarks.

Comrade Wm. Herndon offered a resolution that the pictures of all Past Department Commanders, whose pictures have not already been printed in former Journals, be printed in this year's Journal, which was approved by the Committee on Resolutions, and agreed to by the Encampment, providing that each Past Department Commander will furnish his own cut.

The following communication from the people of Perryville was read:

To the State Encampment of the G. A. R., now convened at Lancaster Ky.:

We, the people of Perryville, ask your august body to meet with us. We are struggling for a park to be erected at our place,


EMINENCE, KY., May 21, 1900.





# JUDGE ADVOCATE'S REPORT.

Office of Judge Advocate, Department of Kentucky, G. A. R., Louisville, Ky., May 22, 1900. C. Matthews, Asst. Adjt. General:

DEAR SIR AND COMRADE—I have the honor and pleasure to submit to you my report as Judge Advocate of this Department. Through you I desire to tender my thanks to our Commander General Joseph H. Browning for the honor conferred upon me by the appointment to this high office, and to the other officers of this Department for many courtesies shown me during my term of office. I am gratified with the harmony and good will which has prevailed throughout the Department since our last Encampment, which good feeling accounts for the small amount of work referred to me.

#### DECISION No. 1

IN APPEAL OF CHAS. MAUNDERS.

LOUISVILLE, KY., August 12, 1899.

Comrade Chas. Maunders, S. V. C., of Granville Moody Post No. 89, has appealed to the Department Commander from a finding of guilty of a Post Court Martial; also from a vote or decision of his Post, dropping him from the rolls of his Post. I am requested by the Department Commander for an opinion.

The record in the Court Martial proceedings before me is scant and meager, but purports to be a copy of the entire proceedings in that matter, and as it is upon the record as certified that I am required to give an opinion, I will be compelled to assume that only such things were done as are shown in the record, certified by the Post Adjutant.

It appears that Comrade Maunders was Chairman of a certain Drum Corps Committee of his Post, and it was claimed by his Post that he failed on demand to account for sums of money alleged to have come to his hands as such Chairman. Thereupon an attempt was made to court martial Comrade Maunders for his failure to account for the said and disobedience to an order of his Post to make a report as such Chairman.

The remedy by court martial proceedings is a very harsh one, and should be resorted to only after all brotherly efforts have failed, and when resorted to, the law and usages of the order must be strictly followed, as a court martial proceeding has all the characteristics of a criminal proceeding at the criminal law.

The record before me has the following entry as certified by the

Post Adjutant from the minutes of April 7, 1899: "A motion by Comrade James W. Ellis to prefer charges against Chas. Maunders as chairman of drum corps, so ordered. Charges—Contempt, specification, conduct prejudicial to good order and discipline."

Now it does not appear that a court martial was ever ordered convened by a majority vote of the Post. And this the only way in which a Post court martial can be convened or organized. See blue book 1899, page 286.

It is my opinion that the so-called court was never legally organized or convened, and that as a matter of fact it had no jurisdiction to try the accused, and that the finding is a nullity.

It is also my opinion that the specification is not sufficient in law. The object of a specification, like a warrant or indictment in a criminal proceeding, is to inform the accused of the exact nature of the offense charged against him. It is necessary in the specification to set forth the acts or deeds which constitute the offense so that the accused may know the nature of evidence for his conviction or acquittal.

If this specification were all that is required, there would be no end to the range of evidence that could be introduced. If it were the object to try Comrade Maunders for failing to account for funds of the Post in his hands, it should be so stated in the specification. Or if he were to be tried for failing to make a report of the acts of his committee, that should be set out in the specification.

It does not appear that the accused was notified of the time or place of trial, or that he was afforded the right to enter his appearance. In all court martial proceedings the accused should be served with a written notice of the time and place of trial, and should be furnished with a copy of the charges and specifications.

It does not appear that the accused Comrade was afforded an opportunity to enter a plea to the charges and specifications, nor that a plea was entered for him. In the absence of a plea, he could not legally have been found guilty unless there should appear something in the record showing that his absence was wilful.

Comrade Maunders, in his grounds of appeal, claims that he was not allowed to be present or make defense. In this he is borne out by the record before me. Now in every such case a Comrade is entitled to be present, to make defense, to cross examine the witnesses against him, to challenge members of the court and to give evidence and introduce witnesses in his behalf. He is also entitled to the assistance of counsel. Any member may act as such counsel, or he may have the assistance of a practical attorney, if such attorney be a member in good standing of the Grand Army of the Republic. If the

accused be denied any of these privileges, the finding should be reversed on appeal.

The law requires that all steps in court martial proceedings should be reduced to and kept in writing. This includes the charges, specification notices, vote of the Post ordering and convening the court, order of the Commander appointing court, naming President and Judge Advocate thereof, minutes of each meeting, the names and evidence in full of all witnesses, plea of accused, finding of the court, etc. Now it seems that nearly all these essential requirements of law were omitted in this case. There is not in this record a single word of evidence, and without the evidence, a finding of guilty ought not to be approved.

So far as shown by this record, there is no evidence that Comrade Maunders has, or ever had in his possession, any funds belonging to the Post, nor is there any evidence that he willfully refused to make a report.

It appears that the accused was severely censured—I assume in the presence of the members of the Post—thus executing the findings of the court. This ought not to have been done. It was a very irregular and uncalled for proceeding. Granting that the court had proceeded in a regular manner, its findings then should have been presented to the Post for approval or disapproval by a majority vote thereof. This was not done, and even had it been done and the findings approved by the Post, the sentence should not have been imposed until the appeal to the Department Dommander had been acted upon. The infliction of the punishment pending an appeal or before the accused was given a reasonable time to get his case before the Department Commander was a contempt of the authority of the Department Commander.

It appears to me that the action of the Post in dropping Comrade Maunders from the rolls was illegal. It appears to have been done on the same day he was censured, and has all the appearance of haste, ill-advised and uncalled for action. It looks what might be called a snap judgment against him.

The legal way to drop a member a year or more in arrearages for dues, is for the Post Quartermaster to notify him in writing of the amount due and request payment. Then if the dues are not paid within two months after notice and demand, the Post may by vote drop such members from the rolls. As Comrade Maunders was not so notified, the action of the Post in dropping him was illegal.

For the reasons herein given, I am of the opinion that the court martial proceedings are null and void, and that the findings thereof should be set aside, the charges and specification should be quashed, and the minutes of the Post censuring or reprimanding Comrade Maunders should be expunged. This is without prejudice, however, as new charges may be preferred, if instituted in a regular and proper manner. The vote of the Post dropping Comrade Maunders from the rolls should, by action of the Post, be set aside, and the Comrade restored to the privileges of a member and be given the opportunity to settle his arrearages, if any.

I think it would be well for the Post Commander to appoint a committee to confer with Comrade Maunders and hope that all differences may be thus amicably adjusted. Respectfully submitted,

From April, 1861, to April, 1865, Kentucky furnished for the defence of One Flag and One Country this great and grand army of her best young men.


# GEORGE A. JONES
