The results of inspection and the analyses of official samples of commercial feedstuffs sold in Kentucky during 1940 are given in this bulletin.* The tonnage, estimated from the number of guaranty tags issued, 350,000 tons, was about the average for Kentucky in normal years. During the year, 1,452 samples were analyzed chemically and microscopically and the results reported in detail with appropriate comment to those concerned.

The results of analyses as a whole showed that manufacturers met their guaranties well and deficiencies mostly were of a minor nature. It must be said, however, that the products of some manufacturers making low-grade filler feeds and of many small mills making wheat feeds are very poor. The records of these concerns are given in the summary of results in the latter part of this bulletin, and the individual concerns violating the law have been dealt with directly by the Department.

LOW-GRADE FEEDS

Many low-grade feeds are offered for sale in Kentucky. Because of their competitive nature, these feeds contain the cheapest and trashiest fillers that can be obtained, such as screenings, screenings refuse, weed seeds, hulls, chaff, waste by-products and highly fibrous materials.

The Feed Control Department tries in several ways to protect the feeder from the loss that usually results from buying and using these low-grade feeds.

First, telling the feeder that filler feeds are usually uneconomical and are the costliest feeds he can buy. They are uneconomical and costly because of their low productiveness as compared with high-quality feeds and because of the chance taken with the health of the animals when such feeds are used.

Second, establishing minimum chemical standards for straight byproduct feed materials and special-purpose feeds. The minimum allowed for protein is sufficiently high to assure a reasonable amount and, thereby, to indicate a desirable source. The minimum allowed for fat requires the use of materials that have not been degermed, and excludes excessive fillers of low fat content. The standard for fiber excludes excessive fillers and materials of a highly fibrous nature, and assures a high percentage of nitrogen-free extract. These standards were established for the purpose of protecting the feeder by requiring reasonable percentages of desirable protein and fat and by excluding or limiting the use of highly fibrous materials or fillers of various sorts having little or no feed value. The standards are adjusted from time to time when the need is indicated by experimental evidence.

Third, establishing a system of labeling to mark conspicuously certain important differences in the character of feeds, thereby making it easier for the purchaser to select feeds on the basis of their real value. A farmer who buys feeds intelligently must read and be guided by the information on the state tags or labels. The system of labeling will aid him materially. (See system of labeling, page 5.)

THE FEEDER'S PROBLEM

A feeder often has to select his feed under varying conditions. The cost of the feed as compared with the market prices of his produce such as milk, eggs, meat, and wool is an essential matter to be considered. At the same time he must know what his animals need and what feeds will supply these needs, if he is to succeed in his livestock enterprise. Publications of the Agricultural Experiment Station and of the Agricultural Extension Service are helpful in this connection.

The feeder has several aids to guide him in selecting a feed. He should never buy a feed that is not registered and labeled with an official guaranty tag. He should read the tag carefully and base his selection on the information in the guaranty rather than on the claims made by the salesmen. If a feed is not labeled, he should refuse to accept it regardless of any claims made for it. He can also safeguard himself by buying from reputable manufacturers who have good records and make good, clean feeds. He should look with suspicion on all yellow-tag feeds, as such feeds contain fillers of little or no feed value. Such fillers sometimes contain poisonous weed seeds, fungi, and inert material such as sand and dirt, and may therefore be dangerous. As a general rule, a feed containing a complex vitamin and mineral mixture is to be avoided, because a long list of materials has no particular merit and needed vitamins and minerals usually can be supplied at lower cost in simple materials.

The Feed Control Department constantly makes check analyses of feeds sold in Kentucky. The results are summarized and published with other valuable data on feeds and their use, in bulletins, which are sent free to any one interested. Other publications that should be of interest to feeders and are available to those who desire them, can be obtained from the county agricultural agent or by writing to the College of Agriculture Extension Service, Lexington.

"Vellow Tag" Feed

SYSTEM OF TAGGING

This Department groups feeds into three general classes: "straight" feeds, "straight mixed" feeds, and "yellow tag" feeds, and labels them accordingly. (See examples of these tags, page 4.) The purpose of this system of labeling is to mark conspicuously certain important differences in the character of feeds. It is designed to aid in the selection of feeds. The tags are issued according to a three-color scheme, as follows:

A manila tag printed in black ink designates a feed made from one grain or plant. This class of feeds is known as "straight" feeds. *Examples*: wheat bran, hominy feed, cotton-seed meal, alfalfa meal.

A manila tag printed in red ink designates a feed made from the products or byproducts of two or more grains, or plants, or animal byproducts. This class of feeds is known as "straight mixed" feeds. *Examples:* a mixture of wheat bran, hominy feed, and cottonseed meal; a mixture of corn chop, crimped oats, wheat bran, and alfalfa meal; or a mixture of yellow corn meal, wheat gray shorts, ground oats, alfalfa leaf meal, soybean oil meal, meat scrap, dried buttermilk.

A yellow tag printed in black ink designates a feed containing a material or materials of little or no nutritive value. Such are usually known as "yellow tag" feeds. Examples: feeds containing oat hulls, corn cobs, cottonseed hulls, screenings and screenings refuse or waste, or other similar materials containing an excessive percentage of fiber.

READ THE TAG

A farmer who buys his feeds on price instead of on quality, tho price is a factor always to be considered, is practicing false economy. In reality a feeder pays more for the nutrients in cheap, filler feeds than if he bought good, clean, well-balanced feeds at a somewhat higher price per bag. A cheap, filler feed may be the costliest feed a farmer can buy, because of the small amount and inferior quality of the nutrients and the unwhole-someness of the filler.

Let us illustrate by taking two dairy feeds, the first a 20-percent protein straight mixed feed containing ingredients of known quality and value, and the second a 16-percent protein filler or yellow-tag feed that contains (as such feeds usually do) the maximum percentage of filler allowed, which is 25 percent, of unknown and questionable value. It should be noted that while the fillers are low in nutrient value, as a general rule the other ingredients used in this type of feed are low in quality also.

Example 1—Containing Ingredients in the Proportions Usually Found in High-Grade, Well-Balanced Feeds

This feed will analyze approximately 20 percent protein, 4 percent fat, and 9 percent fiber. It would bear a manila tag printed in red.

The second is made of the usual ingredients found in "low-grade" filler feeds and proportioned in approximately the following manner:

This feed will analyze approximately 16 percent protein, 3.5 percent fat, and 15 percent fiber. It would bear a yellow tag printed in black.

The total digestible nutrients of Example 1 is approximately 61 percent while that of Example 2 is 40 percent. Calculating the cost of ingredients at local prices and allowing a reasonable

sum for mixing, handling and profit, Example 1 costs approximately 1 cent less per pound of total digestible nutrients than does Example 2. This shows a considerable saving in favor of the straight mixed feed.

QUALITY OF FEEDS

The usefulness of a feed as nourishment for an animal depends on the kind, amount, and quality of nutrients it contains, and the presence of the vitamins necessary for growth, maintenance, and reproduction. The feed must be palatable, free from poisonous or injurious substances, and must not contain too much indigestible material. The chemical analysis on the tag shows the percentages of the principal nutrients and the statement of ingredients helps a buyer to form an estimate of the probable digestibility, palatableness, and vitamin content of the feed.

The usual chemical analysis shows the percentages of the following substances, except vitamins.

Protein is the nitrogenous part of a feed. Animals use it for the building and repair of body tissues. However, when carbohydrates and fats are deficient in the diet, heat and energy can be obtained from protein, but this is usually undesirable both physiologically and economically. Protein is the most important and most costly constituent of feed materials. Plants build up protein from the inorganic elements of the soil and air. Protein from animal sources such as milk, meat scrap, and tankage—is plant protein which has been partly broken down by the digestive processes of the animal and reconstructed into the protein specific for the animal. The nutritional value of proteins differs greatly; therefore, it is well to select feed ingredients which contain the right kind of protein or to make up the ration from materials which contain more than one kind. Proteins derived from animal sources, such as milk, meat and meat byproducts, are very desirable for poultry, dogs, hogs, and young animals of They are not so necessary for mature animals, especially the ruminating animals, because these have the power to utilize other proteins.

Fat is a nutrient in feeds soluble in ether. It produces heat and energy in the animal economy, its value for such being 2.25

times that of either nitrogen-free extract or protein. Fats also help to maintain the normal function of the digestive tract, and excess fat may be stored in the body. Comparatively small amounts of fat are needed for animals. Most rations contain a sufficient amount.

Fiber is the woody portion or structural part of plants, grains, and outer grain coating. It consists mainly of cellulose, which has little feed value. When present in too large quantity, it has a retarding effect on the digestion of other nutrients and is itself only slightly digested. Its chief value appears to be its mechanical action in the intestinal tract, the cattle, sheep, and goats digest a considerable amount of it. Excessive fiber in a feed generally indicates that the percentage of essential nutrients is low and that their digestibility is impaired. Stems, hulls, and chaff are mainly fiber.

Ash is the mineral matter or residue obtained when a feed has been completely burned. The ash of clean vegetable materials contains mineral substances which the plant has taken from the soil. Most of these are essential constitutents of feeds. They form the bony structure of the animal and are essential in maintaining the normal functions. It follows that the same is true of some rations. Because of the nature of commercial feeds suitable for different kinds of animals, mineral deficiencies are more likely to occur in mixtures for poultry and hogs than in those for cattle, horses, and sheep. The mineral substances most commonly deficient are calcium and phosphorus. An excess amount of ash in a feed usually means the presence of inert matter, such as dirt or sand.

Water is present in all feeds. It adds nothing to their value because animals receive their main supply of water from other sources. Water reduces the value of a feed by decreasing the percentages of the other nutrients, and much water lowers the keeping quality of the feed.

Nitrogen-free extract. In making the usual chemical analysis of a feed, the chemist determines the percentages of protein, ether extract (fat), fiber, ash, and water and terms the remainder nitrogen-free extract. It is composed chiefly of starch and sugars, which are easily digestible. In grains it is practically all starch. Nitrogen-free extract and fat in the diet of an animal are oxidized to maintain body heat and produce energy for work.

While nitrogen-free extract is less than half as effective as fat in this respect, it is present in so much larger quantity that it is more important in a feed. Also, nitrogen-free extract may be used to produce fat stored in the body, as in fattening an animal.

Vitamins are organic food substances distinct from the more familiar nutrients (proteins, fats, carbohydrates, and minerals) but necessary in nutrition for normal growth and reproduction. Altho these substances are required only in very small quantities, some feeds do not contain enough for proper growth and productiveness. Deficiency in each vitamin leads to specific disease symptoms usually first manifested by lack of growth. Frequently, the feeder does not suspect a vitamin deficiency because he notices only retarded growth. The typical symptoms usually appear only in the later stages of the disease. When the feeder uses commercial feeds, he should select feeds made by reputable manufacturers whose record for making reliable feeds is good. When he is home-mixing feed, he should select only ingredients of high quality whose values are well known.

The vitamins are widely distributed in plant and animal materials commonly fed to livestock and poultry. Green feeds, legumes, and natural green hays are the principal sources of carotene (vitamin A) and riboflavin (vitamin G). All grains except yellow corn have very little vitamin-A activity, but are good sources of vitamin B. Vitamin E is present chiefly in leafy materials, vegetable and animal oils, and the germs of seeds, especially the germ of wheat. No feeds are good sources of vitamin D, the chief source for farm animals being direct sunlight and fish oils, or their equivalent.

The first principle of avoiding vitamin deficiencies in feeding is the maximum use of high-quality roughages and direct sunlight. High-quality roughages include green pasture, legume or grass silage, corn silage, leafy and green sun-cured legume hays. Animals that normally consume large quantities of roughage of this sort will not need special vitamin supplements. Poultry and hogs consume more concentrates than roughages and therefore should be given maximum use of green pasture and direct sunlight. However, when these are not available, they should be given a liberal amount of milk byproducts and alfalfa leaf meal. The most practical way to supply vitamin D

to confined fowls is to use biologically tested fish oil or its equivalent.

BETTER KNOWLEDGE OF FEEDING NEEDED

The Feed Control Department tries to protect users of commercial feeds by requiring to be printed on the state guaranty tag as complete information as possible on the composition of the feeds, and by limiting the content of a filler to 25 percent. Nevertheless, about 37,000 tons of "yellow tag" feed were sold in Kentucky last year, as estimated from the number of tags issued.

The fact that 37,000 tons of yellow-tag feed could be sold in the state points to the need of feeders for better knowledge of the feed requirements of livestock and the most practical way to supply those requirements. Farmers need a more general knowledge of feeds and their use, based upon well-established principles of nutrition. Farmers who have a good general knowledge of feeds and feeding are in a position to make better application of new nutritional discoveries.

The immediate need of most farmers is a sufficient practical knowledge of feeds to be able to select them on the basis of their quality and economical productiveness. Every farmer who grows livestock should understand the value of the feeds he grows on his farm and should know how to supplement those homegrown feeds with suitable materials to make a balanced ration. The Feed Control Department is endeavoring to carry as much practical information as possible to the feeders thru its inspection service, correspondence, and publications.

Many manufacturers are rendering valuable service to farmers in an educational way, but unfortunately some are confusing the minds of feeders, and because of this are doing the feed industry as well as the livestock industry a great harm thru extravagant claims of salesmen and advertising.

The Extension Service of the College of Agriculture thru a well defined and active program can render a distinct service to the farmer in this particular phase of his need. A feeder needing help on his feed program should call on his county agricultural agent or the Animal Husbandry or the Feed Control Departments of the Experiment Station, or some successful neighbor feeder.

ANALYSES OF SOYBEANS

The Feed Control Department has followed its usual custom in making analyses of certain feeding stuffs grown on the farm. In previous bulletins the results of analyses of corn, legumes and grasses have been reported. In this bulletin are given the analyses of soybeans grown in Henderson county, Kentucky.

The usual feed analysis was made of 30 samples of soybeans grown in Henderson County, representing 15 varieties of beans. Seventeen of the samples, grown on bottom land, had an average analysis of 39.7 percent protein, 18.4 percent fat, 5.4 percent fiber, 25.0 percent nitrogen-free extract, 6.7 percent water, 4.8 percent ash. The remaining 13 samples, grown on upland, had an average analysis of 30.4 percent protein, 21.5 percent fat, 5.6 percent fiber, 30.4 percent nitrogen-free extract, 6.1 percent water, 5.9 percent ash. The individual analysis of each sample is given in the table. The beans grown on the richer soil

averaged higher in protein and lower in fat and nitrogen-free extract than the same varieties grown on the poorer soil.

TONNAGE IN 1940

The total tonnage of feeds sold in Kentucky in 1940, computed from tax tags, was 353,138. The feeds are classified as straight by-product feeds, 177,720 tons; special-purpose feeds, 162,743 tons; stock feeds (idle stock), 9,485 tons; and miscellaneous, 3,190 tons.

Of the total tonnage, approximately 37,000 were yellow-tag or filler feeds. The maximum filler allowed is 25 percent. Practically all filler feeds contain this amount, but in order to be conservative, only 20 percent is used in this calculation which

gives 7,400 tons of fillers sold in feeds during 1940.

The formulas on page 6 used for comparison show that the average yellow-tag feed contains approximately two-thirds as much total digestible nutrients as does the straight-mixed feed. On this basis 24,666 tons of straight-mixed feed will supply the same amount of total digestible nutrients as 37,000 tons of yellow-tag feed. This means that at prevailing prices in 1940 the feeders of Kentucky lost \$270,000 in cash by purchasing yellow-tag feeds.

DOG FEEDS

Fifty-nine samples of dog feeds, 5 dry and 54 canned, were analyzed during 1940. The results were as follows: of 5 samples of dry feed, 4 equalled guaranty and 1 was misbranded; of the 54 samples of canned feed, 11 were deficient in protein, 10 in fat, 15 in net weight, 2 had excess fiber, 17 excess water, 20 were misbranded as to the ingredients and amounts of nutrients guaranteed, and only 20 equalled guaranty. The detailed results are printed in Table 2.
