

# CERTIFICATE OF PURCHASE AT TAX SALE.

THIS CERTIFIES THAT REASON S. JUDY, Collector of the State and County Revenue, in and for the County of Cass, in the State of Missouri, in accordance with the provisions of Chapter Thirteen of the General Statutes of the State of Missouri, 1865, concerning the collection of the Revenue, and by virtue of a Precept issued from the County Court of Cass County, Missouri, bearing date the 23<sup>rd</sup> day of July, 1868, did on the 5 day of October, 1868, publicly expose for sale, before the Court House door, in the City of Harrisonville in said County, continuing the sale from day to day, (Sundays excepted,) all the lands and town lots in said Precept described, and remaining unredeemed; and did sell separately, so much of each and every tract of Land and Town Lot as was sufficient to pay the taxes, interest and costs due thereon; at which sale R.
