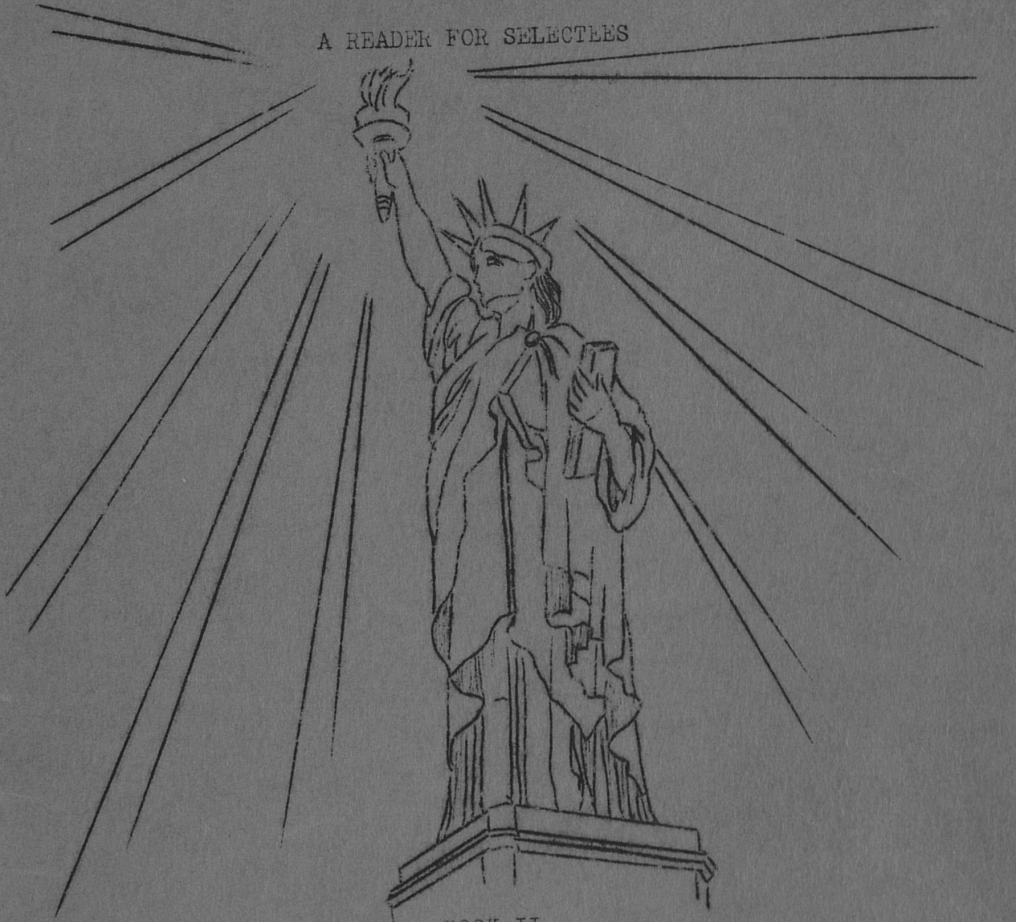

P R E F A C E

The purpose of this reader is to teach selectees rejected because of educational deficiencies, to read and understand their registration certificates and to write their names and addresses.

For selectees who have had no educational reading experience and do not know one letter or word, Book I of the Literacy Education Series is recommended. This reader is to be used with selectees who have limited reading ability.

The content of the reading is based on all words which appear on the registration certificate and other words needed for sentence structure. The content has been progressively approached step by step until the entire reading content of the card has been covered. Some of the words are above the fourth grade level, but if the right approach to teaching is made, the selectee should not have much difficulty.

The method of approach is through the selectee's interest in his registration certificate. The teacher will use sample registration certificates or selectee's own certificate. The card should be placed in the blank space above the reading content of each lesson. The content should be printed on flash cards and the blackboard and then associated with the words on the card. Arithmetic may also be taught by using the numbers on the card as an approach.

The reader can be used as a test of the selectees reading ability. After this reader has been mastered by the selectee, the teacher should secure the " Bulletin of Information for Persons Registered" as reading material. These bulletins should be secured by the superintendent from the selective service board for the teacher. The bulletin should contain information which will be of interest to the selectee.

The first edition has been tried out by a large number of teachers on WPA in the state and has been reviewed by the WPA Consultants of the Washington Staff of Education.
