The consumption of commercial feeds in the State, in 1934, estimated from license tags sold, was about the same as in 1933, the prices increased materially. During the year, 1,175 samples were analyzed and reported to those concerned. The results showed that the commercial feeds on the market in Kentucky were of high quality and free from adulteration and misbranding. Manufacturers conformed well to their guaranties and the feeders of the State were able to obtain commercial feeds of high quality, at reasonable prices. Three important feed products came into use in large volume this year, distillers' dried grains, brewers' dried grains and lespedeza. These are desirable feeds and their cost is reasonable.

DISTILLERS' AND BREWERS' DRIED GRAINS

The increased production of whisky and beer made available a large tonnage of distillers' and brewers' dried grains, both stock feeds of high quality. These products are defined as follows: Distillers' corn dried grains and Distillers' rye dried grains are the dried residues obtained in the manufacture of alcohol and distilled liquors from grain. The product must bear the designation indicating the cereal predominating.

Brewers' dried grains is the dried residue obtained in the manufacture of beer.

The residue left after distillation of the fermented mash, in the manufacture of alcohol from grain, whether for beverage or industrial use, is a thick slop of which about 95 percent is water and about five percent is solids, part in solution, but about fourfifths in the form of solid particles suspended in the liquid. Fermentation has removed most of the starch originally present in the grain, but practically all the protein, fat and fiber remain, so that this solid matter is richer in protein and fat, than the It is a desirable protein feed, when separated from the The usual procedure is to strain or press out as much water. of the suspended matter as practicable, dry it and market it as distillers' dried grains. Sometimes the thin liquid that goes thru the strainers is evaporated and the residue added to the main part. This procedure adds to the grains mineral matter and protein that otherwise would be wasted.

In brewing there is no distillation because the liquid is made directly into beer, but the general process of straining out the suspended matter and drying the byproduct is about the same as with distillers' grains. The byproduct is similar in feed value to distillers' dried grains, since the fermentation has concentrated the protein, fat, and fiber thru the elimination of starch.

Distillers' grains differ in character according to the kinds and proportions of grain used. If the proportion of corn is 90 percent, as in making straight corn whisky and alcohol, the residue is 30 to 35 percent protein, an exceedingly rich feed. A recent sample analyzed, protein 34.8 percent, fat 11.4 percent, fiber 9.5 percent. If a large proportion of some other grain, such as rye, is used with corn, the percentages of protein and fat are diminished and that of fiber is increased.

Distillers' and brewers' dried grains are high in protein and fat, and make excellent supplements for home-grown and other low-protein materials used in feeds, especially dairy feed. While they are high in digestible protein and carbohydrates, they cannot properly be compared with oil meals and some other

byproducts used as supplements, because distillers' dried grains contain protein from three different kinds of grain, namely corn, rye and barley, and the protein differs in kind and quality from that of other materials. Brewers dried grains contain protein of one grain only and differ in character more or less from other feed materials.

LESPEDEZA

In 1934, lespedeza was grown extensively in the State. Much of the hay was ground and used as lespedeza meal in mixed and special-purpose feeds. Analyses of samples of lespedeza meal ranged from 9.50 percent to 15.50 percent protein, 2 percent to 3.50 percent fat and 25 percent to 30 percent fiber. The analysis of lespedeza is somewhat lower than that of alfalfa grown in the same sections in Kentucky and the feed quality seems to be correspondingly lower. Lespedeza seed are very rich in nutrients, analyzing from 30 to 45 percent protein, 10 to 16 percent fat and 8.50 to 10.75 percent fiber.

Because of the interest among farmers in including lespedeza as a part of their program a great demand for seed was created. Threshing for seed was done on a large scale and two byproducts were obtained, screenings and stems. The screenings consist of materials common to the cleaning of seeds, such as weed seeds, hulls, chaff, stems, sticks, straw, dirt and sand. The screenings vary in quality according to the amount of lespedeza and weed seeds they contain, especially the lespedeza seed. The analyses range from 15 to 30 percent protein, 4 to 6 percent fat and 9 to 20 percent fiber.

The stems are ground and often are added to mixed feeds as lespedeza meal. When this is done it is misbranding which is a violation of the law. Stem meal varies somewhat in analysis according to the efficiency of the threshing process and the degree of ripeness of the hay. The more seed left in the stem byproduct, the higher the analysis will be. Analyses range in protein from 5 to 10 percent, fat from 1.50 to 2 percent, and fiber from 28 to 45 percent.

FAT CONTENT OF COMMERCIAL FEEDS

The fat content of feeds varied more than usual during the year. In many instances it was apparent that this was because

of the more perfect process of fat extraction in the manufacture of materials for human foods, the byproducts from which go into feeds. Examples: Meat byproducts were offered for registration under a guaranty of 0.5 percent fat; soybean oil meal 0.5 percent; corn gluten meal 1 percent; other oil-mill byproducts materially below former percentages; some wheat feeds and other byproduct feeds are very much lower in fat than formerly. When byproducts low in fat content are used in mixed and special-purpose feeds, the fat content of the mixture is perceptibly reduced.

Modern methods of manufacture which affect the fat content of byproducts also may affect the mineral and vitamin contents. Manufacturers have sensed this fact and are endeavoring to meet this condition by making special supplement mixtures containing mineral- and vitamin-carrying materials to be combined

with basic feed materials.

When a byproduct material has had nearly all the oil extracted, the keeping quality of the material may be affected. Oil is a protective substance, but it is problematical whether oil from another source when added as a supplement will preserve the basic product from which its natural oil has been almost entirely extracted.

Too much oil may have just as bad effect on the keeping quality of feed materials. Frequently, byproducts have been noted with oil content in excess of that amount occurring in the Tankage and rice bran are examples. natural products. Materials with excessive oil become rancid and would therefore affect any material with which they are mixed. During the year we have experienced high fat contents—greatly in excess of guaranties—apparently by reason of such products as noted above.

Manufacturers using cod liver oil should include the amount as part of the fat guaranty. It was evident in many instances that guaranties in fat were based on the ingredients other than cod liver oil. The fat determination is an excellent means of detecting whether or not ingredients present are as guaranteed. Manufacturers should make reasonably accurate fat guaranties.

In this class are grouped all feeds containing one or more materials of little or no feeding value. These feeds are called by the trade "yellow tag" or "adulterated" feeds. It is by the use of such fillers without declaration that most of the adulteration and misbranding is done. The most common fillers are screenings and screenings waste, oat hulls, clipped oat byproduct, flax plant byproduct, alfalfa stem meal and, more recently, lespedeza stem meal. Fillers used vary in kind and quality according to availability and price. Often a feeder has materials going to waste on his own farm which have as much feed value as some of the filler materials he buys in mixed feeds at handsome prices.

If fillers or adulterants when mixed with feeds could be placed on their own merit both in feed and money value, there could be little objection to using them in commercial feeds. But when disguised in whole or part by other materials, and sold to feeders at prices not commensurate with their feed value, such practice becomes objectionable from a legal as well as an economic standpoint.

Poisons, especially cumulative poisons, molds, disease germs and injurious materials are most likely found in the filler feeds that contain damaged and inferior grains and waste materials. Careful consideration should be given by feeders when buying such materials in feeds.

Filler feeds are rarely uniform. It is safe to say that no two shipments of the same brand of filler feed will have the same quality filler. Therefore, the feeder cannot expect uniform and satisfactory results in feeding such feeds.

DOG FOODS

During the last two or three years a tremendous trade in canned dog food has developed. It has been stated on good authority that canned dog food stood first, in 1934, in output of canned goods. Canned tomato goods stood second and this product exceeded five hundred million cans. Whether this estimate is correct or not, it is certain that the volume of canned

dog food is tremendous. The dog food industry has increased so rapidly that the business at this time is in a chaotic condition. In many instances the names of the products are misleading as to their composition, the ingredients incorrectly stated and the claims for the products extravagant. In addition to statements of content, such statements as "Government inspected", "Fit for human food" are often printed on the labels. It is reported on good authority by handlers of these products that in the larger cities a considerable amount of dog food is consumed by needy folk.

The manufacturing plants of this class of food are situated at strategic points to supply of materials, such as beef and beef byproducts, horse meats, fish and animal byproducts. These foods have as a base, an animal byproduct supplemented with cereals and other materials such as wheat, oats, soybean oil meal, rice, barley, alfalfa leaf meal, carrots, salt and cod liver oil.

The feedstuffs law requires all dog foods, regardless of the way they are packed, to be registered with the Feed Department of the Kentucky Agricultural Experiment Station and labeled with a State official label giving the manufacturer's guaranty, as in all stock foods. To offer for sale or sell any dog foods in the State, unless properly registered and labeled, is a violation of the State feed law and subjects the offender to prosecution.

MISCELLANEOUS ANALYSES

From year to year, the Department has made analyses of samples of feed and feed materials of a miscellaneous nature. Table 1 contains analyses of such samples received during 1933 and 1934. Earlier analyses of a similar nature are reported in Bulletin No. 340. Tables 2 and 3 include samples analyzed by the Department as a check on products found on the market. Extreme variation was noted in many instances due in part to the many processes and formulas in use in the revived brewing and distilling industry. Table 4 contains results of investigational work with lespedeza.
