ACTIVITIES OF ARISE, INC.

The Applied Research Institute for Social Equality, Inc. (ARISE) is a new non-partisan organization working in behalf of the urban poor and those persons and communities suffering from the results of racial discrimination. It was established as a not-for-profit corporation to act as a clearinghouse for intelligence, resource development and the dissemination of functional information adaptable for local consumption.

ARISE, Inc.'s overall purpose is to build a network of able, informed leaders of all races who will rely on research, fact-finding, and policy analysis to assist community-based-institutions by infusing practical applications in search for solutions.

Although ARISE, Inc. is not a membership organization, it will rely on *associates* and *volunteers* around the country to promote and carry out its work. Associates may represent academic institutions, community-based-organizations, public and business entities.

THE INSTITUTE AND ITS MISSION

- ♦ *To establish a national organizational vehicle to facilitate the application of research of solutions, transfer information on successful models, and train leadership who work on behalf of those communities suffering from the results of racial, ethnic discrimination and class isolation*
- ♦ *To establish a center/clearinghouse for community practitioners representing institutions in search for successful models or appropriate research findings adaptable for improving the quality of life in racially and economically isolated communities*
- ♦ *To bring scholars, business, and community leaders together who are concerned with improving the status of the urban poor and build a network of able and informed citizens of all races, relying on research, fact-finding, proven models, policy analysis and their wits as sources of power for positive societal changes.*

CIVIL RIGHTS NICHE

ARISE, Inc. accepts the thresholds of racial progress made possible by persistent advocacy, the enactment of civil rights legislation, and subsequent judicial rulings undergirding the constitutional basis for equal protection for all American citizens.

The Institute is dedicated to furthering and supporting interracial cooperation with public, private, and community sectors on an agenda for lasting, economic results-oriented change that will improve the quality of life for minorities and the poor. Traditional civil rights groups will benefit as many of their research efforts, program models, relevant studies, conference findings, public policy positions, will be made available to local communities. The Institute will become an extension of their efforts by insisting on moving from research findings and rhetoric to concrete applications.

The Institute seeks to accomplish these goals by working with applied researchers and model practitioners -- transferring their findings into practical initiatives to improve the quality of life for African Americans, other minorities, and the urban poor.
