## CLR GRANTS AND PROGRAMS

The Council on Library Resources has announced a number of grants and programs available to librarians which will be awarded to librarians in the coming year. The Academic Librarian Management Intern Program, which is offered biennially, will select up to three interns for the 1990-1991 academic year. Successful candidates will spend the academic year working with the director and senior administrative staff of a large and well-managed research library observing and participating in management activities and special assignments. Deadline for applications is October 16, 1989.

The CLR Fellows Program offers financial support to individuals who wish to undertake research or conduct analytical studies pertinent to library operations and services or to pursue other professional projects of importance. The program is open to professional staff members of academic, research, and public libraries. Applications are considered three times each year, on March 1, October 1, and December 1.

CLR Cooperative Research Grants are designed to support research projects proposed jointly by librarians and members of the teaching faculty. Grant deadlines are April 1 and December 1.

CLR Research Grants are meant to encourage exploration or the issues and questions posed by a changing information structure, with special attention to the needs of faculty and students and the services and responsibilities of academic and research libraries.
