STAFF ACTIVITIES

Sandra McAninch, head of the Government Publications/Map Department of King Library, has been elected to the position of Chair/elect of the American Library Association's Government Documents Round Table (ALA/GODORT), a national

interest group composed of nearly 2000 librarians. The Round Table's purpose is to provide a forum for discussion of problems and concerns relating to government information; for exchange of ideas by librarians working with or interested in government information; for initiating and supporting programs to increase availability, use and bibliographic control of government information; to increase communications between documents librarians and other librarians; and to contribute to the extension and improvement of education and training of documents librarians.

Sandee brings to this position her years of government documents experience acquired as the head of two federal depository collections, as an appointed member of the Depository Library Advisory Council to the Public Printer, as elected Clearinghouse Committee chair of ALA/GODORT's official publication, DtTP (Documents to the People) and Assistant Coordinator of the Federal Documents Task Force of the Round Table.

Sandee's current interest in and work with the joint Committee on Printing's Ad Hoc Committee studying the dissemination of government information in electronic format through the depository library program speaks clearly for her diligence in making government information free and accessible to the public. Antoinette Paris Powell, head of the Agriculture Library, recently published an article entitled, "Word-processing software: applications, selections, and use," in the May/June 1987 issue of Library Software Review. Originally presented as a paper at the SCIL '86 Conference in Atlanta, the article recommends procedures for selecting word-processing software, and the various ways that such software can be put to good use in a library setting.

Russell Powell, head of the Engineering Library, has had two books published in the past few months. The first is the second edition of Handbooks and Tables in Science and Technology, published by Oryx Press. The other, also published by Oryx Press, is Core List of Books and Journals in Science and Technology.

HUMANITIES PROJECTS IN
LIBRARIES
National Endowment for the
Humanities Grants

These grants support programs to increase public understanding of the humanities through the discovery, interpretation, and greater appreciation of books and other library resources.

Projects should address one of the following areas:

the appreciation and interpretation of cultural works; the illumination of historical ideas, figures, and events; or an understanding of the humanities disciplines. Two types of support are offered: planning grants for collaborative efforts between scholars and administrative staff to design programs, and implementation grants. 29TH ALLERTON INSTITUTE

The Allerton Institutes are sponsored by the Graduate School of Library and Information Science of the University of Illinois at Urbana-Champaign. The purposes of the Institute are 1) to provide an opportunity for library participants to reflect on the field of personnel management as it relates to libraries; 2) to provide current information and training on specific issues in personnel management; and 3) to provide an opportunity for participants to share ideas and problems of common interest related to personnel in libraries. The conference is held at Robert Allerton Park near Monticello, IL, on 1500 acres of woodlands and Allerton House, a 20 room Georgian mansion. Conference activities will be held in Allerton House, and limited accommodations are also available there.

This year's Institute address "Critical Issues in Library Personnel Management"

and will be held November 6 - 8, 1987. The conference will touch on building job commitment among employees, various collective bargaining issues, recruitment, support staff, employee turnover, performance evaluations, managing resistance to change, employee productivity, stress, wage and compensation, and discipline. Speakers include Martin Maehr (co-author of The Motivation Factor: A Theory of Personal Investment); Kathleen Heim, Dean, School of Library Science, Louisiana State University; Sheila Creth, Director, University of Iowa Libraries; Charles Martell, Jr., California State University; and Charles Bunge, University of Wisconsin--Madison.

The total fee for the conference is \$350, which includes registration, room and meals (including snacks!) Not only that, but according to Treasury regulation Section 1.162-5 permits an income tax deduction for certain expenses undertaken to maintain or improve skills required in one's employment, and to meet express requirements of an employer or law imposed as a condition to retention of a job or employment. Registration is limited.
