

Minutes of the University Faculty, October 14, 1957

The University Faculty met at 4:00 p.m., Monday, October 14, 1957 in the Assembly Room of Lafferty Hall. President Dickey presided. Members absent were A. D. Albright, N. B. Allison, C. The minutes of July 31 were read and approved.

The report of the Faculty Committee on Elections was presented by Dr. Dana G. Card, Chairman. The University Faculty approved the report of the Elections Committee and President Dickey expressed a welcome to new members and to members who had returned from leave of absence.

Dear President Dickey:

This is to certify the results of the current election of members for the University Faculty. The persons elected are listed according to the group to which they belong.

In accordance with our telephone conversation of several days ago, persons have been elected to fill all vacancies. Those with the largest number of votes are listed for the three-year terms, and those with the next highest number of votes are listed to fill vacancies caused by death, resignation, or leave of absence.

Literature, Philosophy and Arts

Seven vacancies were to be filled from this group. Six elected to three-year terms are: Jacob H. Adler, Jesse DeBoer, Maurice A. Hatch, Arthur K. Moore, Edward W. Rannels, and Kenneth R. Wright.

Alberta Server was elected to replace Dr. D. V. Hegeman whose term expires in 1959.

Social Studies

Five vacancies were to be filled from this group. One was to come from the Department of Social Work in accordance with the rule that each department in the College of Arts and Sciences must be represented on the Faculty at least once in four years. Harold E. Wetzel was elected from the Department of Social Work for a period of three years terminating in 1960. Three others were elected for three-year terms to expire in 1960. They are: Carl B. Cone, Thomas P. Field, and Gladys M. Kammerer.

Thomas D. Clark was elected for one year to replace Dr. J. B. Shannon whose term expires in 1958.

Four vacancies were to be filled from this group. Three were elected for three-year terms to expire in 1960. They are: Richard S. Allen, Wilbur A. Heinz, and Frank A. Pattie.

Physical Sciences

Agriculture

Five vacancies were to be filled from this group. Four were elected for three-year terms ending in 1960. They are: Lawrence A. Bradford, George B. Byers, Wyatt M. Insko, and Drayton T. Kinard.

Herbert F. Massey was elected for two years to take the place of Harald R. Jensen whose term expires in 1959.

Home Economics

One vacancy was to be filled from this group. Abby L. Marlatt was elected for a three-year term ending in 1960.

Engineering

Two vacancies were to be filled from this group. Those elected for a three-year term ending in 1960 are: Sam C. Hite and Warren M. Walton.

Education

Three vacancies were to be filled from this group. Morris Cierley was elected for a three-year term ending in 1960. Leonard E. Meece was elected for two years to replace Dr. Fred E. Harris whose term expires in 1959. Vernon A. Musselman was elected for one year to replace Dr. A. D. Albright whose term expires in 1958.

Commerce

Two vacancies were to be filled in this group. Joseph L. Massie and H. W. Hargreaves were elected for three-year terms ending in 1960.

The elections committee was composed of Staley F. Adams, Wendell E. Beals, Thompson R. Bryant, John M. Carpenter, James C. Eaves, Helen M. Reed, John E. Reeves, Dorothy Salmon, and Jonah W. D. Skiles.

Resolutions on the deaths of Dr. D. V. Hegeman and Dr. Ernest Meyers were presented by Dean White and resolutions on the death of Professor Morris Beebe were presented by Professor Crouse.

Resolution on the Death of Dr. Daniel V. Hegeman

Dr. Daniel V. Hegeman came to the University of Kentucky as a member of the Modern Foreign Language Department in 1934. Dr. Hegeman had earned his B.A. degree from Princeton and his Ph. D. degree from Yale, and during the process he had displayed such intellectual capacity that his teachers recommended him wholly and without reservation in the most glowing terms.

During his years of service at the University, Dr. Hegeman distinguished himself as an excellent teacher. In the classroom he was admired and respected by his students, and his superior students were inspired to unusual intellectual efforts. By students and staff alike he was recognized as a superior teacher with a high sense of duty and intellectual integrity. He was one of those rare teachers who leave a lasting impression students.

As a member of the faculty, Dr. Hegeman took an active part in affairs of the campus. He served on numerous committees where he was inclined to be a silent member. However, when he saw fit to speak he was listened to with respect and consideration. Among his numerous services were included the presidency of Phi Beta Kappa, the University Faculty Club on the campus, and he had most recently been active in the newly organized Faculty-Alumni Club at the Coldstream Farm.

Dr. Hegeman's death on May 28, 1957, was a distinct loss to the University. He was a gentleman, a scholar, and a teacher of the sort who will not easily be replaced.

It is recommended that a copy of these expressions of respect be made a part of the minutes of this body, and that a copy be sent to his family.

Resolution on the Death of Dr. Ernest Meyers

Dr. Ernest Meyers came to the University of Kentucky as Instructor in 1948. During the next nine years he served the University as Instructor, Assistant Professor and Associate Professor and served the Arts and Sciences Faculty as Secretary for the past two years. His death came suddenly and unexpectedly, to to coronary occlusion, on July 20, 1957, when he was thirty-eight years of age.

Dr. Meyers was born in Pittsburgh, Pennsylvania on June 25, 1919. He earned his B.S. degree at Rutgers University and the Masters and Ph.D. degrees at Columbia University.

During most of his teaching career at the University of Kentucky he held the major responsibility for the course in introductory psychology and through this work, had wide contact with and considerable influence on a large number of students. The students of the University have lost an understanding, patient, stimulating, friendly teacher. He gave much of his personal time to individual counseling and instruction.

He was an interested and active participant in many organizations on the campus and in the community. In recent years he had been able to give more time to research and writing and two of his papers were accepted for publication during the past year. At the time of his death he was engaged in an investigation of the readability of Braille printing. Many theses and dissertations prepared by graduate students bore the imprint of his thinking and counsel.

The Faculty of the College of Arts and Sciences would like to express a deep sense of personal loss. This committee recommends that this statement be made a part of the minutes of the Faculty and that a copy be sent to his family.

Unanimously passed by the Faculty of the College of Arts and Sciences, September 30, 1957.

Morris Wilson Beebe, retired Associate Professor of Metallurgical Engineering, who had been on an extended leave of absence since 1948 on account of his health, died unexpectedly of a heart attack on May 5 last.

Beeb, as he was affectionately known to his associates and his students, was a native of Apalachin, New York. He received his early education in the schools of that city and later was graduated from Syracuse University with a Bachelor of Science degree in Chemistry, subsequently receiving a Master of Science degree in Metallurgical Engineering from the University of Kentucky.

He was appointed a part time Instructor in Metallurgical Engineering at the University in 1922, later being advanced to Assistant Professor and Associate Professor, the position he held when his health forced his retirement in 1948.

Professor Beebe held membership in Alpha Chi Rho social fraternity, Alpha Chi Sigma, honorary chemical fraternity, Tau Beta Pi, honorary engineering fraternity and the Kentucky Society of Professional Engineers. He was also a member of the Board of Stewards of the First Methodist Church, a Mason and a veteran of the first World War.

Professor Beebe joined the staff of the College of Engineering during the initial growth of the Department of Metallurgical Engineering and his wise council and unstinted effort and support had much to do with the development of that program.

He was always kind, courteous and considerate in his relations with all of those with whom he came in contact, always willing to give freely of himself for the good of others.

The ideals of living which he exemplified will be carried far into the future in the lives of the students who came into the orbit of his influence.

Professor Beebe was in every meaning of the word a Good man and he will be greatly and sincerely missed.

The Faculty voted that these resolutions be included in the minutes.

Dr. Koppius, Chairman of the Schedule Committee, reminded the Faculty that the Committee had been asked last year to make a study of the Calendar for 1958-59 before it was presented to the University Faculty for approval. He announced that the Committee had held one meeting and would hold other meetings before the November Faculty meeting and that they would welcome any suggestions that any member of the Faculty wished to present. He asked that these suggestions be presented in writing. The next meeting of the Schedule Committee was set for Monday, October 21.

Dean Slone presented for the College of Pharmacy a recommendation that William Ament Beeler, Jr. be awarded the degree, Bachelor of Science in Pharmacy, as of October 14, 1957. Mr. Beeler completed his requirements in August 1957 after the end of the Summer Session. He wishes to take a State Board Examination in January for licensure and to do so must be certified as a graduate. The University Faculty approved recommending Mr. Beeler to the Board of Trustees for the degree, Bachelor of Science in Pharmacy.

Dean Spivey presented for the Graduate Council recommendations for the approval of graduate credit for two Home Economics courses previously approved for undergraduate credit. These courses were approved by the Faculty.

1. The Graduate Council recommends approval of graduate credit for the following courses, previously approved by the University Faculty for undergraduate credit.

- Home Economics 133. Fashion (2)
How the fashion world works. Study of French, Italian and American designers who have greatest influence on current trends. Field trips to augment lectures. Lecture - two hours.
Prerequisites: Home Economics 27; Home Economics 134
- Home Economics 180. Aging and Later Maturity (3)
Aging and the years of later maturity; with respect to characteristic adjustment problems and potentialities of retirement, employment, living arrangements, mental health, family relationships.

Dean Spivey also presented for the Graduate Faculty recommendations for approval of a doctoral major in Guidance and Counseling to be administered jointly by the College of Education and the Psychology Department. The recommendation of the Graduate Faculty was approved by the University Faculty.

President Dickey read to the Faculty a statement regarding the election of faculty members to faculty-board committee.

STATEMENT REGARDING ELECTION OF FACULTY MEMBERS
TO FACULTY-BOARD CONFERENCE COMMITTEE

In my estimation this is one of the most important faculty meetings which we have had in some time. I make this remark because at this session we are embarking upon several ventures which involve greater participation of the faculty in certain areas of University affairs. I hope that you have the same view as I regarding these moves - namely, that they are steps in the right direction.

During the summer - at our last faculty meeting - a Faculty Committee on Committees was established and this Committee has taken its first step by recommending to the President members of the faculty at large to serve on the Faculty Committees. You have received the list of these appointments, all names recommended by the Committee on Committees. The Library Committee, which had already been named for this year, has been transferred to the list of Faculty Committees and henceforth will operate as do the other Faculty Committees. The Committee on Committees (whose composition was determined only after consultation with the various college deans) is now engaged in a long term study of the functions of the Faculty Committees and the possible need for other committees. It is our hope that those persons serving on these committees will feel a real responsibility to their colleagues to perform their duties as effectively as possible.

I think you will be interested in knowing that these steps have been taken after serious consultation with members of this group extending as far back as December of 1956. As I have indicated, I believe this action represents a step in the right direction.

Today's faculty meeting also holds some importance for us because it brings a recommendation that this body elect three members to serve on a Faculty-Board of Trustees Conference Committee. This committee, it is hoped, will serve a worthwhile purpose, by making available to the faculty an impartial and objective committee to which the faculty may take problems which involve differences between the faculty and the administration. It is sincerely hoped that such a committee will have few occasions when it will be necessary to act but the establishment and the presence of such a conference committee is believed to serve a worthwhile purpose. It is proposed that this committee be composed of three members of the Board of Trustees (and that body has already approved the appointment of members to the committee should the Faculty give its approval) and three members of the University faculty-at-large to be elected by this University Faculty. This committee would meet on the Call of the chairman to hear such cases as the faculty might bring to it. This committee will serve for a one-year term and members will be eligible for re-election.

I am ready to entertain a motion from the faculty that this committee be established and, if you are ready to nominate and elect your three representatives, we can move ahead with that action.

President Dickey asked Dr. Trimble if he wished to make a report on the activities of the Committee on Committees. Dr. Trimble, as Chairman of this Committee, reported that the Committee had met and appointed the members for the Standing Faculty Committees. Dr. Trimble also stated that the Committee on Committees has two responsibilities: first, to recommend the personnel for the standing faculty committees, and second, to study the responsibilities of the various standing committees in order to make the work of each committee effective and avoid duplication of efforts.

President Dickey then recommended that the Faculty elect three faculty members to serve on a joint Faculty-Board of Trustees Conference Committee. This Committee would make available to the faculty an impartial and objective committee to which the faculty may take problems which involve differences between the faculty and the administration. President Dickey's recommendation was approved by the Faculty. After some lively discussion as to the ways and means of conducting the election the following persons were elected to the Committee: Paul Oberst; Ralph Weaver; and Howard W. Beers.

The Faculty adjourned at 5:35 p.m.
