Consider a point charge q at the origin. The electric field is given by $\mathbf{E} = \frac{q}{4\pi\epsilon_0} \frac{\mathbf{r}}{r^3}$. The electric potential V is defined such that $\mathbf{E} = -\nabla V$. For a point charge, $V = \frac{q}{4\pi\epsilon_0 r}$.

2. ELECTROSTATIC POTENTIAL ENERGY

The potential energy U of a system of charges is given by $U = \sum_i q_i V_i$.

3. GAUSS'S LAW

Gauss's law states that the total electric flux through a closed surface is equal to the total charge enclosed divided by ϵ_0 .

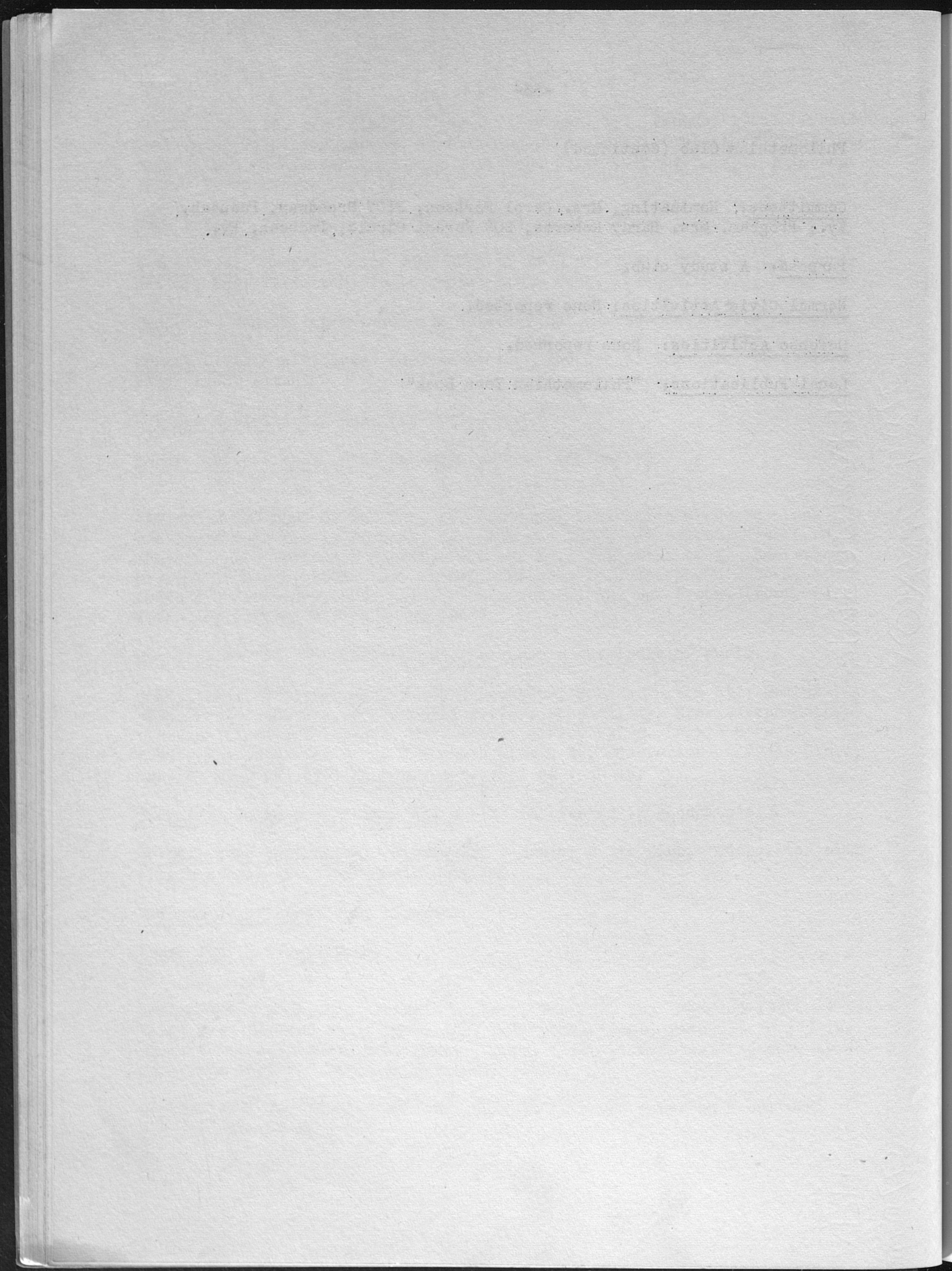

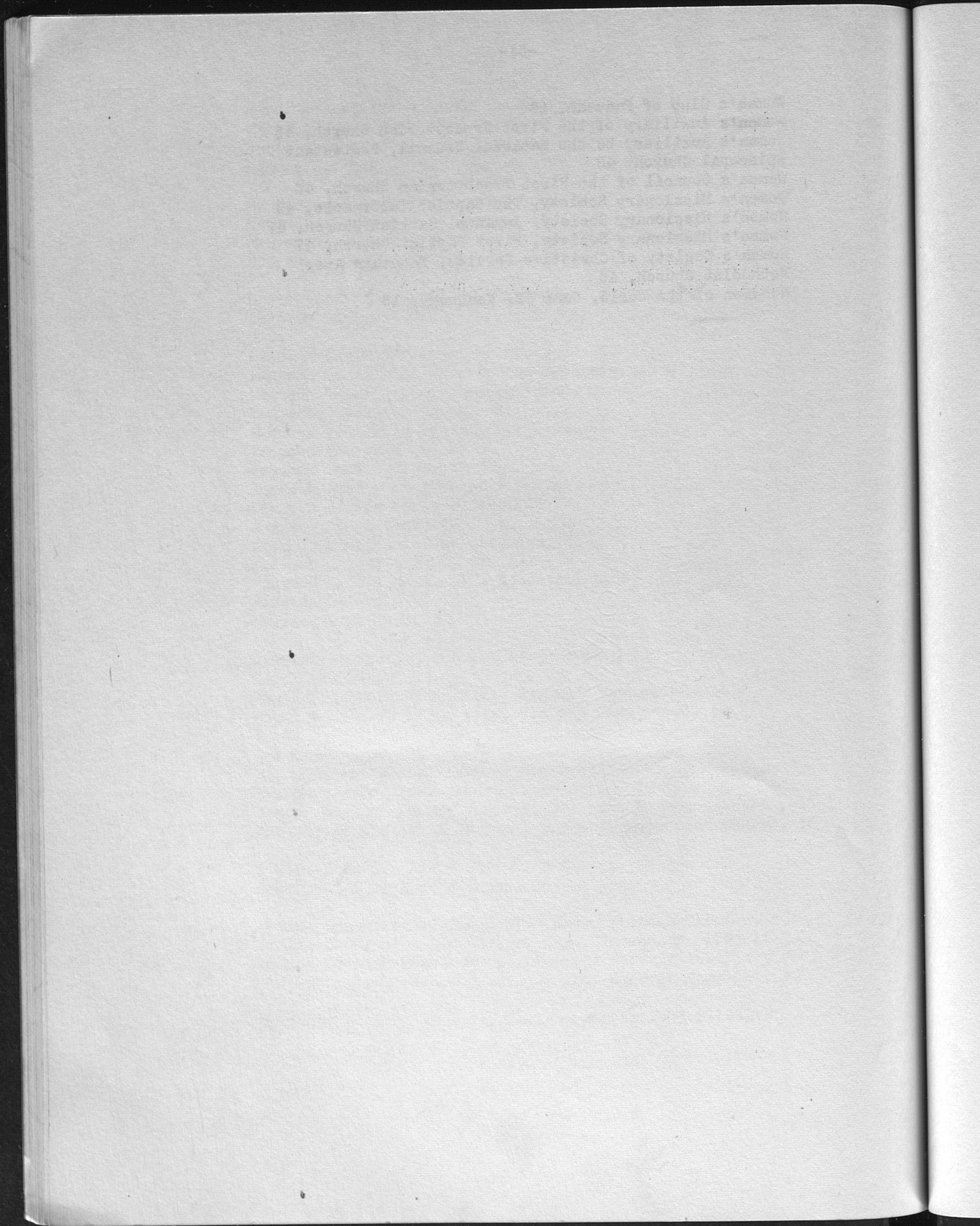
