

PROCEEDINGS—FIRST DAY—MORNING SESSION.

Shelbyville, Ky., August 8, 1922.

The seventh annual session of the State Grand Temple of the Sisters of hte Mysterious Ten and Juveniles was called to order at 12:05 in the Clay Street Baptist Church by State Grand Princess, Sister Nellie M. RECOMMENDATION:

The State Grand Temple has not centered its activities in any definite Child Welfare Charity of the State, and in view of the fact that there are six thousand dependent race children in the State who are deprived of the chance for the noble pursuits of life, and that the State Legislature is giving some assistance to an organization which is operating in our State and receiving homeless children of the race who are committed to its care from all the counties of the State, and

Be it further stated, that the appropriation received from the Legislature does not give entire support and maintenance to this institution, and for this reason the purchase of the building in which the children are being housed together with other incidentals vital to their comfort, care and education have to be met by free-will offerings and donations, and since the Kentucky Legislature is the first of the Southern States to give this assistance to the homeless and dependent children of our race, I therefore

Recommend, that this State Grand Temple give as an evidence of the charitable phase of our Order, and of our hearty sympathy with the homeless and orphan child, and as an evidence of our appreciation for what the Kentucky Legislature has done; a levy of one cent per member from the entire mem-

bership of the Temples of the State as a special annual tax. The same to be brought to the State Grand Temple by the delegate representing the subordinate Temple, as a donation to the Kentucky Home Society for Colored Children, located at Louisville, Ky.

Be it further resolved, that the Presiding Officer of the State Grand Temple be empowered to name a State Child Welfare Commission of twelve persons to be chosen from the four geographical sections of the State. That the Presiding Officer of the State Grand Temple be an ex-officio officer of this commission, which shall be composed of persons having special fitness, by adaptability, character, professional and practical knowledge of the conditions and requirements affecting child welfare. That such persons must be members of the Order, not necessarily delegates.

As the Presiding Officer of the State Grand Temple, being a member of the commission will be prepared to give the required information. This commission will meet twice a year at a place and time designated by the State Grand Princess. Members of this commission charged with certain definite responsibilities upon submitting an itemized statement of expenses to the State Grand Princess for approval, said expenses will be paid by the State Grand Temple.

This commission will be named thirty days after the annual meeting of the State Grand Temple, after which plans as to the scope and service of the commission will be promulgated by the State Grand Princess.

Motion by Sister Frances Wells, seconded by Sister Roxie Edwards that the communication be received for discussion. Motion carried.

Sister Bessie Allen made a statement in regards to the communication by request of the State Grand Princess.

State Grand Princess asked the V. G. P., Sister Mary B. Foston, to come forward and take her seat and Sister Susan Carr to take the seat of the V. G. P., since she was called out.

Motion by E. C. Adams, seconded by Sister Belle Bullitt, that each member put aside one cent a year for the home.

Amendment to the motion by Sister Martha V. Webster and seconded that we strike out the word tax and insert the word lay aside. Amendment with the motion carried.

Motion by Sister Nannie L. Fields,, seconded by Sister B. L. Hughes to adopt the communication as read. Motion carried.

Word was received that Queen Esther Guards were at the door. They were then escorted in and introduced to the Grand Temple.

Committee on Credentials reported in full. Motion by Sister Carrie Gibson, seconded by Sister Mary A. Lytle that the report be adopted. Motion carried.

Time having arrived for memorial services, Sister Hattie Payne played a march while the Grand Lodge marched in.

G. M., Brother G. T. Halliburton, called the Grand Lodge and Grand Temple to order at 2:30 p.m. for the purpose of holding memorial services and stated we would be brief with the services.

Scripture read, 90th Psalm, by Grand Chaplain, Brother P. W. Garrett. Joined in singing, "Shall We Gather at the River," led by Sister Hattie Payne.

Report of Committee on Condolence was read.

Eulogy of deceased of Grand Lodge by Brother McNary. Joined in singing, "We'll Meet Our Sister in our Father's House."

Remarks by P. G. M., Brother W. D. Tardiff. Joined in singing, "Over in the Beulah Land," led by Sister Alice Goodloe. Remarks by Brother B. F. David. Joined in singing, "There Is Joy in That Land Where I Am Bound."

Remarks by N. G. P. Sister E. A. Watkins.

G. M., Brother G. T. Halliburton, stated that at this time while we were together I. Willis Cole wanted just ten minutes to speak. Brother H. C. Russell introduced Mr. I. Willis Cole, who spoke in interest of his paper the "Leader" and asked that he be allowed to sell the copies.

Committee on Grand Officers Report stated that they were ready to report.

Grand Princess then asked the N. G. P. Sister E. A. Watkins, to preside since the committee was to report her report first.

The Committee read their report. Motion by Sister Bessie Ballard, seconded by Sister Jennie L. Poole, that the recommendations be adopted by sections. Motion carried.

- 1. Recommended that no one shall be placed in nomination for State Grand Princess or Vice Grand Princess who has not served as Princess in their local Temples. Motion by Sister Cora Richardson, seconded by Sister Ada Pullam, that the Recommendation be adopted. 100 for motion, 10 against. Motion carried.
- 2. Recommended that the Assistant Grand Secretary be allowed to attend the Board meetings since she would have to assume the responsibilities in the absence of the Grand Secretary. Then she will be in touch with the work and will know where to begin. Motion by Sister Cora Richardson, seconded by Sister Scrilda McAdo, that the Recommendation be adopted. 114 for the motion, 1 against. Motion carried.
- 3. Recommended that before a Sister's endowment is paid to the beneficiaries that a receipted bill be produced from the undertaker. For so many times the beneficiaries go with the money in their pockets and the funeral bill remains unpaid. And we feel that each Sister should provide that her just debts be paid and the remainder be paid the beneficiaries, if she has not enough for the body to be buried outside of the endowment funds. Motion by Sister Jennie L. Poole, seconded by Sister Belle Bullitt, that the Recommendation be adopted. Motion having been voted on, was lost.

- 4. In going over the jurisdiction I find so many of our Temples marching through the streets behind big drums which I think is very unbecoming, as ladies as well as S. M. T. We should always look forward to things that have a tendency to lift us up. Therefore, I recommend that no Temple be allowed to march upon any occasion. Motion by Sister Jennie L. Poole, seconded by Sister Scrilda McAdo, that the Recommendation be adopted. Motion carried.
- 5. Recommended that this Grand Temple create the office of Grand Organist, whose duties it shall be to preside at the organ and have charge of the selections. Motion by Sister Bessie Ballard, seconded by several, that the Recommendation be adopted. Motion carried.
- 6. Last, but not least, as it has been our custom to save the best for our Sisters until the last. Take it gently Sisters, it will do you good. I recommend that where a Sister is appointed to sit up and fails to go without a lawful excuse or furnish a substitute, shall be fined the sum of \$2.00. Trust that you will consider this as it is best for the Order (and we are obligated to care for our sick, and we have gotten to the place where we do not care for a dollar. Motion by Sister Susie Tardiff, seconded by Sister Emma Tinsley, that the Recommendation be adopted. Motion carried.

Motion by Sister Louisa T. Evans, seconded by Sister Belle Bullitt, that that part of the report pertaining to finance be referred to the Committee on Mileage and Per diem. Motion carried.

Motion by Sister Mary B. Foston, and seconded by several that the report of the committee be adopted and committee excused. Motion carried.

Committee on Rules was called and excused.

N. G. P. Sister E. A. Watkins, then said at this time we would hear from Brother Humphrey, who spoke on the salaries of officers and what they should be paid. Grand Secretary, \$500.00; Grand Princess, \$300.00; V. G. Princess, \$20.00; Grand Treasurer, \$200.00; but could not say what the salary

of Assistant Grand Secretary should be as more work had been added to the office. Motion by Sister Bessie Ballard. seconded by Sister Belle Hughes, that we adjourn to meet at 7:30 p.m. Amendment to the motion to meet at 8:00 p.m. Amendment carried.

Benediction by Grand Chaplain, Sister Alice Goodloe.

Committee on Grand Temple Returns reported. Motion by Sister Mary B. Price, seconded by Sister Jennie B. Ware, that the report be adopted. Motion carried.

G. P. then asked the V. G. P. to come forward and take her seat and Sister Clarine Livas to take V. P. chair.

Committee on Courtesy reported. Motion by Sister Emma Tinsley, seconded by Sister Roxy Edwards, that the report be adopted. Motion carried.

Committee appointed on Juveniles—Sisters Frances Wells, Evelyn Miller and Maria Bloch.

Committee on Finance reported. Motion by Sister Mattie V. Burton, seconded by Sister E. C. Adams, that the report be adopted. Motion carried.

N. G. P., Sister E. A. Watkins, spoke of the Henderson Memorial Day and stated that March 4th of every year is the Memorial Day.

Committee on Mileage and Per diem reported. Motion by Sister E. B. Brown, seconded by Sister Mattie V. Burton, to adopt the report by items. See report.

First Item read. Motion by Sister Myrtle Humphrey, seconded by Sister B. F. Hughes, that the item be adopted. Amendment to the motion by Sister Cora Richardson, seconded by Sister Hattie Payne, that the salary of G. P. be \$125.00. Ninety-two for amendment, 6 against. Amendment carried.

Second Item read. Motion by Sister E. C. Adams, seconded by Sister Bullitt, that the item be adopted. Amendment to the motion by Sister Cora Richardson, seconded by

Sister Mattie V. Burton, that the salary of the V. G. P. be \$20.00. Ninety-three for amendment, 2 against. Amendment carried.

Fourth Item read. Motion by Sister Cora Richardson, seconded by Sister Eliza Arnett, that the Assistant Grand Secretary be given \$25.00. Ninety-four for motion, 6 against. Motion carried.

Fifth Item read. Motion by Sister Belle Bullitt, seconded by Sister Mattie V. Burton, that the item be adopted. Amendment to the motion by Sister Cora Richardson, and seconded, that the salary of Grand Treasurer be \$75.00. Amendment having been voted on was lost. Original motion was voted on: 58 for the motion, 37 against. Motion carried.

N. G. P., Sister Watkins, stated that she never knew of any one to value the feet more than they did the head, as you can get along without some parts of the body, but you cannot get along without the head. Motion by Sister Bessie Ballard, and seconded by several, that we rescind the action of giving the Grand Princess \$125.00 and make it \$175.00. Motion carried.

Sixth Item read. Motion by Sister E. C. Adams, seconded by Sister Louisa B. Jones, that the janitor be paid \$4.00. Motion carried.

Seventh Item read. Motion by Sister Mattie V. Burton, and seconded, that the Organist be paid \$4.00. Motion carried. Motion by Sister E. B. Brown, and seconded, that the Finance Committee be paid \$1.00 per day. Motion carried.

Committee on Mileage and Per Diem was called and excused.

Committee on Juveniles reported. Motion by Sister Cora Richardson, seconded by Sister Mamie E. Tuxun, that the report be adopted. Motion carried.

Grand Princess asked that all mother matrons stand and there were five. She suggested that we have a State Grand Mother Matron.. Motion by Sister Cora Richardson, seconded by Sister Belle Bullitt, that we have a State Grand Mother Matron. Motion carried. Sisters Maria Bloch, Frances Wells, Charlotte Powell and Georgia Ann Wilson were placed in nomination for Grand Mother Matron. Motion and second that the nominations be closed. Motion carried. Tellers appointed, Sisters Myrtle Humphrey, Mary L. Brooks and Jennie B. Ware. Votes having been cast, Sister Bloch received 24 votes; Sister Wells 56 votes; Sister Powell 23 votes; Sister Wilson 16 votes. Sister Wells receiving the highest number of votes was declared elected Grand Mother Matron. Motion by Sister Cora Richardson, seconded by several, that we go into the election of officers. Motion carried.

Motion by Sister E. B. Brown, seconded by several, that the N. G. P. Sister E. A. Watkins, preside during the election of officers. Motion carried.

N. G. P., stated the first thing in order was the election of G. P. Motion by Sister Cora Richardson, seconded by several that the rule be suspended and Sister Nellie M. Haggard be elected by acclamation as Grand Princess. Motion carried.

Motion by Sister Lula Rowland, seconded by Sister Wilson, that the rule be suspended and all officers be elected by acclamation. Sisters Jennie L. Poole, Bessie Ballard and Annie G. Phillips decline as members of the Grand Board of Managers. Motion having been voted on was carried.

Motion by Sister E. C. Adams, seconded by several that Sister Susie Tardiff be chairman of the Board of Managers. Motion carried.

Motion by Sister Belle Bullitt, and seconded that the rule be suspended and Sister Carrie Gibson be elected by acclamation as third members of the Board. Motion carried. Sisters Alice Boswell, Myrtle Humphrey, A. E. Wilson, were placed in nomination for fourth member of the Board. Motion and second to close the nominations. Motion carried.

Tellers appointed, Sisters Mary B. Foston and Mary F. Chatman. Votes having been cast Boswell received 66 votes; Humphrey 30 votes; Wilson 19 votes. Boswell receiving the highest number of votes was declared elected fourth member of the Board.

Sisters E. C. Adams, Susan Carr, Ella Scott, Mary Burnsides and Mary F. Simmons, were placed in nomination for fifth member of the Board.

Sister Mary Burnsides declines the nomination. Votes having been cast, Sister Carr received 50 votes; Sister Adams 11 votes; Sister Scott 22 votes; Sister Simmons 30 votes. Sister Carr receiving the highest number of votes was declared elected fifth member of the Board.

Motion by Sister Mary F. Chatman, seconded by Sister Cora Richardson, that we adjourn to meet Friday at 9:00 a.m. Motion carried.

REPORT OF NELLIE M. HAGGARD, GRAND PRINCESS.

TO THE GRAND TEMPLE OF THE SISTERS OF THE MYSTERIOUS TEN AND JUVENILES OF THE STATE OF KENTUCKY: GREETINGS:

In accordance with an established custom and law of this honored organization, we have assembled in the city of Shelbyville, to hold our annual meeting, along life's pathway amid its thorns and roses, and the greatest events of modern civilization amid the frequent changes of human minds, men and women or often called upon to pause and reflect. Called upon to review their past acts to recount their past deeds and frequently requested to suggest if possible a more successful course for their future are the future of those whose interest has been assigned to their care. Having served you as State Grand Princess, for a period of five years, I assure you that I am grateful and highly pleased with the honor conferred and with pride welcome this privilege to report to you the business transacted by this your servant the past two years.

Whatever I have accomplished has been done through the will and help of Him Who gives His divine approval of the noble efforts of all men who toil earnestly and unselfishly for the uplift of their fellowman, and all things that stand for the good of our Order and lifting her principles and conditions far above the level of the ordinary in life.

I am glad to report to you at this hour that the ranks of our official family have not been broken by the great monster death. While we as Sisters drop tears of love and sympathy with the dear ones we commend them to him who doeth all things well. But! what of ourselves? During the year which has just rolled out into space carrying upon its bosom our joys and sorrows, have we as Sisters, lived the life that we will not regret in after years. Let us pause for a moment and ask ourselves this serious question, for we know not how soon we may be called upon to render an account for our stewardship here.

Our jurisdiction has lost 125 members this past year, but remembering the words of the poet so well when he composed that wonderful song we all love to sing because it inspires our very soul, when we begin to sing: "Be not dismayed whatever betide, God will take care of you." We trust that we shall all be united again and shall live for ever and ever in that beautiful land of rest, Peace to their ashes and Rest to their souls.

May 3rd, found me in Harvesville; Owensboro, 4th; Henderson, 5th; Marshal, 6th; Corydon, 8th; Morganfield, 9th; Providence, 10th; Madison ville, 11th; Earlington, 12th; Morton's Gap, 13th; Greenville, 15th; Dawson Springs, 16th; Paducah, 17th; Cadiz, 18th; Trenton, 19th; Allensville, 20th; Russellville, 22nd; Gordonsville, 23rd; Frankfort, 24th; Lawrenceburg, 26th; Versailles, 27th; Lexington, June 1st; Harrodsburg, 2nd; Perryville, 3rd; Atoha, 5th; Danville, 6th; Junction City, 7th; Houstonville, 8th; Summerset, 9th; Shelbyville, 10th; Bloomfield, 13th; Lancaster, 15th; Davistown, 16th; Paris, 19th; Cynthiana, 20th; Covington, 21st; Earlanger, 22nd; Maysville, 23rd; Flemingsburg, 24th; Millersville, 26th; Carlisle 27th; Little Rock, 28th.

I must say I was treated royal, everywhere we visited the Sisters did everything in their power to make it pleasant for me. We met the Juveniles at each place on the afternoon the day of our visit, and I was the recipient of quite a few tokens from the different Juvenile Departments. Temple No. of Paris, Ky., presented me with a lovely Silver Cream Ladle which was highly appreciated.

At Providence, May 10th, we organized the Royal House with 39 members. Also at Madisonville, May 11th, with 25 members; Earlington, May 12th we organized a Royal House with 45 members; Winchester, with 59 members. The Temple at Columbia has gone out of existance, but thanks be to the Lord who giveth us the victory they are alive again and in good working order.

I find in going over the Jurisdiction we are increasing greatly in membership. Sisters, there is a great work for us to do; we must make the Order interesting to make it attractive for our young members. I want to ask the prayers of this body of loyal brothers and sisters in behalf of two Temples at Cadiz. I have been struggling for about three years to bring them together. I have been trying to impress them with this thought, that in union there is strength. I believe our prayers will be answered. I have not given up yet. Sisters, we must be more concerned about our children for in all ages they are the hope of the com-

ing generation, and realizing that they some day must take our places when we have passed to the great beyond. Therefore we must train them up in the true principles of the Order, and as the scripture teaches us, "Train up the child in the way it should go, and when it is old it will not depart from it." Some of our Juvenile Departments have organized a military department, which will mean much to this Order in the near future.

Dear Sisters and Juveniles, I would like to personally mention each and all who have shown me favors, but it would require too much of your precious time and space, so let me say from the bottom of my heart to all of my Sisters and Juveniles I extend to you my heartfelt thanks.

For years there was a cry made throughout the State of Kentucky, what was it, we need a home? Finally the home was purchased and it seems now that we are standing still. There has been another cry made throughout this jurisdiction, Please open the doors and let us in, to care for our Widows, Orphans and Aged, superanuated members. If we are ever going to be in need of a home it is now. If we cannot use this one, Brothers for the Lord's sake do not dream so much about oil being there. But let us dispose of it and buy elsewhere so we can get a home in operation. The sun is too high now for us to sleep and dream of things no one has ever thought of. Brothers, let us stop dreaming and go to work, for we will all be gone to the other shore, and we will have a home then. What we want is a home now. We cannot afford to have so much money involved just for two or three bags of potatoes. Sisters, what say you?

In the city of Harrodsbough, in 1918, you placed upon my shoulders a great responsibility. You commissioned me to go forward and impose the banner of Justice, Mercy and Truth. I accepted the trust, assumed the responsibility, took the obligation, went forth in the name of Him who rules both heaven and earth to deliver the message of peace and good will in accordance with our ten mysteries.

If I have fallen short in my efforts in carrying out your will in advancing the work of the sisterhood in the State, I assure you in the name of our heavenly Father that the failure was not due to the willful neglect and official carelessness. For whatever I have done I have endeavored to create a spirit of push, with the sisters that we may grow, and forever keep its high standard as we have always done throughout the jurisdiction. It would be selfish in me indeed were I to close this report without going to the Officers of the Grand Temple, who have done so much to make this year's work a success. The members of our Grand Board have ever been active in looking out for the best interest of the Grand Temple. I wish to thank them for their hearty support during my administration. I wish for you a happy and

prosperous session, and pray that our words and actions may be guided by that wisdom which cometh from above. And when we shall go from this session may each carry with him the fond recollection of duties bravely done, noble sentiments magnanimously disseminated and character cautiously sustained.

Again thanking you for the confidence place in me and the loyal support with which you save sustained this administration, wishing one and all the prosperity and happiness which comes to the upright in heart. Let me be a woman in this world of beauty, let my labors be of love, not for a sense of duty, ready with my hands and heart, glad to do a woman's part. In the quite little sphere where I've been placed to labor here, let me be a woman.

RECOMMENDATIONS.

First: I recommend that no one shall be placed in nomination for State Grand Princess, or Vice Grand Princess, who has not served as Princess in their local Temples.

Second: Recommend that the Assistant Grand Secretary be allowed to attend the Board meetings, since she would have to assume the responsibilities in the absence of the Grand Secretary, then she will be in touch with the work and will know where to begin.

Adopted.

Third: Recommend that before a sister's endowment is paid to their beneficiaries that a certified bill be produced from the undertaker. For so many times the beneficiaries go with the money in their pocket, and the funeral bill remains unpaid. We feel that each sister should provide that her just debts be paid and the remainder be paid the beneficiaries, if she has not enough for the body to be buried outside of the endowment funds.

This recommendation was not adopted.

Fourth: In going over this jurisdiction I find so many of our Temples marching through the streets behind big drums, which I think is very unbecoming for ladies as well as S. M. T's. We should always look forward to things that have a tendency to lift us up. Therefore I recommend that no Temples be allowed to march upon no occasion, but does not include auxiliaries.

Adopted.

Fifth: We recommend that the Grand Temple create the office of Grand Organist, whose duty it shall be to preside at the organ, and have charge of the selections. The Grand Organist to receive one dollar per diem.

Adopted.

Sixth: Last but not least, as it has been our custom to save the best for our sisters until the last, take it gently, Sisters, it will do you good. I recommend that where a sister is appointed to set up and fails to go without a lawful excuse or furnish a substitute, shall be fined the sum of (\$2.00) two dollars. Trust that you will consider this as it is best for the Order, and we are obligated to care for our sick, and have gotten to the place where we do not care for a dollar.




A nurse fund may be set aside to provide for recommendation number one.

REPORT OF GRAND AUDITOR AND DEPUTIES

REPORT OF PROF. W. H. HUMPHREY, GRAND AUDITOR.

The Grand Auditor can truly be called the watch dog of the treasury. It is his business as Grand Auditor to keep a direct line on the sources of receipts, on the channels of expenditures, to make balances between these, and to report these findings to you at stated times. 



We, the Committee on the Grand Officers' Report, beg leave to submit the following report:






