Income for the operating account is from C.D. and Treasury Note interest and profit from the Friends of the Garden party. Our projected income for 1996 is as follows:

Our expenses in the garden from January through September have been \$11,928.69. For the same period we have additional expenses of \$2,395.94 for supplies, speakers, newsletter, and other related club expenses. Judy's concern is that expenses are continuing to increase and our income is decreasing. Interest rates are still down; additionally we spent \$41,000.00 of principle to reprint the cookbook so we have less invested this year. We had carry over garden expenses of \$1,000.00 for the sundial and \$2,000.00 for masonry work approved in 1995 but not billed until 1996.

Betty asked for discussion concerning McConnell Springs. We gave them the \$5,000.00 from the Founders Fund award. We will continue to support them with volunteers when possible and hopefully have a workday and tour this fall.

Callie updated us on the Milward Memorial Fund. Bob Milward has made an additional contribution to the fund. Callie moved, at this time, to purchase 1 lead chair to match existing chairs and not exceed \$600.00 and 2 lead planters, not to exceed \$4000.00. Libby seconded and the motion carried.
