Order of Business

Louisville, Ky., May 23, 1905.

The Twenty-third Annual Encampment of the Department of Kentucky Grand Army of the Republic convened in Germania Hall, at 10 o'clock a.m., and was called to order by the Department Commander W. T. Bausmith, who thereupon opened the convention in the regular form, Department Chaplain, E. P. Marrs invoking divine blessing.

The roll was called, and all officers answered to their names excepting the Senior Vice Commander.

Past Department Commanders present were: M. Minton, O. A. Reynolds, D. O'Riley, L. M. Drye, John Blaes, J. H. Browning, T. F. Beyland, A. Wheedon and W. G. Foree.

The Committee on Credentials reported 145 Delegates and Past Commanders present and entitled to vote. A motion prevailed to accept the report, and constitute the same as the roll of the Encampment.

The Department Commander then read his report, as follows:

Department Commander's Address

Comrades:

We have met here to-day, in the largest and most beautiful city of the grand old Commonwealth, to open the sessions of the Twentythird Annual Encampment of the Department of Kentucky, of the Grand Army of the Republic. I feel it to be one of the greatest pleasures of my life to meet with you, my comrades. One year ago, at the city of Frankfort, the Twenty-second Annual Encampment met, and you elected me as your Department Commander. In accepting the high and honorable office, I promised to fulfill the duties devolving upon me in a soldierly, trustworthy and economical manner. I have used the power of the office with prudence and judgment, and with regard to the feelings of those associated with me; and with only one thought—the interest of my comrades of our noble Order. When I was about to assume command of this Department, I was obligated by that noble man, Commander-in-Chief John C. Balck. The obligation I then assumed I have, to the best of all the good that is within me, and with the great help given by my A. A. G., T. F. Beyland, and to the best of my ability, kept and performed. It is now with my record opened before you for you to say in what measure I have succeeded.

During the year past, nothing has occurred in the Department but good feeling and an endeavor to get the old boys that wore the blue into closer fellowship with us whose noble obligations are unbroken, and which, I hope and trust, will remain unbroken until the last roll call shall sound.

Now, my comrades, I will say, for the kind treatment, the hospitality and the assistance you have bestowed upon me during my administration, I return my heartfelt thanks. The labor that myself and co-workers have performed has been done in the spirit of love and for the welfare of our beloved Order. Now, shall I say more, my comrades, with reference to the aid given me in the discharge of my duties by the officers of my staff? I ask your particular attention to the reports of the officers of this administration.

In the discharge of the duties placed upon me as Commander, I have visited several Posts in this Department, but I have been unable to visit all that the honor conferred demanded and warranted. So, my comrades, I have used printed matter. Other duties required my attention and prevented official visits that otherwise would have been made. The G. A. R. is an organization that will in a few years be no more, but the principles that brought it into existence will exist until time shall be no more. So let it be our individual and united effort to keep together in the bonds of Friendship, Charity and Loyalty.

In reference to our trip to the Thirty-eighth National Encampment, held in Boston, August 17 and 18, 1904, I would say that it was all joy and glory to all that were present, and I will refer you to my General Order, No. 4.

SONS OF VETERANS.

The object of this organization is full of meaning. They have come upon the scene of action since the days when their fathers stood in the serried ranks of war, and with sword, sabre and musket, in army and navy, were shaping the future of the Republic. Let us, comrades, make them feel that theirs is a heritage of glory, so that they can honor the kinship. They do not ask to share your glory or to be accorded membership in the Grand Army; they hold that as sacred as we do. But they do ask the cheering words and confidence and counsel of their fathers. They are your sons; give them a place at the fireside.

WOMAN'S RELIEF CORPS.

This valuable organization, auxiliary to the Grand Army of the Republic, continues with unabated zeal the splendid work for which it was organized and to which it is devoted. For years it has been most helpful to the G. A. R., has helped the Posts, has encouraged the weak and shared honors with the strong. It has been a messenger of comfort and happiness to the widow and orphan of the veteran, has dignified and sweetened the services of Memorial Day by active participation therein, and along all lines of usefulness and patriotism has indeed been auxiliary to our organization. Its affairs are administered with an ablity and enthusiasm that merit the confidence and approbation of every member of the Grand Army of the Republic.

LADIES OF THE GRAND ARMY OF THE REPUBLIC.

This organization, not by official action made an auxiliary, is none the less earnest and active in the work in which they are so lovingly and loyally engaged. They have grown and prospered, and have gathered under their banner those who claim kinship with the soldier or sailor, and are lending a helpful hand in alleviating distress and teaching love of flag and country. To them and to the Daughters of Veterans, the Grand Army of the Republic gives its Godspeed.

I have not the power of language to fully express my inability to entirely meet the requirements of the high station of Commander of this Department; but I have tried to maintain its dignity, guard its honor and intensify its fraternity. Now I am about to step back into the ranks to continue the enjoyment of its comradeship. I shall ever hold in grateful remembrance the kindness shown to me. Now may all your ways be ways of pleasantness and all your paths be peace.

So I trust that you, my comrades, will rally around my successor with an the loyal support you can give him.

The per capita as now received at headquarters is not sufficient for the needs of this Department. Our finances show a loss from year to year, and this year's expenditures exceed the receipts, although less money has been spent than by any former administration since the founding of this Department. I therefore heartily recommend raising the per capita from 20 cents to 30 cents per annum, payable in semi-annual installments of 15 cents. I deem this a necessary measure, and one that will add vitality to the Order, as yearly losses of members and Posts are inevitable.

Report of Department Historian

Mayfield, Ky., May 22, 1905.

Commander William T. Bausmith:

Greeting:—Your Historian would most respectfully submit as his annual report that he could not find any of the old records that once belonged to the office of Historian. All that he could find to aid him was the annual reports that had been printed from year to year in the journals. Therefore, he began the search for such records as he could get to find what Kentucky did in the way of defence of Old Glory in the dark days from April 13, 1861 until April 30, 1865.

On April 13, 1861, our State troops were under S. B. Buckner, a grand man, who had done service in Mexico, but who soon espoused the cause of the South, and attempted to take with him the pride of the State—her trained militia. But he was thwarted by such men as Rousseau, Nelson, Jackson, Hobson and many others; so he, aided by Breckinridge and many others of the former leaders, only succeeded in getting about 60,000 to leave homes and loved ones to become soldiers under the stars and bars. Arranged under the Old Flag we find 75,000 of Kentucky's gallant sons enlisted in United States service, and 8,000 responded to calls from the Governor from time to time, until we find our State furnished all told, both State and United States troops, 83,000 white men. Besides these, we find she gave 22,100 of her former slaves, swelling the list, white and black, to 105,100 men. Often we find that from the same home brothers would leave, one to don the Blue and one the Gray. Often would the mother or sister divide her last sheet of paper to let her brother in Blue and her brother in Gray know the happenings at home around the old fireside where they had played and where mother now sat and prayed for her son in Blue and her son in Gray. She did not care so much for country or fame; but, oh! God be merciful and spare my son in Blue and keep my son in Gray from harm.

While no official records are at hand to show what was the fatality of the sixty thousand who left the State for the cause of the Stars and Bars, go into many homes, see the wall adorned with the faded pictures of a young man; see the aged mother as she steps to it: "Yes, that is my oldest son; he fell at Shiloh in the charge made on Sunday. You see his body was never recovered; we only had that picture taken in his Gray uniform. Yes, that is my second son; he fell at Gettysburg. We never got his body. He had just sent that photo to his young wife. Poor thing! she died under the shock. You see, he wore the Blue." Many homes have been made sad on account

of sons and husbands that wore the Blue or the Gray, that never came home.

As we have made some search and found that most of the white regiments kept a record, we will give, as near as we can, what became of the 83,000 who went out under Old Glory. We could find no records of the colored troops, though they suffered much loss.

Which accounts for almost the entire white army. Of that vast army, most have passed over on the other side, for we find that, soldiers of all wars, their widows and orphans, less than 40,000 pensions are enrolled at the Louisville Agency.

All reports of officers were referred to the Committee on Resolutions.

It was decided by motion that the regular order of business be suspended, and that the Encampment now proceed with the Election of Officers.

The Department Commander appointed Comrades Mat. Wade, G. H. Burgtorf, Geo. Wood and C. C. Vaughn as Tellers. Nominations for Department Commander were called for, and Gen. M. Minton being first recognized, placed the name of Bernard Matthews, of Thomas Post, No. 6, of Louisville, before the Convention for the position of Department Commander for the ensuing year. This was pleasant to all, and the Assistant Adjutant General was instructed to cast one ballot for Bernard Matthews, as being the unanimous choice of the Convention.

Nominations for Senior Vice Commander were now declared in order, and C. C. Vaughn nominated G. W. Saunders for that position. Wm. Sandlin placed L. V. Dodge in nomination. Comrade Dodge declined the position in favor of G. W. Saunders, and the Assistant Adjutant General, by vote of the Convention, cast a ballot for G. W. Saunders as Senior Vice Commander.

Comrade Minton placed the name of John Hicks before the Convention for Junior Vice Commander, and E. P. Marrs named G. W. Ward for Department Chaplain. There being no further nominations for these respective offices, they were declared elected by unanimous voice of all assembled.

Cyrus Edwards, L. V. Dodge and John T. Gunn were placed in nomination for Department Historian. All three declined, and Gen'l. O. A. Reynolds, of Covington, was put in nomination, and was declared elected unanimously.

J. L. Howard was elected Medical Director by acclamation. Hereupon the Convention duly adjourned to meet at 2 p. m.

The Convention reassembled and was duly convened, the Chaplain opening with prayer. The officers of the day reported the Women's Relief Corps and the Ladies of the Grand Army in waiting, and the Commander appointed Comrades Barr, Reynolds and Saunders a Committee of Escort and Welcome. The Commander received them with a few well chosen remarks, and the ladies were seated upon the stage, and brought words of cheer and comfort. Comrade G. W. Smith responded in an eloquent and touching manner. Mrs. Mary Lyle Reynolds, acting for the President of the W. R. Corps, read the report of that organization, as follows:

Another time are we permitted the pleasure and privilege of greeting the Grand Army of the Republic, of the Department of Kentucky. To the Comrades of the Grand Army of the State of Kentucky:

It is with pleasure that I have to inform the Comrades of this Department of arrangements which have been made for our trip to Boston for the Thirty-eighth Annual Encampment.

The various attractive points of interest have been considered in the selection of the route, and it is thought that these features, and the quick time which will be made, make the railway lines selected the best in all respects which can be used en route to the Re-union.

The Kentucky headquarters train will leave Louisville from Union Station, Tenth and Broadway, at 8:30 a. m., Saturday, August 13th, via the L. & N. R., in charge of Junior Commander H. C. Pearce and Past Adjutant General J. H. Browning. At La Grange, Senior Vice Commander Val Berberich will be met, and at Cincinnati the Commander and Assistant Adjutant General will join the train.

The route will be via the L. & N. R. R. to Cincinnati, Erie R. R., Cincinnati to Binghamton, Delaware & Hudson R. R. to Albany and Boston and Maine R. R. Albany to Boston.

A first-class Pullman tourist sleeping car will start from Louisville at 8:30 a.m., August 13th, arriving at Cincinnati at 12:01 noon, and will leave Cincinnati at 3:20 p. m., arriving at Boston at 10:30 p. m., Sunday August 14th. The rate for a double berth, accommodating two

persons in this sleeping car will be from Louisville, \$2.75; from Cincinnati, \$2.50.

Members of Posts south and west of Louisville should join the headquarters train at Louisville. Those from points in Eastern Kentucky should join the train at Cincinnati.

Comrades in the Department are requested to use the L. & N. R. R. to Cincinnati and the Erie R. R. beyond. The usual low excursion rate will be made, and all Comrades who will be able to make the trip are requested to consult the nearest Ticket Agent, and purchase their tickets through to Boston and return via the route mentioned.

DATE OF SALE AND LIMITS.

Tickets will be sold August 12th, 13th and 14th, and will be limited to August 20th for return. The return limit, however, may be extended until September 30th by depositing return portion of the ticket with the joint railway agent in Boston, and on payment of 50 cents.

Stop-overs of ten days each within the final limit of the tickets will be allowed in either direction at Lake Chautauqua, N. Y., Cambridge Springs, Pa., or Nigara Falls. While through sleeper from Louisville to Boston will not run via Niagara Falls on the going trip, those who purchase tickets via the route mentioned above will be allowed to go through Niagara Falls if they desire, either going or returning. It is presumed that most of the stop-overs will be made on the return trip, and in such cases the Erie R. R. upon notice to conductors, will honor tickets from Binghampton to Niagara Falls and from there to Cincinnati, allowing stop-overs indicated, without additional charge.

Comrades:—Your Commander desires to call attention to a matter especially dwelt upon in the address of the Commander-in-Chief, and

quotes therefrom as follows: "The most strenuous efforts have been made during the year to stay the decrease in our membership, but natural causes render such decrease inevitable. It is left with us to cling the more closely together in the bonds of the Order. Recognizing the inevitable, the Rules and Regulations (see Chap. 2, Art. 2, Sec. II) have authorized the division of Post members into resident and non-resident members; have given the Department power to authorize Posts to fix territorial limits within which resident members may be found, and beyond which non-resident members may The initiation of this movement is with the Departments, and each Department may act for itself in so authorizing its Posts to divide their members. Outposts may be allowed by a Post of such Departments whenever there is a sufficient number of applicants —two, three or a dozen—and they can organize under the third paragraph of Sec. II, and in this way can keep in touch with this grand fraternity so long as they are spared, and when the time comes in the providence of God for passing away, be then, as now, part of the Grand Army of the Republic. Moreover, such sub-organizations are a measure of economy, both to the Order and to the individual; above all, it keeps us in touch with one another." The Department Commander submits this matter to the various Posts for discussion and action at their meetings.

GENERAL ORDER, No. 8.

Bellevue, Ky., April 1, 1905.

Comrades:—In accordance with our usual custom, we call attention of all Posts in the Department to the observance of Memorial Day, when we and our families will pay homage and respect to the heroes gone before, by gathering at their silent resting places, and deck their graves with the flag of our country and strew flowers over them as a symbol of our unwavering fidelity to their memories, and as a tribute from their old Comrades of an undying love.

We rejoice as the day approaches to be able to attend to this sad yet pleasant duty, to show to the world our appreciation of the loyalty exemplified by these sacred dead, who in many cases gave up their lives that the nation might live, and others who were stricken before their alloted time, caused by the deprivations and hardships encountered during their soldier's life.

The ranks are thinning and the bowed head is more gray from year to year, but with faltering steps and dimmed eyes we perform this sacred obligation, buoyed up by a heart filled with gratitude for the preservation of our country as a whole, and breathing loyalty, imbuing a love for the flag, instilling patriotism and disseminating all those better sentiments into the minds of the coming generation that are conducive to solidifying the nation and for the promotion of better citizenship.

All Posts will observe the Sabbath preceding this day as a special day to attend divine service, and on that day sermons should be based on loyalty and patriotism with reference to the great War of the Rebellion and its departed and surviving participants.

The reading of President Lincoln's address at Gettysburg is made a feature in all Memorial Day exercises conducted under the auspices





of the Grand Army of the Republic. The address is as follows, and Commanders of Posts are specially requested to have the same read with the exercises of the day:

PRESIDENT LINCOLN'S ADDRESS AT GETTYSBURG.

"Four score and seven years ago, our fathers brought forth on this continent a new nation, conceived in Liberty, and dedicated to the proposition that all men are created equal.

"Now we are engaged in a great civil war, testing whether that nation, or any nation so conceived and so dedicated, can long endure. We are met on a great battlefield of that war. We have come to dedicate a protion of that field as a final resting place for those who here gave their lives that that nation might live. It is altogether fitting and proper that we should do this.

"But, in a larger sense, we can not dedicate, we can not consecrate, we can not hallow this ground. The brave men, living and dead, who struggled here, have consecrated it far above our poor power to add or detract. The world will little note nor long remember what we say here, but it can never for get what they did here. It is for us, the living, rather to be dedicated here to the unfinished work which they who fought here have thus far so nobly advanced. It is rather for us to be here dedicated to the great task remaining before us; that from these honored dead we take increased devotion to that cause for which they gave the last full measure of devotion; that we here highly resolve that these dead shall not have died in vain—that this nation, under God, shall have a new birth of freedom, and that government of the people, by the people, for the people, shall not perish from the earth."




