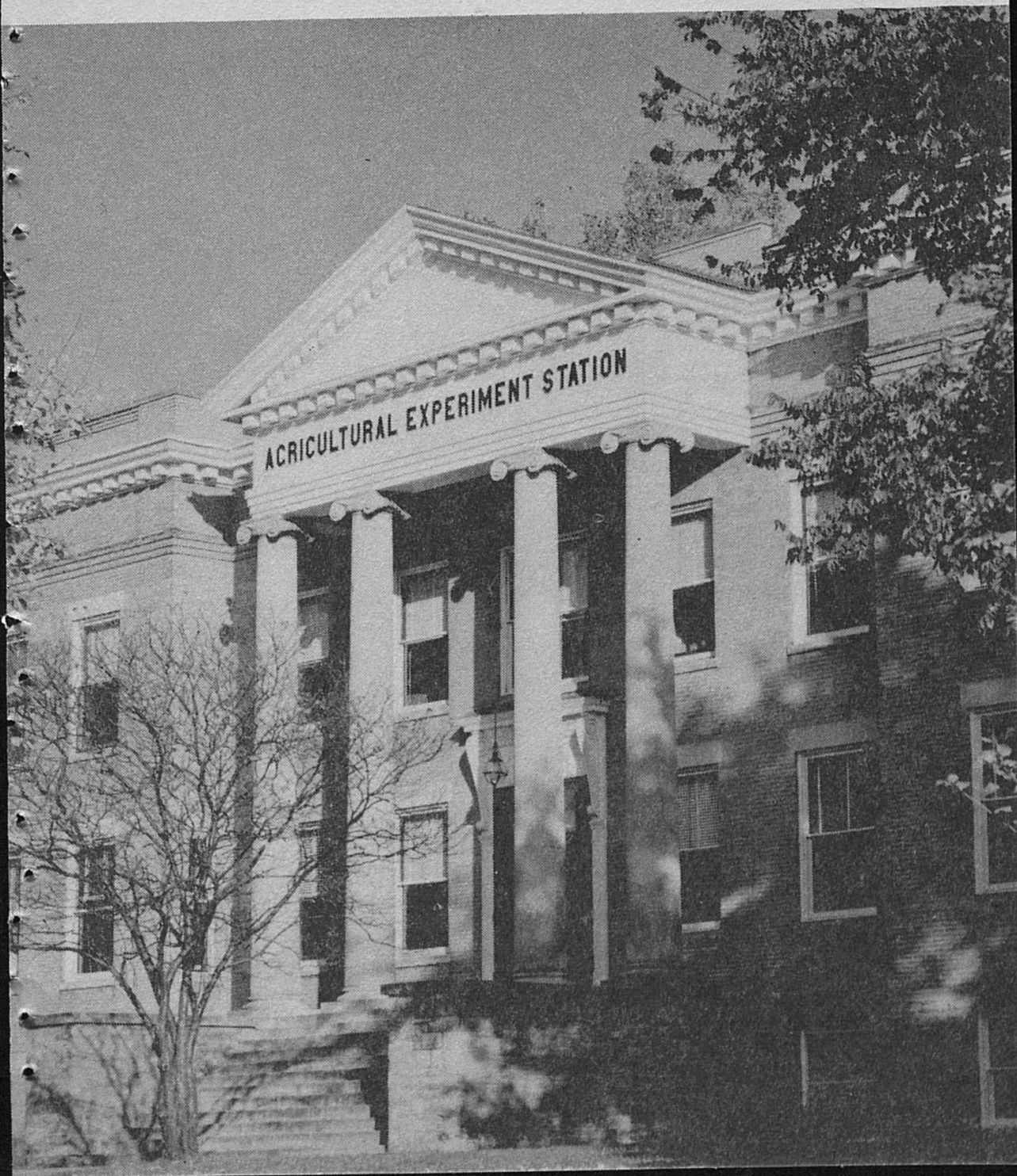

INTRODUCTION

During 1977, Regulatory Inspectors made 3,800 inspectional calls on manufacturers and retailers of bagged, bulk and liquid feed to monitor the distribution of 964,886 tons of registered commercial feed. Approximately 6,000 different commercial feeds are registered for distribution by 500 feed companies. These feeds range in diversity from specialty pet foods to livestock feeds and ingredients. Official samples of 2,739 commercial feeds were collected for laboratory analysis to determine if product guarantees were being met. Laboratory analyses were made for 37 different feed components for a total of 9,363 laboratory findings. This total included 2,523 crude protein, 675 urea, 263 fat, 2,122 fiber, 733 calcium, 557 phosphorus, 571 salt, 293 trace mineral, 74 pesticide residue and 1,075 drug and antibiotic determinations.

The Division participated for the fifth year in the joint State-Federal Cooperative Program for the inspection of mills manufacturing medicated feed. Regulatory Inspectors are commissioned officers of FDA and perform inspections under both State and Federal laws. Kentucky has approximately 250 mills registered as drug establishments with FDA. Inspection of 112 mills were performed to determine compliance with Good Manufacturing Practice Regulations for Medicated Feeds. The feed industry has made substantial progress in adopting and employing good manufacturing practices.

New GMP regulations were promulgated and became effective on January 1. These regulations are written in understandable language and specific requirements are spelled out in detail aiding interpretation and compliance. The maintenance of drug receipt and inventory records and master formula and production records are emphasized as production controls to ensure that feeds are safe and effective for the consuming animal and safe for the consumer of livestock products.

Aflatoxin became a household word in 1977. Initial speculation feared the aflatoxin problem encountered during harvest of the southern corn crop would extend into the Kentucky and northern corn crop. Many grain buyers examined corn under ultra-violet light (black-light) for possible fluorescences before purchase. Regulatory Services tested corn samples collected over the state and established a testing program. Based on the information obtained from this survey and other reports, aflatoxin contamination of corn was not a significant problem.

Information presented in this bulletin was compiled from data collected from analysis of official feed samples taken during 1977 and is intended to provide the feed purchaser with knowledge as to the manufacturing standards maintained by feed manufacturers distributing feed in Kentucky. The intent is not to indicate feed quality but to show the frequency a feed manufacturer failed to meet the guaranteed analysis for one or more feed components.

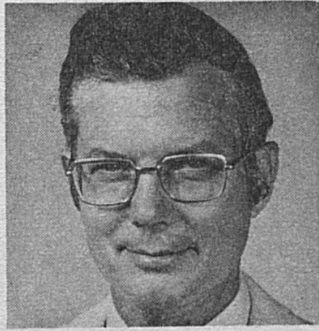

KEYPOINTS OF THE KENTUCKY COMMERCIAL FEED LAW AND REGULATIONS

KRS 250.491 The Director of the Agricultural Experiment Station of the State of Kentucky is to administer the Kentucky Commercial Feed Law of 1972.

KRS 250.501 A "commercial feed" as defined means all material except unmixed seed, whole, unprocessed and not adulterated, which are offered for sale as feed or for mixing in feed. Other exempt commodities include raw meat, hay, straw, stover, silage, cobs, husks, and hulls when unground and not mixed or intermixed with other materials.

KRS 250.511 Registration provisions include:

- a. Registration of facilities manufacturing commercial feed within the state. Firms manufacturing customer-formula feeds are additionally required by regulation to register as a Customer-Formula Feed Distributor.
- b. Registration of commercial feeds, except customer-formula feeds, prior to distribution. Registration continues in effect unless canceled by the registrant or the Director.
- c. Refusal or cancellation of registrations when products are not in compliance. An opportunity for a hearing is provided.

KRS 250.521 Labeling requirements for commercial feeds set forth.

Registered commercial feed shall be accompanied by a label with the following information:

- a. Net weight.
- b. The product name.
- c. A guaranteed analysis to advise the user of the composition of the feed or to support label claims. Guaranteed components must be determinable by an approved laboratory method.
- d. Name of each ingredient or listing by collective term.
- e. Manufacturer's name and mailing address.

- f. Adequate directions for use including warning or caution statements necessary for safe and effective use of the feed.
- g. If a drug is used the word "medicated" would follow the brand name with a statement of the drug purpose and concentration.

Customer formula feed shall be accompanied with labeling providing the following information:

- a. Manufacturer's name and address.
- b. Purchaser's name and address.
- c. Delivery date.
- d. List of ingredients by brand or common name and the weight used in the mix.
- e. Adequate directions for use including warning or caution statements necessary for safe and effective use of the feed.
- f. If a drug is used the drug purpose and concentration in the mix would be stated.

KRS 250.531 A commercial feed is deemed misbranded when the labeling is false or misleading or does not conform to labeling requirements.

KRS 250.541 A commercial feed is deemed adulterated:

- a. If it contains a naturally occurring poisonous or deleterious substance which is injurious to health or if it bears or contains any added poisonous or deleterious substance, food additive or pesticide chemical, which is unsafe within the meaning of the Federal Food, Drug and Cosmetic Act.
- b. If its composition or quality differs from that represented by the labeling.
- c. If it contains a drug and the methods used in or the facilities or controls used for its manufacture, processing or packaging do not conform with current good manufacturing practice regulations.
- d. If it contains any viable prohibited weed seed or more than 480 viable restricted weed seed per pound.

KRS 250.551 Prohibits the manufacture and/or distribution of adulterated or misbranded commercial feed, the removal or disposal of feed under stop sale without permission and the refusal to register, file tonnage reports and pay inspection fees. Regulatory employees are prohibited from releasing trade secret information acquired under authority of the feed law except for judicial proceedings or to other regulatory agents similarly prohibited by law.

KRS 250.561 Sets an inspection fee at the rate of twenty cents per ton for commercial feed, except customer formula feed. An annual fee of \$25 per product is paid in lieu of the inspection fee for feed distributed only in packages of ten pounds or less. Registrants are required to submit an accurate quarterly statement of tonnage distributed and maintain distribution records. Fees collected provide support for the program.

KRS 250.571 Authorizes the Director to promulgate rules and regulations for commercial feeds and adopts the official ingredient definitions and terms of the American Feed Control Officials and regulations promulgated under authority of the Federal Food, Drug and Cosmetic Act.

KRS 250.581 Regulatory Service Employees are authorized to inspect, for the purpose of enforcement of the feed law, any factory, warehouse or establishment or transportation vehicle within the state in which commercial feeds are manufactured, distributed or held. Inspection may include verification of records to determine compliance with GMP Regulations, inspection of equipment, finished and unfinished materials, containers and labeling and collection of samples. Requires reporting the results of sample analysis to the manufacturer and purchaser.

KRS 250.591 Provides for the withdrawal from distribution of feeds when reasonable cause exists to believe that any lot of feed is in violation of the feed law. Disposition of the feed will be consistent with the quality of the feed.

KRS 250.601 Provides for reasonable administration of the feed law by not requiring prosecution, seizure proceedings or withdrawal from distribution orders when the best interest of the public is served by suitable written notice of warning. The distributor is given an opportunity to present his views to the Director before prosecution proceedings are instituted. Temporary or permanent court injunctions are provided for to restrain any person from violating or continuing to violate provisions of the feed law.

KRS 250.621 Requires the annual publication of information concerning sales, production and the results of laboratory analysis performed on commercial feeds when compared to label guarantees. This information shall not disclose the operation of any person.

KRS 250.990 Penalties for any person convicted of violating provisions of the feed law shall be adjudged guilty of a misdemeanor and be fined not less than \$25 and not more than \$100 for the first violation and not less than \$50 and not more than \$500 for subsequent violations.

Note: The keypoints represent a summary of some but not all of the requirements. For specific information on label format, expression of guarantees and other provisions, copies of the law and regulations are available on request.
