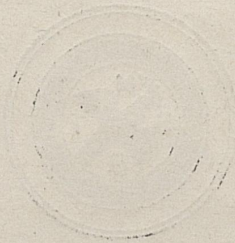

Owensboro, Ky., August 14, 1923.

FIRST DAY—MORNING SESSION.

The eighth annual session of the State Grand Temple of the Sisters of the Mysterious Ten and Juveniles was called to order at 12:45 in the Fourth Street Baptist Church by State Grand Princess Sister Nellie M. Haggard. Password was taken by Joshua, with the assistance of Senior and Junior Marshals, and found all in possession of the proper password except one, who came forward and received the same.

Meeting was opened in ritualistic form with singing, "I surrender all," followed with prayer by Grand Chaplain Sister Alice Goodloe. Introductory remarks by Grand Princess Sister Nellie M. Haggard. Motion by Sister Mary A. Lilly, and seconded, that the report be adopted. Amendment to the motion by Sister Cora Richardson, seconded by Sister Katie B. Lawrence, that where it reads "Officers, 25 cents fine," that it read "All delegates pay 10 cents fine for being late." Amendment having been voted on, was carried. Original motion having been voted on, was adopted, saving the 25 cents fine for officers. Motion by Sister Nannie L. Fields, seconded by Sister Belle Hughes, that the bar for the delegates extend back to the post of the balcony. Motion carried.

Sister Cantrill stated that a gentleman was at the door and said that some one had picked up the wrong suit case, it belonging to an elderly lady, and asked that it be returned.

FIRST DAY—AFTERNOON SESSION.

Owensboro, Ky., Aug. 14, 1923.

The Grand Temple and Grand Lodge in joint session was called to order at 3:10 P.M., with Grand Master Brother G. T. Halliburton presiding. Brother G. F. David was asked to preside during the reading of the reports of the Grand Officers. Sister Hattie Payne presided at the organ while we joined in singing "Since Jesus Came Into My Heart," led by Grand Chaplain Sister Alice Goodloe. Scripture read by Rev. Bigbee, 90th Ps., followed with prayer by Grand Chaplain Rev. Bigbee. Joined in singing "Shine for Jesus." All officers who were to make reports were asked to take the platform.

Brother G. F. David, P. N. G. Chaplain, suggested that we stand and sing "Blest Be the Tie That Binds" and shake hands. The suggestion was carried out, and every one seemed to enjoy it, as we are bound together with the tie of Justice, Mercy and Truth.

Word was received that Bro. Washington was at the door, wanting to speak to the Grand Temple about the certificates. Sister Bessie Ballard was asked to escort the brother in. He was then introduced to the Grand Temple and made a statement concerning the certificates, and said he would call for same this afternoon.

Joined in singing "There Is Sunshine in the Soul," led by Grand Chaplain Sister Alice Goodloe.

Western Deputy Sister Scharlotte Powell read her report.

Motion by Sister Katie B. Lawrence, seconded by Sister Mary Crow, to adopt the report of the Western Deputy. Motion carried.

Eastern Deputy Sister Clarine Livas read her report.

Motion by Sister Maria Bloch, seconded by Sister Mattie V. Burton, to adopt the report of the Eastern Deputy. Motion carried.

Minutes of the second day's morning session were read. Motion by Sister Belle Hughes, seconded by Sister Mary F. Simmons, that the minutes be adopted. Motion carried.

The following sisters paid 10 cents fine for being late: Sisters Clara D. Lee, Willie Broner and Myrtle Mansfield.

Central Deputy Sister Cora Richardson's report was read by Assistant Grand Secretary Mary F. Chatman.

Motion by Sister Louisa B. Jones, seconded by Sister Emma Tinsley, that the report be adopted. Motion carried.

Motion by Sister Alice Boswell, seconded by Sister Carrie Gibson, that we go into the election of officers at 10 o'clock. Motion carried.

Motion by Sister Cora Richardson, seconded by Sister Eliza Arnett, that Sister Annie Swannigan, of Louisville, preside during the election of officers. Motion carried.

Motion by Sister Nannie L. Fields, seconded by several, that we extend the time until the Committee on Credentials report. Motion carried.

The Credentials Committee were then sent back to complete their report. While we were waiting on the committee to report we joined in singing "You May Look for Me," led by Grand Chaplain Sister Alice Goodloe; "Shine on Me," led by Sister Frances Wells, also "Leaning on the Everlasting Arm."

Motion by Sister E. B. Brown, seconded by Sister Mattie V. Burton, that we pay the janitor \$5, Finance Committee \$3, Installing Officer \$2, Assistant Installing Officer \$1. Motion carried.

Committee on Mileage and Per Diem reported.

Motion by Sister Belle Bullitt, seconded by Sister Emma Tinsley, that the report be adopted. Motion carried.

Committee on Credentials made a final report.

Motion by Sister Emma Tinsley, seconded by several, that the report be adopted. Motion carried.

Sister Annie Swannigan was asked to come forward and take the Grand Princess' chair, as she was to preside during the election. Sister Swannigan then asked that all delegates come forward and be close together.

Motion by Sister Cora Richardson, seconded by several, that we elect by acclamation. Motion carried.

House was then polled and there were 112 delegates.

Joined in singing "Assembled in Thy Courts Once More." Followed by prayer by Grand Chaplain Sister Alice Goodloe.

Motion by Sister Bessie Allen, seconded by several, that the rule be suspended and our present Board be re-elected by acclamation. Motion carried.

Motion by Sister E. B. Brown, seconded by Sister Hattie Payne, that we dispense with the election of Attorney, Auditor and Grand Medical Register until we can hear who the brothers elect. Motion carried.

Motion by Sister Cora Richardson, and seconded, that Sister Bessie Allen be installing officer. Motion carried.

Motion by Sister Louisa T. Evans, and seconded, that Sister Blanche Hupsel be assistant installing officer. Motion carried.

Motion by Sister Mary F. Simmons, seconded by Sister Mary Burnside, that Sisters Nellie M. Haggard, E. B. Brown and Mary F. Chatman be the delegates to the National Grand Temple.

Joined in singing "I Heard the Voice of Jesus Say."

Motion by Sister Susie Tardiff, seconded by Sister Carrie Gibson, that we meet at the usual hour tomorrow morning to install officers. Motion carried.

Motion by Sister Mattie V. Burton, and seconded, that Sister Louisa T. Evans be first alternate to National Grand Lodge. Motion carried.

Motion by Sister Henrietta Sawyer, and seconded, that Sister Bessie Ballard be second alternate. Motion carried.

Motion by Sister Alice Boswell, and seconded, that Sister Susie Tardiff be third alternate. Motion carried.

Sister Susie Tardiff withdraws her motion to meet tomorrow morning at the usual hour to install officers.

Motion by Sister Ella Scott, seconded by several, that we meet tonight to install the officers. Motion carried.

Sister Emma Tinsley made a statement to the Grand Temple that we ought to get a jewel for our Grand Princess, so that we may send her up to the National Temple next year looking pretty, and asked each one present to donate ten cents. REPORT OF NELLIE M. HAGGARD, GRAND PRINCESS

To the Grand Temple of the Sisters of the Mysterious Ten and Juveniles of Kentucky, Greetings:

If I live a life that is clean and square and I love my fellow man and I lend him a hand to help him bear his burdens whenever I can, I need not fear what the future holds nor what the reward shall be, for the mighty love that all enfolds will most surely care for me. If I speak a good word of cheer to one whose sorrows have borne him down and give him new hope to journey on and change to a smile his frown, I shall not dread when the shadows fall and the end of my life draws near. For that wondrous love that shelters all will drive away my fear. For my life is measured by what I meet, and I earn my own reward. So the love I give makes my heart complete and through it I gain the reward.

DEAR SISTERS AND MOTHERS

Matrons, another year has passed over the bridge of time into the land of yesterday. Each day, as it passed from the sunlight fields of time into the shadow land of eternity, has told its story of defeat and victory, shadow and sunshine, sorrow and gladness, tears, laughter, failure and success. The fruit of hope so temptingly held to one's famished lips may have turned to ashes in our sight. Ideals may have failed to ripen into realities, sorrow's heavy hand may have been pressed down upon us until our hearts have ached beneath their burdens. But, thank God, no sorrow, no tears laden with grief have hidden from us our guiding light—Justice, Mercy and Truth.

I rejoice today that the great I Am, He that suffers not a sparrow to fall without His knowledge, has cared for and guided our steps during the past year and has permitted us to again assemble in what I hope will be the most pleasant and profitable of all our sessions in the past. As I look into the faces of this magnificent body of delegates who have come from all parts of the State to inspect the work of the past year, to note the defects and to draw plans for the future, it is indeed a pleasure to me to extend to each and every one of you a cordial welcome to this, our eighth annual session. To you who are with us for the first time I trust this session will be an inspiration to you. We pray you have come to help us make this session one long to be remembered. We separated at the adjournment of our last Grand Temple meeting in Shelbyville with a resolution and a fixed purpose to do more to better our condition and those with whom we come in contact. These fixed purposes and resolutions meant well, but we judged the future by the past, for we had no conception of the arduous task which confronted us. The many, many difficulties we would have to surmount, the many hard battles to be fought before we reach the goal of our ambition as members

of this grand and historic order, an order from the dawn of existence to the present moment that has always stood for and maintained the best there is in womanhood. You should unite your forces and with gigantic struggles come to the rescue of the many bleeding hearts and struggling souls who stand so much in need of your counsel, your guidance, your cheering words of helpfulness. For what purpose are organizations if they do not bind us closer together in friendship, truth and love and make us feel each others' care, bear each others' burdens and sympathize with them in their sorrows and difficulties. To feel and care for those who love us. To labor for the peace and happiness of those only who are bound to us by fraternal obligations. As members of S. M. T. our highest aim is to make the world better for having lived therein. You have met in this grand session not simply to hear reports and to adjust such other business as may come before you. These are minor matters. But as a body of ladies here assembled, some of the best in refinement, culture and intellectual ability that come within our jurisdiction.

Secret organizations have their places in life. They have done much to solve the many problems confronting our people, they have brought comfort to many bereaved families and have been a very present help when afflictions and death cast their shadow on life's pathway. We should never think that the organization can not exist without us. God forbid. The nation moves on if the President dies. Our good deeds of peace, honor, passions, temperance, fidelity, charity, justice, mercy, purity and truth should live in the hearts and affections of a gracious people. The demand for strong womanhood was never more audible than now. Women who possess the ability to do, who can and will do regardless of cost or sacrifice. Your capacity to do may not be as great to do as some one else. God did not give all the same talent. But he has given us the ability to utilize that which we possess. Hide it not in the sands of negligence.

OFFICIAL ACT

There is a time in executing the duties of your office that demands the utmost consideration in rendering decisions and passing opinions on matters which come before you. Much depends upon the safety of our Grand Temple and the welfare of all concerned. It should be beneath the dignity of any officer to rule with tyranny and malice. March 1, 1923, I granted a dispensation to all Temples for ninety days to take in new members. Some of the Temples grasped the opportunity and some did not. June 4, 1923, I began my annual visits with the assistance of our deputies. Found some of them in a healthy condition, some not doing so well, as too many want to rule. We visited the following places:

Louisville, Hawesville, Owensboro, Henderson, Marshall, Corydon, Morganfield, Madisonville, Princeton, Fredonia, Marion, Paducah, Cadiz, Hopkinsville, Russellville, Trenton, Allensville, Gordonsville, Smith Grove,

Icy Link, Horse Cave, Lebanon, Lexington, Georgetown, Lawrenceburg, Versailles, Harrodsburg, Perryville, Columbia, Aatoka, Danville and Winchester. I am not reporting every visit separately. Each visit will ever be remembered with pleasure by me, also the many tokens of love. At Louisville I was presented with a box of candy from the Knights of Friendship, a beautiful chocolate set from Friendship Temple No. 25 and a grand reception from the twelve Temples at Louisville, which was highly appreciated and enjoyable. At Madisonville the Temple gave sterling silver salt and pepper shakers. The Juveniles, two beautiful bath towels. Also the Juveniles at Louisville \$2.00. I shall never forget the kindness shown me by my sisters and brothers everywhere. I have been royally entertained in every home since I have been your State Grand Princess. Sisters, I would have you to know that it is not the great numbers of fraternal organizations with which we have to compete, or yet the opposing forces from without that we need to fear, but rather the petty jealousy and over-ambitious spirits of our membership that must be controlled and held in subjection if the integrity of our great order is to be maintained. I am glad to report to you today that the majority of our Temples throughout the state continue to grow in interest, finance and membership. Have tried to impress upon the members that the ballot is not a means of getting even or a way to show your dislikes, but the ballot is to protect the order. The innocent should not be made to suffer at the hands of those who use black balls to gratify personal ends. Let us not heap burdens upon others that we ourselves would not like to have put upon us. We must more carefully study the thoughts, principles and purposes of our order as expressed in our rituals. We should blend all our efforts toward putting them into practice in our daily lives at home and abroad as well as in our lodge rooms.

NECROLOGY

The icy hand of death, the king of terror, has been with us on every hand. Many homes have been touched and the despairing cry of many broken hearts have been heard. The young and aged have fallen before his withering hand and we are brought face to face with the unanswered question of all the ages, What is death? On June 29, 1923, death took from us another landmark in the person of Sister Ada Pullen, of Paducah, our Past State Vice Grand Princess, Deputy Grand Princess and National Grand Treasurer at the time of her death. She was faithful to her trust, doing at all times what she could to uphold the principles of our beautiful order. She lived a Christian life for a number of years. Therefore naught remains for such a sainted life but to fall asleep. Peace to her ashes. May we so live that when coming to the margin of death may it be said of us:

"Servant of God, well done;
Rest from their love employ,
The battles fought, the victory won,
Enter their master's joy."

We are opening a new field of labor in the Cumberland Mountains. At our next meeting we will be able to report to you and several others.

RECOMMENDATIONS

We find so many Temples that do not have their annual sermons because the brothers do not.

I recommend that every Temple in our jurisdiction assemble themselves some place together the fourth Sunday in May each year to give God thanks for the many blessings he has bestowed upon us in the past and to implore continuation of the same in the future. Every Temple failing to turn out on same date shall be fined the sum of \$5.00, to be paid into the treasury of the Grand Temple, unless they have been granted a dispensation for the same.

I close this report of my year's work with you with a feeling of gratitude unprecedented since it has been my good pleasure to preside over you. There will always rest in my heart the most profound appreciation for the honor imposed. It has been my greatest desire to promote the welfare of our order, regardless of labor or sacrifice. In all my decisions which the duty and the obligations of this office demanded, I have endeavored to do so with love for all and malice toward none. The principles which bind us together if put into practice will make strong, influential and great members.

They call for women whose standing in the community points to high and noble deeds. Women whose good name stands above reproach or blemish. To the Grand Officers, and sisters as well, you have stood by me. Without your support and the help of my God I could not have been successful. Time has passed so swiftly it seems but yesterday since you presented me the gavel of authority and the badge of this office. Today I bring it back to you. I trust you will find it untarnished and unsoiled. May this session be long remembered.

It has often been thought wise by many in the business or commercial world to report only the bright side of their business transactions; to present only the prosperous and encouraging side to the public. Whether that is a wise plan or not, I am not here to say.

But I will say that in our fraternal relations with brother, sister and juvenile of our noble Order it is our policy, and especially my pleasure, to report at all times the true side, whether it be altogether as we would like it or not.

But, dear sisters, we are more than happy to say we have nothing to report but words and transactions of encouragement.

Our worthy State Grand Princess has already reported to you the general condition of our Order among the sisters and juveniles during the past year, and the facts and figures in my report are intended to verify the same.

Therefore I urge that you carefully study my itemized report for your complete satisfaction. Just at present, however, I wish to add we have many things in the past year's transactions to encourage us.

First, you observe that while our death rate is larger than last year, we have paid off all death claims promptly and met all outstanding financial obligations and still have an encouraging balance.

But that is not all; we have also been able to place on deposit in both bank and building association the good round sum of \$3,000. And this, too, at a fair rate of interest, so that your money is growing while you sleep. We have felt it is more business-like to be getting a neat little percentage on our surplus than to let it remain in bank idle while the bankers were making 6 or 8 per cent on it.

Financial success is not always the greatest item of success in a large and growing institution like ours. Pleasant and friendly co-operation among brothers, sisters and children, reasonable contentment and satisfaction resulting in greater confidence in all and for all have been the goals at which we have aimed. And in these respects I feel we have not failed. Much more might be said along similar lines, but time is precious and we will simply add:

May we continue to move onward and upward in our earnest and honest effort to better the condition of our fellow-man, and our Heavenly Father's blessing will continue to follow us.

REPORT OF GRAND BOARD OF MANAGERS

Owensboro, Ky., August 14, 1923.

Most Worthy State Grand Princess, Officers and Members:

After the expiration of another year, through the all-wise providence of an Almighty God we are permitted to come before you to give an account of our stewardship. We are thankful to say that peace and harmony has prevailed throughout the year, and we come praising God and singing, "An' are we yet alive to see each other's face: Glory and praise to Jesus give for his redeeming grace."

In the very beginning of the year we realized the fact that it was our very important duty to protect the interests of the State Grand Temple, especially the financial interest. Since it was not in our power to reduce the expenses other than in our own department, in our first meeting it was unanimously decided to hold no more meetings than were absolutely necessary. So we are pleased to report to you that our first meeting was held November 18, 1922, and our next meeting August 13, 1923, which we feel shows wonderful progress over other years, for the work has gone on in fine shape and we have been able to save the Grand Temple the expense of two meetings, thus we have protected the interest of the Grand Temple and its treasury as well.

We have paid one hundred and seven death claims, with a few un-adjusted claims, but nothing of a serious nature.

REPORT OF GRAND AUDITOR

Owensboro, Ky., August 14, 1923.

Officers and Members of the Grand Temple in Session, Greetings:

The reports of the Grand Officers, both sisters and brothers, who have handled your finances are correct as read. Hence to repeat the figures and statements made by them is wholly unnecessary in the extreme.

As stated in the respective financial reports, the brothers have above all outstanding indebtedness in the Relief and Grand Lodge approximately \$18,000 and the sisters have in the two departments approximately \$10,500. Hence both Grand Bodies have at this writing in the neighborhood of \$30,000. This is an enormous saving for both Grand Bodies in the short time of four or five years, when the great odds that were overcome are considered.

A ship laden with 8,000 souls of Kentucky's best, many of whom are children, with \$30,000, and blazing the trail for 200 ships of a lesser size, make such a ship require safe, sound and highly intelligent and efficient steersmen. The great measure of prosperity and happiness which the two Grand Bodies are now enjoying is a fair indication of the type of official family you have on your roster.

REPORT OF GRAND ATTORNEY

To the Grand Lodge of the U. B. F., S. M. T., and Juveniles of Kentucky, Worthy Grand Master, Worthy Grand Princess, Officers, Brothers and Sisters, Greeting:

It gives me great pleasure to present to you my first report as Grand Attorney of this great organization.

First, I wish to thank you for your confidence and trust placed in me by selecting me to look after the legal affairs of this Grand Lodge, and I hereby express to you my appreciation for the high honor your suffrage has given me.

I take great pleasure in saying that the Grand Attorney has been called upon for legal services through our Most Worthy Grand Secretary and Grand Board of Managers of the U. B. F. and the Most Worthy Grand Princess and Board of Managers of the S. M. T., in a number of important cases and questions in connection with the Endowment Department. I shall like to take up some of the cases of the U. B. F. in detail and then some of the cases of the S. M. T.

First, the case of Amelia Wheeler vs. U. B. F., S. M. T. and Juveniles was a case which grew out of Jacob's Lodge No. 8, U. B. F., of Lexington, Ky., and the facts of the case are these:

That one Fletcher Robinson took out a policy in 1905 in the U. B. F. and made one Amelia Wheeler beneficiary, but in 1916 he came to the Lodge and verbally started to the Lodge that the policy had been lost and asked that a new policy be issued to him in which he made his estate beneficiary.

The Lodge required the said Fletcher Robinson to make no written statement that the policy had been changed, and the Grand Secretary had no notice that the beneficiary had been changed; the result was that, after the death of said Fletcher Robinson, it seems as if one Amelia Wheeler, Covington, Ky., held the original policy, under which she claimed the proceeds of the same, and one Sudie Robinson, of Georgetown, wife of Fletcher Robinson, was claiming the proceeds of the same policy as administratrix of the said Fletcher Robinson. The said Amelia Wheeler brought action in the Fayette Circuit Court on the original policy, but after a couple of trips to Lexington and filing many answers and cross-petitions the Grand Attorney was able to have the case dismissed, settled; that is, he got the attorneys of both parties together and they agreed to split the proceeds of the policy and call the whole off.

I shall like to say that this was a dangerous case, and if the same had gone through Court it was likely the Lodge would have had to pay for both the policies, namely because the local Lodge was negligent in not complying with the laws of the Grand Lodge concerning the change of beneficiary.

The Grand Attorney had been called on by the Grand Secretary to render many opinions touching vital questions of the laws of the U. B. F., and also the laws of the Commonwealth of Kentucky.

Concerning some of the specific work rendered the S. M. T., I shall like to state that when I came into the office last year there was one very serious case hanging fire, known as the Sarah Craig case.

I do not remember all of the names of the parties connected with this case, but the facts, as well as I remember, are these: That one Sarah Craig had named a party beneficiary in her policy and said party died before Sarah Craig died. After the death of Sarah Craig the proceeds of the policy were paid to the heirs of the deceased beneficiary. Sarah Craig made a will giving all of her property to another party, and the executor of the will contended that the proceeds of said policy should come into his hands as executor, as against the heirs of said deceased beneficiary.

In the beginning it seemed to me that the Secretary of the S. M. T. had made a mistake in paying the money to the heirs of the deceased beneficiary. But after looking into the matter I found that the law was in favor of paying the money to the said heirs.

The following is a copy of the letter in regard to the matter which I wrote to Dr. Edmund J. Wood, executor of the estate of Sarah Craig:

October 4, 1922.

Dr. Edmund J. Wood,
Danville, Ky.

Dear Mr. Wood:

As the Attorney for the U. B. F., S. M. T., Miss Brown of Covington, the Grand Secretary of the S. M. T., turned your letter over to me for a reply and an opinion.

I shall like to state that I have thoroughly looked into the law touching this matter and can safely say that your client is not entitled to the proceeds in question, but the heirs of the representative of the beneficiary.

I shall like to cite you to the following authorities upon which I have based my decision:

The leading case, *Bright vs. Supreme Council, etc.*, 183 Ky., 388; *id.*, 209 S. W., 379; other cases, 143 Ky., 618; *id.*, 136 S. W., 1006; 149 Ky., 588; *id.*, 149 S. W., 937; Ky. Statutes, Sec. 655.

If your attorney will look into these decisions he will see that unless the beneficiary to the policy was changed, even though the beneficiary died before the insured, then the proceeds of the policy should go to the heirs of the beneficiary.

I hope that this explanation is satisfactory.

This letter seemed to have settled the threat, as I have not heard anything further from the case.

The Grand Attorney has also given many opinions touching claims in the Relief Department of the S. M. T. and also suggested the change of one of the sections of the by-laws touching the same.

The Grand Attorney would like to state that he assisted Brother Morton in settling the serious *Eugene Hopson vs. Carthagina Lodge No. 50* case of Louisville, Ky. This was a case in which Brother Eugene Hopson had been suspended from the Lodge and he was threatening suit against the said Lodge, and Brother Morton and I were appointed as a committee of two to arbitrate the matter, and we settled the matter once for all by having Brother Eugene Hopson square up with the Lodge and the Lodge square up with Brother Eugene Hopson, Brother Hopson being reinstated and transferred to another Lodge.

At the last Grand Session of this Lodge the Grand Attorney, together with the Grand Master and Grand Secretary, were appointed a committee of three to revise the constitution and by-laws of the U. B. F.

We are glad to report that we have worked on the said constitution and by-laws, nights after nights, faithfully and we are ready to submit to the Grand Lodge, not a new constitution and by-laws, but practically the same constitution and by-laws, with all amendments adopted since the constitution and by-laws were passed in 1911 at Mt. Sterling, Ky., and from this addition we have rearranged the said constitution and by-laws and placed the same so that they may be easily found.

I will again state that I thank you for the confidence and trust you have placed in me, and state that I have worked hard and faithfully on every subject given me during the year and hope that this report will heartily meet with your approval.

SUGGESTED AMENDMENT TO THE RELIEF LAWS OF THE S. M. T.

ARTICLE 12.

Section 2 and 3 read as follows:

Section 2. The interest of any person so designated is not transferable and shall cease and determine in cases of her death during the lifetime of such member.

Section 3. Upon the death of a beneficiary the benefit as specified in the certificate shall be transferred to some other person, to be designated by said member, and the Board shall issue such member a certificate containing the names of the substituted beneficiaries; provided, that no transfer shall be made for any consideration except that of natural love and affection.

I suggest that Section 2 be eliminated altogether and Section 3 be amended so as to read as follows:

Section 3. Upon the death of a beneficiary the benefit as specified in the certificate shall be transferred to some other person, to be designated by said member, and the Secretary shall issue such member a certificate containing the names of the substituted beneficiaries; provided, that no transfer shall be made for any consideration except that of natural love and affection; and that, in case the member should die after the death of the beneficiary named in the certificate, without designating a new beneficiary, then the proceeds of the said certificate shall go to the heirs of the deceased beneficiary.

Most Worthy Grand Officers and Members of State:

We, your Committee on Grievances, make the following report:

We received a letter from Mrs. L. J. Buckner, of this city, saying she had applied for membership in the Temple in this city; that they received her money and kept it for two months and finally refused her admittance, saying she was past the age. She herself says she was born four years after the war, at that rate making her over the age for admission. We recommend that Temples be more careful in taking in applications and holding people's money.
