## Bernie Shively Is Chosen As Athletic Director; Ab Kirwan Gets U. K. Head Coaching Position

### Reunion Classes Ending In "3" And "8" Scheduled For Return To Campus In June

As this issue of the Alumnus goes to press only two short months remain before the classes ending in "3" and "8" will gather on the University campus for the June reunion activities.

Last year some 600 alumni made their way back to the campus and registered at the Alumni Office for the occasion. The number returning for the reunion of "3" and "8" is expected to greatly exceed that of last year.

The hub of reunion activities will be in the new Student Union building where the Alumni Office will be quartered in its new office, a suite of three rooms. It is thought that many of the class reunion luncheons will be held in the Student Union building and perhaps the annual alumni banquet, which is the climax of the reunion activities. Returning alumni will want to stroll over the campus and note the

striking changes made within the last five years. The new law building, named Lafferty hall, has been completed, is now in use and will be dedicated sometime during the June reunion. The engineering quadrangle and the Student Union building are almost complete and construction of the new biological building is well under way.

Alumni as hitherto, will have the privilege of attending baccalaureate and commencement exercises as well as enjoy an informal get-together at the annual alumni tea given by Dr. and Mrs. McVey at the Maxwell Place.

### Bronze Plaque Honoring President McVey Will Be Placed In The University Library

With the realization that President Frank L. McVey has rendered many years of valuable service to the University of Kentucky, a movement is under way by which a bronze plaque is to be placed in the university library in recognition of his service.

A committee met with Dr. McVey and received his approval of the project, after which, a contract was signed with Mr. Christian Petersen, sculptor, who is now working on the plaque. The plaque is to be installed on the ground floor of the library in the entrance facing the north side. It will be six feet high and four feet wide.

The project having been approved by the Alumni Executive Committee, Dr. G. Davis Buckner, Dr. George H. Wilson, Miss Lulie Logan, and Ralph Edwards were appointed as a committee to contact alumni.

The amount to be raised is \$2,000 and the whole hearted support of all alumni is needed to carry the movement through to a successful finish. Many alumni have already subscribed to the fund. Others wishing to do so are asked to fill in the coupon on page three and mail it to Robert K. Salyers, Alumni Secretary, University of Kentucky, Lexington, Kentucky.

With the appointment of Bernie Shively, '36, acting head of the physical education department, as director of all University athletics, who immediately selected Ab Kirwan, '26, football coach at du Pont Manual High School, Louisville, as head varsity football coach, all University alumni and friends are viewing with an air of optimism Kentucky's new deal in athletics in which eleven University of Kentucky Alumni hold responsible positions.

The new set-up in athletics follows almost in detail the plan outlined by the Alumni Executive Committee which was drawn up from suggestions received at the six alumni meetings held throughout the state where alumni were asked for their views on the University athletic situation.

The selection of Mr. Shively, former All-American football player from the University of Illinois, was unanimous. He came to the University in 1927 as assistant football coach under Harry Gammage and in 1934 was made head of the Physical Training Department of the University High School.

With Mr. Shively lies the full responsibility of all University athletic affairs. He will arrange all schedules and has the power to hire coaches for all sports, the coaches for which are considered as faculty members and will receive pay according to faculty schedules.

To Mr. Kirwan will go the honor of being the first University graduate ever to return and serve as head football coach. While at the University he played end and half-back and was captain of his team in 1925. On Thanksgiving day of his senior year in a game with Tennessee he threw three touchdown passes to Len Tracy, '26, now sports writer for the Louisville Times. Kentucky won 23 to 20.

Regarding the policy of the new administration, Mr. Shively said that Coach Rupp's record speaks (Continued on Page Three)
