ABOUT THE LIBRARIES

PASD presents program for UK Librarians:

The first program of the Professional Activities and Staff Development (PASD) Committee will concern the use of public relations in the academic library. It will be held on Thursday, 13 January from 1 p.m. to 4 p.m. in the President's Room of the Student Center and will feature Mr. Fred J. Glazer, Director of the West Virginia Library Commission.

Mr. Glazer, a former adman and now an enthusiastic library publicizer, has much information that he will share with us on the subject. After he has spoken, we will divide up into groups to discuss specific ways that we can implement public relations in our library. A reception for Mr. Glazer will follow the program.

All interested library staff members are invited to attend and bring their PR ideas with them.

Music in the Gallery - Spring recital series:

A preview of the contemporary opera <u>Rumpelstiltskin</u> will be the first in a series of spring recitals <u>scheduled</u> for the Gallery, Department of Special Collections, King Library North. The series, which began last October, is sponsored jointly by the School of Music and the University of Kentucky Libraries.

The preview of Rumpelstiltskin, which premiers later in the month at the Lexington Opera House, will be conducted in the Gallery at noon on Friday, 14 January 1977, by Phyllis Jenness. Ms. Jenness is on the faculty of the School of Music and is in charge of musical preparation for the opera. In addition to selections from the opera performed by several soloists and ensembles, Ms. Jenness will discuss the story and production of the opera.

The Music in the Gallery series is presented at noon on selected Fridays throughout the semester and is free and open to the public.

MRAP update:

The MRAP Implementation Committee has been looking at the overall organization of the library and will now begin to meet with various planning committees and the library administration to discuss their ideas.

Serigraphy in South Lobby:

Fourteen silk-screen prints make up this fine exhibit of professional and "student" art work. This suite of prints is the result of the Louisville School of Art's experimental summer project called the "Storefront Studio." Four Louisville-area high school students worked under the guidance of professional printmaker Garry Kaulitz of the Louisville School of Art faculty. The exhibit will be on display through 26 January.

MINI-REVIEW:

A recent acquisition of note is the <u>Biographical dictionary of the federal judiciary</u>, compiled by Harold Chase (and others), (Ref.: 347.7314:B5205c). Covers federal judges from 1789-1974; biographical section based on material from <u>Who's Who in America</u> and <u>Who Was Who in America</u>. Detroit: Gale Research Co, (1976).

This publication claims to be for the use of scholars, lawyers, historians, journalists and students. The compilers have included only those judges with lifetime tenure and there is an introductory essay titled "Perspectives on biographical data on the federal judiciary."
