'Don't Ask, Don't Tell' surveys sent out to 400,000 service members

[Jim Miklaszewski, "First Read from NBC News", 07 July 2010] The Pentagon today sent out 400,000 surveys to service members for their opinions on the repeal of the "Don't Ask, Don't Tell" policy barring gay and lesbian personnel from serving openly. The survey includes questions about the impact the repeal might have on morale and readiness, and a service member's willingness to share quarters, bathrooms, and shower facilities with gay or lesbian service members.

The 200,000 active duty and 200,000 guard and reserve forces were chosen at random for the surveys, which were e-mailed and must be completed and returned by Aug. 15. A similar survey will be sent to the family members of service members around the first week in August.

Although the identity of all those who respond will remain confidential, there is a separate link within the survey for those gay or lesbian service members, who wish to provide additional comment without fear of being singled out and separated from the service as required by the existing law.

Once the surveys are completed and analyzed, the Pentagon has until Dec. 1 to come up with an implementation plan for the repeal of "Don't Ask, Don't Tell" and the open service of gay and lesbian service members.

Argentina Approves Gay Marriage

[By Alexei Barrionuevo, New York Times "Americas", 15 July 2010] BUENOS AIRES — Argentina's Senate narrowly approved a measure early on Thursday authorizing same-sex marriages, making Argentina the first country in Latin America to allow gay couples to wed.

The same-sex marriage measure will give gay people the same marital rights as heterosexuals, including adoption and inheritance rights.

Mexico City became the first jurisdiction in Latin America to legalize same-sex marriages last year. Two other countries in the region, Uruguay and Colombia, allow civil unions for same-sex couples.

GSA Sponsors Anti-Bullying Film

The GLSO Gay Straight Alliance for Youth used it's profits from the Pride Festival to become a financial sponsor of the Southern Poverty Law Center (SPLC) film "Bullied: A Student, a School and a Case that Made History." The 40 minute film will highlight the experiences of Jamie Nabozny who was bullied throughout middle school and high school.

Nationally, more than 80 percent of LGBTQ youths said their teachers never, or rarely, interrupt homophobic remarks, according to a 2007 survey by the Gay, Lesbian and Straight Education Network (GLSEN). While some teachers may look away due to their own biases, most teachers fail to interrupt these remarks because they don't understand their obligations or know how to help.

The SPLC film will be distributed free to many schools. The GSA will receive a copy for its sponsorship. We will arrange a screening of the film iin the fall. Thanks to all who supported the GSA booth at the festival.

Another focus of SPLC has been the presence of members of hate groups in the U.S. military. In 2006. The SPLC informed the U.S. military about extremist activity among active-duty personnel. For years the Pentagon denied that a problem existed and said that it's policy of "no active participation" was sufficient to keep organized racists out of the military.

SPCL sends information to the Pentagon when they find evidence that soldiers are participating in hate groups. Numerous active-duty members were found to engage in a range of activities including posting racist, homophobic and anti-Semitic messages to social networking websites and e-mail lists or maintaining online profiles filled with extremist materials.

An unclassified FBI Intelligence Assessment in Fall 2008 detailed more than a dozen investigative findings and criminal cases involving Iraq and Afghanistan veterans as well as other active-duty personnel engaging in extremist activity in recent years. The FBI report warns that the military training veterans bring to the white supremacist movement increases the possibility of offenders carrying out violence within the United States.

The Pentagon has recently tightened its policy on extremist activity and made it more specific. The policy has been in effect since November 2010 but was announced only a month ago. Under the new policy, military personnel "must not actively advocate supremacist doctrine, ideology or causes" "otherwise advance efforts to deprive individuals of their civil rights." The new rules specify that "active participation" includes activities such as recruiting, fundraising, demonstrating or rallying, training, organizing and distributing supremacist material, including online posts.

As the "Don't Ask, Don't Tell" policy approaches its end, it will be interesting to see if anti gay harassment increases within the military. If it does, we can count on the SPLC to continue to pay attention to hate crimes involving military personnel and to be an ally in our progress for full inclusion in all aspects of American life.

Faith

"Come on you can do this, I have faith in you." "If you only have faith...." "Have faith in yourself." "Just take that step of faith and do it." We have all heard these phrases before, but what are we really saying? Aren't we saying, have confidence, know that you can do it, believe in yourself?

Hebrews 11:1 says, "Now faith is the substance of things hoped for, the evidence of things not seen." I have heard it said that to have faith is to have the title deed to whatever it is. It is having the evidence or the proof of the thing. Only in Christ we take it one step further and hold the title deed or the proof even if we don't see it with our eyes.

New Testament faith covers a variety of levels of personal commitment. In Hebrews 11 we see a variety of men of faith being mentioned due to their intense level of faith. We also see the disciples themselves demonstrating a variety of levels of faith. Yet the one common thread with each of these is the fact that they put their faith to work.

James 2:14-26 says that faith works together with our work. In other words to simply said you have faith doesn't mean a whole lot. However, you can demonstrate your faith by how you live and what you do.

How do you handle difficult circumstances that come up in your life? Do you fall apart at the first mention or notion of problems or do you turn your eyes upon Jesus and know (have confidence) that He has everything under control. I would say that probably most of us fall somewhere in the middle.

Faith is at the center of the Christian live. Hebrews 11:6, "But without faith it is impossible to please Him, for he who comes to God must believe that He is, and that He is a rewarder of those who diligently seek Him." I would like to be able to say that I have confidence in God and not get upset or worried, but I know (through experience) that I don't always do that. However, it should be our goal to aspire to this level of faith. The Word tells us that if we lack faith all we have to do is ask God and He will give it to us.

Then there is the faith that leads to salvation which is a personal attachment (abiding) in Christ. Apart from God we can do nothing, even believe that He is. He chose me, I didn't choose Him. Unless the Spirit of God pulls at me, I am unable to attach myself to Him.

Once I understood this, I changed how I prayed for the lost. I now ask God to begin to speak to the person, to woo them to Himself, to open their spiritual eyes to see. I can have faith (confidence) that God hears this prayer because I know that is His desire, to have intimate communion with each one of us.

Will I always see it come to reality? No, it may not come in my life time. It may not come at all because we all have our will, the right to choose or not to accept Christ as our personal Savior. This is part of what use to confuse me so much about faith. I can have the faith, but in this instance, the person has to choose as well. It takes both.

The Bible defines faith in the book of Hebrews. Hebrews 11:1, "Now faith is the substance of things hoped for, the evidence of things not seen." The substance of things hoped for, or in other words, the concrete evidence of things hoped for. To have faith is to know that you know a given thing is here, or on the way, even if we don't see anyway for

it to happen.

Faith in Christ is confidence in Christ. God told Sarah she would bear a child and she believed God even though she was entering the age of being unable to bear a child. Hebrews 11:11, "...and she bore a child when she was past the age, because she judged Him faithful who had promised." Abraham was willing to offer his son to God as a sacrifice because of His faith in God. He knew God would provide for him and he did. (Hebrews 11:17-19)

Hebrews continues on in verses 34-40 showing all the turmoil, difficulties, and heartaches of those who chose to follow Christ. This tells me that having faith doesn't mean we will not have difficulties in live, but rather it shows me that through faith we are able to endure the difficulties.

A footnote in my Bible says, "The same faith that enables some to escape trouble enables others to endure it. The same faith that delivers some from death enables others to die victoriously. Faith is not a bridge over troubled waters, but is a pathway through them." This truth brought me a long way into my understanding of Biblical faith. Whether or not I see an answer to my prayer is not the important part. It's the attitude of my heart. In my heart, I know God to be true to His word. How He chooses to answer is totally up to Him. How I respond to His answer if totally up to me.

The first part of the book of Jude talks about how false teachers have come in trying to teach something other then the true faith. In verse 3 Jude pleads with the saints to hold on to the faith handed down to them, the faith of their forefathers like Abraham, Isaac, and Moses. Jude 3, "...I .. urgently appeal to and exhort (you) to contend for the faith which was once for all handed down to the saints – the faith (which is that sum of Christian belief) which was delivered verbally to the holy people of God." (Amplified Bible)

This is my plea to the body of Christ, hold fast to the faith of our fore-fathers. Don't allow the ideologies of this world to creep in and overtake what you know to be true in God's word. Have confidence in Christ. Know that He will do that which He says He will do. Has my understanding of faith changed as I've grown in God? Absolutely! Do I still wonder at times why God chooses to do a certain thing a certain way? Sometimes, but the difference now is that even though I don't understand why, I know that He is in control and that I can rest in that truth.




