

Minutes of the Meeting of the Board of Trustees of the University of Kentucky, Tuesday, December 9, 1975.

The Board of Trustees of the University of Kentucky met in regular, statutory session at 4:00 p. m. (EST) on Tuesday, December 9, 1975, in the Board Room on the 18th floor of the Patterson Office Tower on the Lexington campus with the following members answering the call of the roll: Professor Michael Adelstein, Mr. William R. Black, Mr. Stanley Burlew, Mrs. Robert O. Clark, Mr. Albert G. Clay, Mr. Richard E. Cooper, Mr. John R. Crockett, Mr. George W. Griffin, Mr. James Harralson, Mrs. David Hermansdorfer, Mr. Thomas B. Kessinger, Mr. Zirl A. Palmer, Mr. Frank Ramsey, Mr. Homer W. Ramsey, Professor Paul G. Sears, Mr. William B. Sturgill, Mr. James A. Sutherland, and Dr. John R. Woodyard. Absent from the meeting was Mr. John R. Gaines. Members of the University administration present included President Otis A. Singletary; Vice Presidents Lewis W. Cochran, Robert Zumwinkle, Raymond R. Hornback, Jack Blanton, and Donald B. Clapp; Mr. John Darsie, Legal Counsel; and Dr. Howard Bost, representing Vice President Peter P. Bosomworth. Representatives of the various news media were also in attendance.

A. Meeting Opened

The Chairman, Mr. William B. Sturgill, called the meeting to order at 4:20 p. m. After the invocation, pronounced by Mr. Black, the Secretary called the roll and reported 18 members present and one absent. A quorum being present, the Chairman declared the meeting open for the official conduct of business at 4:23 p. m.

B. Minutes Approved

On motion duly made, seconded, and carried, the reading of the Minutes was dispensed with and the Minutes for the October 7, 1975, meeting of the Board of Trustees were approved as published.

C. President's Report to the Trustees

In the interest of saving time, President Singletary suggested that the members of the Board read his monthly report in lieu of an oral presentation and recommended its acceptance. The Chairman accepted the report, and it was ordered filed.

D. Recommendations of the President (PR 2)

Mentioning that PR 2, Recommendations of the President, contained only routine personnel changes and the quarterly report on gifts and/or grants received by the University, President Singletary recommended approval of PR 2 as a whole. Mr. Cooper so moved. His motion was seconded by Mr. Frank Ramsey and, without dissent, PR 2 was approved as a whole and ordered made an official part of the minutes of the meeting. (See PR 2 at the end of the Minutes.)

E. Supplemental Recommendations of the President (PR 3-I)

Since the resignation of Mr. James O. King in October, the University has conducted a nation-wide search for a replacement for him. As a result of this search, President Singletary said that it was the unanimous decision of those involved that Dr. Peter Fitzgerald, Assistant to the President at the University of Maine, was the best person available and recommended that Dr. Fitzgerald be named Director of the Office of Policy and Operations Analysis effective on or before February 16, 1976. At the request of the President, Dr. Clapp gave a brief resume of Dr. Fitzgerald's qualifications for the position. He concluded his remarks by mentioning the fact that the title for the job had been changed, adding that the change in title did not change the function of the office.

The Chairman, having determined there were no questions or discussion, called for a motion to approve the recommendation that Dr. Peter Fitzgerald be named Director of the Office of Policy and Operations Analysis effective on or before February 16, 1976. Mrs. Clark so moved. Her motion was seconded by Mr. Homer Ramsey and passed without dissent. (See PR 3-I at the end of the Minutes.)

F. Supplemental Recommendations of the President (PR 3-II)

The second part of PR 3 included an extension of leave for special assignment with State government for Mr. Jack B. Hall for an additional year (January 3, 1976-January 3, 1977) and the reappointment of Mr. Joseph T. Burch as Acting Dean of Students from January 3, 1976 to July 1, 1976 or until such time as a permanent Dean of Students might be named, whichever might come first. President Singletary recommended approval of Mr. Hall's leave and Mr. Burch's reappointment.

In the discussion which followed it was made clear that Mr. Hall's position as Dean of Students and Assistant Vice President for Student Affairs would not be left open for him. A search for a permanent Dean of Students will begin immediately and hopefully the position will be filled prior to the end of the current academic year.

The Chairman called for a motion for approval of President Singletary's recommendation relative to Mr. Hall's leave and Mr. Burch's reappointment. The motion was made by Professor Sears and seconded by Mr. Harralson with all present voting aye. (See PR 3-II at the end of the Minutes.)

G. Candidates for Degrees-University System (PR 4)

President Singletary pointed out that the recommendation for approval of the awarding of degrees in the University System was for those persons completing their work at the end of the current semester and recommended approval of the persons whose names appeared on the list attached to PR 4.

On motion by Mr. Palmer, seconded by Mr. Cooper and passed, the President was authorized to confer upon each individual whose name appeared on the list the degree to which he is entitled upon certification by the Dean of Admissions and Registrar and approval by the University Senate that the individual has satisfactorily completed all requirements of the degree for which he has made application. (See PR 4 at the end of the Minutes.)

H. Candidates for Degrees-Community College System (PR 5)

Approval of recipients of degrees and certificates in the Community College System must be given by the Board of Trustees, and President Singletary recommended that such approval be given to the persons scheduled to complete requirements of the specified degrees in December upon certification by the appropriate officials that such requirements had been completed. The list of names was attached to PR 5.

On motion by Mr. Black, seconded by Mr. Griffin, and passed, the awarding of the degrees and certificates specified on the attached list be awarded to the persons named upon certification that the requirements for those degrees or certificates have been satisfactorily completed. (See PR 5 at the end of the Minutes.)

I. Budget Revisions for 1975-76 (PR 6)

President Singletary recommended approval of PR 6, Revisions in the 1975-76 Budget, noting that they were all routine in nature. There being no questions, on motion by Mr. Homer Ramsey, seconded by Mr. Frank Ramsey, and passed, the budget revisions for 1975-76 were authorized and approved. (See PR 6 at the end of the Minutes.)

J. Proposed Amendments to the Governing Regulations (PR 7)

President Singletary noted that certain proposed amendments to the Governing Regulations had been received at the September meeting of the Board of Trustees and tabled at that time for action at a later meeting. He said that the required month having elapsed, it was now appropriate to remove the proposed amendments from the table and act upon them.

Professor Sears said that he would like to recommend two language changes on page two under "b. Faculty Assemblies". In the underscored section he recommended changing the words "librarians" to "librarianship" and "counselors" to "counseling" so that the recommended change would now read, "Full time faculty members devoting more than fifty percent of their effort to teaching, librarianship, and counseling are eligible for membership in the Faculty Assembly. Other members of the faculty may become members upon invitation by a majority of the members of the Assembly."

Dr. Adelstein moved that the language changes recommended by Professor Sears be accepted. His motion was seconded by Mr. Harralson and passed without dissent.

The Chairman then called for a motion on the adoption of the proposed amendments to the Governing Regulations as amended. Dr. Adelstein moved that the proposed amendments to Parts V; VII-A-8-b as amended, VII-B-8; VII-B-9; VIII-A-3; and X-B-1 of the Governing Regulations received and tabled at the September 16, 1975 meeting of the Board of Trustees be removed from the table and approved. His motion was seconded by Mr. Clay and passed without dissent. (See PR 7 at the end of the Minutes.)

K. Retirement Resolution (PR 8)

At President Singletary's request Mr. Darsie discussed the proposed amendment to the Retirement Resolution saying that it could best be described as "walk-away" retirement. Under present regulations a person must work until age 65 in order to receive supplemental retirement income. The proposed amendment would permit University personnel who would otherwise qualify for supplemental retirement income except that they had not attained age 65 to terminate their employee status on or after attainment of age 60 without forfeiture of accrued benefits, subject to certain specified conditions as set forth in PR 8. However, payment of benefits would not begin until age 65.

Professor Sears said there had been considerable discussion among the faculty and staff members of the University about the desirability of such

a change and he felt it would be welcomed by University personnel. There being no further discussion, on motion by Mr. Sutherland, seconded by Mr. Kessinger, and passed, the recommendation in PR 8 was approved as presented. (See PR 8 at the end of the Minutes.)

L. Amendment of Trust Created by Will of Phil E. Richards, Deceased (PR 9)

After a brief explanation by Mr. Darsie, it was moved by Mr. Homer Ramsey, seconded by Dr. Woodyard, and passed, that the President be authorized and directed to execute, on behalf of the University, an Amendment of a Trust created by virtue of the provision of Article X of the Will of Phil E. Richards, deceased, who died on May 8, 1972, leaving a remainder interest in his property to the University. (See PR 9 at the end of the Minutes.)

M. Information Item

President Singletary said this concluded his part of the agenda but, before yielding the floor, he wished to make two announcements which would be of interest to members of the Board.

1. The resignation of Dr. George Hardy as Dean of the College of Law, effective July 1, 1976, to become Dean of the Bates College of Law at the University of Houston. President Singletary noted that Dean Hardy has done a good job here and he regretted to see him go; however, that is the danger inherent in bringing good young people to an institution in that other institutions soon seek them out and entice them away.

2. The gift by Mr. and Mrs. James C. Givens of Hopkinsville and Mr. and Mrs. Marvin Friedman of Nashville of a motel near Madisonville to the University of Kentucky. The motel, which until recently was part of the Holiday Inn system, has 62 rooms, dining area, kitchen, lobby, and swimming pool, situated on about three acres of ground.

The University is most grateful for this generous gift and it will be used in conjunction with the Madisonville Community College and as a continuing education center in Western Kentucky for such professional fields as Engineering, Medicine, Law, Mining Technology, and others.

N. Interim Financial Report (FCR 1)

Mr. Clay said that the Finance Committee had not met prior to the Board meeting, but that a telephone canvass of its members had resulted

in a unanimous committee recommendation that the Interim Financial Report for the period ending October 31, 1975, be accepted and ordered made a matter of record, and he so moved. His motion was seconded by Mr. Harralson and passed without dissent. (See FCR 1 at the end of the Minutes.)

O. Meeting Adjourned

After determining that there was no further business to come before the meeting, the Chairman called for a motion for adjournment. The motion being duly made, seconded and carried, the meeting adjourned at 4:45 p.m.

SUPPLEMENTAL RECOMMENDATIONS OF THE PRESIDENT

I. Administrative Appointment

Recommendation: that Dr. Peter H. Fitzgerald be appointed Director, Office of Policy and Operations Analysis effective not later than February 16, 1976.

Background: Dr. Fitzgerald is eminently qualified to direct this office which has responsibilities in the area of institutional studies, management information and planning. The office is currently titled Management Information and Analysis but will be titled Policy and Operations Analysis effective with Dr. Fitzgerald's appointment. Dr. Fitzgerald is currently Assistant to the President of the University of Maine at Orono, having general staff responsibility for institutional studies, management information systems, planning, and professional personnel management. He holds a Ph. D. degree in Higher Education Administration from Stanford University and a M. A. degree in English from the University of Maine. Dr. Fitzgerald previously held appointments on the Department of English faculties at the University of Cincinnati and the University of Maine at Orono. He is currently an elected member of the School Board in the city of Bangor, Maine. Dr. Fitzgerald replaces Mr. James O. King who resigned in October to become an assistant to Senator Wendell H. Ford.

II. Appointments and/or Other Staff Changes

Recommendations: (1) that approval be given to the appointments and/or other changes which require Board action; and (2) that the report relative to appointments and/or changes already approved by the administration be accepted.

Background: A copy of PR 8 which was received and tabled at the September 16, 1975, meeting is attached. As explained at that meeting, most of these proposed changes are primarily editorial.

VII-A-8-b amended to read:

b. Faculty Assemblies

[Each] The faculty of a community college may organize [itself as] a Faculty Assembly for the purpose of making recommendations relating to [any phase of the academic program of the college or of the Community College System and to] the professional welfare of its members. It shall prepare a set of rules which shall describe its organization and procedures for the performance of its functions. Full-time faculty members devoting more than fifty percent of their effort to teaching, librarianship and counseling are eligible for membership in the Faculty Assembly. Other members of the faculty may become members upon invitation by a majority of the members of the Assembly.

PROPOSED AMENDMENTS TO THE GOVERNING REGULATIONS

Recommendation: that the following proposed changes in the Governing Regulations of the University of Kentucky be received for consideration and be put on the agenda for approval by the Board of Trustees at its next regular meeting.

Background: Recently all regulations, policies and procedures relative to the University of Kentucky Community College System have been reviewed with respect to adequacy, clarity and correctness. The eight amendments to the University of Kentucky Governing Regulations which are proposed herewith were included among the recommendations resulting from the reviewing. Amendments (a), (b) and (f) were initially recommended to the President by the Community College Council and/or Senate of the Community College System; the other five amendments were recommended by an Ad Hoc Advisory Committee to the President.

(Note: Proposed additions are underlined; proposed deletions are bracketed.)

- (a) Change Part V, page 16, to describe the seventh function of the Senate of the Community College System as follows:

Recommending to the President all candidates for degrees and certificates from the community colleges and technical institute.
The Senate may delegate this function to the faculties of the community colleges and the technical institute.

Rationale: This addition makes it permissive for the Senate of the Community College System to delegate one of its functions to the faculties of the community colleges and technical institute. The faculty of an individual community college or technical institute is appropriately qualified for recommending to the President all candidates for degrees and certificates from that educational unit. There is no obvious advantage to justify the faculty time and travel costs associated with convening the Senate of the Community College System, or its Community College Council, to perform this function.

- (b) Change the first paragraph of Part VII, A, 8, b to read:

b. Faculty Assemblies

[Each] The faculty of a community college may organize [itself as] a Faculty Assembly for the purpose of making recommendations relating to [any phase of the academic program of the college or of the Community College System and to] the professional welfare of its members. It shall prepare a set of rules which shall describe its organization and procedures for the performance of its functions. Full-time faculty members devoting more than fifty percent of their effort to teaching, librarians and counselors are eligible for membership in the Faculty Assembly. Other members of the faculty may become members upon invitation by a majority of the members of the Assembly.

Rationale: The modifications in this section provide needed clarifications concerning the membership and functions of Faculty Assemblies.

- (c) Separate the last two sentences from the first paragraph of Part VII, B, 8 and, after modification, add these sentences as new second and third paragraphs in that section to read:

[He] The director shall review and finalize the performance evaluations [submitted] recommended by the division chairmen or [members] other administrative personnel of his college.

[He] The director shall be responsible without delegation for recommendations on salaries, salary changes, appointments, reappointments, terminal appointments, decisions not to reappoint, post-retirement appointments (X, C, 8), promotions and granting of tenure for members of his college or for ultimate action thereon when such authority has been delegated to him by the Vice President for the Community College System or the President.

Rationale: These changes provide needed clarifications and emphases with respect to certain roles or responsibilities of the director of a community college.

- (d) Change the first sentence of the second paragraph of Part VII, B, 9 to read:

The division chairman shall be responsible for advising the director [or his designate] on the appointment of new members of the division, promotions, reappointments, terminal appointments, decisions not to reappoint, post-retirement appointments and the granting of tenure, following consultation with the tenured [and senior] faculty of the division.

Rationale: The changes in this section provide needed clarification of the direct role of a director in handling personnel matters and deletion of the ambiguous term "senior".

- (e) Expand the third paragraph of Part VII, B, 9 to read:

The division chairman shall be responsible for the periodic evaluation of members of the divisions by procedures and criteria established by the University, the Community College System and the community college and divisional faculties. The division chairman shall make recommendations to the director who shall make final decisions relative to such evaluations.

Rationale: This addition provides further clarification of the roles of the director and the division chairman with respect to faculty performance review.

- (f) Change the seventh paragraph of Part VIII, A, 3 to read:

A search committee for a director of the community college shall be appointed by the Vice President for the Community College System after consultation with [the Community College Council and] the faculty of the community college.

Rationale: This deletion will permit the Vice President for the Community College System to appoint a search committee without prior consultation with the Community College Council which normally meets only three or four times per year. Believing that little is gained from such consultation, the Council itself initiated the recommendation for this change.

- (g) Change the eighth paragraph of Part VIII, A, 3 to read:

Search committees for chairmen of divisions in community colleges shall be appointed by the director of the college after consultation with at least the tenured [and senior members of the faculty] faculty members of the concerned divisions.

Rationale: This change in wording eliminates the ambiguous term "senior" and establishes a minimum level of consultation prior to the appointment of search committees for chairmen for divisions in community colleges.

(h) Delete the last sentence in Part X, B, 1:

Full-time academic appointments shall be of three kinds: (1) non-tenure appointments; (2) appointments with tenure; and (3) post-retirement appointments (X-C-8). [After the expiration of a probationary period, non-tenure appointees may be granted tenure.]

Rationale: The deleted sentence is considered unnecessary and, to some extent, misleading since a faculty member may be promoted to associate professor and granted tenure prior to the full length or expiration of a probationary period.

RETIREMENT RESOLUTION

Recommendation: that members of the faculty and staff who would otherwise qualify for supplemental retirement income pursuant to the University's Retirement Resolution as amended, except that they have not attained age sixty-five, be permitted to terminate their employee status on or after attainment of age sixty without forfeiture of accrued benefits, subject to the following conditions:

1. Payment of benefits shall not begin until the month in which the employee attains age sixty-five.
2. Service credit shall not accrue during periods in which the retiree is in a non-employee status.
3. The annual salary rate used to determine supplemental retirement income shall be the salary for the last year of active employment.
4. Employees who elect to proceed under this option shall not receive additional supplemental retirement benefits which exceed 20% of salary at retirement plus 1% for each year of service to the University.
5. The computation of supplemental benefits will be based upon the amount of a single life annuity payable to the employee at retirement. This computation is to assume that all funded contributions made by the employee and the University were made solely to TIAA from the beginning of such contributions regardless of the allocation of contributions between TIAA and CREF actually selected by the employee.
6. Supplemental retirement benefits are not payable to survivors in the event the retiree dies prior to the attainment of age sixty-five. . . .

Background: Under current University practices many employees who were employed prior to July 1, 1964 will receive retirement income from two sources: one is the TIAA-CREF funded retirement plan; the other is the unfunded retirement plan under which the University will pay supplemental retirement income to the affected individuals. Some employees will receive benefits only by virtue of the unfunded plan.

At present an employee who elects to terminate his or her employment status prior to age sixty-five, except in certain circumstances beyond the control of the employee, loses all entitlement to retirement income under the unfunded plan.

Under this proposed amendment employees who reach age sixty may retire early and begin to receive retirement benefits when they reach age sixty-five.

AMENDMENT OF TRUST CREATED BY WILL OF
PHIL E. RICHARDS, DECEASED

Recommendation: That the President be authorized and directed to execute, on behalf of the University, an Amendment of a Trust created by virtue of the provisions of Article X of the Will of Phil E. Richards, deceased, who died on May 8, 1972, leaving a remainder interest in his property to the University.

Background: This Amendment is authorized by Sections 386.350, 386.355 and 386.360 of the Kentucky Revised Statutes and will permit the charitable trust interests created under the Will to maintain a tax benefit extended to the beneficiaries thereof, namely, the right of the estate to deduct on its estate tax return the appropriate value of the bequest to each such charitable trust interest. The net result will be a tax savings of \$28,724.54 to the estate and ultimately a proportionate benefit to the University as one of four remaindermen.
