## Classes Ending in "4" and "9" To Return In June

## Fifty-Five Gridders Report For Drills

Fifty-five gridders reported for practice on the first day of the spring football drills held on Stoll field. Five more were expected to report for practice at the close of the current basketball season. All the veterans and promising freshmen of last year were on hand. The total includes some 35 men from last year's varsity squad, 22 of which are lettermen.

A short drill of passing, kicking, calisthentics and other forms of limbering-up was directed by Coach Kirwan and his staff, which includes Line Coach Bernie Shively, End Coach Frank Mosely, and Freshman Coaches Gene Myers and Joe Rupert.

Making his appearance on Stoll field also was a voluntary assistant coach who will remain as a member of the coaching staff until the spring drills are over. The new coach was Bert (Man o' War) Johnson, former Kentucky grid star, now a member of the Chicago Bears professional team.

If weather will permit it is hoped that the squad will get in at least six weeks of good practice this spring.

The spring football drills officially move Coach Ab Kirwan into his second season as head Wildcat coach.

## Frosh Caps To Stay

A virtual mandate to continue the freshman cap custom on the UK campus was voiced by students when more than 400 votes were cast for retention, 43 against.

The custom originated in 1913 and was designed to replace the campuswide habit of shaving the head of first-year men. The plan was short lived and the old policy of headshaving returned. In 1917 headshaving again fell into disfavor and the wearing of the caps was again introduced.

Since that year every class of freshmen entering the University has been required to wear the caps.

## Wildcats Win Southeastern Net Crown; Five Players Given Conference Honors

The University of Kentucky Wildcats won their third Southeastern basketball championship since 1933 by defeating the hard fighting Tennessee Volunteers by a score of 46 to 38 in the final game of the Southeastern tournament at Knoxville, Tenn., March 4.

Kentucky won its way to the finals of the Conference tourney by virtue of victories over the University of Mississippi, 49 to 30, and Louisiana State University, 53 to 34

Kentucky, fighting uphill to overcome a 17 to 10 lead piled up by Tennessee in the opening minutes of play, had forged ahead at the end of the half by a score of 24 to 19. From then on the ferocity of the Wildcat's attack and the brilliant playing of Bernie Opper, guard, were too much for the Volunteers.

During the second half the issue was never in doubt although Tennessee kept on trying with the vigor of a team unwilling to give up. Summed up, the Wildcat's victory was due to their superior speed, strength, coaching and power; the inspired leadership they received from Opper, whose 13 points topped the scores for both teams; and the Cat's ability to make 14 out of 20 free throws.

The superior playing of Opper won for him a place on the mythical all-Conference team selected by newspaper men. He received more first place votes than any other player participating in the tourney. Two other players, Keith Farnsley, forward, and Homer Thompson, center, were placed on the second mythical team. Lee Huber, guard, Mickey Rouse, guard, and Marion Cluggish, center, received honorable mention.

The winning of the Southeastern Conference title this year marks Coach Adolph Rupp's ninth year at the University. During this time
