The SAALCK (State Assisted Academic Library Council of Kentucky) group accepted a proposal at their meeting in Elizabethtown on 3 Feb. 75 to implement a Clearinghouse operation located at UK. It will work in the following manner.

Member libraries will send information on all library purchases of \$100 or more to Interlibrary Loan at UK. ILL will maintain the file by title.

Also, any member library that is interested in any item \$100 or more may send information on that item to ILL at UK and ILL will poll member libraries to see if anyone has it or is considering buying it. This information will then be sent back to the requesting library. These transactions will largely be handled by TWX. A file will also be kept on these inquiries by title.

It is hoped that after about six months of operation the Clearinghouse operation will yield sufficient data to enable to SAALCK group to decide whether to keep it or discontinue it.

The basis for the Clearinghouse is the belief that it will help the SAALCK member libraries make better use of their resources. In other words, cut down on duplication of expensive library materials.
