



We enclose herewith a copy of opinion of Mr. Dummit, Attorney General of State of Kentucky.

Under the Federal Act, Congress recommends to the different States the enactment of laws giving absentee voters the right to vote for Federal, State and Local officials by absentee ballots, while serving or attached to the Armed Forces of the United States.

The Kentucky law pertaining to absentee voters provides that the absentee voter shall have the right to vote in all Special, General and Primary elections of electors for President and Vice President of the United States, United States Senator and Representatives in Congress, and you will note that it makes no provision for the absentee voter voting for State and Local officials in time of war.

As we see the law under the Kentucky Act, it will be necessary for us to withdraw all absentee voter's cards prior to Primary or General Elections held for the purpose of electing State or Local officials. You will see, however, that some of these absentee voters who are now in service will no doubt be out of service before the next Primary and General Election in 1946 and no doubt will present themselves in person to vote and will find that their cards are withdrawn from the record. There is no way for us to ascertain which of these absentee voters will return prior to that time and, therefore, we do not know what to do under these circumstances and ask that

November 13, 1944.

Dear Mr. Moore:

We have your letter of the 10th in which you ask  
what you should do with these registrations under the Absent  
Voter Law, who were eligible and registered by you, as  
provided in Section 4, of this Act.

Under this section regarding registration, you  
register them, if eligible, and mark them "Absent Voter".  
The Statute reads:

"The same shall constitute sufficient registration  
under the laws of this State."

It would seem from this that these registrations  
are supposed to be permanent like regular registrations until  
the voter moves or his registration is cancelled.

Of course, a person may be an absent voter in  
these elections of President and Vice-President and Federal  
Representatives for a particular election, but not an absent  
voter except in that election. The application as an absent  
voter refers to a specific election, and we do not think there  
is an assumption that the voter so absent will continue to  
be absent in other elections not specifically designated in  
the application. However, we believe you should continue these  
registrations as a part of your regular registration records  
and not discard them from being registered voters for future  
elections.

This is our interpretation under the statute above  
quoted.

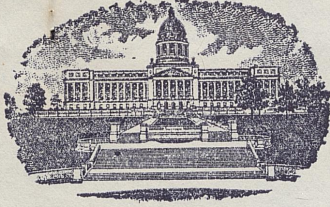
