PREFACE

The publication herewith presented, an index to the probate cases filed in Trinity County, Texas, is No. 228 of the Texas series of counties. The publication is intended to meet the requirements of day-to-day usage by the officials of the county, attorneys, businessmen, and other citizens who have occasion to consult probate case records for the proper conduct of their affairs. The publication may be used by historians and genealogists to obtain references to unpublished source material.

The names of the deceased persons, minors, and other principals are arranged alphabetically, with reference to filing date of the case and the case number. Differentiation between probate cases assigned duplicate numbers is accomplished by the addition of a letter following the case number, except in lunacy cases the prefix "L" is used. Case numbers preceded by "O" were assigned to previously unnumbered cases. The following numbers in series 1-933 were not used as case numbers: 1-4, 6-10, 33, 62, 97, 260-299, 556, 912-917, 931.

In Trinity County all probate records are in the custody of the county clerk. Case papers are filed in separate file jackets in steel file drawers - the active cases, dating from July 1934, in 3 file drawers in the county clerk's office; the inactive cases in 23 file drawers in the clerk's vault.

Since the transfer of territory from one county to another has affected probate jurisdiction and has determined the county in which the probate case should be filed, a map and table of territorial changes are included herein. Notations concerning present location and availability of records pertinent to Trinity County follow:

Houston County, Crockett, all probate records prior to November 1859 destroyed by fires in 1865 and 1882.

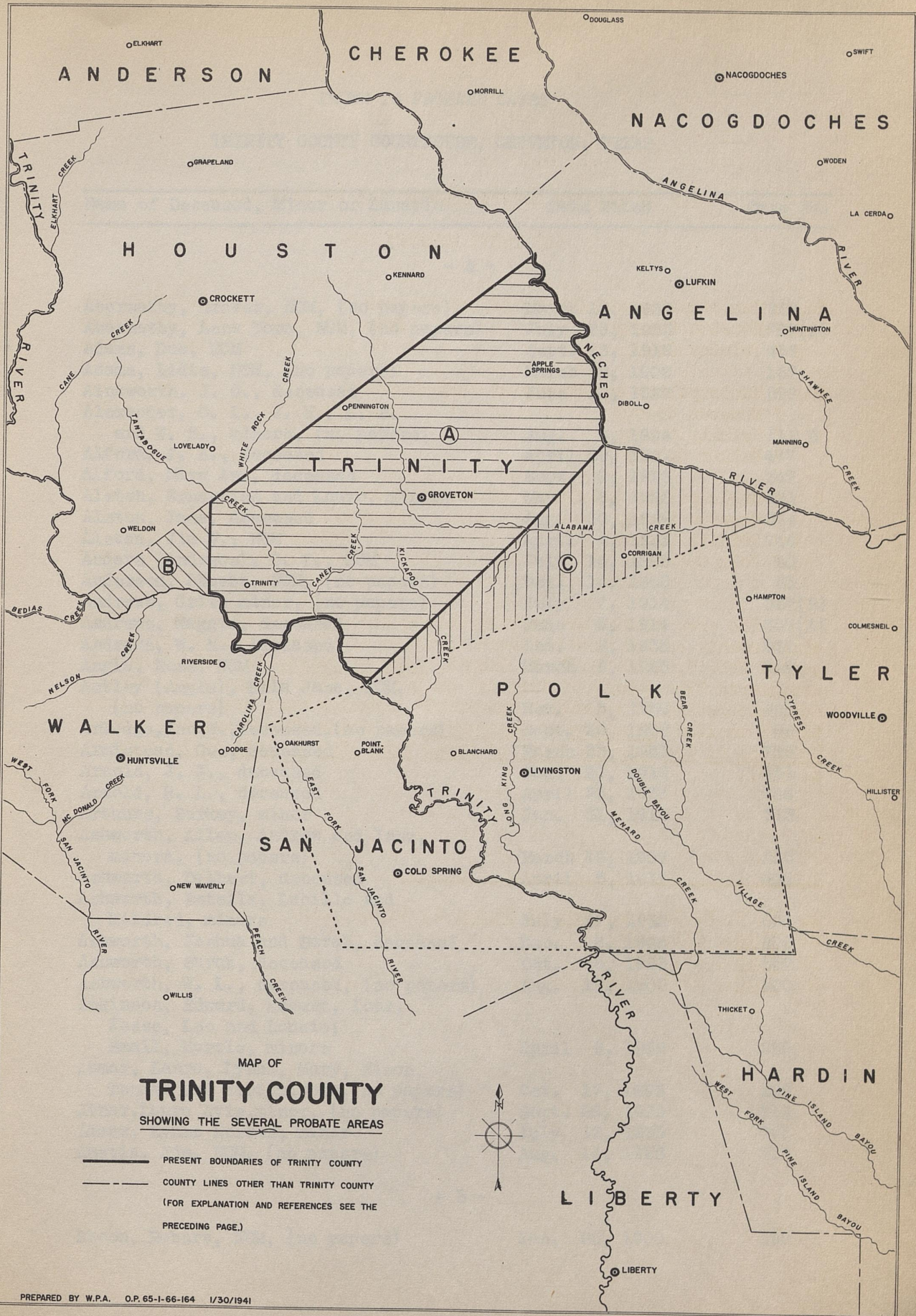
Nacogdoches County, Nacogdoches, all records extant.

The area within the heavily dotted lines was organized as a "judicial" county called "the Northern division of Liberty County" by an act passed Feb. 5, 1840 (H. P. N. Gammel, Laws of Texas, II, 379), and was designated "The county of Trinity" on Dec. 7, 1841 (Gammel, II, 680). Acts attempting to establish "judicial" counties were held unconstitutional in 1842 (Stockton v. Montgomery, in James Wilmer Dallam, comp., Opinions of the Supreme Court of Texas from 1840 to 1844 Inclusive, p. 473).
