Wildcat '38 Football Campaign Closes With 2 Wins, 7 Losses

The 1938 Wildcat football season with two wins and seven losses is now history. Bad history in a way, but again in the light of pre-season predictions not so bad. None of the sports writers predicted Kentucky to sweep all foes before it. None of them picked the Wildcats to win half of their games. On the contrary, it was conceded that four games won out of nine games played would be an extremely fortunate break.

Only the optimistic fans gave Kentucky a chance of winning over any of its Southeastern Conference foes. Yet the Wildcats scored on three of their Conference opponents. Last season they failed to score a single point on these foes.

No one doubted that Maryville

and Oglethorpe would be easily defeated. The Xavier and Clemson games were said to be tossups. Only in one game did the predictions of the sports writers fall short, that being in the Washington and Lee-Kentucky game which the Wildcats lost.

The 1938 team failed to live up to expectations in but two instances, these being its poor showing against Tennessee and its defeat at the hands of Washington and Lee. On the other hand the Wildcats were not expected to put up such a fight against Vanderbilt, Alabama, and Georgia Tech.

Thus as to games won and lost the Wildcat campaign was some what a disaster. But from the point of material at hand and schedule encountered it was successful.

Classes ending in "4" and "9" will return to the campus in June to attend their reunion, which also marks the fiftieth anniversary of the Alumni Association of the University of Kentucky.

The Alumni Office is now busy compiling lists of reunion classes and as soon as these are completed they will be mailed to members of the respective classes. On these lists will be several alumni from which mail has been returned unclaimed. Information as to the whereabouts of these alumni will be much appreciated by the Alumni Office.

Interest in the June reunion is already mounting. Heber Holbrook Rice writes, "As president of the Class of 1904, I would be glad if you will announce that we hope to make the thirty-fifth anniversary of our class in June, 1939, a great class reunion on the campus of the University. I urge all members of the Class of 1904 to honor the occasion with their presence that the 'Echoes of 1904' may still reverberate!"

A letter from Marcus C. Redwine, president of the Alumni Association and a member of the Class of 1919, states that "the Class of 1919 is going to do its best in leading all the rest of the classes next June in its reunion plans." Hugh M. Milton, II, president of New Mexico State College and also a member of the class of 1919 writes, "The reunion of my class makes it doubly insistent that I should be present next June. I can assure you that this has been my plan for several years, and I am hoping that no unforeseen event will interfere with my presence on that occasion."

The reunion program will consist of class luncheons, banquet, commencement exercises, the McVey tea, in addition to a special program in celebrating the Association's fiftieth anniversary.

The Alumni Office solicits your correspondence and suggestions concerning the coming June reunion, especially from class officers. Help make your reunion the best ever.

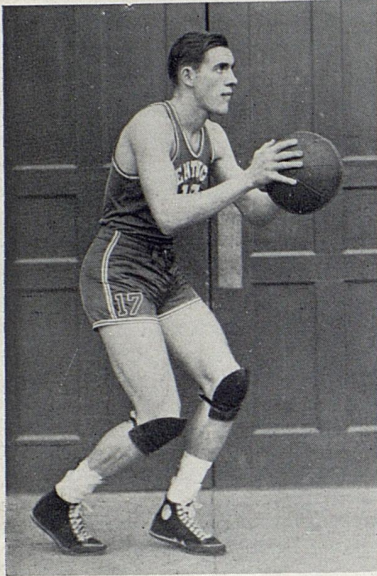

Plaque Ceremonies Honor Dr. McVey

Honoring President Frank L. McVey's 21 years of service to the University of Kentucky, a bronze plaque, the gift of students, alumni, faculty members, and other friends, was unveiled at 4 p. m. Tuesday, November 22, in the main lobby of the University library.

Over 500 persons attended the unveiling ceremonies of the plaque which was secured through contributions and sponsored by Omicron Delta Kappa, men's leadership fraternity.

Virginia Murray Tilton, granddaughter of President McVey, unveiled the plaque. Music for the dedication was furnished by the Men's Glee Club.

A dinner in honor of President McVey, sponsored by Omicron Delta Kappa, was given at seven o'clock in the ball room of the Student Union Building following the dedicatin of the plaque.

Principal speaker was Lena Madison Phillips, '17, prominent New York attorney and the first woman graduate of the University of Kentucky College of Law. Some 225 persons attended the dinner.

Active membership in the University of Kentucky Alumni Association for the current year to date is 1635.

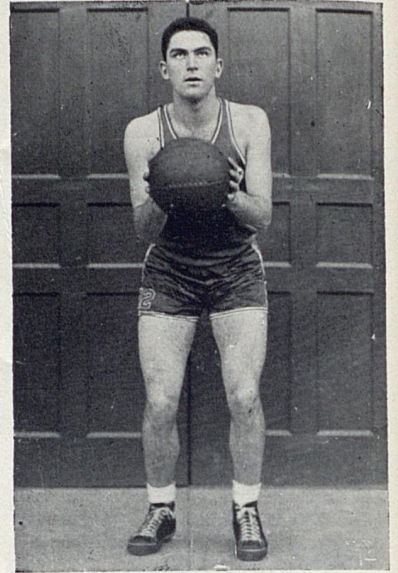
The University of Kentucky basketball squad for 1938-39 has potentialities of giving the school one of its finest teams in basketball history.

Coach Adolph Rupp is very much pleased over the outlook and he is never inclined to become too optimistic unless there is really something to be optimistic about. Rupp is definitely rounding his squad into shape with the thought of winning the Southeastern Conference championship, which the Wildcats won two years ago.

Present indications show that there will be no glaring weakness at any spot in the Wildcat team. The team will be well-balanced and there should be no weakening of the team when subs are shoved into the game.

Kentucky has probably the finest corps of guards in the country. There is Capt. Bernie Oppen, an all-conference man last year, and Layton (Mickey) Rouse, who as a sophomore last season played with flashes of brilliant form. Then there are Lee Huber and Ernie Jefferson, both all-state high school players two years ago. Huber is also the state's No. 1 tennis player. Walter (Whirly) Hodge, another player in the guard ranks, remains

a question mark. Hodge was an all-conference guard two years ago but football injuries kept him out of action last season. Both knees were operated on last spring and it remains to be seen if they will take the punishment that basketball requires.

Vieing for the center position are "Tub" Thompson and Marion Clugish, both big fellows but natural ballplayers.

The top men in seeking the forward positions are Jim Goodman, a junior, and Keith Farnsley, a sophomore. However, stiff competition will be had from Elmo Head and Cab Curtis, both seniors who have seen considerable action in the past two years. Also working for the forward position will be Donald Orme, sophomore.

Coach Rupp, ably assisted by Paul McBrayer, '31, is working with a squad of about twenty.

Whatever combination the coaches finally decide on as their first-string team will prove stiff competition for all the Wildcats' opponents. Kentucky should be the outstanding team in the Southeastern Conference this year.
